4 workers killed in cylinder blast at factory in Assam's Cachar, CM condoles deaths

SILCHAR: (Jul 26) At least four workers were killed in a suspected cylinder explosion at an iron casting unit in Cachar district of Assam on Sunday, police said. The incident took place in the afternoon at a shared compound of Kade Global Infrastructure LLP and IRID Casting Works LLP in Pangram under Udhlabond police station limits, a senior officer said. "A sudden explosion shattered the factory and several people suffered injuries. They were taken to Silchar Medical College and Hospital, where four people were declared dead," he said.

CM Revanth seeks lower age limit for elections

Proposes Jai Jawan Jai Kisan Jai Yuva Seeks Lower Age Limit for Contesting Elections

Hyderabad (TSIT Bureau):

Telangana Chief Minister A. Revanth Reddy has proposed a new national slogan, "Jai Jawan, Jai Kisan, Jai Yuva," stressing that youth should play a greater role in shaping India's future. He urged the Central Government to amend the Constitution and reduce the minimum age for contesting Assembly and Lok Sabha elections from 25 to 21 years.

Addressing representatives of the national media in Hyderabad, the Chief Minister said young people have emerged as leaders across the world in governance, technology and business, and deserve greater opportunities in democratic institutions.

He also expressed con-



cern over issues related to national-level examinations such as CBSE, NEET and NEET, urging the Centre to safeguard students' interests, review cases registered during student protests and extend support to affected families.

Revanth Reddy noted that many 21-year-olds already serve as IAS and IPS officers, lead global organisations and hold elected positions in local bodies. He argued that they should also be eligible

to contest Assembly and Lok Sabha elections at the same age.

The Chief Minister proposed reducing the minimum age for contesting Legislative Council and Rajya Sabha elections from 30 to 25 years. He announced that a joint session of the Telangana Legislative Assembly and Council would be held in August to discuss the proposal and adopt a resolution to be forwarded to the Centre after consultations with all political parties.

He also urged the Central Government to consider the proposal along with electoral reforms such as delimitation, an increase in Parliamentary seats and women's reservation, saying greater youth participation is vital for India's democratic future.

WILL NOT CONTEST 2028 ASSEMBLY POLLS: SIDDARAMAIAH

Former Karnataka Chief Minister Siddaramaiah on Sunday, July 26, announced that he will not contest the 2028 Assembly polls, citing advancing age and politics becoming "deeply polluted". The Congress Working Committee



member, however, asserted that he will remain active in politics and continue to be a voice for the people's hardship and well-being. "Politics has become deeply polluted today, and for that reason I will not contest the 2028 Assembly elections. However, I will remain active in politics and continue to be a voice for the people's hardships and well-being," Siddaramaiah said in a post on 'X', detailing what he said at a private event held on Saturday in K R Pet in Mandya district.

PM asks Nilekani panel to draft exam reforms

New Delhi (TSIT):

Prime Minister Narendra Modi on Sunday announced the constitution of a task force on exam reforms under Infosys co-founder Nandan Nilekani. Prime Minister Modi said that the report of the task force will be used for taking steps to ensure the credibility of upcoming examinations.

The decision to rope in Nilekani, who is the brain behind Aadhaar number, comes a day after a students' agitation against alleged paper leaks concluded following the resignation by Union Education Minister Dharmendra Pradhan.

Sharing a video statement on Sunday, Prime Minister Modi said, "The Government of India is continuously taking various measures for the future of students. Those who tampered with the



students' future are languishing in jail. We have already established fast-track courts. We are also moving towards enacting new legislation in Parliament that incorporates stringent legal provisions." "However, we must look to the future. Our examination system needs to be reliable and transparent, and it must make maximum use of technology. Keeping all these factors in mind, we have decided to constitute a high-powered task force under the lead-

ership of the world-renowned technology expert Nandan Nilekani," the Prime Minister added.

"This task force will focus on examination reforms, and based on its report, steps will be taken to ensure the credibility of upcoming examinations at the earliest," he said.

Apart from technology expert Nandan Nilekani, the task force will include former ISRO Chairman S. Somnath, former IB Director Tapan Deka, IIT Chennai Director V. Kamakoti, former Education Secretary Anita Karwal and Logistics Expert Amrit Lal Meena, an official statement said.

Earlier on Sunday, Union Minister Pralhad Joshi, who assumed charge as the Union Education Minister on Sunday, expressed gratitude to PM Modi for entrusting him with the responsibility.

After Pradhan's resignation, BJD, Cong demand Odisha minister's removal over textbook errors

A day after Dharmendra Pradhan resigned from the Union Cabinet over the NEET paper leak,

opposition parties in Odisha on Sunday demanded the removal of state minister Nityananda Gond for alleged errors in the school textbooks for classes 1 to 8.

Odisha Pradesh Congress Committee president Bhakta Charan Das threatened to call a statewide bandh if Gond does not resign for the "grave mistakes in the school textbooks". "We know that Pradhan was forced to resign. Odisha's School and Mass Education Minister Nityananda Gond should resign, taking responsibility for the textbook errors. Our party has given an ultimatum to the Mohan Charan Majhi government in Odisha either to take the resignation of Gond or sack him," Das said.



Lotus-shaped lab-grown diamonds from Surat shine aboard Vikram-1: CEO

Surat (TSIT):

The CEO of a Surat-based firm has claimed that its lotus-shaped design of laboratory-grown diamonds sparkles on recently launched Skyroot Aerospace's Vikram-1 orbital rocket. The firm has sent its lotus collection of lab-grown diamonds to Skyroot. "When the sun rays fall on the rocket orbiting space, the diamonds sparkle

wonderfully," said Nityas Gems and Jewellery CEO Rajnikanth Chanchad on Sunday. He claimed Surat, known as the diamond city, has for the first time sent a diamond into space. Skyroot Aerospace recently successfully launched India's first privately developed orbital rocket, Vikram-1, under Mission Agaman from the Satish Dhawan Space Centre (SDSC-SHAR) in Sriharikota.

3RD T20I:

Mayank picks 3-29 as India beat Zimbabwe by 35 runs, complete 3-0 sweep

Harare (TSIT):

Spearheaded by Mayank Yadav's impressive 3-29, India capped off a clinical trip to Zimbabwe with a 35-run victory in the third T20I and complete a 3-0 series sweep at the Harare Sports Club on Sunday. The victory also gave new T20I skipper Shreyas Iyer his maiden series sweep as India's captain.

Having arrived on the back of disappointing series defeats in Ireland and England, India produced a clinical all-round performance to assert their dominance. Vaibhav Sooryavanshi set the tone early with a sparkling 81 to



lift India to a formidable 192/5 on a slow pitch.

In defence of the total, Mayank was clinical in using short of good length and short balls to ensure Zimbabwe were never in the hunt. Despite a sloppy display in the field that saw five chances being dropped, India restricted

Zimbabwe to 157/7 to wrap up a comfortable series win. Chasing 193, Zimbabwe's reply got off to a disastrous start as Mayank struck with the very first ball of the innings - just like he did in the first T20I. The express pacer produced a 147kph thunderbolt that nipped

away and drew an edge from Brian Bennett, which Vaibhav Sooryavanshi caught sharply at first slip.

Yash Thakur's double-strike in the fourth over effectively derailed Zimbabwe's chase. Thakur first outsmarted Dion Myers (19) with a clever 125kph bouncer, which the batter tamely chipped to Shreyas Iyer. On the very next ball, Thakur produced a moment of magic - getting a 143kph delivery to take skipper Sikandar Raza's leading edge before diving dynamically in his follow-through to pluck a sensational one-handed stunning catch.

Telangana sanctions Rs 2,278 cr for joint-user airfield in Adilabad

Hyderabad (TSIT) : The Telangana government on Saturday, July 25, sanctioned Rs 2,278.14 crore for the establishment of a joint-user airfield in Adilabad. Roads, Buildings and Cinematography Minister Komatireddy Venkat Reddy hailed the move as a key step in the development of North Telangana.

A total of 2,009.23 acre of land will be acquired for this project, out of which 1,609.23 acre will be allocated to the Indian Air



Force (IAF) and 400 acres will be allocated for the civil aviation enclave, MRO, cargo terminal, hangars and future expansion needs.

The funds will cover all ancillary works such as diversion of existing roads, relocation of 765 kV high-

tension power lines, diversion of streams, alteration of Mission Bhagiratha drinking water pipelines, and removal of electricity poles.

Komatireddy said that the Adilabad Joint User Airfield is a strategically crucial project for the state as it will provide a significant boost to industrial development, investments, cargo transport, tourism and defence sectors in North Telangana. The project will also create direct and indirect employ-

ment opportunities for thousands of youth, he said. The minister said that the project is progressing at a fast pace due to continuous coordination with the Union Ministry of Defence, the Ministry of Civil Aviation and the Airports Authority of India.

District administration has been instructed to complete the land acquisition, replacement of roads, power lines and other infrastructure works by December 31 this year.

Komuravelli Railway Station Inaugurated Kishan Reddy Highlights Telangana Railway Development

Hyderabad TSIT: Union Minister for Coal and Mines G.Kishan Reddy on Sunday inaugurated the newly constructed Komuravelli Railway Station, calling it a major milestone that would improve connectivity to the renowned Mallikarjuna Swamy Temple and benefit lakhs of devotees.

Addressing the gathering Minister said the station, built at a cost of Rs.6 crore, was designed to reflect the architectural grandeur of the temple and was constructed despite not being part of the original railway proposal. He said the project, whose foundation stone was laid in 2024, has now become a reality.

Kishan Reddy announced that Secunderabad-Siddipet DEMU trains will now halt at Komuravelli, providing affordable travel with fares as low as Rs.25 from Secunderabad. He said the service would benefit pilgrims, students, employees and small traders while promoting religious tourism and local economic activity.

Highlighting the Centre's investment in Telangana's railway sector, the Minister said railway projects worth Rs.47,984 crore are currently under various stages of execution. He noted that 340 km of new railway lines, 576 km of doubling, tripling and quadrupling works, and 2,034 km of railway electrification have been completed in the State.

Telangana since 2014.

Referring to future plans, the Union Minister said the Centre has proposed high-speed rail corridors connecting Hyderabad with Bengaluru, Chennai and Pune, besides approving the final location survey for the Regional Ring Rail (RRR) project.

Congratulating Indian Railways, South Central Railway officials, public representatives and local residents for completing the project, Kishan Reddy expressed confidence that the new railway station would strengthen connectivity, boost tourism and contribute to the overall development of the region.

Model United Nations Inaugurated with Grandeur at The Hyderabad Public School, Warangal

Telangana's Employee Health Scheme Makes a Promising Beginning

Fulfilling a long-pending demand of Telangana Government employees and pensioners State Government under the leadership of Chief Minister A. Revanth Reddy launched the Employee Health Scheme (EHS) on July 17, 2026. The scheme provides cashless medical treatment to serving employees, pensioners and their eligible dependants through a network of empanelled hospitals across the State.

The scheme has made an encouraging start, with employees and pensioners availing cashless medical services from the very first week of its implementation. Between July 18 and July 25, a total of 437 beneficiaries received cashless treatment through 153 empan-



elled hospitals across 17 districts of Telangana, highlighting the swift rollout of the scheme.

Of the total beneficiaries, 184 government employees underwent treatment worth 40,42,786, while 253 pensioners received treatment valued at 73,70,035. Overall, cashless treatment worth Rs. 1,14,12,821 was extended during the first week itself, demonstrating the scheme's immediate impact on employee welfare.

The empanelled hospital network became operational across the State from day one. Hyderabad leads with 47 hospitals, followed by Medchal-Malkajgiri (21), Rangareddy (14), Karimnagar (13) and Hanamkonda (12). The extensive hospital network enables beneficiaries to access quality healthcare closer to their homes without the burden of arranging funds before hospitalisation.

For government employees and pensioners, the availability of cashless healthcare has been a long standing requirement. The launch of the Employee Health Scheme marks a significant milestone in strengthening the social security framework for the

State's workforce and retired employees. By eliminating the need for upfront medical expenses at empanelled hospitals, the scheme offers timely financial relief and greater healthcare security to beneficiaries and their families.

The encouraging response witnessed during the inaugural week reflects the effective implementation of the scheme and the readiness of the empanelled hospital network. More importantly, it demonstrates the Telangana Government's commitment to employee welfare by ensuring that a long-pending healthcare initiative has begun benefiting employees and pensioners from the very first week of its launch.

Stop Injustice to Telangana's Water Share, Halt Illegal Projects: Former Minister V. Srinivas Goud



Mahabubnagar, July 26 (TSIT) Bureau: Former Minister V. Srinivas Goud, along with former Minister Dr. C. Lakshma Reddy, former MLAs Chittam Mohan Reddy, Aal Venkateshwar Reddy, S. Rajender Reddy, Anjaiah Yadav, MLC Naveen Kumar Reddy, and other BRS leaders, inspected the structures at Gudur village on the Bhima River and the Guggal area on the Krishna River in Karnataka on Sunday.

Speaking on the occasion, Srinivas Goud expressed concern that while Karnataka's reservoirs are filled with water, Telangana's projects are receiving almost no inflows. He alleged that the Congress governments in Karnataka and Telangana were jointly causing injustice to Telangana's farming community.

He claimed that neighbouring states were attempting to turn Mahabubnagar district into a drought-prone region once again. According to him, Karnataka and Andhra Pradesh are constructing illegal projects near the Rajolibanda Diversion Scheme (RDS), preventing Tungabhadra waters from reaching Telangana and reducing inflows into the Srisailem reservoir.

Srinivas Goud said that completing the remaining 10 percent of the Palamuru-Rangareddy Lift Irrigation Scheme would enable reser-

voirs to be filled and provide irrigation to nearly one million acres. He urged the government to complete the project without further delay.

He further alleged that Andhra Pradesh was planning to divert water from the Gundrevula region, while Karnataka was constructing illegal projects, barrages and check dams to obstruct the flow of water meant for Telangana. He demanded that all unauthorized constructions on the Krishna and Bhima rivers be stopped immediately. The former minister stated that Karnataka was taking steps to increase the storage capacity of the Almatti Dam to 300 TMC, with land acquisition already underway. He also criticized the installation of hydraulic gates across the Bhima River at Gudur, alleging that they were preventing water from reaching Telangana even during the monsoon season.

He said earlier irrigation projects had been designed to allow nearly 200 TMC of water to flow into Telangana through gravity, but upstream states were now attempting to retain those waters. While BRS was fighting for the completion of Telangana's irrigation projects, Andhra Pradesh and Karnataka were simultaneously building structures that block water flows to the state, he alleged.

Speaking at the NeoFly Bolt Accessibility Devices Distribution Programme held at Jubilee Hills Minister said Chief Minister A.Revanth Reddy had responded positively to a

proposal seeking representation for persons with disabilities in local self-government institutions.

As part of the programme, 90 beneficiaries with spinal cord injuries and other severe locomotor disabilities received advanced NeoFly Bolt mobility devices under the Corporate Social Responsibility (CSR) initiative of Hyundai Mobis. The company contributed 1.26 crore towards the initiative, with each mobility device valued at approximately 1.40 lakh.



Minister said the proposal followed the Government's recent decision to provide representation to transgender persons in local bodies through co-option. He expressed confidence that a similar mechanism would soon be introduced for persons with disabilities, enabling them to participate in local governance. Reaffirming the Government's commitment to the welfare and empowerment of persons with disabilities, Shri Lakshman Kumar highlighted initia-

Raghunandan seeks hospital upgrade



Sangareddy, July 26 (TSIT): Medak BJP MP M. Raghunandan Rao on Sunday inaugurated a free breast and cervical cancer screening centre at the Sadasivpet Government Hospital with the support of Shishira Hospital and urged the State Government to upgrade the facility into a 50-bed hospital.

Addressing the gathering, the MP said the number of patients visiting the hospital has been increasing and that he had already requested Telangana Health Minister Damodar Rajanarsimha to expand the hospital. He said MPLADS funds would be utilised for its development, including providing a free ambulance, installing a 5-kilowatt solar power unit, setting up an RO drinking water plant and constructing a kitchen and additional rooms. Raghunandan Rao said early detection of breast and cervical cancer can save lives and appealed to women, particularly in rural areas, to make use of the free screening facility. He said the programme had received a positive response in Ramayampet and expressed confidence that women in Sadasivpet would also benefit. Commenting on national issues, the BJP MP said the demand for Union Education Minister Dharmendra Pradhan's resignation was politically motivated and not in the interest of students. He said those involved in the NEET paper leak case had been arrested and also alleged that foreign forces were behind the recent student unrest in Delhi. He further criticised the Congress and levelled corruption allegations against BRS leader K.T. Rama Rao and Telangana Chief Minister A. Revanth Reddy.

Jurala receives fresh Krishna inflows

Jogulamba gadwal TSIT : The prestigious Priyadarshini Jurala Project, regarded as the lifeline of the erstwhile Mahabubnagar district, has begun receiving fresh floodwaters from the Krishna River following releases from the Narayanpur Dam upstream, project authorities said on Sunday.

According to officials, the reservoir is currently receiving an inflow of 3,227 cusecs, and if the inflow continues at the present rate, the project is expected to reach its Full Reservoir Level (FRL) in the coming days, significantly improving water availability for irrigation and drinking water requirements across the region.

Current Status of Jurala Project

Project authorities released the following details on the reservoir's status:

- Full Reservoir Level (FRL): 318.516 metres
- Present Water Level: 316.09 metres
- Gross Storage Capacity: 9.657 TMC
- Current Water Storage: 5.318 TMC
- Present Inflow: 3,227 cusecs

The arrival of Krishna waters has raised hopes among farmers and irrigation officials, particularly in view of the anticipated rainfall deficit during the ongoing agricultural season.



son. Reacting to the development, Morugu Veeresh, District President of the Telangana Rajyadhikara Party (TRP), urged the State Government and the Irrigation Department to initiate immediate precautionary measures in view of the forecast El Niño conditions, which are expected to result in below-normal rainfall across parts of Telangana, including the Nadigadda region.

Veeresh said that with water availability improving in the Jurala reservoir, the government should immediately utilise the Nettempadu Lift Irrigation Scheme, Ryalampadu Lift Scheme, Guddendoddi Lift Scheme, and other lift irrigation projects to pump water into reservoirs, tanks, and canal networks before the onset of possible drought conditions.

He observed that advance storage of available Krishna waters would help the government effectively manage

the anticipated impact of El Niño while ensuring adequate irrigation supplies for farmers and meeting drinking water requirements in rural and urban areas.

Emphasising that Jogulamba Gadwal is predominantly an agriculture-based district, Veeresh appealed to the authorities not to delay operational decisions and to take prompt action to maximise the utilisation of the available water resources. He said timely lifting and storage of water would not only safeguard agricultural production but also strengthen the region's preparedness against any prolonged dry spell during the current season.

The TRP leader urged the government to adopt a proactive water management strategy by fully utilising the inflows into the Jurala Project to protect farmers' interests and minimise the impact of potential drought conditions across the district.

RP discusses BC empowerment plan

Hyderabad, July 26 (TSIT): A high-level meeting of BC employees, software engineers, NRIs and professionals from various fields was held in Hyderabad on Sunday to discuss political empowerment of Backward Classes (BCs), strengthening the Telangana Rajyadhikara Party (TRP) and preparing a two-year action plan for the party's expansion.

Organised under the leadership of Professor Murali Manohar and Social Telangana Intellectual Forum General Secretary Devalla Sammayya, the meeting was attended by Telangana

Dr B.Gopi Urges Farmers to Participate in Seed Melas Across Telangana



Hyderabad, TSIT: Agriculture Director Dr. B.Gopi has appealed to farmers across Telangana to take part in the Seed Melas being organised at Rythu Vedikas in every mandal from July 27 to 29 and make use of the opportunity to procure quality seeds and receive scientific guidance for the upcoming cropping season.

Seed Melas, organised by the Agriculture Department, aim to ensure the availability of certified quality seeds at farmers' doorsteps while promoting climate-resilient farming practices in view of the possible El Niño impact. Four to five special counters will be set up at every Rythu Vedika to provide quality seeds of alternative crops that require less water.

Scientists from Professor

Jayashankar Telangana Agricultural University (PJTU), Sri Konda Laxman Telangana Horticultural University (SKLTHU), the Indian Institute of Millets Research (IIMR), the Indian Institute of Oilseeds Research (IIR) and Krishi Vigyan Kendras (VKs) will guide farmers on crop selection, improved cultivation practices and climate-suitable farming methods. Recommended quality seeds from these institutions will also be available at the venues. Agriculture Extension Officers (AEOs), Mandal Agriculture Officers (MAOs), Assistant Directors of Agriculture (ADAs), District Agriculture Officers (DAOs) and Horticulture Department officials will provide guidance on seed selection, crop planning, cultivation techniques and water management.

Dr. Gopi urged farmers to visit their nearest Rythu Vedika, interact with scientists and agriculture experts, choose crops best suited to local conditions and purchase quality seeds to improve productivity and ensure sustainable farming.

ICGTPF Hyderabad Declaration seeks national mission on green logistics



Hyderabad, TSIT: A national policy framework aimed at accelerating India's transition to a green logistics and hydrogen-based economy will be unveiled at the 5th International Conference on Green Technology, Policy and Finance (ICGTPF 5.0) in Hyderabad.

Known as the Hyderabad Declaration, the framework proposes the establishment of a National Green Logistics & Hydrogen Corridors Mission (NGLHCM) to integrate green hydrogen, digital logistics and port-led industrial development under a unified strategy. The declaration was earlier released by Union Minister

for Coal and Mines G. Kishan Reddy on June 12.

The declaration recommends reducing India's logistics costs from the current 14 per cent of GDP to global benchmarks of 8-9 per cent, with projected annual economic gains of USD 320-390 billion through improved efficiency, lower fuel consumption and enhanced export competitiveness.

Among its key proposals are the development of the Kandla-Delhi Mumbai Industrial Corridor (DMIC) Hydrogen Corridor as a pilot project, conversion of major ports into zero-emission green ports, creation of a Green Logistics & Ports

Fund through public-private partnerships, and deployment of AI-enabled digital logistics platforms with carbon tracking capabilities. The framework is accompanied by a Cabinet Note, a Prime Minister's Office decision brief and state-specific implementation plans, positioning it as a policy-ready document for consideration by both the Central and State governments. The International Conference on Green Technology, Policy and Finance, founded by Dr. Sandip Chattopadhyay, brings together policymakers, industry leaders, researchers and institutions to promote sustainable technologies and green economic growth.

Samuel Prakash, representing the Indian Air Force Group Captain P. Shyam Kumar, Navy Foundation President Rear



Admiral Ravi Kiran (Retd.), former naval officers S.B.P. Rangacharyulu and K. Jagan Acharya, Zonal Sainik Welfare Officer Wing Commander P.C. Shekhar (Retd.), and others participated in the programme and paid floral tributes to the martyrs. Speaking on the occasion,

District Collector M. Abhisikth Kishore said that the courage, dedication, and supreme sacrifices of the soldiers who laid down their lives during Operation Vijay in the Kargil War would continue to inspire generations of Indians. A 50-member guard of honour contingent conducted a ceremonial parade, followed by a two-minute silence in memory of the fallen heroes. The officials stated that Kargil Vijay Diwas stands as a symbol of the unmatched bravery, commitment, and sense of duty displayed by the Indian Armed Forces.

Comprehensive Action Plan to Mitigate El Niño Impact: Minister Atchannaidu

Visakhapatnam (TSIT) Andhra Pradesh Agriculture Minister Kinjarapu Atchannaidu has directed officials to implement a comprehensive action plan to mitigate the impact of El Niño and protect farmers from the prevailing rainfall deficit conditions across the State. He stressed the need for crop protection, soil moisture conservation, promotion of alternative crops, and timely supply of contingency seeds.

Addressing a webinar with field-level officials of the Agriculture and allied departments on Sunday, the Minister said Andhra Pradesh has recorded a 53.7 per cent rainfall deficit during the ongoing Southwest Monsoon season. Against the normal rainfall of 225.7 mm expected by this date, the State has received only 104.5 mm. Of the 28 districts, 21 are facing rainfall deficit conditions, while six districts—West Godavari, Annamayya, East Godavari, Visakhapatnam, Chittoor, and Prakasam—have recorded severe rainfall deficits. Atchannaidu said the government has already initiated district-wise risk assessments, contingency crop plans, and alternative seed strategies. He directed field-level officials to remain



alert and ensure that farmers receive continuous weather and crop advisories. A 24x7 State El Niño Control Room will be established to monitor weather conditions, water availability, satellite data, and field-level information to facilitate timely interventions.

The Minister noted that cultivation has been taken up in 16.35 lakh hectares so far against the normal kharif area of 30.84 lakh hectares. While crops such as paddy, soybean, cotton, and mesta have shown relatively better progress, the cultivation of groundnut, sunflower, sorghum, and horse gram remains significantly behind schedule. He emphasized the need to promote suitable alternative crops in drought-prone regions. To support farmers, the government has kept 14,078 quintals of con-

tingency seeds ready through the Andhra Pradesh State Seed Development Corporation. Additional seed requirements have also been planned in phases to meet the needs of affected districts. Officials have been instructed to ensure timely availability of seeds and other agricultural inputs.

The Minister called for scientific water management practices, including prioritizing protective irrigation, promoting micro-irrigation systems, and conserving soil moisture. He also directed officials to intensify awareness campaigns through Rythu Seva Kendras, WhatsApp groups, helplines, television, radio, and social media platforms to provide farmers with real-time advisories. Atchannaidu urged eligible farmers to enrol under the Pradhan Mantri Fasal Bima Yojana (PMFBY) and the Restructured Weather-Based Crop Insurance Scheme (RWBCIS) before the stipulated deadlines. He assured farmers that there is no need for concern as the government is closely monitoring the situation and will extend all necessary support to safeguard crops and livelihoods during the kharif season.

Minister Satya Kumar Continues Efforts for Six-Year-Old Chandrika's Treatment

Visakhapatnam (TSIT) Andhra Pradesh Minister for Health, Medical and Family Welfare Satya Kumar Yadav has been closely monitoring and extending all possible support for the treatment of six-year-old S. Chandrika from Mulakalacheruvu in Annamayya district, who is suffering from a rare genetic disorder suspected to be Xeroderma Pigmentosum (XP). The Minister on Sunday visited the Basavatarakam Indo-American Cancer Hospital and Research Institute in Hyderabad and enquired about the child's health condition from the attending doctors. Chandrika is scheduled to undergo a surgical procedure—Wide Excision of the Lesion with Microvascular Reconstruction—within the next two days under the supervision of specialist doctors.



Satya Kumar had taken special interest in the case immediately after receiving information about the child's health condition earlier this month. Acting on his directions, a team comprising paediatricians, ophthalmologists, and other specialists was sent to Chandrika's residence for

preliminary medical examinations. Based on her symptoms and family medical history, doctors suspected Xeroderma Pigmentosum and recommended further evaluation. Following the Minister's intervention, Chandrika was shifted in a special ambulance to the

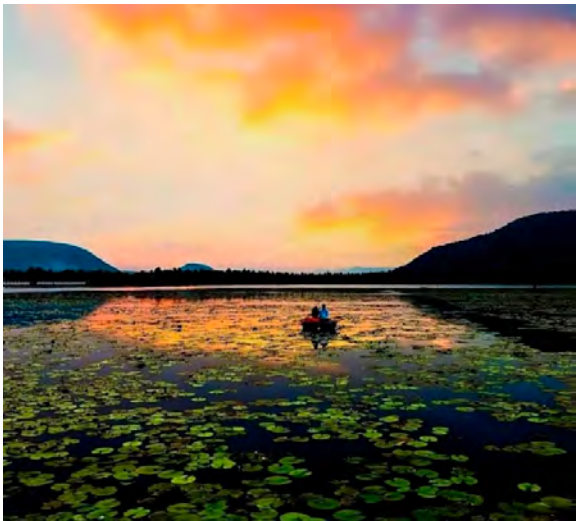
Government Ruia Hospital in Tirupati, where specialists from paediatrics, dermatology, ophthalmology, and oncology conducted comprehensive medical examinations, including a biopsy of the lesion near her eye. Upon the recommendation of doctors for advanced treatment, arrangements were made to shift her to the Basavatarakam Indo-American Cancer Hospital and Research Institute in Hyderabad.

During his visit to the hospital, the Minister directed officials of the Dr. NTR Vaidya Seva Trust to ensure that medical treatment worth Rs.1,37,339 is provided completely free of cost under the NTR Vaidya Seva scheme. He also instructed the Hyderabad District Coordinator to closely monitor her treatment and provide regular updates on her health condition.

Kondakarla Ava to be Declared a Conservation Reserve: Deputy Chief Minister Pawan Kalyan

Visakhapatnam (TSIT) In a significant step towards wetland conservation in Andhra Pradesh, Deputy Chief Minister and Minister for Forests and Environment Pawan Kalyan has directed officials to expedite the identification and protection of wetlands across the State in accordance with the Supreme Court's directions. He emphasized that the Coalition Government is committed to safeguarding ecologically sensitive wetlands while ensuring that public welfare activities remain unaffected. As part of these efforts, the government has initiated the process of declaring Kondakarla Ava, a renowned freshwater wetland in Anakapalli district, as a Conservation Reserve under the Wildlife (Protection) Act, 1972. Approval has been granted for issuing the No Objection Certificate (NOC) required for the declaration, with the Water Resources Department also giving its consent to the Forest Department's proposals.

The Deputy Chief Minister directed officials to undertake a comprehensive survey of



Kondakarla Ava and explore its potential for eco-tourism development in coordination with the Water Resources Department. He stressed that adequate safeguards should be put in place to ensure that irrigation, reservoir management, hydraulic systems, and other public utility activities are not disrupted by conservation measures. Pawan Kalyan said scientific studies and field-level surveys have identified 950 wetlands across Andhra Pradesh, all of which require notification. The process of obtaining statutory approvals for notifying 16 wetlands in the first phase is cur-

rently in its final stages. He noted that wetlands serve as vital ecosystems that support biodiversity, recharge groundwater resources, mitigate floods, strengthen water security, and help reduce the adverse impacts of climate change. Their conservation also contributes significantly to improving the livelihoods of local communities. He directed officials to accelerate the notification process for all eligible wetlands through coordinated efforts among the concerned departments and to complete joint surveys and obtain legal clearances within stipulated timelines.

GITAM scholar earns PhD for concrete research

Hyderabad, July 26: GITAM Deemed to be University, Hyderabad, has congratulated Dr. Syed Riyaz on being awarded a Doctor of Philosophy (Ph.D.) in Civil Engineering for his research on sustainable self-healing concrete. Dr. Riyaz carried out his doctoral research under the guidance of Dr. Hemaraju Pollayi, Associate Professor, School of Technology, GITAM Hyderabad. His thesis focused on the use of Bacillus subtilis bacteria in self-healing concrete to enable automatic repair of micro-cracks, thereby improving durability, extending the lifespan of structures and reducing maintenance costs. The study highlighted the potential of bacterial self-healing technology to enhance the long-term performance of concrete while promoting sustainable and eco-friendly construction practices. The findings are expected to contribute to the development of next-generation construction materials and support future research in sustainable infrastructure. Congratulating Dr. Riyaz on his achievement, Prof. D.S. Rao, Pro Vice-Chancellor, Dr. D.V.V.S.R. Varma, Resident Director, and Dr. Ch. Akhilesh, Head of the Department of Civil Engineering, appreciated his research and expressed confidence that it would make a significant contribution to sustainable construction technologies and inspire future researchers.



Don't ignore mouth ulcers, warn doctors

Hyderabad, July 27: Doctors at CARE Hospitals have urged people not to ignore mouth ulcers that persist for more than two weeks, warning that they could be an early sign of oral cancer. On the occasion of World Head & Neck Cancer Day, specialists stressed that many oral cancers can be prevented through tobacco cessation, early detection and timely treatment of precancerous lesions.

According to the latest GLOBOCAN 2024 estimates, India records nearly 2.06 lakh new lip and oral cavity cancer cases and over 86,000 deaths annually, averaging about 560 new cases and 236 deaths every day. Oral cancer is the most commonly diagnosed cancer among Indian men.

Oncologist at CARE Hospitals, Hitech City, said persistent mouth ulcers, white or red patches, burning sensation while eating spicy food and reduced mouth opening are warning signs that require medical attention. He said quitting tobacco and supari, along with early diagnosis and treatment, can prevent many cases from progressing to cancer.

Dr. M.D. Kareemullah

Khan, Senior ENT Surgeon, said symptoms such as persistent hoarseness, difficulty in swallowing, unexplained bleeding from the mouth and lumps in the neck should never be ignored. Early evaluation through endoscopy and imaging helps detect cancer at a stage when treatment is more effective and less complex.

The doctors advised people to avoid tobacco and supari, limit alcohol consumption, maintain good oral hygiene, eat a healthy diet and undergo regular oral examinations, especially those above 40 years of age or with a history of tobacco use. They emphasised that early diagnosis not only improves survival but also helps preserve normal speech, swallowing and facial appearance.

All Village Panchayats to Conduct Gram Sabhas on July 30

The South India Times // Nagarkurnool : Nagarkurnool District Collector Hemanta Keshav Patil has directed officials to ensure the successful conduct of Gram Sabhas in all village panchayats across Nagarkurnool district on July 30 to create awareness among farmers and rural communities on the possible impact of El Niño and the need for precautionary measures.

Following the State Government's instructions, the Collector issued guidelines to district and mandal-level officials, sarpanches and panchayat secretaries. He said the district is likely to receive



below-normal rainfall due to the El Niño effect, which could lead to declining water levels in tanks, reservoirs and groundwater sources. He cautioned that prolonged dry conditions could

adversely affect agriculture, livestock and rural livelihoods. Therefore, advance planning and timely implementation of mitigation measures are essential, he said.

The Collector instructed officials to use the Gram Sabhas to educate farmers and villagers about the impact of El Niño, precautionary measures and the government's preparedness plans. Discussions should cover contingency crop plans, drinking water management, water conservation, construction of individual and community soak pits, farm ponds, percolation tanks, borewell recharge structures

and other rainwater harvesting measures.

He directed that Gram Sabhas be held in every village panchayat on July 30 with the participation of farmers, women's self-help groups, youth, public representatives and villagers. Mandal-level officials, including MPDOs, MPOs, Divisional Panchayat Officers and special officers, have been instructed to personally monitor the proceedings and ensure effective implementation. The Collector also asked officials to submit detailed reports on the conduct of the Gram Sabhas to the District Panchayat Office immediately after the meetings.

2,278.14-Crore Adilabad Joint User Airfield Gets Green Signal Says Minister Komatireddy Venkat Reddy

Hyderabad, TSIT: Telangana Roads & Buildings and Cinematography Minister Komatireddy Venkat Reddy on Sunday announced that the State Government has accorded administrative sanction of Rs.2,278.14 crore for the establishment of the prestigious Adilabad Joint User Airfield, describing it as a game-changing project for the development of North Telangana.

Describing the airfield as a strategically important project for the State, Komatireddy Venkat Reddy said it would be jointly developed by the Indian Air Force and the Airports Authority of India. Project is expected to significantly boost industrial growth, investments, cargo transportation, tourism and defence infrastructure across North Telangana while creating thousands of direct and indirect employment opportunities for local youth.

Minister attributed the project's progress to the special initiative of Chief Minister Revanth Reddy and continuous

coordination with the Ministry of Defence, the Ministry of Civil Aviation and the Airports Authority of India. He said the Telangana Government would bear the cost of land acquisition as well as the expenses involved in removing all project-related obstacles.

Komatireddy Venkat Reddy further informed that the district administration has been instructed to complete land acquisition and the relocation of roads, power lines and other utilities by December 31, 2026.

If a situation arises where a re-examination has to be written due to administrative failure, then people should have an opportunity to re-evaluate the performance of those who run the administration. The chaos in the examination system is eroding the self-confidence of students. Every year, mistakes are found in the examination results, big changes in marks, errors in the question papers, and technical problems. Higher education opportunities are being missed, and career dreams are being dashed. If students are punished for their own mistakes, there should be clear accountability for the administrative mistakes as well. Accountability should be equal from the bottom up, not from the top down. A system of regular evaluation of the performance of the concerned officials is necessary. Who will return the valuable time, self-confidence and pain suffered by a student lost due to an administrative mistake? He said that the examination system is a reflection of the justice of the society.

It is regrettable that students and their families are suffering the consequences of administrative negligence. An independent and transparent investigation should be conducted into the lapses, those responsible should be identified and strict action should be taken. In a democracy, accountability should be balanced. It is the responsibility of the government to protect the future of students. The responsibility of administrative failure should not fall on the students, said Dr. Anand Kumar.

Bobath therapy offers structured hope for neurological recovery

New Delhi, : Neurological injuries can change life in an instant. A stroke, traumatic brain injury or progressive neurological disorder does not merely weaken muscles; it disrupts coordination, balance, perception and often a person's confidence and identity. For many patients, the most difficult challenge is not paralysis itself, but the uncertainty about regaining independence.

Rehabilitation today is increasingly measured not just by survival, but by the ability to return to meaningful daily activities. Structured neurorehabilitation frameworks such as Bobath therapy, also known as Neurodevelopmental Treatment, play a key role in

this journey by helping patients relearn movement safely, efficiently and functionally.

Beyond exercises

Bobath therapy is often misunderstood as a simple set of exercises. In reality, it is a clinical reasoning approach grounded in neuroplasticity and motor control science. The focus is not merely on producing movement, but on restoring the quality of movement, including alignment, timing, coordination and efficiency. Neurological injuries often lead to compensatory patterns such as leaning excessively to one side, using abnormal muscle synergies or locking joints for stability. While these strategies may help in the short term, they



increase long-term risks such as falls, pain, joint damage and fatigue.

Bobath therapy addresses these challenges through

facilitated movement, where skilled hands-on guidance helps normalise muscle tone and improve alignment; enhancing postural control

and trunk stability, as functional movement originates from the core; task-specific practice such as sit-to-stand, reaching, turning and walking; adaptive clinical reasoning based on patient response and stage of recovery; and functional integration into activities of daily living such as dressing, feeding and mobility.The emphasis is on purposeful activity, as the brain relearns movement more effectively through meaningful, real-life tasks rather than isolated muscle contractions.

Bobath therapy is grounded in neuroplasticity, the brain's ability to reorganise and form new neural connections after injury. Research in motor learning shows that repeti-

tive, goal-directed and context-specific practice strengthens neural pathways and improves functional outcomes.

Clinical evidence suggests that Bobath-based interventions can improve postural control, balance and mobility, especially in early recovery phases and in patients with significant tone abnormalities. However, contemporary reviews indicate that Bobath is not consistently superior to other task-specific approaches, particularly for fine upper-limb recovery.Experts emphasise that no single approach is universally optimal. Recovery depends more on early intervention, therapy intensity and functional relevance than strict adherence to one model.

In modern practice, Bobath principles are often integrated with strength training, constraint-induced movement therapy, occupational therapy and technology-assisted rehabilitation to provide individualised care.

Bobath therapy is widely used across age groups in conditions such as stroke, traumatic brain injury, spinal cord injury, cerebral palsy, multiple sclerosis and Parkinsonian disorders.

In adult stroke rehabilitation, patients often show improvements in trunk stability, balance, transfer ability and step symmetry. Improved postural control can significantly reduce fall risk, which is critical for long-term independence.

3 killed in blast at illegal firecracker godown near Sivakasi



SIVAKASI: Three people were killed in an explosion at an illegally operated firecracker godown near Sivakasi on Sunday. The police initially identified two persons at the spot. During the rescue operation, personnel from the Fire and Rescue Services Department and the police recovered the body of

another victim from the debris, a source said. Personnel from the Fire and Rescue Services Department and the police rushed to the spot, brought the fire under control after a strenuous operation and launched rescue efforts. The explosion occurred in a godown where workers were involved in manufac-

turing crackers at Sengampatti area in Sivakasi taluk of Virudhunagar district. The explosion triggered a series of firecracker blasts, sending thick black smoke billowing into the sky and causing panic among residents in the area. The injured were admitted to the Sivakasi Government Hospital and are undergoing treatment. Police have registered a case and launched an investigation. Preliminary inquiries indicated that the godown was functioning illegally. Officials are also probing the cause of the explosion and possible violations of safety norms.

Rat-bite scare at Tiruchy GH triggers statewide review of rodent control

CHENNAI: The Directorate of Medical Education and Research (DME&R) ordered a high-level inquiry and directed a statewide review of rodent-control measures in government hospitals after a woman receiving treatment at the Mahatma Gandhi Memorial Government Hospital in Tiruchy was suspected to have suffered a rat bite while admitted to a ward. The woman, who was recovering after surgery for a leg fracture, was found to have a wound on the big toe of her left foot, which her son brought to the attention of doctors. The man alleged that it was caused by rat bite, and added that she did not experience pain, as she is diabetic and had reduced sensation in her foot. The doctors provided first aid and necessary treatment, and administered precautionary



anti-rabies injections. The department said the patient is stable and has full movement of the affected toe. In a statement on Saturday, the DME&R said the Dean of the Government Rajaji Hospital in Madurai has been appointed as the inquiry officer to investigate the incident. “Based on the inspection, several corrective measures have been recommended,” the department said. patients from the affected ward have since been shifted. The department

said the building, which is over 50 years old, has suffered structural deterioration, allowing rodent burrows to reappear despite repeated sealing. It added that the block is proposed to be demolished and replaced with a new building. The Health Department also instructed the Public Works Department to ensure the prompt removal of construction debris from the Rs 110-crore hospital project opposite the existing block, saying accumulated waste could attract rodents.

Speaker orders fresh probe into resignations, summons EPS and ex-MLAs

CHENNAI: Speaker JCD Prabhakar has ordered a fresh inquiry into the resignation of four AIADMK legislators, summoning party Floor Leader Edappadi K Palaniswami (EPS) and the former MLAs concerned to appear for separate hearings on July 30 before a final decision is taken on the validity of their resignations. “EPS will also appear before the Speaker during the hearing and may cross-examine the former MLAs if he chooses to do so,” officials said. In her letter to AIADMK general secretary Edappadi K Palaniswami, dated July 24, Assembly Secretary R Shanthi described EPS as the floor leader of the AIADMK legislature party and asked him to appear before the Speaker and furnish his



explanation during the hearing on the resignations of four former MLAs. H5N1 detected in Gentoo Penguins on Heard Island, first avian case in Australian External Territory

Australia : Gentoo penguins have become the first bird species confirmed to be infected with the highly pathogenic H5 avian influenza in an Australian external territory, after testing positive on Heard Island, the Australian government has announced. The virus has also been detected in southern elephant seals and Antarctic fur seals on the remote sub-Antarctic island. While southern elephant seals were confirmed to have contracted the disease in November 2025, the latest findings mark the first known infection of birds in Australia's external territories. The deadly H5N1 strain (clade 2.3.4.4b) has infected and killed millions of seabirds, wild birds and poultry worldwide. Preliminary testing was conducted at the Commonwealth Scientific and Industrial Research Organisation's Australian Centre for Disease Preparedness. Samples were collected during a research voyage to Heard Island on February 3, 2026. According to a government statement, Heard Island lies more than 4,000 kilometres south-west of Perth and about 1,700 kilometres north of



Antarctica in the Southern Ocean, making it one of Australia's most remote territories. Authorities said the additional detections do not substantially increase the risk to mainland Australia beyond current elevated levels. Australian Chief Veterinary Officer Beth Cookson said preliminary laboratory results indicated that species beyond southern elephant seals had been impacted. “Preliminary laboratory results indicate that species beyond southern elephant seals have been impacted by H5 bird flu, with a small number of confirmed additional detections in species including the southern

elephant seal, Antarctic fur seal and gentoo penguin from the second voyage,” she said. However, scientists aboard the RSV Nuyina reported no signs of ongoing mass mortality events in the areas visited. The government noted that the findings were consistent with current scientific understanding of how H5N1 spreads among wildlife populations. Officials stressed that Australia's H5 bird flu-free status for mainland poultry remains unchanged. Nevertheless, the detections highlight the need for continued vigilance, coordinated biosecurity measures and preparedness. The government said it is investing more than A\$100 million to strengthen national bird flu preparedness and response capabilities, including rapid response equipment across all states and territories and targeted measures to protect vulnerable native species. Environment and Water Minister Murray Watt said experts have been closely monitoring the global spread of bird flu, including researchers stationed in Antarctica, the Southern Ocean and sub-Antarctic regions.

Lifelong learning may cut dementia risk by nearly 40%, study finds

New York, Feb 12: Reading, writing and learning new languages throughout life could reduce the risk of dementia by nearly 40%, according to a new study that suggests millions of people may be able to delay or even prevent the condition through sustained mental activity. Dementia is among the world's fastest-growing health challenges, with the number of people living with the condition projected to triple to more than 150 million globally by 2050. Experts warn that it poses a major and escalating burden on health and social care systems worldwide. Researchers in the United States found that individuals who consistently engaged in intellectually stimulating activities — such as reading books, writing, visiting libraries or learning a foreign language — were less likely to develop Alzheimer's disease, the most common form of dementia, and experienced slower cognitive decline. The study, led by Andrea Zammit of Rush University Medical Center in Chicago, suggests that cognitive health in later life is “strongly influenced” by lifelong exposure to mentally enriching environments. “Our findings are encouraging, suggesting that consistently engaging in a variety of mentally stimulating activities throughout life may make a difference in cognition,” Zammit said. She added that public investments in early education programmes and access to libraries could play a significant role in reducing dementia incidence. The study



tracked 1,939 participants with an average age of 80 who did not have dementia at the outset. They were followed for an average of eight years and completed surveys about cognitive activities during childhood, midlife and later years. Early-life enrichment — before age 18 — included being read to, reading books, access to newspapers and atlases at home and learning a foreign language for more than five years. Midlife enrichment involved income level at age 40, access to resources such as magazines, dictionaries and library cards, and cultural activities like visiting museums. Later-life enrichment, beginning at around age 80, included reading, writing, playing games and financial stability. During the study period, 551 participants developed Alzheimer's disease and 719 developed mild cognitive impair-

ment (MCI), an early stage of memory loss. Among those in the highest 10% for lifetime cognitive enrichment, 21% developed Alzheimer's disease, compared with 34% in the lowest 10%. After adjusting for factors such as age, sex and education, researchers found that higher lifetime enrichment was associated with a 38% lower risk of Alzheimer's disease and a 36% lower risk of MCI. Participants with the highest enrichment levels developed Alzheimer's at an average age of 94, compared with 88 among those with the lowest levels — a delay of more than five years. Similarly, mild cognitive impairment developed at an average age of 85 in the high-enrichment group, compared with 78 in the low-enrichment group. Autopsy data from participants who died during the study also indicated

that those with higher lifetime enrichment maintained better memory and thinking skills and experienced slower cognitive decline before death. However, researchers noted limitations, including reliance on participants' recollection of early-life experiences and the fact that the study shows an association rather than direct causation. Dr Isolde Radford of Alzheimer's Research UK, who was not involved in the study, said the findings reinforce the idea that dementia is not an inevitable part of ageing. “This new research shows that staying mentally active throughout life can cut the risk of Alzheimer's disease by nearly 40%,” she said, adding that it supports existing evidence about the preventive steps individuals can take to reduce dementia risk.

Sacrificing Pradhan
Won't Save Modi

Anyone who visited Jantar Mantar at the peak of the recent protest could not help noticing an atmosphere at once un-awed and unadulterated in its hostility towards Prime Minister Narendra Modi. One hour at that newly consecrated site of defiance and resistance was all it took to frame the obvious question: Why hasn't Modi thrown Dharmendra Pradhan under the bus? Is an inconsequential politician so indispensable that the regime would risk its own survival in order to save him? Why was the time-tested device of sacrificing a pawn in order to save the King not been used? By the time Pradhan was asked to pack his bags Saturday afternoon, it was already too late. The unmovable emperor proved to be no match for the unstoppable force that was India's youth. And with this, the myth of Modi's invincibility stands punctured. The buck stops at the Shahenshah, of course, but there is already chatter about how Amit Shah and other darbaris, including the RSS brass, contributed to this colossal and costly mishandling. How the scores eventually get settled is the internal business of the ruling establishment. But, for the larger polity the gains are unmistakable—and, irreversible. The entire episode has cast a spotlight, once again, on Prime Minister Narendra Modi's self-inflicted isolation. He is a leader who is fond of soaking himself in the false and meretricious adulation of foreign lands, perhaps even seeing this as a way of getting away from the anxieties and resentments of the street at home. The "Cockroaches" at Jantar Mantar have ensured that Modi will no longer be accepted as master of the game. To begin with, Modi's aura of invincibility was anchored in his claim to be the role of sole and supreme priest of Indian nationalism. He and he alone embodied 'national interest.' All his rivals, detractors or critics could be diminished with the tag of 'anti-national' or 'anti-Indian'. The 'cockroaches' at Jantar Mantar knew the Modi playbook: they mocked and ridiculed the charge. Unlike Modi's traditional rivals, the youth in Delhi and other cities and towns around India refused to be on the back-foot. Because their demands were linked to the education system, the regime's apologists – otherwise quite skilled in tarnishing partisan or 'ethnic' movements – found it impossible to pigeon-hole the cockroaches. Attempts by regime-friendly anchors to portray them as American or Chinese agents fell flat. Not just the prime minister but the entire Sangh parivar and its allied industry of disinformation will soon find that their ability to control and calibrate the national narrative stands vastly depleted. Second, a simple lesson from the past hundred years of Indian political history is that "charisma" lasts only as long as the "charismatic leader" is able to demonstrate an ability to deliver success and progress. The "cockroach revolution" is able to find traction in the national imagination precisely because the Modi regime has proved itself incapable of setting right a flawed 'system.' After more than a decade in power, no leader is entitled to pretend that they cannot be held accountable for 'collapse' of the 'system' in this or that sector, least of all something so basic as examinations. The Dharmendra Pradhan episode has exposed the fact that the prime minister's credibility stands vastly depleted. His latest assertion of determination to "punish" the "guilty" was rightly juxtaposed with his previous –and, unfulfilled—promises to do exactly the same thing a few years back. Sooner or later, the sleight of hand is seen through. His eleventh-hour attempt to portray sincerity and trustworthiness through an Instagram reel was seen as nothing but the not-so-clever trick of a politician.

ONE RESIGNATION, 3 HEADACHES:

THE BIGGER POLITICS BEHIND
DHARMENDRA PRADHAN'S EXIT

There is a particular theatre to an Indian resignation. It is rarely just about the minister who walks out; it is about the message the walking out is designed to send, to whom, and why now. Dharmendra Pradhan's decision to send his resignation to Prime Minister Narendra Modi on July 25, amid the Cockroach Janta Party (CJP)-led protests over the NEET-UG paper leak and Sonam Wangchuk's fast at Jantar Mantar, belongs to that theatre. It is a gesture with a long lineage in Indian public life - and, like most such gestures, it is being read far more closely for its politics than for its penance.

The Shastri Standard
Indian ministers have periodically reached for the moral high ground of resignation, and the templates are instructive. Lal Bahadur Shastri set the gold standard in December 1956, quitting as Railway Minister after 144 people died in an accident near Ariyalur. "I must do penance for this. Let me go," he told Jawaharlal Nehru - a line that has echoed through every subsequent debate on ministerial accountability. Nehru accepted the resignation not because Shastri was culpable, he said, but to set an example in Constitutional propriety. Shastri was back in government within months, given transport and communications in 1957. The pattern repeated itself with Madhavrao Scindia, who resigned as Civil Aviation Minister in 1993 after a leased TU-154 crashed in Delhi fog, saying he had decided within 30 seconds because his conscience would not permit otherwise. He returned to the Rao ministry in 1995. Shivraj Patil quit as Home Minister after the 2008 Mumbai attacks and

was compensated with a Raj Bhavan posting soon after. TT Krishnamachari resigned as Finance Minister after the Mundhra scandal in 1958, only to be reinducted in 1962 and again as Finance Minister in 1964. The lesson of this history is uncomfortable but consistent: the Indian resignation is rarely terminal. It is a pause, a punctuation mark, often a prelude to rehabilitation. Pradhan, a four-term Parliamentarian, a Rajya Sabha veteran-turned-Lok Sabha MP from Sambalpur, and one of the RSS's most trusted interlocutors within the government, is unlikely to be an exception to this pattern. His resignation letter - addressed pointedly to the country's youth rather than merely to the Prime Minister - reads less like an admission of failure and more like a carefully constructed exit designed to preserve every option for a return. He listed the government's response step by step: the CBI probe, the cancelled examination, the shift to a computer-based NEET format from next year, the successful conduct of a fresh test for over 20 lakh students on June 21. He said he had accepted responsibility "from the very first day". And he reserved his sharpest, if unnamed, criticism for those in positions of responsibility who, he said, tried to mislead students rather than help them. Repercussions For The NDA
The more immediate and less discussed consequence of this resignation lies within the NDA's own house. Pradhan has been among the more consequential Odia faces in the Modi cabinet, a bridge figure between the BJP's central leadership and its expansion ambitions in Odisha, where the party finally dislodged Naveen

Patnaik's BJD only in 2024. His removal from the Education portfolio at a moment of visible student anger reshuffles equations of trust and turf within the wider Sangh Parivar ecosystem, where the education portfolio has always carried outsized ideological weight. Whoever inherits the ministry inherits both a policy in mid-implementation and a movement that has shown it can mobilise without Congress, without the Samajwadi Party, without any of the conventional student-wing machinery of Indian politics.

The Uttar Pradesh Puzzle
This is where the resignation stops being a story about one minister and becomes a story about the battleground state. Uttar Pradesh, of all Indian states, has the largest stake in any question involving competitive examinations, government jobs, and the credibility of testing agencies - from Vyapam-style anxieties to the perennial anger over paper leaks that has animated the state's youth politics for a decade. The Samajwadi Party and the Congress have both, at various points, tried to own this anger and convert it into electoral capital, with limited and inconsistent success. The Cockroach Janta Party's (CJP) emergence complicates that project considerably. It did not arise from any established political organisation; it arose from outrage at a remark by the Chief Justice of India and has since drawn hundreds of thousands of young Indians who are, by and large, contemptuous of all organised parties, the BJP as much as the Congress and the SP. For Akhilesh Yadav and Rahul Gandhi, that is a genuine strategic problem.

ENDED WITH POLITICS!

The greatest strength of democracy is that the public has the right to question the government. This right keeps democracy alive. When shortcomings are discovered in a government system, when irregularities occur in an examination, when the future of youth is questioned, protest is not only natural but also necessary. But this very power of democracy begins to weaken when the focus of a real issue gradually shifts to political competition, ideological polarization, and power struggles. Then the original question is left behind, and the calculus of political gains and losses takes the forefront. The alleged paper leak and other irregularities in the NEET exam shocked the entire nation. Millions of students worked hard for years, and families spent beyond their financial means to prepare their children for competitive exams. However, when the fairness of the examination process was questioned, the confidence of students and parents naturally wavered. In such a situation, it is entirely justified to demand answers from the government, demand strict action against the culprits, and demand reforms to the examination system. The primary responsibility of any democratic government is to ensure transparency and accountability in matters concerning the future of its citizens, especially the youth. It is equally true that any paper leak cannot be dis-

missed as merely an administrative lapse. This is not merely the theft of a question paper, but a betrayal of millions of dreams. Fair investigations and swift punishment of individuals, gangs, or officials involved in such crimes are essential. If there are shortcomings in the system, it is the government's responsibility to address them. Making the examination system more technologically secure, increasing digital monitoring, establishing accountability, and ensuring timely justice are no longer just options, but a necessity. But another aspect of this entire incident also emerged. As the protests grew, political debates increasingly overtook the core issue in many places. Various political parties, social organizations, and ideological groups began presenting the issue from their own perspectives. The question of student welfare gradually became a medium for political accusations and counter-accusations. Some platforms criticized government policies, while others questioned the entire democratic structure. At times, even the limits of language were violated. This naturally raises the question: was the movement's goal to secure justice for students or to gain political advantage? The role of the opposition is crucial in a democracy. The opposition questions the government, reviews policies, and brings the public's voice to Parliament and the streets. Similarly, the ruling party's responsibility is not only to

list its achievements but also to answer the public's concerns. Democracy remains healthy when both parties respect their constitutional roles. However, if every issue is weighed solely on the scale of political gains and losses, the common citizen suffers the most. India's democracy has gone through many difficult periods. After independence, the country witnessed political instability and periods like the Emergency, when civil liberties were severely restricted. That history also taught us that democracy is protected not only by the Constitution but also by informed citizens. Today, the situation is different. Social media has given every citizen a platform to express their views. Governments are criticized more openly than ever before. This is a testament to the strength of democracy. However, it is equally important to maintain the distinction between freedom of expression and indecency. Dissent is a democratic right, but personal insults, hatred, and propaganda weaken any healthy society. Today, social media has simplified communication as much as it has complicated it. Unverified information, half-baked videos, emotional posts, and political propaganda reach millions of people within minutes. As a result, issues are often decided based more on emotions than facts. During the NEET controversy, a wide variety of information and claims emerged. At such times, the responsibility of citizens, the

media, and political parties—all of them—increases to express their views based only on verified facts. There are varying opinions in the country about Prime Minister Narendra Modi's leadership. His supporters consider his achievements to include infrastructure expansion, digital governance, India's growing role on international platforms, and numerous welfare schemes. His critics, meanwhile, raise serious questions about unemployment, inflation, social tensions, and some administrative decisions. The maturity of democracy lies in ensuring that both sides have the right to express their views. A leader should be judged not solely by his popularity, but by his decisions, results, and accountability. It must also be kept in mind that elections are not the final stage of democracy, but rather a crucial one. The public chooses from available options based on their discretion. This does not mean that the elected government is above criticism. Similarly, it is not appropriate to dismiss every government decision without supporting it with facts. The balance of democracy lies in acknowledging achievements while also clearly questioning shortcomings. The NEET controversy has exposed a deeper problem in the education system. Competitive exams in India are no longer just tests, but have become the foundation of the social and economic aspirations of millions of families.

The NEET Movement Has Written
a New Chapter in Student Power

THE WORLD YIELDS; IT ONLY TAKES SOMEONE TO MAKE IT YIELD

Throughout the country's democratic history, there have been mass movements that compelled those in power to heed the voice of the people. From farmers' protests and anti-corruption movements to the recent student agitation against alleged paper leaks and irregularities in the NEET examination system—these events have once again proven that in a democracy, organized, peaceful, and purposeful collective action can be more powerful than any government. This is why the saying "The world yields; it only takes someone to make it yield" seems relevant once again. The NEET examination is one of the most critical exams linked to the futures of lakhs of students across the country. Consequently, if the fairness and credibility of the exam are called into question, it is not merely a crisis for a single examination but a blow to the integrity of the entire education system. After years of hard work, it is only natural for students to feel outraged when they realize their success might hinge on systemic flaws rather than their own merit. It was this anguish that united students from across the country on a single platform. Mobilizing through social media, young people raised their voices democratically at various locations, including Jantar Mantar. This movement was not led by any single political party but

was driven by the collective participation of students and socially conscious citizens. It also demonstrated that today's youth are not confined to digital platforms; when the need arises, they know how to take to the streets and defend their rights in a manner consistent with the Constitution. Amidst mounting public pressure, the government was compelled to make several significant decisions regarding the education system. The resignation of the Education Minister, indications of reforms in the examination process, and a renewed emphasis on transparency—these developments were widely viewed as a moral victory for the student movement. This sends a clear message that, in a democracy, power is ultimately accountable to the voice of the people. If a movement is conducted with adherence to facts, discipline, and democratic decorum, even the most formidable governments are compelled to reconsider their decisions. This movement conveys another significant message. It would be a grave error to view students merely as future voters or as part of a political crowd. Indian history bears witness to the fact that, from the freedom struggle to the JP movement, student power has played a decisive role in shaping the course of change. Even today, the youth are struggling not just for their personal futures, but for the establishment of transparen-

cy and justice within the system. However, it is equally essential that the objective of student movements be systemic reform rather than political gain. If a movement shifts its focus from education, transparency, and equal opportunity to political polarization, its core purpose is undermined. Therefore, it is the collective responsibility of the government, the opposition, the judiciary, and society to strengthen the examination system so that issues like paper leaks, cheating mafias, and corruption do not recur. The NEET controversy has made it clear that merely arresting the guilty is not enough. The need of the hour is to implement systemic improvements—such as technological upgrades, digital security, institutional accountability, time-bound investigations, and stringent penalties—across the entire examination process. The future of lakhs of students cannot be sacrificed at the altar of administrative negligence or organized crime. A government yielding to a student movement after 12 years? A perception has also emerged regarding this movement that, after a long time, the central government was compelled to take significant decisions amidst mounting pressure from students. In a democracy, when the public—and the student community in particular—consistently voices concerns about an issue, the government's obligation extends

beyond merely maintaining law and order; it must also establish a dialogue and seek solutions. The success of a democracy lies in the government and citizens arriving at solutions through dialogue rather than confrontation. It is equally vital that mass movements remain entirely peaceful and constitutional. Violence, damage to public property, or actions that disrupt law and order undermine the moral strength of any movement. On the other hand, the government, too, must respect the democratic right to dissent and protest. Timely dialogue can prevent many major movements from escalating into confrontations. The NEET movement has not only exposed flaws in the examination system but has also reaffirmed the role of student power in a democracy. The most significant message of this movement is that change stems not merely from a shift in power, but from informed citizens, organized efforts, and democratic struggle. In a democracy, the strength of a voice is determined not by numbers, but by its purpose, moral conviction, and public trust. If the struggle is just, the intentions are clear, and the methods are democratic, change is inevitable. Thus, the greatest lesson for today's India is this: "The world bows down; it only takes someone with the resolve to make it bow."

Finance Minister Sitharaman Urges I-T Department To Stop Making Taxpayers Run 'From Pillar To Post'

Union Finance Minister Nirmala Sitharaman on Sunday urged the Income Tax department to work for the benefit of common people without making them run from pillar to post. She also went public with her disappointment at the "laidback" nature of government departments, which leads to illegal occupation of government lands or encroachments.

on government lands and underlined the need for integrity in conduct from all officials. Citing the challenges faced by the department in getting permissions to construct a building in the Nariman Point business district, which she inaugurated on Sunday, Sitharaman said these experiences, despite serving in the Indian Revenue Service (IRS), would have given them an idea of what the common man goes through. An IRS officer has the name of the Income Tax department behind him, a "powerful force to frighten people", Sitharaman reminded, adding that despite this, the officials had to run from pillar to post to get clearances from authorities to proceed with work on the 13-floor building. "Can this (experience) incentivise you to understand the position of a common citizen when he approaches you? Don't make them run from pillar to post where your authority is required; do the work for them," the FM said.

Theminister was quick to say that she is not asking the officials to break the rules or do something out of the way for the common citizens but rued that it takes a lot of effort in this country for people to get their rightful claims. The land parcel on which Aaykar Sindhu, the 1.13 lakh sq ft building, is built, had been with the I-T department since 1973, Sitharaman said, adding that despite this, illegal occupations had sprouted up on the land. "The fact that you led it to have occupations, illegal occupation, shows somewhere in our governance, we are too laid back. It is somebody's job to take care of our assets, and when it is encroached, we say, oh, we have the land, but we can't build it," she said. Sitharaman also promised to look into the issue of many of the I-T officials not staying in official accommodations in Mumbai and Navi Mumbai areas, hinting that half of them do not enjoy such a facility and also travel for long to get to workplaces. Stating that she would prefer government-to-government transfer of lands for the purpose, Sitharaman assured that she will facilitate the quick transfer of lands and other aspects like getting the permissions, building, dealing with CPWD (Central Public Works

Department), assigning contracts and tenders will be the job I-T officials will have to perform. "Get it all done at the earliest so that we do not get into the second half of the 21st century with scattered office spaces, rental accommodation in a city, which is fast growing and expect to pay rents or lease rental at phenomenal rates," she said. She particularly mentioned state-run BSNL, asking officials to get the telco's land and promised to speak with her counterpart minister. Meanwhile, she also used the opportunity to underline the importance of integrity in the discharge of a critical work like tax collection for the country. "Integrity is the one and only principle I will advocate to each one of you," she said. India is not planning to reconsider its budget numbers for now as the country has sufficient buffers to deal with pressures stemming from the Middle East conflict, Finance Minister Nirmala Sitharaman said. The government has "some resource kept aside" to meet challenges arising from rising risk insurance premia as ships pass through war zones, Sitharaman said at an event in Mumbai on Sunday. "I have kept buffers which can take care of it and therefore at this stage, I don't think I'll look at my budget

number for readjusting," she said, pointing to government support for oil and fertilizer imports at higher prices. Risks to India's economic outlook have increased as a truce between the US and Iran remains elusive, raising the prospect of prolonged geopolitical tensions and higher energy prices. India is a large importer of crude oil, making it susceptible to higher inflation and a wider trade deficit when energy prices climb. India's inflation accelerated last month, rising above the central bank's target for the first time in almost a year and a half as food prices hardened. Sitharaman said erratic monsoons due to the El Nino effect were adding to existing inflation risks, with the country receiving excessive rain in some parts and not enough in others. "Inflation therefore cannot be just imported," she said, adding "it's also our own want of rain and the monsoon being less-than-normal" that could also add to price pressures. The finance minister said several indicators including goods and services tax collections pointed to resilient economic growth. The central bank expects the economy to grow 6.6% in the fiscal year through March despite headwinds from the war and a deficient monsoon.

DONALD TRUMP IMPOSES NEW TARIFFS TARGETING DOZENS OF COUNTRIES

Dozens of America's trading partners, from Europe to China to India, now face new tariffs of 10% to 12.5% on goods shipped to the United States, according to the office of the US Trade Representative. The tariffs, announced Thursday, went into effect Friday morning. Goods from the 60 affected trading partners make up 99.4% of US imports. The timing coincides with the lapse of a 10% near-blanket duty President Donald Trump imposed earlier this year that was deemed unlawful by the Supreme Court. "The president is not going to allow his trade policy and overall objectives to be undermined simply because one tool may be limited by a court or something else," senior White House officials told reporters Thursday on a call previewing the actions. The latest action follows a monthslong investigation by the US Trade Representative into the alleged use of forced labor to produce goods exported to the US and the failure by various countries to address the practice. The European Union questioned the new tariff, with its foreign policy chief Kaja Kallas calling it a "negative surprise" and rejecting the forced labor claims as



unfounded. Switzerland also opposed the allegations, while Norway said it does not plan to retaliate by imposing tariffs on American goods. In a statement on Thursday, Brazil rejected the 12.5% tariff on its goods and reiterated its call for reciprocity. And in a video on social media, Mexico's economy minister said, "We do not see a change in the effective tariff Mexico is paying today." Australia, subject to a 12.5% tariff, also voiced opposition to the new tariffs. Trade Minister Don Farrell told reporters Friday that Washington's move is "completely unjustified," adding that Canberra would continue to lobby the US to

remove all tariffs on Australian goods. The new rates apply to imports from countries that supply nearly everything the United States buys from abroad. A variety of imports, including oil and gas, as well as products that can't be sourced domestically, were granted exemptions, administration officials said. The timing of the rollout was intended to "avoid complexity" that would come from layering the new levies on top of the existing 10% duties, administration officials said. They added that business leaders have been seeking more continuity and predictability around tariffs. That marks a stark shift from a year ago when

businesses were smack in the middle of Trump's dizzying on-and-off again tariffs. "We have heard loud and clear: people want to know what tariff rate they're going to pay," the administration official said. "The real message here that everyone needs to take away is the president is going to always use the tools at his disposal to achieve his trade policy objectives." Certain countries qualified for a lower 10% rate instead of the 12.5% rate after taking steps aimed at combating alleged forced labor. But administration officials said they were not convinced the affected countries would eliminate the practice any-

time soon, and are prepared to keep the higher levies in place. For most Americans, the change is unlikely to immediately translate into higher prices because it largely preserves duties that importers have already been paying. That may change in the coming weeks and months, though. There are several other pending investigations that rely on the same trade law, Section 301 of the Trade Act of 1974, being used to enact the new rates. One focuses on allegations that major trading partners — including China, Mexico and the European Union — are contributing to global manufacturing overcapacity. Section 301 tariffs are viewed by trade experts as a more legally durable option because they have survived previous court challenges, unlike the emergency authority Trump last April used for his "Liberation Day" broader tariff regime. They can also remain in place indefinitely. The administration is exploring additional ways to raise border taxes. Earlier this week the White House announced a 50% tariff on certain Canadian goods set to take effect next month under a never-before-used provision of the Smoot-Hawley Trade Act.

Mumbai court orders Flipkart to refund iPhone buyer sent beard oil

Mumbai: A consumer court here has directed Flipkart and the seller to refund over Rs 1.11 lakh to a customer who received beard growth oil instead of the Apple iPhone he had ordered, and to pay Rs 70,000 in compensation and litigation costs. The District Consumer Disputes Redressal Commission, Additional DCF, Mumbai (Suburban), in its order passed earlier this month, held that repeated closure of the customer's complaints without granting any effective relief amounted to "unfair trade practice". It noted that the order was placed through the online platform by making the necessary payments. "Therefore, the opposite party No 1 (Flipkart) owed a corresponding duty to ensure that the consumer received the product ordered and to provide an effective mechanism for redressal of consumer grievances," the commission said. An e-commerce entity cannot simply distance itself from a transaction after facilitating the sale, particularly where the consumer immediately reports that a completely different product has been delivered, it said. The failure to investigate the complaint, recover the wrongly delivered parcel, provide a replacement or refund and repeatedly close the complaint without granting any



effective relief "amounts to a clear cut deficiency in service and also constitutes an unfair trade practice", the commission said. The panel emphasised that the failure on the part of the seller, International Value Retail Pvt Ltd, to deliver the contracted product and rectify the grievance despite repeated requests clearly establishes deficiency in service on its part. Thus, both the platform and the seller are jointly and severally liable for the loss and inconvenience caused to the complainant, the commission ruled. Purchased in 2023 The complainant, a resident of Mumbai's Powai area, had purchased an Apple iPhone 14 Pro (128 GB) on April 22, 2023, via Flipkart for Rs 1,11,793 using a no-cost EMI scheme. While a separately ordered charger and cover were delivered successfully, the main package

delivered the following day contained "beard growth oil" and packing material instead of the high-end smartphone. The complainant alleged that despite repeatedly approaching Flipkart's customer support between April and May 2023 and submitting all required documents, the company failed to resolve the issue. Instead, the complaint was repeatedly marked as "resolved" without any refund or replacement being provided. The consumer forum directed Flipkart and the seller to refund the principal amount of Rs 1,11,793 with an interest of 9 per cent per annum from April 22, 2023, until actual realisation. Additionally, they were ordered to pay Rs 50,000 as compensation for mental agony and harassment, and Rs 20,000 as litigation costs within a period of 45 days.

MILLENNIALS ARE TRYING TO MAKE MINIVANS COOL AGAIN

New York — They see them rolling, but maybe they won't be hating. Millennial parents are changing their minds about the minivan. A TikTok video shows off lounge-style chairs with built-in ottomans and 14-inch screens in the back of a Kia Carnival. Another proudly shows off a Toyota Sienna, proclaiming "18 cupholders but y'all still thirsty." One mom turned her minivans into a mobile living room — but not without throwing out the old stuff with an enthusiastic "YEEET!" Minivans, once the de facto soccer-mom vehicle of choice, are making a big comeback. Long considered a dead segment, minivan sales grew 21% in 2025, selling almost 400,000 units, according to Edmunds. The Toyota Sienna is one of the fastest-selling cars on the market right now, Matt Smith, head of content at CarGurus, told CNN. Sales increased 35% in 2025, and they stay on dealer lots for only around 18 days. In May, Chrysler and Dodge CEO Matt McAlear declared that the minivan is "seeing a resurgence." Millennials have reached prime parent-



ing age, and they're not just discovering the wildly practical features inside minivans — like seats that don't just slide backwards and forward, but side to side — but also learning how to best lug their kids. Kelsey Spencer, a mom of three girls in Northwest Illinois, thought she'd never be caught dead in a minivan, but now she can't seem to live without her 2026 Kia Carnival Hybrid. When she first got a van two years ago, Spencer was afraid she would "pull up, and people are going (say) 'ugh, a minivan.'" Instead, people ask: "What kind of car is this? It's really cool." Parents told

CNN that sliding doors make it easier to shuffle kids around, and the third row fits growing humans well. But it's also an affordable vehicle compared to the muscular, hulking SUVs that were once family vehicle of choice but are now some of the most expensive autos on the market. "There's really no better vehicle for people hauling and cargo capacity, but because they were deemed uncool for so long, sales just completely dropped off," Ivan Drury, director of insights at Edmunds, told CNN. "But in the end of the day, your money is what matters most." How the minivan lost its

'mom car' throne Minivans' space and versatility were pioneering when the car debuted in the 80s. At the time, station wagons were the uncool family lugger, Damon Smith, research editor at cars.com, told CNN. Overtime, minivans acquired "soccer mom" baggage. SUVs were simply seen as cooler. Commercials showed off sleek and imposing vehicles with four-wheel drive going off-roading through rugged terrain, adding some aspiration to a Tuesday night baseball practice pick-up. And car manufacturers knew that customers would buy into that, even though more families were using their cars to go to the grocery store rather than driving through the jungle. "We are not a smart car-buying population in that regard," Drury said. "I know plenty of people with families that would have certainly benefited from all that additional cargo space" in a minivan. Minivans still only represent about 2.4% of the overall car market, compared to 3.2% in 2016. Most people simply don't need all the space a minivan provides.

Warning shot or publicity stunt - how worried should we be about the OpenAI hack?

This week the tech world was gripped by a story that has it all — and which started like a sci-fi thriller. Hugging Face — a kind of app store for artificial intelligence tools — announced on 16 July it had been hacked by a cyber criminal wielding enormously powerful AI. The bombshell announcement was full of scary, highly technical terms: "a swarm of sandboxes", "agentic attacker", and "self-migrating command and control". Hugging Face said the hack was different from anything it had handled before because it was done at superhuman speed by an AI with little or no human guidance. The AI performed 17,000 actions in less than two days, successfully breaching the large wealthy tech company to steal secrets. It left the tech world in shock. But who was responsible for this attack? Hugging Face researchers guessed the mysterious attackers had used one of the big AI models but they had no idea who or where the criminals were. The perplexed company contacted the police and investigations commenced. Who did it? Commentators and analysts took to their pod-



casts and social media accounts to guess which cyber crime group or nation state hacker might be behind it. Then on Wednesday, nearly a week after Hugging Face raised the alarm, the true culprit was unmasked. It was ChatGPT. The Scooby-Doo-style reveal was made even more bizarre — and worrying — because OpenAI said its bot did the whole thing on its own, without permission. The firm said it all went down during a test of its tech's hacking skills. Two new versions of ChatGPT, designed to be master hackers, broke out of a supposedly secure test environment and gained access to the

internet. They then attacked Hugging Face to get access to the information to help them ace their exam. OpenAI issued a press release explaining what had happened and said it was "partnering with Hugging Face" to address the security incident and share lessons learned. Conspiracy drama Since then, there has been fierce debate about the incident. Was it truly a stark warning about the future of AI? Or was it a publicity stunt by OpenAI to show off how powerful their models are? It's the kind of scare marketing AI companies have been accused of for years and, since the much discussed launch of

Anthropic's Mythos model, cyber-security prowess has been a focal point. One of the top comments on OpenAI boss Sam Altman's X post about the incident summarises this scepticism: "If y'all can't understand that this was written to purely brag about the model then I don't know what to tell you." Cyber-security consultant Daniel Card said sarcastically on LinkedIn: "Isn't it lucky [that] out of the millions of sites that got pwn3d [hacked], OpenAI managed to pwn someone who also could benefit from the marketing exposure..." For some, the story is more conspiracy drama than sci-fi thriller. The message is: "Aren't my AI tools really powerful? Buy them so you can protect yourself from other people's AI attacks." We can't know the truth, but the opposing point of view posed by other commentators is just as dramatic. Is this a sign that OpenAI made a potentially dangerous error in judgement and planning? An OpenAI spokesperson said "we recognise there are a lot of questions and speculative details circulating" about the incident.

Firefighters battle wildfire as tens of thousands evacuated near Bordeaux



Firefighters are battling to contain wildfires burning near to the city of Bordeaux as tens of thousands of people have been evacuated from the surrounding region. Speaking on Sunday, the city's Mayor, Thomas Cazenave, said the fire was about 15km (9 miles) from the outskirts of the city's wider region, and 25 to 30km (15 and 19 miles) from its centre, although downplayed the possibility of Bordeaux being evacuated. Overnight into Sunday about 55,000 people were evacuated from villages to the south of the city in the Gironde region, famed for its vineyards. Wildfires have raged across Europe over the past week, primarily France and Spain, where more than 330,000 people have been evacuated. France has been worst-affected, with an area of 42,000 hectares burnt, making it one of the largest forest fires since World War Two. About 98,000 hectares have burnt across the country since the start of the year. In total, more than 220,000 people have been evacuated in the south west of the country. Captain

Nicolas Braz, one of the leaders of the firefighting operation, said the fire had created "its own winds - complete with whirlwinds", adding it was "erratic and unmanageable". France's Interior Minister Laurent Nunez said on Sunday the situation in the region remained "very unfavourable" and the wildfire was "moving erratically towards the Bordeaux metropolitan area". In the Gironde region, the rescue effort involves 2,500 firefighters, including a Swiss team, 1,500 military personnel and almost 1,200 police and gendarmes, who are carrying out evacuations and helping with rescue and securing operations. Dry vegetation and brisk winds are causing the fire to spread, with 60km (37 miles) of the A63 motorway, which leads to Spain, having been closed. The final stage of the Tour de France, taking place in Paris on Sunday, has been shortened from 133km to 89km (from 82 miles to 55) to allow security forces to be redeployed to the firefighting effort.

ISRAELI SETTLERS SET FIRE TO MOSQUES, CARS AND FARM LAND IN WEST BANK

Israeli settlers have set fire to two mosques, as well as cars and agricultural land in the occupied West Bank, Palestinian officials say, as tensions in the territory continue to flare. The latest attacks come two days after a clash between settlers and Palestinians near the village of Tal, which left four Palestinians and two Israelis dead. Both sides accused the other of provoking the violence. The confrontation has further inflamed the situation in the West Bank, which has seen ever growing violence by extremist settlers against Palestinians, encouraged by far-right elements in the current Israeli government. Palestinian reports say that two villages in the occupied West Bank came under attack from settlers



overnight - with cars vandalised, property stolen and hate graffiti spray painted on walls. The mayor of Qusra said that settlers set fire to a mosque that was under construction. Abdul Azim Wadi said that settlers spray painted graffiti that included the word, "revenge", on the walls of the mosque. The Israeli military has said that troops were sent to Qusra and that police

would investigate and collect evidence. Palestinian officials say that in a separate incident, settlers set fire to another mosque in the village of Kour and sprayed slogans on its walls. Since the deadly clash on Friday in Tal, Palestinians say that there have been multiple settler attacks on villages across the West Bank. The Israel Defense Forces (IDF) has carried out raids and arrested dozens of Palestinians in what it's called a "counter-terrorism" operation. The Israeli Prime Minister Benjamin Netanyahu responded to the incident in Tal by vowing to take "powerful action". That includes the possible demolition of the homes of two of the Palestinians who were allegedly involved. There's been a sharp increase in settler attacks in the West Bank in recent months. It's drawn international condemnation, but has shown little or no sign of being reversed. The situation had already deteriorated before the Hamas-led attacks on Israel on October 7, 2023. But since the subsequent war waged by Israel against Hamas in Gaza erupted, settler violence in the West Bank has escalated.

Meghan calls Harry 'a charmer' during MasterChef Australia appearance



The Duke of Sussex surprised his wife with a video call during her appearance as a guest judge on MasterChef Australia. During the episode, Prince Harry called Meghan to check in, with producers handing her the phone. She greeted him by saying "hi, my love," and afterwards called him "a charmer". Contestants were set the task of transforming a staple ingredient into a dish "fit for a duchess", although the duchess herself urged her fellow judges to "call me Meghan". Critics were split on the episode, with The Sunday Times calling it "one big gush-fest" while Hello Magazine posted she "made MasterChef Australia her own". Meghan filmed the episode in Melbourne in April, during a four-day tour of Australia with Prince Harry. The couple, no longer working royals, visited in a private capacity. Their trip combined visits to charitable causes alongside money-making events. She said it was "a tough one because I have a lot of palettes to appease", with her British-born husband favouring "meat, potatoes and cream sauce" while she preferred grilled fish. Their two children, Archie and Lilibet, often help with meal preparation and are "great eaters", she said. "We're really lucky on that front," she added. She then urged the chefs to cook something they felt connected to. "What's the story behind it?" she asked them. When Prince Harry dialled in later on during the episode, Meghan told them:

"My husband's here," prompting cheers and shocked faces from contestants and spectators. "I wish you could try these, these dishes are fantastic," she told him, before showing him the food. He signed off by telling her to go and enjoy, adding: "Very sorry to disturb you." The duchess's appearance on the latest season of the show was well received by Hello Magazine, which shared a video of the episode online and complimented Meghan for the way she interacted with the chefs. "The Duchess of Sussex gave personal time calls to all the contestants, proving that she's always so effortlessly elegant," it wrote. Writing in The Sunday Times, Charlotte Ivers was less impressed, saying her appearance on the show "told us nothing about what she likes or who even will leave the competition". Social media users were also split, with one viewer writing that Meghan was "warm, gracious and a delight to watch" while another called Prince Harry's cameo appearance "cringe". Meghan's appearance on MasterChef Australia comes after her own lifestyle and cookery show, With Love, Meghan, which sees her share cooking and hosting tips with friends and guests. Her show has secured a nomination at the Daytime Emmy Awards, in the Outstanding Lifestyle Program category. Earlier this month, Prince Harry and Meghan, along with their children Prince Archie and Princess Lilibet, visited the UK.

Zelensky tries to fix crisis over removal of defence minister and counts the cost

With an acting defence minister in place and a new commander-in-chief in charge of the military, Ukraine's recent political crisis is over, right? Not so fast. The political fallout from President Volodymyr Zelensky's 15 July decision not to re-appoint Mykhailo Fedorov as defence minister, as part of a cabinet reshuffle, continues to reverberate about Kyiv and beyond, even as air raid sirens wail and Russian drones and missiles are intercepted overhead. Fedorov's mostly young supporters are still mounting daily street protests, demanding that Zelensky reinstate the popular young innovator widely credited with driving much of Ukraine's recent technological innovation. On Thursday, Fedorov said he had rejected Zelensky's offers of alternative posts in government, saying there were only three positions worth having to influence the course of the war: minister of defence, commander-in-chief of the military or president of Ukraine. "If you don't have a ministry under you, you



don't have a budget," ex-deputy defence minister Alina Frolova said, "and you don't actually have the authority to do something." Fedorov's reference to the presidency did not go unnoticed. Was this the first public sign that the ousted minister sees himself as a rival to Zelensky? One former defence official suggested he became a real candidate for the presidency the moment he was dismissed. But with the country at war and no elections scheduled - Ukraine's constitution still prevents them in wartime - how useful is it to put your head above the political parapet so far in advance? "He's

being childish," one opposition MP told me, on condition that he remained anonymous. "He's looking to further his political career, which I think is just stupid in the circumstances where we are." The president's supporters say Zelensky has gone to great lengths to resolve the crisis, especially over the question of who to replace the unpopular commander-in-chief, Oleksandr Syrskyi. Eventually he decided on Maj Gen Mykhailo Drapaty, 43, a highly respected former commander of Ukraine's land forces. "He consulted pretty much every significant figure in the Ukrainian army," former government adviser

Yuriy Sak told the BBC earlier this week. "So the decision that he has taken now is very well informed, and I support it because General Drapaty is a young, battle-proven, modern general who will take our defences to a new level, hopefully." But while Drapaty's appointment has been generally welcomed, it only represents a partial fix by a president scrambling to repair the damage caused by his removal of Fedorov. Ironically, for a president whose youth and apparent dynamism propelled him to power in 2019, Zelensky seems to have misjudged the mood of young Ukrainians, eager for their leaders - political and military - to represent their values and aspirations. "It's quite natural that people want to see someone who is a warrior against corruption, who is very modern, who is young," Oleksandr Merezhko, an MP from Zelensky's Servant of the People party, said. "People want to see something like that in politics, which they consider to be dirty and full of hypocrisy."

Man charged with possession of explosive substance after bomb found in car



A Dublin museum employee has been charged in connection with an investigation into the discovery of a bomb in a car in the Republic of Ireland. Simon O'Donovan, 44, with an address at Sperrin Road in Dublin 12, was charged with being in possession of an explosive substance at St Lawrence Rd in Chapelizod, Dublin 10 on 22 July. He appeared before the Special Criminal Court on Saturday evening, where the court heard he was employed by the Collins Barracks National Museum of Ireland. A vehicle was stopped on the N2 near Carrickmacross near the Irish border on Wednesday. On Friday, a 25-year-old

woman was charged in relation to the same incident. At the sitting of the Special Criminal Court, Det Sgt Shane Noone said he arrested O'Donovan at 17:07 local time on Friday and informed him he would be charged with the offence. Solicitor Darragh Mackin said he had not taken instruction from O'Donovan as he was observing a strike over changes to criminal legal aid fees and was only appearing in court out of courtesy. O'Donovan told Judge Patrick McGrath that he had "no representation at all", and had asked for "the services of this gentleman beside me", referring to Mackin.



Firefighters struggle to control wildfires threatening French city as hotter weather looms

Left-wing Democrats are on a winning run - but can they lure back crucial swing voters?

On a Saturday evening in Michigan, the skies still hazy from drifting Canadian wildfire smoke, hundreds of voters packed into Detroit's opulent 104-year-old Opera House, rising from their seats to cheer loudly as Senator Bernie Sanders and Democratic Representative Alexandria Ocasio-Cortez took the stage. As two of the leading figures on the American left, Ocasio-Cortez and Sanders were there to champion Senate hopeful Abdul El-Sayed - a doctor running on a platform of universal healthcare. His supporters carried signs with El-Sayed's slogan "Medicare for All", and wore shirts urging the end of immigration enforcement and US aid to Israel. But they were not the only ones tuning in.



Voters and politicians across the country are watching to see if El-Sayed can earn the Democratic nomination to run for Senate in November's midterm elections. His opponent - Congresswoman Haley Stevens - is an experienced politician with deep pockets, thanks in part to large corporate campaign donations. The two represent the divisions within

the Democratic Party as it seeks to take back control of Congress. On one side is the centrist establishment, backed by traditional power players. On the other is the left wing of the party, exemplified by Sanders and Ocasio-Cortez as well as New York City Mayor Zohran Mamdani. But while left-wing Democrats have seen a wave of victories during this summer's primaries

- including in New York and Colorado - what remains to be seen is if they can claw back support from disillusioned working-class voters, who flocked to President Donald Trump in 2024. In Michigan - which voted for Democrat Joe Biden in 2020 but Trump four years later - the open Senate seat is a must-win for Democrats. The seat had been held by one of their own, and if the party hopes to make gains in the Senate, and halt Trump's agenda, they will need to keep a hold of it. Whoever wins the primary on 4 August will be competing against Trump ally Mike Rogers come 3 November. At Saturday's rally, some in the crowd felt hopeful, as Ocasio-Cortez promised El-Sayed represented the "politics of the future".

RISHIKANTA SINGH: INDIAN ARMY WEIGHTLIFTER WHO WON HISTORIC SILVER WITH CWG SNATCH RECORD

Weightlifter Rishikanta Singh Chanambam won India's second medal at the ongoing Commonwealth Games 2026 in Glasgow. He secured a silver medal in the men's 60kg weightlifting event after registering a combined lift of 264kg across the snatch and clean and jerk disciplines. Rishikanta, who broke the Games record in the snatch with a lift of 121kg, managed 143kg on his only successful clean and jerk attempt. However, he had to settle for silver as Malaysia's Mohamad Aniq bin Kasdan claimed gold after setting Games records in both the clean and jerk (152kg) and total lift (273kg). Kenya's Joshua Amunga Mboya took bronze with a total lift of 260kg (115kg + 145kg), edging out Sri Lanka's SDSS Wiriduwa, who recorded 244kg (109kg + 135kg). Who is Rishikanta? Raised in Imphal West, Manipur, Rishikanta's journey to the



top has been shaped significantly by the training, guidance, and support provided by the Indian Army's sports programme. Currently, he is also representing the Indian Army. His breakthrough moment came at the 2025 Commonwealth Weightlifting Championships in Ahmedabad, where he clinched the gold medal in the 60kg category with a combined lift of 271kg. The impressive performance not only earned him the top podium spot but also set a new national record and

secured his direct qualification for the 2026 Commonwealth Games in Glasgow. The upcoming edition is Rishikanta's second appearance at the Games, having previously represented India in the men's 55kg event at Birmingham 2022 before transitioning to the newly introduced 60kg weight class. Earlier, at the 2024 National Weightlifting Championships, he had underlined his potential by establishing a national snatch record of 124kg while competing in the 61kg division.

Mirabai Chanu Shatters Big Record To Clinch India's First Gold At Commonwealth Games 2026



Mirabai Chanu shattered the Commonwealth Games record to clinch the gold medal in women's 48kg weightlifting event in Glasgow on Sunday. Chanu first broke the Games record in snatch with a brilliant 85kg attempt and then followed it up with a 105kg attempt in clean and jerk - another Commonwealth Games record. It took her total to an impressive 190kg. This was her third consecutive gold medal at the Commonwealth Games and India's first gold medal at Commonwealth Games

2026. The result was never really in doubt; the only question was how far Mirabai would push the limits. And the Manipuri superstar answered in emphatic style, rewriting the record books with a stunning display of strength and composure. The 31-year-old shattered the Commonwealth and Commonwealth Games records in the snatch, while also setting new CWG marks in clean and jerk and total. She lifted a commanding 190kg, with a best effort of 85kg in snatch and 105kg in clean and jerk.

VAIBHAV SOORYAVANSHI, MAYANK YADAV SHINE AS INDIA SWEEP ZIMBABWE 3-0 IN T20I SERIES

Vaibhav Sooryavanshi's remarkably adaptive 81 and an equally solid effort from bowlers led by pacer Mayank Yadav ensured India's smooth 35-run win over Zimbabwe in the third and final T20I in Harare on Sunday. Along with the victory, India also completed a 3-0 sweep, a fine step-up after surrendering the previous two series to England (0-4) and Ireland (0-2). Zimbabwe had to bat out of their skin to chase down 193 on a rather sluggish pitch. But they did not have enough patience or nous for it, ending up at 157 for seven despite Ryan Burl making a fine unbeaten 54. Just like in the previous matches, Zimbabwe lost one too many wickets early as they could not properly use the Power Play segment. Pacer Yash Thakur (2/45) got rid of Dion Myers and skipper Sikandar Raza off successive balls in the fourth over as the hosts slipped to 34 for three. Earlier Mayank (3/29), who bowled with heaps of pace and accuracy, had ousted Brian Bennett in the first ball of the innings as



Zimbabwe struggled for an early move-on. It became a trend as the innings progressed despite Indians grassing as many as four catches and conceding couple of boundaries in another sloppy fielding effort. Burl played a nice innings of assurance and formed a good 60-run alliance with Wesley Madhevere (28) for the fifth wicket. The Zimbabweans played some forceful shots around the park, but the early damage was too big to mitigate. India too suffered an early jolt, los-

ing a struggling Abhishek Sharma for 2 after opting to bat. But Sooryavanshi showcased another side of his batting during the 49-ball innings on a slightly tacky pitch at the Harare Sports Club, and The 15-year-old started in a relatively subdued fashion - first 10 balls produced a mere 11 runs, the next 10 saw the arrival of 15 runs, and eventually his second T20I fifty came in 31 balls. There were a few stunning shots as one would expect in a Sooryavanshi innings.

MALAYSIA RETURNS TO F1 CALENDAR AFTER 9 YEARS, TO HOST 'BAHRAIN GRAND PRIX' IN OCTOBER 2026

The Bahrain Grand Prix, which was cancelled in April due to the Middle East war, will be held in Malaysia in early October, Formula One organisers announced on Sunday. "Formula 1 and the FIA can confirm that Malaysia will host the... Bahrain Grand Prix at the Sepang International Circuit from October 2-4 2026," F1 and motorsport's world governing body said in a statement. The original F1 calendar featured 24 races but those in Bahrain and Saudi Arabia were cancelled because of the war. Upcoming events in neighbouring Qatar and Abu Dhabi also remain in doubt. Sepang circuit, to the south of Kuala Lumpur, returns to the calendar for the first time since 2017 to host what will be called the "Gulf Air Bahrain Grand Prix in Malaysia".



"This is fantastic news for our fans. They will continue to enjoy a full and exciting Formula 1 calendar, while also seeing the sport return to a great venue," said Formula One chief executive Stefano Domenicali. "Malaysia is an incredible

country, and Sepang holds a special place in Formula 1 history. "It will provide a spectacular setting for racing and an unforgettable experience for fans at the circuit and watching around the world." Uncertainty still hangs over the end of the sea-

son, as the last two rounds are supposed to take place in Qatar and Abu Dhabi on November 29 and December 6. These two races could be cancelled, and several options are on the table to replace them, such as staging two consecutive Grands Prix

in Las Vegas at the end of November, or even holding one or two final races in Europe. In that case, the Imola (Italy) and Portimao (Portugal) circuits are the most likely candidates, several sources within the paddock told AFP. No final decision on the last two rounds in the Gulf is expected before late September or early October, with authorities opting to wait and see how the situation develops. Formula 1 has added Malaysia to its 2026 schedule as the host of the Bahrain Grand Prix that was postponed earlier in the season. The sport's bosses had hoped to reinstate the event to the calendar, but the continuation of conflict in the Middle East, which was the original cause of the cancellation of April races in Bahrain and Saudi Arabia, has forced a change of plan.

Shaheen Afridi Threatens To Quit T20 League, Lodges Complaint After 'Impact Player' Usage Goes Wrong



Pakistan pacer Shaheen Afridi found himself in the centre of drama in the ongoing Lanka Premier League (LPL) 2026. According to multiple reports, Afridi lodged a complaint with the anti-corruption unit of the LPL after being denied the chance to play in a match due to an unusual error. Playing for Kandy Royals, Afridi was seemingly set to feature as

an 'Impact Player' in a match against Colombo Capitals. However, a mistake led to his name not being included in the team list. As per Pakistan-based news reports, the head coach of Kandy Royals apologised to Afridi during their batting innings, stating that a mistake by the team analyst caused Afridi's name to not be included. After the incident, Afridi reportedly not only lodged a complaint to league officials, but also flew back to Pakistan immediately. An apology from team officials and league organizers reportedly convinced the player to stay in the tournament. Afridi went on to play in Kandy Royals' next game against Jaffna Kings, picking up three wickets with the ball and also slamming 22 with the bat. However, Kandy Royals lost the game, leaving them bottom of the table. Further controversy in LPL 2026 Former India Under-19 cricketer Manjot Kalra, one of the co-owners of Lanka Premier League franchise Jaffna Kings, was arrested in Sri Lanka on Friday for allegedly trying to induce a player into corrupt practice, according to local media reports in Colombo.

Shikhar Dhawan Hails Anahat Singh After Historic World Junior Squash Win

Former India cricketer Shikhar Dhawan congratulated teenage squash sensation Anahat Singh after she scripted history by becoming the first Indian to win the World Junior Squash Championship. The 17-year-old achieved the milestone on Saturday at Niagara-on-the-Lake, Ontario, Canada, defeating Egypt's Ruqayya Salem in straight games to secure the biggest title of her career and end Egypt's 15-year dominance in the women's event. Reacting to the landmark achievement, Dhawan took to X to applaud the youngster's accomplishment and its significance for Indian sport and wrote, "History created! Congratulations to Anahat Singh on becoming the first Indian to win the World Junior Squash Championship. A phenom-



enal achievement that will inspire generations. Keep shining!" Anahat entered the tournament as the top seed and lived up to expectations with a commanding 11-3, 11-7, 11-9 victory over second seed Ruqayya Salem in the final. The triumph also made her the first non-Egyptian player to lift the women's World Junior title since American Amanda Sobhy achieved the feat in

2010. The Indian had already signalled her title ambitions by reaching the final on Friday, becoming the first player from the country in 21 years to make it to the championship match. She earned that place with a four-game semifinal victory over Egypt's Barb Sameh before overcoming another Egyptian opponent in the title clash.

TAIWAN'S CHOU TIEN-CHEN SNATCHES CHINA OPEN TITLE AT AGE 36



Taiwan's Chou Tien-chen overpowered his opponent in the China Open men's singles final on Sunday, becoming the oldest tournament champion in the category at age 36. World number six Chou vanquished 27-year-old Toma Junior Popov of France in three games, 21-15, 7-21, 21-13, to claim his first Super 1000 title since winning the Indonesia Open in 2019. The veteran needed just

over an hour to seal the outcome in the championship matchup in Changzhou, eastern China. When an official video review showed that a final return from Popov had dropped out of bounds, an exhausted and emotional Chou kneeled face-down on the court, hands outstretched in victory. Popov, ranked 16th worldwide, had been chasing his first victo-

ry at a Super 1000 tournament. His younger brother Christo, ranked fifth, was eliminated in the round of 16 at this year's China Open. Earlier on Sunday, Japan's Akane Yamaguchi defeated host-country hope Chen Yufei to win the top prize in the women's singles final with an efficient 21-18, 21-16 performance. The final pairing represented a rematch of last year's World Championship in Paris, which was also won by Yamaguchi.

Ahead Of CWG 2026 Athletics, Neeraj Chopra Makes Stunning 90m Remark



Two-time Olympic medallist Neeraj Chopra says he is not "obsessed" with breaching the 90-metre mark every time he competes, insisting that winning major titles and delivering consistently in difficult conditions matter more than chasing a magical number. The reigning world champion, who finally

crossed the coveted 90m barrier with a personal best throw of 90.23m at the Doha Diamond League last year, said his priority at any championship is to finish on top, with distance being secondary. "No, I don't feel that pressure, nor do I obsess over a specific distance. As an athlete, my goal is always to improve my distance," Chopra said in response to a PTI query. "I always feel in major Games, the main challenge is winning gold among the best athletes in the world. The second thing is distance. So I feel I need to keep increasing my distance." The 28-year-old acknowledged that weather and other external factors often influence javelin competitions, making consistency just as important as throwing big. "But when the conditions are tough, we are not able to get the distance. In that case, we have to be consistent. So I feel I should maintain my consistency and see how I can also increase my distance," he said.

Rs 10 Crore + Dube And Brevis: Report Hints At CSK's Sensational Offer To MI For Hardik Pandya

The Chennai Super Kings (CSK) seem to be pushing their pursuit of Hardik Pandya, who is all set to leave the Mumbai Indians ahead of the Indian Premier League (IPL) 2027 season. A report has claimed that MI had asked for Ayush Mhatre plus cash from CSK in the trade deal involving their captain. However, CSK are reportedly not keen to trade Mhatre for Hardik. Rather, they have reportedly offered Dewald Brevis and Shivam Dube plus Rs 10 crore for the MI all-rounder. According to a report in Hindustan Times, Mumbai Indians are seeking a heavy return for their star all-rounder. Their ideal package includes seasoned hard-hitter Shivam Dube alongside rising top-

order prodigy Ayush Mhatre. MI view Mhatre, who impressed in his brief IPL 2026 campaign with a strike rate near 180, as a vital long-term asset to rebuild their squad balance following an underwhelming season. However, Chennai Super Kings are said to be fiercely protective of Mhatre's future with the franchise. Reluctant to part ways with the 19-year-old batter, CSK have reportedly countered with an alternative arrangement. The Men in Yellow are said to have offered Dube, South African dynamic batter Dewald Brevis, and a cash payment of Rs 10 crore to pull off the deal. If finalized, the proposed counter-offer from CSK could represent a total asset evaluation

exceeding Rs 20 crore, marking a potential windfall for Mumbai Indians. Hardik remains an exceptionally rare commodity in Indian cricket as a pace-bowling, middle-order leader who does not occupy an overseas slot. However, his recent performance in IPL 2026, scoring just 206 runs and picking up four wickets, has raised questions about whether CSK are paying for potential rather than immediate output. With neither team confirming an official agreement, the standoff highlights a classic trade dilemma: Mumbai's demand for verified young talent versus Chennai's intent to preserve their core while adding elite all-round utility. Should negotiations

between the two powerhouses stall, rival franchises such as Kolkata Knight Riders are reportedly monitoring the situation, ready to swoop in if the deal Hardik's reputation inevitably carries a premium. There are very few Indian players capable of batting at No.5 or No.6 and providing genuine pace-bowling overs, and that scarcity alone makes him more valuable than a conventional comparison of runs and wickets would suggest.

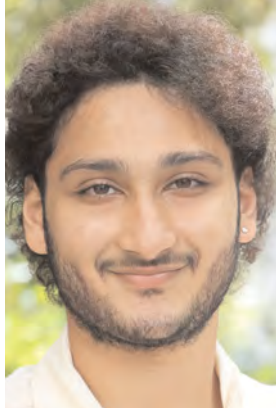
