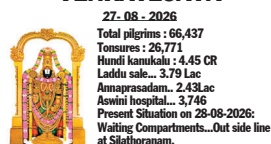

579 confirmed dead, 1924 still missing as Nepal waives trekking fee for Kailash Mansarovar pilgrims returnees

Kathmandu: Nepal has waived the trekking fee for foreign nationals returning from the Kailash Mansarovar pilgrimage through the western Hilsa border point in Humla district for one week, amid disruptions caused by the devastating floods in the Bhote Koshi River. The Department of Immigration said in a notice on Friday that the waiver applies to foreign pilgrims returning from the Kailash Mansarovar pilgrimage who had earlier obtained departure permits from the Immigration Office in Rasuwa.

TWO ARRESTED IN NEPAL FOR STEALING EARRINGS FROM DEAD WOMAN'S BODY AFTER VIRAL VIDEO

Kathmandu, Aug 28: Nepal Police said they had arrested two men for allegedly stealing gold earrings from the body of a woman who was swept downstream into the Narayani River during devastating floods in the country. After a video showing the incident went viral on social media and sparked widespread outrage, police arrested the suspects after identifying them through an examination of the video. The footage showed two men pulling the woman's body from the river before allegedly removing earrings from both her ears.

CM Naidu Pushes Constituency Vision Plans

Amaravati: Chief Minister N. Chandrababu Naidu directed officials and public representatives to effectively implement Constituency Vision Action Plans to achieve the goal of making Andhra Pradesh a leading state in all sectors.

Addressing a video conference with ministers, MPs, MLAs, collectors, Young Professionals, Knowledge Partners and officials, Naidu said Andhra Pradesh was the first state to prepare and implement vision plans at the constituency level, earning national recognition. He said MPs and MLAs have a key role in achieving targets based on identified Key Performance Indicators (KPIs). Young



Professionals, Knowledge Partners and Swarna Office staff should support implementation through innovative approaches and improved public services.

The Chief Minister called for development plans based on local resources and constituency-specific needs. He directed officials to make effective use of the Data

Lake and technology to analyse information and improve decision-making.

Naidu asked MLAs to regularly review implementation and ensure field-level monitoring is transparent and accountable. He stressed that government welfare programmes should focus not only on financial assistance but also on making beneficiaries economically self-reliant.

He directed officials to increase per capita income in every constituency and ensure industries receiving approvals are actually established in the concerned districts. He also called for greater support to entrepreneurs and the poor through initiatives such as P4.

Karnataka Police Hardship Allowance to Rise 50%



Bengaluru (TSIT): Karnataka Chief Minister D.K. Shivakumar announced that the hardship allowance for state police personnel will be increased by 50%, following the model of Andhra Pradesh and Telangana.

Speaking at the launch of comprehensive capacity-building training for Karnataka Police at Manekshaw Parade Ground, Shivakumar said the government would prioritize the financial and

welfare needs of police personnel and provide necessary facilities.

He praised the National Security Guard (NSG) for training Karnataka police and urged personnel to use their enhanced skills to protect the state and its people. He also highlighted growing cybercrime and the need for police to continuously upgrade their technological capabilities. The Chief Minister said the government would explore agreements

with military and Air Force authorities to facilitate helipads on high-rise buildings for emergency rescue operations. He appealed to builders and developers to cooperate.

Shivakumar also announced steps to establish separate anti-rowdy forces led by IPS officers in Bengaluru and every district to control criminal elements and maintain public safety without political interference.

Karnataka minister B Nagendra resigns over 'Valmiki Corporation scam', slams 'Manuwadis'

Bengaluru (TSIT) Karnataka Planning and Statistics Minister B Nagendra on Friday announced his resignation from the state Cabinet, 25 days after being re-inducted, amid allegations linked to the Valmiki Corporation scam.

His announcement came shortly after he said he would meet Chief Minister DK Shivakumar and announce his decision at a press



conference. "Today I am voluntarily tendering my resignation as the minister," an emotional Nagendra told reporters. He said he had sub-

mitted his resignation to Shivakumar.

The Opposition BJP and JD(S) had been protesting against his re-induction into the Cabinet, two years after he resigned over the same issue. They have alleged his involvement in the Rs 89-crore Karnataka Maharshi Valmiki Scheduled Tribes Development Corporation scam.

320 Indian nationals remain out of contact after Nepal floods, 400 on Chinese side safe: MEA

New Delhi, Aug 28: The Ministry of External Affairs (MEA) said on Friday that 320 Indian nationals remained out of contact following the deadly floods in Nepal, while 400 Indian nationals on the Chinese side were safe.

Addressing a bi-weekly press briefing in New Delhi on Friday, MEA spokesperson Randhir Jaiswal stated that 84 Indian nationals, including 63 Indian nationals who were working at the Trishuli-1 hydropower project, have been rescued so far. He further stated that 96 Indian nationals who were stranded on the Chinese side have safely crossed into Nepal by land.

On the situation of



Indian nationals in Nepal, Jaiswal said, "First good news, 21 Indian nationals who had yesterday arrived in Kathmandu from the area that was affected by this flood, they have today landed in Delhi. They have just landed. These 21 Indian nationals, are from Tamil Nadu and they arrived by Indigo flight which just landed in Delhi. Yesterday our

Ambassador had met them in Kathmandu and inquired about their well-being. In addition to these 21 Indian nationals, yesterday I had informed you, we had given you an update about 63 Indian nationals who are working at Trishuli-1 hydropower project, they were also rescued yesterday."

"In addition to these 21 and 63, we have learnt that 96 Indian nationals who were stranded on the Chinese side have safely crossed into Nepal by land and efforts are underway to have them evacuated. We shall be sharing with you details about them as and when we have more information about the particulars etc," he added.

NTA overhaul after NEET row: Centre appoints 2 new directors, joint director

New Delhi, Aug 28: Continuing the revamp of the National Testing Agency (NTA) following the NEET UG row, the Central government appointed two new directors and a joint director to the key examination agency, official documents showed on Friday.

According to official orders issued by the Department of Personnel and Training on August 27, the Indian Administrative Service (IAS) officer Prasanna Venkatesh V and IPS officer Ravi Kumar Singh have been appointed as directors in the National Testing Agency.

Prasanna Venkatesh, a 2012 batch IAS officer, has been posted in the NTA under the Central Staffing Scheme for a period of five



years. The IAS officer, a graduate from Tamil Nadu Agricultural University, has served as Secretary, Social Welfare Department and AP Social Welfare Residential Education Institutions Society, Guntur.

Ravi Kumar Singh, a 2012 batch Andhra Pradesh cadre Indian Police Service (IPS) officer recommended for

Central deputation by the Union Home Ministry, has also been appointed as director in NTA, said an official memorandum issued on Thursday.

He has also been shifted to the Department of Higher Education for a period of five years, the order said. Ravi Kumar Singh served as Deputy Commissioner of Police, Economic Offences Wing,

Delhi Police. The Department of Personnel and Training further informed that Amit Samdaryia, a 2016 batch Indian Revenue Service (IRS) officer, will serve as joint director (deputy secretary level) in the NTA for a period of four years.

The Central government began an overhaul of the NTA soon after the students' protest at Jantar Mantar last month to highlight NEET UG-2026 irregularities.

As part of the revamp, the NTA sacked 47 of its officials, a measure aimed at initiating legal and criminal action may against some of them amidst the students' agitation led by the Cockroach Janta Party (CJP) over NEET paper leak and other exam irregularities.

Telangana pushes for SCCL joint venture with Hutti gold mines

Hyderabad (TSIT): Telangana Deputy Chief Minister Mallu Bhatti Vikramarka on Friday, August 28, directed officials to explore a joint venture between SCCL and Karnataka's Hutti Gold Mines. Vikramarka, on the second day of his visit to Karnataka's gold mining areas, visited the Hutti and Uti gold mines in Raichur district. He inspected the various stages of gold production, from ore extraction to refining, a press release said. He said combining the technical expertise of state-owned Singareni Collieries Company Limited with Hutti Gold Mines' experience in gold mining could help increase domestic production.

He suggested combining this expertise with Singareni's capabilities in mineral exploration and



mining. He directed Singareni officials to prepare an action plan for collaboration between the two organisations in gold exploration, mining, extraction, processing and refining, as well as the adoption of modern technologies, deployment of technical experts and human-resource training.

He emphasised the need to reduce dependence on gold imports and increase domestic production. A

Hutti-Singareni partnership could help boost gold production, promote the use of advanced technologies, create local employment and contribute to economic development, he said. Vikramarka inspected the production unit, ore processing plant and electrowinning facility at Hutti Gold Mines. Officials informed him that the Hutti project produces an average of two to four kg of gold a day.

India likely to co-produce Javelin Anti-Tank Missile in future

New Delhi, Aug 28: The United States is upbeat about India's decision to purchase the Javelin anti-tank guided missile system. Sergio Gor, the US Ambassador to India, has said that the system could be co-produced in India in the future.

"The United States welcomes the Indian Army's signing of a Letter of Offer and Acceptance (LOA) for the purchase of the Javelin anti-tank guided missile system through the US Foreign Military Sales process. The milestone reflects the enduring partnership between the US and Indian Armed Forces. It opens the door for future collaboration between the US and Indian defence industries," the US Embassy in India posted.

"This agreement reflects a defence partnership that is growing deeper, more capable, and more consequential," Gor was quoted as saying by the embassy.



On X, Gor posted: "BIG news! India plans to buy the battle-tested Javelin anti-tank system. Just as @secwar highlighted at the May 2026 Shangri-La Dialogue, this is a great step forward in the US-India defence relationship and opens the door to co-production possibilities. The engagement between our two nations is

at record-high levels!"

"The Javelin agreement demonstrates the depth of US support for the Indian Army and creates new opportunities for our defence industries to work together. We see tremendous potential for future cooperation that strengthens the defence industrial bases of both countries," the embassy

quoted the ambassador as saying. With the signing of the LOA, India becomes a customer of the Javelin system, an advanced, medium-range, fire-and-forget anti-tank guided missile. The US Army, US Marine Corps and numerous international customers use the Javelin. It is designed for use against a wide array of targets, including armoured vehicles and fortified positions.

The Javelin is a man-portable anti-tank missile system jointly developed by Lockheed Martin and RTX for use against armoured targets. The US and allied forces have widely deployed the system.

The shoulder-fired system features an automatic guidance mechanism that allows the missile to track its target after launch, enabling the operator to take cover and avoid counterfire. Soldiers or Marines can also reposition after firing or reload to engage another threat.

APJAC Amaravati Announces Phased Agitation Over Employees’ Pending Demands

Vijayawada, August 28, 2026: The Andhra Pradesh Joint Action Committee (APJAC) Amaravati on Friday announced a phased agitation demanding the immediate resolution of 29 major issues concerning State government employees, including appointment of the Pay Revision Commission (PRC), announcement of Interim Relief (IR), release of pending Dearness Allowance (DA) dues and payment of other financial benefits. Addressing a State-level conference held at the M a k i n e n n i B a s a v a p u n n a i a h Auditorium near Raghavayya Park in Vijayawada, APJAC Amaravati Chairman Bopparaju Venkateswarlu said employees had been repeatedly approaching the government through representations, discussions and meetings, but there was considerable delay in resolving their issues.

He said the history of employees’ organisations showed that several rights had been secured only through democratic struggles. The 11th Pay Revision Commission, he recalled, was achieved after sustained agitations, including the “Chalo Vijayawada” programme. Bopparaju said the present agitation was not against the government but was aimed at securing the legitimate rights and financial benefits of employees. He appealed to the government not to test the patience of employees any further.

The APJAC leader said the State-level conference



discussed the future of employees and teachers in detail and decisions were taken democratically after obtaining the opinions of district-level leadership. He said the State leadership would implement the agitation programme based on the decisions taken by the districts, keeping in view the interests of nearly 13 lakh employees. APJAC State Secretary General Palishetti Damodara Rao said employees were only seeking financial benefits legally due to them and the implementation of assurances made to employees in the election manifesto of the coalition government.

He said employees were seeking payment of pending benefits relating to PRC, DA, surrender leave, gratuity, leave encashment and additional quantum of pension, among others. He urged Chief Minister N. Chandrababu Naidu to ensure that the money due to employees was paid without further delay.

Phased agitation announced

As part of the first phase, APJAC will submit an agitation notice to the Chief Secretary on August 28. From August 31 to September 11, employees

will undertake a series of programmes.

On August 31, district units will meet Collectors through the PGRS programme and submit notices regarding the agitation. They will also inform the Collectors about the proposed “Work to Rule” programme from September 15.

On September 1, employees will display the message “CM Sir, Give Us Our Money” as their mobile phone display picture. From September 1 to 5, employees will wear black badges while attending their duties.

From September 2 to 8, a “Hand to Hand” campaign will be conducted by visiting divisional and district offices and mobilising employees. Lunch-hour protests will be held from September 3 to 5.

On September 11, round-table meetings will be organised at all district headquarters with representatives of APJAC-affiliated organisations, AITUC and CITU to discuss the next phase of the agitation. Work to Rule from September 15.

The second phase of the agitation will be held from September 15 to 26. Employees will observe “Work to Rule” during this

period and discharge their duties strictly according to government rules and prescribed working hours, without taking on additional workload. From September 15 to 22, employees will use WhatsApp, Facebook, Instagram and other social media platforms to publicise the agitation through photographs and reels. Between September 15 and 25, APJAC leaders will meet MLAs, MPs, MLCs and other public representatives and submit memoranda explaining the employees’ demands.

On September 17, employees will organise protests wearing black scarves at major junctions at district and divisional levels and form human chains carrying the slogan “CM Sir, Give Us Our Money.” On September 23, dharnas will be organised at Collectorate and RDO offices with placards highlighting the major demands. On September 26, employees and their family members will hold dharnas at Collectorate and RDO offices demanding payment of their pending dues.

The APJAC leadership said the third phase would include intensified programmes such as multi-zone conferences, non-coop-

eration programmes, relay hunger strikes, “Chalo Vijayawada” and an indefinite strike. A united agitation programme involving other organisations would be announced during the second phase.

AITUC, CITU extend support

AITUC State president R. Ravindranath, State general secretary S. Venkatasubbayya and CITU State general secretary A.V. Nageswara Rao extended their support to the APJAC agitation.

They said employees were not making unreasonable demands and were only seeking implementation of assurances made before the elections and payment of financial benefits due to them. They assured that AITUC and CITU would extend direct and indirect support to the employees’ struggles from the village level to the State level.

Representatives of electricity and RTC employees’ organisations also expressed solidarity with the agitation. AP State Electricity Employees Union-327 State senior working president Y.N.V. Suresh Kumar and RTC Employees Union State general secretary G.V. Narasayya announced their support.

Agitation notice submitted to Chief Secretary’s office

Following the State conference, APJAC Amaravati leaders led by Bopparaju Venkateswarlu went to submit the agitation notice to the Chief Secretary. As the Chief Secretary was not available,

SAAP MD Bharani, Additional SPs, hockey player Rajani, a large number of Amaravati Championship sportspersons, students, officials and others participated. Later, they took a pledge against drugs.

Speaking on the occasion, the District Collector said that over the past four days, competitions were held at the constituency and district levels in 12 sports disciplines for Under-17 and Under-23 age groups. The best performers were brought to Tirupati for further competitions. Approximately 15,000 sportspersons, PDs, PETs and office-bearers participated in these competitions organised



under the aegis of the Sports Authority of Andhra Pradesh (SAAP). Better bus and food facilities were provided to the participants, and the district administration coordinated with SAAP officials to successfully complete all the events. The competitions were conducted in a safe and pleasant atmosphere without any difficulties, untoward incidents or injuries. Among those who participated in the Amaravati Championship, about 65% were students from government schools and government educational institutions, while more than 80% of the sportspersons came from rural areas. The Collector said the championship has emerged as a unique platform to unearth hidden sporting talent in rural areas and to identify students studying in government educational institutions and provide them opportunities at higher levels. Sportspersons who performed well here will be encouraged and sent to state, national and

international level competitions in the future.

He noted that sports play a key role in keeping youth away from drugs. Comprehensive action is being taken on these three fronts to make Tirupati a drug-free district, he added.

Minister Arunraj says TNUHDB tenements dilapidated; Nehru ready for joint inspections



CHENNAI: Health and Family Welfare Minister KG Arunraj on Friday said Tamil Nadu Urban Habitat Development Board (TNUHDB) tenements across the State were in poor condition and lacked basic amenities, prompting Deputy Leader of Opposition KN Nehru to support a joint inspection of the buildings. Participating in the debate on the demands for grants for the Housing and Urban Development Department in the Assembly, Arunraj said the DMK had claimed credit for constructing several TNUHDB tenements, including one at Pattinapakkam. "Those who say they have built several tenements should also see their present condition. Across the State, the tenements are in a dilapidated state and do not provide basic facilities to resi-

dents," he said. Intervening, Nehru said TNUHDB tenements had a lifespan of about 25 years and acknowledged that redevelopment was often delayed because residents were reluctant to vacate their homes. He cited the reconstruction of tenements at Kotturpuram during the previous DMK regime under Chief Minister MK Stalin. "When we proposed reconstruction, the residents agreed to shift. If people are willing to move out for redevelopment, we are ready to discuss construction of new houses," he said. Nehru also agreed to join a proposed joint committee to assess the condition of TNUHDB tenements and suggested that residents be consulted during the inspection, responding to the minister's call for such lines.

Can BJP Expand Its
Political Footprint In
Jadavpur's Left Bastion?

Once upon a time, there were Left Front governments in three states-West Bengal, Tripura and Kerala. We used to say that communism was still alive in these three states and that half a province existed in Jawaharlal Nehru University, or JNU, while the other half existed in Jadavpur University. But eventually, after 50 years, West Bengal was taken over by the BJP. The Left Front ruled Bengal for 34 years, while Mamata Banerjee ruled for 15 years. In Kerala, Congress is now in power, while Tripura is ruled by the BJP. At JNU, after Narendra Modi became Prime Minister in 2014, the political culture of the university also slowly began to change. Swami Vivekananda's statue was installed on the JNU campus, leading to considerable uproar. There was a debate over the installation because Swami Vivekananda was a Hindu sannyasi. Even though he himself spoke about socialism, some ultra-Left students opposed the installation of his statue. The JNU administration has also undergone many changes since the BJP came to power. Even in student elections, although the Left remains dominant, the ABVP has managed to create some space for itself. But today's discussion is not about JNU. It is about the other university of West Bengal, which is now at the centre of a major controversy: Jadavpur University. Before coming to the present controversy, it is worth quickly recalling how Jadavpur University became a Left bastion from the 1960s onwards. Jadavpur University was born out of the Swadeshi movement in 1905. In 1955, the National Council of Education transformed it into a university. But in 1967 and 1970, when the Naxalbari movement was raging in Bengal, Jadavpur University and Presidency College became two of the major centres of Naxal activity in Kolkata. In 1970, unfortunately, the Vice-Chancellor of Jadavpur University, Gopal Sen, was killed by Naxal students because he refused to postpone examinations. That incident firmly established the image of Jadavpur University as a radical university. Then came the long Left Front era, from 1977 to 2011. The CPM ruled Bengal for 34 years. During this period, the student unions of Jadavpur University and the teachers' association, JUTA, came under Left control. Even the famous engineering college's student union, FETSU, was controlled by DSF-the Democratic Students' Front, which was actually an ultra-Left organisation. In the Arts Faculty, FAS and SFI dominated, while in the Science Faculty, WTI, along with independent groups, had a Left-leaning presence. The Trinamool Congress's student wing, TMCP, could never win Jadavpur University, even after Mamata Banerjee came to power in 2011. The TMC made many attempts, but it could not break the Left's hold. Jadavpur is famous for its history of political protest. There were anti-Emergency protests here. In 2007, there were protests against Nandigram. In 2014, the university witnessed the "Hok Kolorob" movement, during which the Vice-Chancellor was kept under siege for around 150 hours following a molestation case. That movement eventually became a national issue. In 2019, BJP Minister Babul Supriyo was also 'gheraoed' at Jadavpur University. The Left has retained control over the hostels. Teachers still have JUTA's dominance.

The Himalayas gave us a brutal reminder this week of what climate change looks like when it stops being a graph and becomes a wall of water, ice, rock, and mud. Across the Nepal-Tibet border, a sudden glacier collapse unleashed a catastrophic flood that tore through communities, roads, bridges, and power infrastructure. Rescue operations are still underway, with at least 482 people confirmed dead so far, and the toll expected to change. But one thing is already clear: this was not an ordinary monsoon flash flood. Early assessments point to an ice-rock avalanche or glacier collapse that turned into a massive debris flow, rather than a conventional glacial lake outburst flood. The US Geological Survey later said the seismic signal first reported as an earthquake was generated by a glacial collapse and debris flow, not by tectonic shaking.

■ **THE TIPPING POINT**
Scientifically, the distinction matters. Politically and morally, it changes little. The Himalaya is turning into a more unstable landscape, and climate change is making it worse. The Global Tipping Points Report 2025, led by the University of Exeter's Global Systems Institute and more than 160 researchers, says tipping-point risks rise as warming approaches and exceeds 1.5 degrees Celsius. Mountain glaciers, it notes, are among the systems capable of non-linear responses under continued warming. Tipping points do not act alone. Most interactions between the systems assessed are destabilising. One shift can make another



more likely, pushing ecological and human systems into cascading risk. The concern, then, goes far beyond the valleys hit this week. A warming glacier does not simply become a smaller glacier. It can become a different kind of threat altogether. As glaciers retreat, meltwater collects in lakes, often held back by unstable walls of ice, rock, and moraine. These lakes can expand quickly. A sudden avalanche, landslide, ice collapse, or breach can release huge volumes of water and sediment downstream. In steep Himalayan valleys, gravity does the rest. A regional analysis of 5,409 Himalayan glacial lakes found both their number and area increasing between 1990 and 2020, with expansion concentrated in parts of the central and eastern Himalaya. Studies of supraglacial lakes tell a simi-

lar story of restless ice and water. These are not abstract risks on a map. They are forming above real villages, roads, bridges, hydropower projects, and pilgrimage routes.

■ **DIFFERENT CONSEQUENCES**
The danger is already built into the landscape. More than 5,000 glacier lakes exist across the region, and work on Himalayan GLOF hazard suggests that a 100-year outburst flood could send peak flows downstream comparable to major monsoon-fed rivers. The glaciers are shrinking too. A Scientific Reports reconstruction of 14,798 Himalayan glaciers found that they had lost at least 40% of their Little Ice Age area, with recent mass-loss rates roughly an order of magnitude faster than the long-term average since

then. Climate change does not mean every kind of glacial lake outburst flood will become more frequent in a neat, linear way. A Nature Climate Change study found no statistically significant increase in moraine-dammed GLOFs in the Himalaya since the late 1980s. The terrain, however, is changing: its exposure, triggers, weak points, and consequences. That is a harder problem, and probably the more dangerous one. We are building roads, dams, tunnels, hotels, and settlements in a mountain system that is no longer behaving according to old assumptions. Himalayan valleys are narrow, and they leave little room for engineering arrogance. Traditional climate risk assessment is not built for such nonlinear behaviour. Tipping-point risks involve uncertainty, sudden

shifts, and cascading impacts. For South Asia, the stakes are enormous. More than three billion people depend on vulnerable monsoon systems, while Himalayan rivers, glaciers, and mountain ecosystems support farms, towns, hydropower, and economies far downstream.

■ **ASKING THE WRONG QUESTIONS**
The ritual question after every disaster is whether climate change "caused" it. That is often the wrong question. The better one is whether climate change is making the landscape more capable of producing disasters that were previously rarer, smaller, or easier to manage. Increasingly, the answer is yes. This is the choice before us. Tip the energy system away from fossil fuels. Tip infrastructure planning

towards climate resilience. Build real-time glacier and glacial-lake monitoring across borders. Create early-warning systems that actually reach the people living downstream. And stop treating Himalayan valleys as empty spaces waiting for another road, dam, or resort. Regional cooperation, therefore, cannot remain hostage to political weather. Rivers, glaciers, and debris flows do not stop at lines on a map, nor do they wait for diplomatic relations to improve. India, Nepal, Bhutan, Pakistan, Bangladesh, and China need shared glacier data, joint hazard mapping, open hydrological information, and disaster-warning protocols that work even during periods of interstate tension. In the high Himalaya, a warning delayed by suspicion can become a warning delivered too late.

Why India's Bureaucrats Have
Learnt That Doing 'Nothing' Is Safer

For decades, the analytical discourse surrounding the institutional labyrinth of the Indian state has been confined to a somewhat sterile duality. We are routinely informed that our administrative failures are the byproduct of either the venality of the corrupt or the vacuity of the incompetent. While these elements undeniably persist within the sprawling architecture of our governance, they fail to account for a far more pervasive, yet curiously invisible, quagmire: the vast, silent arena of administrative inaction. In his new book Decision Velocity: Rational Abdication, the Fear Tax, and the Road to Viksit Bharat, retired IPS officer OP Singh, a man who has traversed the arduous landscapes of field policing and the intricate corridors of the Haryana State Secretariat with equal distinction, proposes a startlingly original third lens with which to view our administrative shortcomings. He identifies a phenomenon that is as pervasive as it is pernicious: a "fear tax" not levied by any formal exchequer, but extracted from the lifeblood of the citizen, in the form of unconscious delay. The Risk of Acting Singh's "Fear Tax" is the price society pays when decision-makers conclude that the safest course is not to decide at all. It is the outcome of a sclerotic system where, for the desk-bound officer, the risk of a decisive signature far outweighs the perceived safety of a pro-

longed silence. As Singh so eloquently demonstrates, our current accountability frameworks audit the traceable action with inquisitorial rigour, yet remain blissfully indifferent to the absent decision. Hence, it's safer not to act at all. This is the central paradox of modern bureaucracy. We have inherited, and subsequently ossified, a colonial-era machinery designed for control, not for velocity. In such a framework, a file that moves is a file that invites scrutiny; a file that rests in a dark corner of a cabinet is a file that poses no threat to its custodian. The result is a Kafkaesque reality where the paralysis of the pen is too often mistaken for the prudence of the professional. This is not merely an inconvenience; it is a profound failure of the social contract. When the state abdicates its responsibility to act, it does not merely delay a project or a permit; it stifles the latent potential of a citizenry waiting for the basic friction of governance to be removed. To understand why this inertia persists, we must venture beyond procedural critiques and into the psychology of the "Iron Frame". The fear of the "audit" - the retrospective, often punitive investigation of administrative decisions, such as happened over the so-called "Coal Scam" that turned out not to be a scam at all - has created an environment of profound risk-aversion. When an officer knows that a decision, however well-intentioned or logical, can be second-guessed by an auditor years later with the benefit of perfect hindsight, especially after a change of government, the most rational individual response is to build a wall of paper, process, and precedent. Rational Abdication This is the "rational abdication" to which Singh refers. It is a survival strategy. If you decide and fail, you are accountable. If you defer, consult a committee, request further studies, or simply wait for a transfer, you are safe. This culture of institutionalised indecision creates a feedback loop: because decision-makers

are penalised for errors of commission but rarely for errors of omission, the entire system evolves to prize stability over progress, and caution over courage. As we set our sights on the ambitious horizon of Viksit Bharat 2047, we must recognise that a nation aspiring to become a leading global economic power cannot afford systems that reward hesitation more than initiative. In the global race for capital, technology, and talent, speed is not merely a virtue; it is a competitive necessity. The cost of delay is not just a line item in a budget; it is the opportunity cost of growth. When a policy-induced delay pushes a manufacturing plant to a neighbouring state or another nation, or when a bureaucratic bottleneck forces an entrepreneur to abandon an innovation, the "Fear Tax" has been paid in full by the Indian economy. We are essentially taxing our own development. The "velocity" that Singh advocates is the antidote to this malaise. It requires a fundamental shift in how we define administrative success. We must move from an obsession with compliance to an obsession with outcomes. Mistakes vs Negligence How? It starts with a reconfiguration of accountability. We must evolve our oversight mechanisms to distinguish between honest mistakes (the byproduct of necessary risk-taking in a complex environment) and true negligence. A system that does not tolerate the possibility of a wrong decision will rarely produce a right one. Furthermore, we must incentivise administrative courage. This involves creating "safe spaces" for decision-making, where the rationale for action is documented and respected, and where the institutional culture shifts from "How can I avoid this?" to "How can this be made to happen?" It requires a re-embrace of the professional ethos of the civil servant as an agent of progress, not merely a guardian of rules. Decision Velocity is a clarion call for a new era of administrative clarity.

Rahul Gandhi Is Cleaning House -
But At The Cost Of The Congress

As Rahul Gandhi remakes the Congress in his image, keeping leaders with decades of patronage, favourable equations, administrative experience, and personal networks at arm's length may spell strategic doom for the party. There is a growing perception within and outside the Congress that some of Rahul's key slogans and campaigns, such as the latest 'smash the patriarchy' crusade, or his support for Gen Z and caste-based reservation, haven't been received well by many among the Congress's old guard, particularly former chief ministers. Privately, these former chief ministers are reportedly concerned that a heavy focus on Gen Z issues might overshadow broader voter priorities, such as inflation and middle-class economic struggles. There is an old rule about the Congress that its present leadership would do well to remember: a Chief Minister never really becomes an ex-Chief Minister. The bungalow may go, the red beacon certainly does, ministers stop returning calls with quite the same urgency, but political capital accumulated through years in office does not disappear with an election defeat or a change of guard. A former Chief Minister leaves behind a web of MLAs, former MLAs, district satraps, contractors, lawyers, business leaders, journalists, bureaucrats, community leaders, religious figures, and party workers who have, at one time or another, received patronage, access, or simply a patient hearing. That is polit-



ical capital. And the Congress today has an astonishing amount of it lying underutilised. Digvijaya Singh, Kamal Nath, Ashok Gehlot, Bhupinder Singh Hooda, Bhupesh Baghel, Siddaramaiah, Prithviraj Chavan, Charanjit Singh Channi, Sushilkumar Shinde, and Rajinder Kaur Bhattal, to cite some of the most important names, have all governed major states. AK Antony and Shinde, who have now withdrawn from active politics, belong to an even older tradition of Congress elders who could be summoned when a crisis required credibility rather than decibels. These are not identical cases, and it would be inaccurate to say each has been banished. Baghel, for instance, is the All India Congress Committee (AICC) general secretary in charge of Punjab, while Channi has been made chairman of the Punjab Congress campaign committee for the 2027 election. Hooda remains the Leader of Opposition in Haryana. Yet, collectively, these former chief ministers appear increasingly periph-

eral to the central political grammar being fashioned around Rahul Gandhi. This may be part of a generational transition. But a generational transition badly handled can easily become institutional amnesia. A Congress Tradition Rahul Should Rediscover The Congress once understood the usefulness of its former chief ministers rather well. AK Antony did not cease to matter when he left Thiruvananthapuram; he became Defence Minister, troubleshooter, and one of Sonia Gandhi's most trusted political consciences. Digvijaya Singh, after 10 years as Madhya Pradesh Chief Minister, moved into the AICC apparatus and handled difficult states. Ashok Gehlot spent years as an AICC general secretary in charge of the organisation between his innings in Jaipur. Sushilkumar Shinde went from being Maharashtra Chief Minister to being appointed Governor, Union Power Minister, and eventually, Union Home Minister. Former chief ministers were dispatched as observers because they

understood the one language every Congress legislature party speaks fluently: ambition. In 2009, for instance, Antony and Digvijaya were among the senior observers sent to Maharashtra after the Assembly election, while Prithviraj Chavan was sent to Haryana. There was logic to this. Someone who has himself negotiated the Chief Minister's chair knows how to recognise a rebellion before the rebel has drafted his press statement. The present Congress, by contrast, sometimes seems eager to demonstrate that nobody is indispensable. It is an understandable impulse given the many cases of regional barons often holding the organisation hostage. Rahul Gandhi wants a younger, more ideological, less transactional party. The trouble is that elections remain stubbornly transactional affairs. The BJP understands this better than its rhetoric suggests. It may retire veterans, but it carefully harvests their networks before doing so. The Congress, on the other hand, often retires the network with the individual. Reservoirs of Political Capital Take Digvijaya Singh. He can be an exasperating presence for his own party, occasionally giving the BJP a quotation it could never have written as effectively itself. Yet, few Congress leaders know the political geography of Madhya Pradesh better. In the run-up to the 2023 election, he was entrusted with difficult BJP-dominated constituencies and spent months meeting cadres and placating disgruntled workers.

JIO GETS SEBI NOD FOR IPO, SET TO BE INDIA’S BIGGEST LISTING

New Delhi: Jio Platforms Ltd, the digital services arm of billionaire Mukesh Ambani’s Reliance Industries Ltd, has received approval from markets regulator Sebi to proceed with an initial public offering (IPO) that could raise about USD 3.8 billion, paving the way for what would be the country’s largest stock-market listing. The Securities and Exchange Board of India (Sebi) issued its final observations on Friday, August 28, according to an update on the regulator’s website. Jio Platforms had filed its draft IPO papers in June. 27 crore shares up for grab The company plans to issue up to 27 crore fresh equity shares, equivalent to about 2.9 per cent of its post-issue equity base, according to its draft prospectus. The offering could value Jio Platforms at about USD 137 billion, people familiar with the matter said. At the estimated issue size of about Rs 37,700 crore (USD 3.8 billion), the offering would surpass Hyundai Motor India’s USD 3.3 billion-equivalent list-



ing in 2024 and become the largest IPO in India. A proposed IPO by the National Stock Exchange (NSE), estimated at about Rs 30,000 crore, would also be smaller. The proceeds will be used primarily to repay or prepay, in whole or in part, about Rs 27,500 crore of outstanding borrowings of Reliance Jio Infocomm Ltd, Jio Platforms’ material subsidiary, according to the draft

prospectus. The remainder is earmarked for general corporate purposes. The public offering comes as India’s primary market has remained active, with strong participation from retail investors and domestic institutions. More than two dozen IPOs have been announced or launched since July 1, nearly matching the 28 recorded in the first half of 2026. Jio telecom is world’s sec-

ond-largest mobile operator Jio Platforms houses Reliance’s digital businesses, including its telecommunications operations. Reliance Jio Infocomm had more than 53.3 crore subscribers as of June-end, making it the world’s second-largest mobile operator by subscriber count after China Mobile, according to company data. The business has also expanded into other areas,

including cloud, artificial intelligence (AI) and enterprise network services. Jio Platforms has previously attracted major global technology and financial investors. In 2020, Meta invested Rs 43,574 crore for a 9.99 per cent stake, while Google invested Rs 33,737 crore for a 7.73 per cent holding. Other investors, including Silver Lake, Vista Equity Partners, General Atlantic, KKR, Mubadala, Abu Dhabi Investment Authority, TPG, L Catterton, the Public Investment Fund, Intel Capital and Qualcomm Ventures collectively invested about Rs 74,745 crore for roughly a 15.2 per cent stake. Reliance Industries owns about 66.4 per cent of Jio Platforms, while Meta and Google together hold about 17.7 per cent, according to the draft prospectus. First offering from Reliance since 2008 The IPO would be the first public offering from the Reliance group since 2008 and the first IPO of a consumer-focused business within the conglomerate.

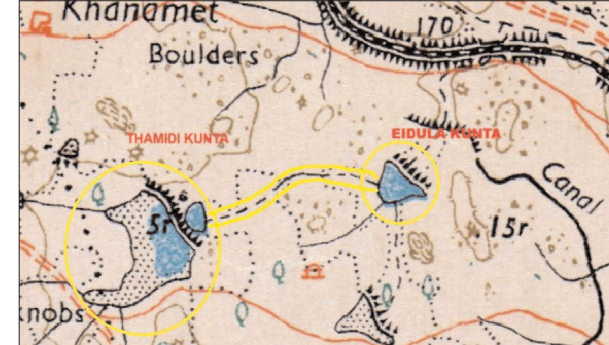

Hyderabad: A National Green Tribunal (NGT)-appointed joint committee has found that Edulakunta, located in Survey no 7 of Khanamet, is a government water body and that NVN Constructions has been carrying out construction activity in it. The Telangana High Court had earlier passed a conflicting order saying that NVN Construction’s 13.17-acre property in Kukatpally does not overlap with the lake. According to a Times of India report, the NGT committee has stated that revenue records classify the entire six acre and five guntas in Survey no 7 of Khanamet in Serilingampally mandal as “Edulakunta Shikam Sarkari.” The land is also included in the Section 22A prohibited list. NVN Constructions’ activities fall under Survey no 7, according to a demarcation done by a mandal surveyor using the Khanamet village map and

ground references and a May 25 inspection by Serilingampally revenue officials. After the inspection, the tahsildar had sought assistance from Hyderabad Disaster Response and Asset Protection Agency (HYDRAA), which fenced the land on May 26 and 27. Lake activists file petition The NGT had taken up the case after lake activists, such as Thakur Raj Singh, filed a petition alleging lake bed filling, debris dumping and unauthorised construction on the lake. The applicants had also alleged that water was being pumped out of the lake to facilitate construction. This allegation was not independently established by the NGT committee. High Court observation On July 31, the Telangana High Court had held that NVN Construction’s 13.17-acre property in survey numbers 1003 and 1006 of Kukatpally was a private patta land and did not overlap with Survey no 7.

PREZ DONALD TRUMP SIGNS ORDER TO RENAME LAKE ONTARIO AS LAKE AMERICA

US President Donald Trump has signed an executive order seeking to change the name of Lake Ontario to Lake America. The move comes after trade talks between the US and Canada collapsed last week, and the US imposed new 50% tariffs on

(C\$28bn) worth of Canadian goods. Canada will implement "dollar for dollar" counter-tariffs next month. Trump said the renaming of the lake, which straddles both countries, was effective immediately. He has broad discretion over how the US recognises landmarks but other countries do not have to follow. Canadian Prime Minister Mark Carney said in response that "things must be called by their name, and this lake is called Lake Ontario - today and forever".

The executive order gives the US Department of the Interior 30 days to update the name change with the Geographic Names Information Service - the official repository of domestic geographic names in the US. Carney noted that the name Lake Ontario could be traced back more than 400 years, adding that it preceded the formation of the Canadian Confederation and the US Declaration of Independence. "We know that the United States is changing," he said. "Their

trade relations, their foreign policy, their national monuments, their hydronyms. "Canadian women and men also know that things must be called by their name, and this lake is called Lake Ontario - today and forever." There is no universally recognised international body setting the names of international waters. When Trump took to the White House in 2025, he signed a similar order that changed the Gulf of Mexico to the Gulf of America.

King Haakon VIII takes the throne in Norway following death of Harald V

Flocks of mourners have gathered outside the Royal Palace in Oslo, where the piles of bouquets and Norwegian flags are growing. Multiple politicians have been seen there, including foreign minister Espen Barth Eide and finance minister Jens Stoltenberg of the Labour Party, as well as leader of the Conservative Party Ine Marie Eriksen Søreide. With King Haakon VIII now the head of state, his daughter Ingrid Alexandra, 22, now becomes the crown princess and heir to the Norwegian throne. It's only in recent decades - since the constitution changed in 1990 - that women have been given the right to inherit the Norwegian throne. It means that Ingrid Alexandra could be Norway's first female monarch since the 15th Century. Born and raised in Oslo, the princess completed her military service in 2025, having spent 15 months as an engineer soldier and rifleman. In May 2025, it was announced that she was to move to Australia to study international relations and political economy at the University of Sydney. Environmental protection and climate change have previously been given as her key interests on the royal family's website - although the biographies are currently unavailable while the site is updated. The Union flag is flying at half-mast over Buckingham Palace, in tribute to King Harald V. The flag placement is a symbol of mourning and respect in many countries, including in the



UK. Harald has ties to the British Royal Family, and was the second cousin of late monarch Queen Elizabeth II. King Harald's coffin will be moved from hospital to the Royal Palace in Oslo this evening, the Norwegian Royal Family has confirmed. His son King Haakon, the new Queen Mette-Marit, Crown Princess Ingrid Alexandra, Harald's wife Queen Sonja, Prince Sverre Magnus, and Princess Märtha Louise will

accompany the coffin. A procession will leave the chapel at Rikshospitalet at 18:30 local time (17:30 BST) and will work its way towards the palace. Norwegian Prime Minister Jonas Gahr Støre has joined the crowd of mourners gathered outside the Royal Palace in Oslo. Støre, who has led the country since 2021, added his own bouquet to the growing number of tributes.

WORLD'S YOUNGEST REIGNING TRADITIONAL MONARCH DIES AGED 34



A traditional Ugandan ruler named as the world's youngest monarch has died aged 34, his prime minister announced. Oyo Nyimba Kabamba Iguru Rukidi IV became king of Tooro in western Uganda at just three years old in 1995 after the death of his father. The Toroo kingdom did not disclose the cause of King Oyo's death, but a Ugandan government minister was quoted in local media saying that he had been critically ill and was seeking treatment in the US. Though Uganda is governed by an elected president and parliament, it has several traditional kingdoms which continue to have significant

cultural influence despite not having political power. Oyo, who Guinness World Records listed as the world's youngest reigning monarch, ruled over more than two million people. He was the 13th monarch of a kingdom that was founded in the early 19th Century. Announcing his death, Tooro's Prime Minister Calvin Armstrong Rwomire Akiiki called his passing on Thursday an "immeasurable loss" to the royal family and the people of Tooro. "I call upon all the people of Tooro to remain united, calm and prayerful during this profoundly difficult time," Akiiki said on Friday.

Tate brothers blast US jail conditions as they seek bail in UK extradition fight

Andrew and Tristan Tate have told a Florida court they should be released from jail so they can fight extradition to the UK on charges of rape and trafficking. Wearing tan jail uniforms, the brothers maintained they did not commit the alleged crimes as they hit out at conditions in US custody. Government lawyers argued that the two were a flight risk and had bragged about having multiple passports, while defence attorneys said the two social media influencers' high profile would make it almost impossible for them to flee. US Magistrate Judge Lauren Louis will issue a written ruling at a later date on whether to grant bail to the dual British-US citizens. The two were arrested in Miami on 19 July. During Thursday's hearing, defence lawyers said the pair had complied with the terms of their release while they battled the UK charges and another case in Romania. US authorities took the men into custody last month



after the UK's Crown Prosecution Service (CPS) unveiled dozens of new charges against them. The British authorities have until 16 September to submit a full extradition request. The brothers, who arrived in court in shackles, were questioned in turn by their defence attorneys and government lawyers as they took the stand. Andrew Tate, 39, declared he has "never committed the crimes I'm accused of". Tristan Tate, 38, described his detention conditions as small and hot, with little sunlight and exercise. "It's

beginning to grate on me because I can't partake in helping with my defence," he told the court, according to CBS News, the BBC's US partner. "It's death by scurvy," he said, adding that he had lost 14lb (6.3kg). The British Embassy filed court documents asking the judge to keep the Tates in custody as the UK pursues extradition. US government lawyers pushed back against the brothers' claims that they had exaggerated their wealth to massage their online personas. The federal attorneys said the Tates had access to

resources that could help fund an escape and they had bragged about having multiple passports. But Andrew Tate, a former professional kickboxer, testified that to support himself financially, he "had to go back to the boxing ring against heavier, younger opponents", according to CBS News. "I've said some stupid things, but sometimes you have to shake the internet to get noticed," he testified about his online statements, according to CBS. "This is the reality of the internet. I'm being treated like El Chapo," he added, referring to the Mexican drug kingpin, "but I have a perfect record in the court system". Under questioning from his attorney, Joseph McBride, Andrew Tate denied he was a human trafficker. The defence also called Natasha Sesay, from England, to testify in support of releasing Andrew Tate. She described a five-year romantic relationship, saying she had had one child with him and was expecting a second.

Dutch court sentences man to life over Rwanda genocide



A court in the Netherlands has sentenced a Dutch-Rwandan man to life for his involvement in the 1994 genocide in Rwanda. The 66-year-old, named only as Eugene N, was accused, among other things, of throwing a hand grenade into a crowd of Tutsis who were seeking shelter in a stadium. He was convicted of war crimes and the crime of genocide, having acted with "genocidal intent", the judge said. Rwanda had sought his extradition in 2014 but the authorities in the Netherlands then launched their own investigation into N, who had become a Dutch citizen. In 100 days in April 1994, an estimated 800,000 ethnic Tutsis and

politically moderate Hutu people were killed by Hutu extremists. The court in The Hague heard N held an authoritative position in the community at the time of the massacre, overseeing around 1,000 people in Mbazi in southern Rwanda. "The suspect was a man who was held in high regard and must have been aware of his role and the influence he had as a local administrator," the court explained, adding that he "committed multiple severe crimes". At a football stadium, he instructed Hutus not to let any of the Tutsis escape. Trapped inside, they were pelted with stones, shot at and had hand grenades thrown at them.

OPTIMUS PRIME AND EEEYORE VOICE ACTOR PETER CULLEN DIES

Actor Peter Cullen, who voiced popular characters including Optimus Prime in Transformers and Eeyore in Disney's Winnie the Pooh franchise, has died at the age of 85. The Canadian actor began his most famous role - as the heroic deep-voiced Optimus Prime - for the Transformers TV series in 1984, then returned for seven Hollywood films from 2007 to 2023 and other spin-offs. He voiced depressive donkey Eeyore in TV animation The New Adventures of Winnie the Pooh from the late 1980s as well as numerous related shows, films and games. His other memorable voice parts included KARR, the evil counterpart to KITT in TV show Knight Rider; the clicking vocalisations of The Predator in Arnold Schwarzenegger's



1987 film; and the roars of King Kong in 1976. He died on Wednesday at his home in Los Angeles, a statement said. "Peter Cullen passed away peacefully, surrounded by his loving family - and held in the hearts of his many friends and countless fans worldwide. "His family asks that you honour his remarkable legacy by



serving your communities and leading others with compassion, integrity, and loyalty and always remember 'be strong enough to be gentle.' Cullen started his career on Canadian TV and radio and was then a regular on programmes like The Sonny & Cher Show before deciding to concentrate on voice acting.

Brother's advice His Optimus Prime voice was inspired by his older brother, a decorated US Marine and Vietnam War veteran, who suggested he should play the character as "a real hero, don't be a Hollywood hero". "He said, 'Don't go yelling and screaming. He's strong enough to be gentle.' "And that resonated with me, and I could hear his voice all the way to the audition. When he drops down, when he gets serious, is where I found Optimus Prime." Cullen gave his brother a cut of the wages he received for playing Optimus Prime until his death. The actor's performance as the character earned him a Daytime Emmy nomination for outstanding performer in an animated programme in 2011.

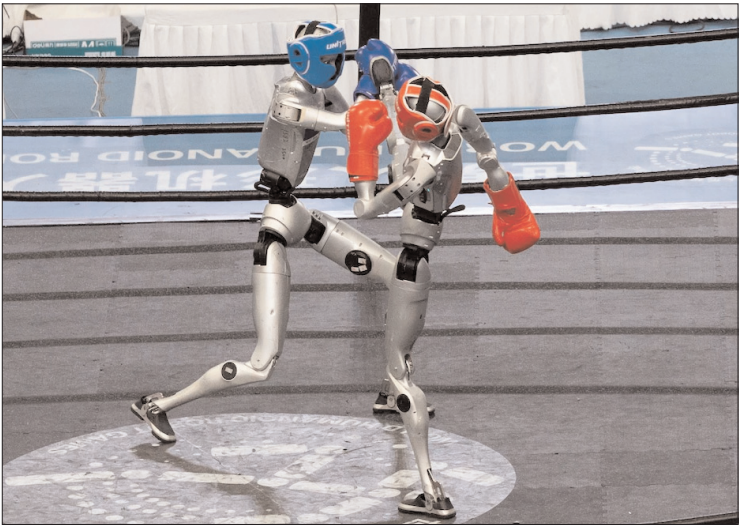

China's World Humanoid Robot Games Offer A Glimpse Into The Future Of Robotics

In 1997, when a computer defeated the reigning chess world champion for the first time in history, many wondered how long it would take for machines to be able to match, or even surpass, humans in competitive sports that involve a high level of physical exertion. Watching the 2nd World Humanoid Robot Games held in Beijing from August 22 to 26, one couldn't help but return to that thought. The annual event brought together 666 teams from 16 countries across six continents, with over 2,000 robots in action. Over the course of the five days, quite a few humanoid robots ran faster than Usain Bolt's 100m world record times, with a few jumping higher than Javier Sotomayor's world record jump of 2.45 metres. These came just months after a humanoid robot beat the human half-marathon world record in Beijing in April. The significance of these feats couldn't be overstated. That robots can already outrun humans when the robotics sector is still at the beginning of an unprecedented boom makes one wonder what possibilities lie a few years down the road. Not all robots, needless to say, displayed the same



level of athleticism or finesse. There were a few erratic ones who malfunctioned or collapsed in the middle of their performances. Yet, the rate of improvement from the first edition of the Robot Games in 2025 was quite stunning. In football, for instance, the robots, albeit still much slower than their human counterparts, showcase improved shooting and passing abilities compared to last year. The underlying aim of the event was to show-

case the advances in capabilities of robots. From a practical viewpoint, it did a good job highlighting the progress robots have achieved in supporting humans in everyday life. The Robot Games featured multiple competitions centred on real-life scenarios. Beyond the headlines about robots outrunning humans, these scenario-based events offered a realistic preview of where robotics is headed. These competitions ranged from

mundane chores like packing, gardening and electric vehicle charging to more serious activities like retail services and industrial assembling. There was also a fire rescue competition that highlighted how robots could be used in emergency response roles that involve high risks for humans. Strolling around the venue of the Robot Games, the National Speed Skating Oval, yours truly had the chance to explore some of the latest offerings in booths set up by some of China's well-known robotics firms. At a robot-run kitchen, one robot sliced through cucumbers while another baked nuggets. They were slow but steady and precise. At another outlet, a robot served orange juice within a couple of minutes, and at yet another one, a robot seamlessly performed the role of a shopkeeper. At one stall, a semi-autonomous wheelchair wowed visitors with its ability to slowly, but steadily, help occupants down a flight of stairs without outside support. There were exoskeletons, brain-computer interface wearables and many other products that highlighted how robotics is gradually entering the medical field, particularly in eldercare.

On Day 1 of the second Test at Lord's, the Pakistan Cricket Board (PCB) reportedly asked the hosts' broadcaster Sky Sports not to air the interview with former captain Imran Khan's sons during the lunch break. Pakistan reportedly threatened a walkout too if their demands were not met. However, Sky Sports went ahead with the scheduled broadcast and aired the interview. A fuming PCB reportedly asked its players to not take the field, prompting the England board to intervene. The 18-minute interview was done by former England cricketer Michael Atherton - one of the 21 captains to sign the letter to Pakistan Prime



Minister - over the worsening health of Imran Khan, who has been behind bars since August 2023. Multiple media outlets, including Cricinfo and The Guardian, claimed that the PCB wasn't happy to see Imran Khan's sons being in the spotlight during the Test. The board even said that Babar Azam's men wouldn't take the field if the interview was shown on TV. Sky Sports continued with the broadcast despite the threats. But Pakistan

still took the field in the post-lunch session, thanks to ECB's timely intervention. A total of two letters have been sent by cricket captains all across the world to the Pakistan Prime Minister over Imran Khan's situation in jail. The first of these letters was drafted in February but it failed to trigger the desired change. The second was sent earlier this week, when Imran was returned to the Adiala jail after a brief medical check-up.
