Infant's body goes missing from burial ground in Hyderabad

Hyderabad (TSIT): The body of a six-month-old girl went missing from the Punjagutta Hindu Graveyard hours after it had been buried, police said on Tuesday, August 11. The child belonged to a couple from Ghansi Bazaar and was born prematurely along with its twin. The two children had been undergoing treatment at a private hospital in Banjara Hills, but one of the twins passed away on August 9.

India rejects China's Arunachal naming claims

■ India has consistently rejected Beijing's territorial claims and its attempts to assign Chinese names to places in Arunachal Pradesh



New Delhi (TSIT) : India on Tuesday hit back at China's rejection of New Delhi's decision to formally identify 27 places and geographical features in Arunachal Pradesh, asserting that the northeastern state was an "inalienable and integral part of India" and that "nothing can change this indisputable reality". Responding to China's description of India's move as "illegal, null and void", Ministry of External Affairs spokesperson Randhir Jaiswal said New Delhi's position on

Arunachal Pradesh remained unequivocal.

"Arunachal Pradesh is an inalienable and integral part of India and this is a fact which is self-evident. At the same time, let me also underline that nothing can change this indisputable reality," Jaiswal said at the weekly media briefing.

His remarks came days after India formally identified 27 locations in Arunachal Pradesh on the Survey of India map using their standard names, in a move that assumes signifi-

cance amid Beijing's repeated attempts to rename places in the state. China had on Monday rejected the Indian exercise, with Chinese Foreign Ministry spokesperson Guo Jiakun saying Beijing does not recognise Arunachal Pradesh, which it refers to as "Zangnan". Describing India's decision to use its own names for the locations as "illegal, null and void", Guo asserted that the move could not alter China's claim over the region.

India, however, has consistently rejected Beijing's territorial claims and its attempts to assign Chinese names to places in Arunachal Pradesh, calling such exercises "vain and preposterous" and maintaining that nomenclature could not alter the ground reality. The 27 locations identified by India include Long Ju, an early flash-point along the Line of Actual Control in 1959, and Maja village in Upper Subansiri district. The list also covers strategically significant high-altitude passes, including Dzo La, Riza La, Pukur La and Thag La.

■ Iridium Treasure Beneath Tekkali?**Srikakulam's mineral exploration points to valuable deposits**

SRIKAKULAM: For a district long identified with migration, unemployment and economic backwardness, a potentially game-changing discovery may be waiting beneath its soil.

Srikakulam, at the northern tip of Andhra Pradesh, has traditionally been known for its long coastline and rich beach-sand mineral deposits, particularly ilmenite and monazite. Now, preliminary exploration in and around Tekkali is reportedly pointing to the presence of iridium, one of the world's rarest and most valuable metals, deep beneath the ground.

According to information available from sources familiar with the exploration, iridium-bearing zones have been identified at depths of around 20 to 25 metres below the surface, particularly in areas around granite and road-metal quarries within a radius of approximately five kilometres from Tekkali.

The reported mineralised zone is spread over nearly three hectares, with indications of other minerals, including manganese and thorium,



as well. If the findings are subsequently confirmed through detailed geological assessment and official exploration, they could place Tekkali and Srikakulam on India's strategic map of critical and rare minerals.

From granite country to critical-mineral zone

Tekkali has long been synonymous with granite. Its granite hills and quarries have provided livelihoods to sections of the local population and contributed to the regional economy. But what lies beneath these granite formations could be considerably more valuable.

Preliminary findings

reportedly suggest that deposits of iridium may occur below some of the existing granite and road-metal quarry areas. The possibility is particularly significant because iridium is an extremely scarce metal with specialised applications in high-technology industries.

The reported discovery, therefore, has the potential to transform the economic significance of the Tekkali region—provided the deposits are scientifically established, economically viable and developed in an environmentally responsible manner.

India to import oil from diversified sources

New Delhi (TSIT) : India is focused on securing its energy needs through diversified sources in order to meet its national priorities amid the supply chain disruptions due to the West Asia conflict, the Ministry of External Affairs said on Tuesday.

"Our energy security, what it is predicated on, is meeting our national priorities, which is securing the needs of our 1.4 billion people," Ministry of External Affairs spokesperson Randhir Jaiswal said. "This remains the cornerstone of our energy security approach. And this is what we want to achieve through diversified sources. We want to source our energy through diversified sources," he told journalists in answer to a query.

The statement comes against the backdrop of the US Senate passing legislation which grants President Donald Trump authority to levy tariffs of up to 100 per cent on goods exported by top buyers of Russian oil, including India.

Western countries see these oil imports helping Russia finance its war against Ukraine. "As far as tariffs are concerned, talks are ongoing between the United States and India on a bilateral trade agreement," the MEA spokesperson added. India has diversified its sources for the import of crude oil to 41 countries compared



with 27 earlier, following the outbreak of the Iran war and closure of the Strait of Hormuz, through which 20 per cent of the world's oil and gas exports transit during normal times. India's imports of crude from Russia have shot up, and during July, accounted for more than half of the country's total oil imports.

Similarly, India has also diversified its liquefied natural gas (LNG) imports from six countries earlier to a total of 15 countries in order to secure its energy supplies.

The US now accounts for a major chunk of these LNG imports. India imports more than 85 per cent of its crude oil requirement, which makes it crucial for the country to ensure supply chain resilience and access to multiple sources of energy in order to reduce the risk of sudden disruptions during a period of geopolitical uncertainty in which the global energy market has turned highly volatile.

Prakash Raj claims name deleted from Bengaluru voter list

Bengaluru (TSIT)

Noted actor Prakash Raj on Tuesday claimed that his name has been deleted from the electoral rolls in Bengaluru during the ongoing SIR process. In a video post he shared on his 'X' account, the actor said claimed that he was one of the 65 lakh voters whose voting rights have been deleted after the Special Intensive Revision of electoral rolls.

However, the Bengaluru Central City Corporation clarified that the actor's name is actively registered at Serial Number 970, Part Number 1 of the 163 Shanthinagar Assembly Constituency as of June 16, 2026 (the date on which the electoral roll data was frozen for SIR activities). **Bihar: Prashant Kishor announces 10,000 private jobs for Bankipur youth in 2 years**

PATNA (TSIT):

Jan Suraj Party founder Prashant Kishor, who was recently elected as the Bankipur MLA in Bihar, on Tuesday announced that he would ensure private jobs for at least 10,000 youths of his assembly segment in the next two years. Kishor was elected as the MLA in the by-election to the Bankipur assembly seat, which was vacated following the resignation of BJP president Nitin Nabin after he was elected to the Rajya Sabha.

He said he would leverage his contacts across the country to provide jobs to qualified youth in different parts of India. In a public address in



Bankipur, Kishor said, "If your children are educated yet unemployed, bring their CVs to our office. We will arrange jobs for at least 10,000 of them within the next two years. Through the big contacts I have, and the people I have helped in the past, I will make sure they get job in different parts of the country."

Kishor said he will facilitate jobs within Bihar once Jan Suraj Party comes to power but "for the time being, you will have to settle for jobs both within and outside the state".

The Bankipur MLA said that apart from facilitating jobs, he will work towards improving the education system, and providing food grains and social security pensions for the needy.

KTR alleges tesseract land deal bigger than MUDA scam

Hyderabad (TSIT):

BRS Working President K.T. Rama Rao on Tuesday alleged that the Tesseract Advanced Systems land deal, which he claimed was linked to Chief Minister A. Revanth Reddy's brother Kondal Reddy, was a bigger scam than the MUDA controversy in Karnataka.

Addressing the media, KTR alleged that Tesseract Advanced Systems was allotted five acres of government land near Raviraj, close to Future City, valued at around Rs.200 crore for Rs.7 crore. He



questioned how a company with a reported paid-up capital of just Rs.1 lakh and allegedly no employees could secure such a land allotment. KTR questioned the ownership and financial credentials of Tesseract Advanced Systems and alleged that Kondal Reddy had represented himself as the company's chairman at various forums.

NO INJUSTICE TO GENUINE OWNERS OF PROHIBITED LANDS

Hyderabad, August 11 (TSIT): Revenue, Housing and Information & Public Relations Minister Ponguleti Srinivasa Reddy on Tuesday assured that genuine land-owners would not face injustice merely because their properties figure in the Prohibited Order Book (POB) or Section 22-A list.

Reviewing 22-A/POB issues with officials from Hyderabad, Rangareddy, Medchal-Malkajgiri and Sangareddy districts, the Minister directed officials to dispose of genuine applica-



tions quickly. He said the government had not added any new lands to the prohibited list and was working to resolve inherited legal and technical issues. Ponguleti ordered officials to upload government orders, land

acquisition proceedings, layout permissions and other relevant documents online by August 14 to prevent forgery and facilitate verification. He directed Sub-Registrars not to reject registrations blindly and to verify records within three days in disputed cases. POB applications will henceforth be sent directly to District Collectors. The Minister warned that while eligible owners must be protected, government properties would be safeguarded and wrongdoing would invite strict action.

CM Revanth Reddy to Launch Smart Ration Card Distribution on Aug.15 Uttam Kumar Reddy



Hyderabad, TSIT: Chief Minister A. Revanth Reddy will launch the statewide distribution of new smart ration cards at a major public programme in Sangareddy on Independence Day, August 15. Irrigation and Civil Supplies Minister N.Uttam Kumar Reddy said on Tuesday.

Reviewing preparations with senior officials, including Civil Supplies Commissioner

Stephen Ravindra and Civil Supplies Corporation Additional Director Rohit Singh, Uttam Kumar Reddy directed officials to make meticulous arrangements and ensure timely and hassle-free distribution of the cards.

The Minister said the Chief Minister's programme in Sangareddy would be accompanied by simultaneous distribution programmes at all 33 district headquarters,

making it a statewide beneficiary initiative.

Telangana currently has 1.06 crore ration cards covering 3.43 crore beneficiaries, with every eligible beneficiary entitled to six kg of fine rice free of cost every month.

Uttam Kumar Reddy, who also spoke to Sangareddy Collector Prateek Jain, directed officials to make detailed arrangements for beneficiary movement, seating, security and card distribution. He said the Chief Minister's programme should be conducted strictly according to schedule.

The Minister asked officials to identify genuine beneficiaries from different sections for receiving smart ration cards from the Chief Minister and ensure that subsequent distribution is transparent and orderly.

Minister sets deadline for Uppal elevated corridor

Hyderabad, August 11 (TSIT): Roads & Buildings and Cinematography Minister Komatireddy Venkat Reddy has directed officials and the construction agency to complete the Uppal Elevated Corridor within the 2026 deadline, warning against delays or further extensions.

Reviewing the project at the Secretariat on Tuesday, the Minister expressed displeasure over the slow progress and ordered the agency to increase manpower and



work in three shifts. He said the government had promised completion by Dasara 2026 and must honour its commitment.

Komatireddy directed officials to take up night works wherever feasible and complete the 6.25-km

BT road beneath the corridor by the end of August. Construction should also be accelerated from the Narapally and Uppal sides.

Officials said nearly 60 per cent of the project had been completed, with 51 of 142 spans finished. The Minister ordered daily progress reports and said he would inspect the project every 10 days.

He directed R&B officials to coordinate with GHMC to ensure related flyover works progress simultaneously.

Transport department warns Mahabubabad vehicle owners

Mahabubabad, August 11 (TSIT): The Telangana Transport Department has intensified its drive against vehicle owners who have failed to pay quarterly motor vehicle tax in Mahabubabad district.

Following directions from the Transport Commissioner, officials are issuing notices to owners with outstanding tax dues. Officials said the dues can be cleared through MeeSeva centres, online service centres or mobile-based online payment facilities.

The department warned that owners who voluntarily clear their dues can avoid further penal action, while cases registered by

enforcement officials may attract penalties under applicable rules.

Officials also advised people who have sold their vehicles but whose names continue to appear in official records to approach the Regional Transport Office with sale and ownership documents and update the records.

District Transport Officer Shankar Naik urged vehicle owners to keep their Registration Certificate, insurance and Pollution Under Control documents valid. Commercial vehicle owners were also advised to ensure valid permits, fitness certificates and tax payments to avoid enforcement action.

Collector urges farmers to choose short-duration crops



Siddipet, August 11 (TSIT): District Collector K. Hymavathi has advised farmers to avoid water-intensive paddy cultivation and opt for short-duration, low-water-consuming crops amid dry conditions attributed to the El Niño effect. At a District Irrigation Advisory Committee meeting held at the Collectorate on Tuesday, officials reviewed water availability in major irrigation projects. The Collector said there had been no significant fresh inflows and existing water should primarily be reserved

for drinking needs. She noted that paddy accounted for about 3.68 lakh acres of the 4.82 lakh acres cultivated last year. This year, crop diversification has covered around 70,000 acres, with farmers taking up pulses, millets, maize, cotton and other crops. The Collector advised farmers to cultivate castor, cotton and oilseeds after August 15. She said irrigation water could be released for agriculture if adequate rainfall occurs in August and September, subject to availability.

Husnabad residents urged to keep surroundings clean



Husnabad (TSIT) Pudari Varaprasad Goud, the Councilor for the 11th Ward of Husnabad Municipality in Siddipet district, urged residents to maintain personal hygiene and keep the surroundings of their homes clean. Mulugu constituency 100 percent complete in SIR process : Collector

Mulugu, August 11, TSIT: District Collector Borkhade Hemant Sahadeva Rao said in a statement on Tuesday that the enumeration of voters in Mulugu constituency as part of the Special Comprehensive Revision (SIR) process has been completed.

Speaking on this occasion, he mentioned that the programme of special comprehensive revision of voter list started on June 25, and in the first phase, enumeration forms were distributed to voters from June 25 to June 30.

Later, from July 1 to August 10, BLOs went door-to-door and collected the completed enumeration forms, as well as



checking the details of the voters and taking up the process of digitization of the forms, he said.

It has been revealed that the process of collection, verification and digitization of enumeration forms has been completed 100 percent in Mulugu constituency.

He said that there are 2,36,970 voters in Mulugu constituency, out of which

2,09,128 voters have digitized their enumeration forms. It is stated that it is 88.25 percent of the total voters. He said that the remaining 27,842 voters were identified as uncollectible. Of these, 8,354 died, 4,015 were double entrants, 14,207 were permanently displaced and 1,219 were unaccounted for. He said that the percentage of those identified as uncollectible is 11.75 percent. The Collector clarified that the process of SIR enumeration is 100 percent complete in Mulugu constituency with 88.25 percent digitization completed and 11.75 percent identified as uncollectible due to various reasons.

District Collector Priyanka Inspects Custard Apple Processing Unit; Orders Land Allocation for New Groundnut Oil Processin:

Narayanpet, August 11 (TSIT): In a major push toward rural women empowerment, District Collector Priyanka visited the women-led Custard Apple Processing Unit at the Damaragidda mandal headquarters.

cent and Khammam 75.42 per cent.

In Khammam constituency, 2,47,540 of the 3,28,203 electors have been digitised. The corresponding figures are 2,26,729 of 2,45,885 in Palair, 2,05,488 of 2,26,126 in Madhira, 1,79,322 of 1,96,475 in Wyra and 2,26,848 of 2,47,092 in Sathupalli. Of the total 12,43,781 electors across 1,460 poll-

ing parts in the district, 10,85,927 have been digitised so far. The report shows 43,131 electors under 'no mapping', while 33,380 have been marked deceased and 1,01,549 as permanently shifted. A total of 11,004 are already enrolled, 11,371 are marked absent and 550 fall under other categories.

Fake Degree Allegation Sparks Controversy at Mahabubabad Gurukul

Mahabubabad, August 11: Allegations of irregularities in the appointment of an outsourced computer operator at the Mahatma Jyotiba Phule Backward Classes Welfare Residential Girls' School at Gummuduru in Gudur mandal have triggered controversy, with complainants alleging that a fake degree certificate was used to secure the job.

According to documents and complaints submitted to the authorities, the individual was appointed as an outsourced computer operator at the residential school in 2019 after allegedly producing a B.Com (Computers) degree certificate as proof of educational qualification.

The complainants have



questioned the authenticity of the certificate, pointing to records that reportedly show the same individual enrolled in B.Com (Computers) through a Dr. B.R. Ambedkar Open University study centre in 2022. They have questioned how the individual could have enrolled for the same degree in 2022 if the qualification had already been completed in 2019 and used for employment.

The complainants have submitted the relevant

documents to the authorities and demanded verification of the original degree certificate with the concerned university.

Three Complaints Before Collector

The complainants alleged that they had submitted written representations along with supporting documents to the Mahabubabad District Collector's grievance forum on three occasions, seeking a detailed inquiry into the appointment.

Coordinated steps must be taken to organise the 80th Independence Day celebrations in a grand manner District Collector Dr. S. Venkateswar

Tirupati, August 11: District Collector Dr. S. Venkateswar directed officials to examine the applications received from the public through the Public Grievance Redressal System (PGRS) within the prescribed time limit and provide quality and satisfactory resolution. On Tuesday evening, in the Video Conference Hall of the local Collectorate, the District Collector, along with District Revenue Officer G. Narasimhulu, reviewed various issues including resolution of PGRS applications, public positive perception on pension distribution, arrangements for the 80th Independence Day celebrations, Har Ghar Tiranga programme, tree plantation drive, illumination of offices, election-related matters, and applications under welfare schemes. The review was held with district officials in person and virtually with Municipal Commissioners, Revenue Divisional Officers, Tahsildars, MPDOs, EROs and other officials in the district.

Speaking on the occasion, the District Collector stated that public grievance redressal and positive public perception on pensions must be strengthened. He noted that while public positive perception on pension distribution had earlier been as high as 91 per cent, it has now declined to 86 per cent, which is a matter of concern. He directed MPDOs, Municipal Commissioners and concerned officials to treat this issue with the highest priority and take special measures to restore and improve public positive perception. Although Secretariat staff have been working efficiently in pension distribution, the decline in public perception is due to reduced supervision over the past few months. The Collector instructed that continuous reviews must be held on this matter hereafter.

He directed all departments to work in coordination to organise the 80th Independence Day celebrations on August 15 in a grand manner. Programmes already suggested by the Joint Collector and District Revenue Officer must be completed within the stipulated time. As part of the



publicity campaigns from August 10 to 15 in connection with Independence Day, under the theme "Ane Nenu", officials, Secretariat staff, teachers, students and staff of various departments should prepare videos stating their personal goals in accordance with their responsibilities and widely publicise them on social media. Officials should formulate their own targets related to their duties, services to be provided to the public, development programmes and implementation of welfare schemes. Through these videos, the programme should be conducted in a manner that fosters patriotism and responsible citizenship among the people. The Collector also directed that the Collectorate and all government department offices should be illuminated with electric lights on the occasion of Independence Day.

He instructed that a mega tree plantation programme should be organised across the district on August 14. Departments of Forest, Horticulture, Rural Development, DWAMA, Panchayat and others should take up the programme in coordination. The programme should be designed to ensure large-scale participation of public representatives, officials and the public, and available saplings should be kept ready in advance.

As part of the Har Ghar Tiranga programme from August 13 to 15, steps should be taken to ensure that the national flag is hoisted on every house, commercial establishment, office, industry, factory and other places. In addition to government departments, commercial organisations, industries, hospitals, medical shops,

homestays, tourism establishments, handloom and textile units and other organisations should also be involved in the programme, he directed the concerned department officials.

He suggested that special videos with patriotic messages featuring prominent sports persons in the district, individuals who have received national and state-level recognition in the handloom sector, awardees and other dignitaries should be prepared and publicised on social media. Tirumala Tirupati Devasthanams, Tourism, Handloom and Sports departments should also involve prominent persons from their respective domains. On the occasion of Independence Day on August 15, patriotic messages should be widely disseminated to the public through IVRS and WhatsApp blast, he directed the concerned officials. Special stalls should be set up during the Independence Day celebrations to explain the government's Super-6 schemes to the public. District-level officials and heads of departments must mandatorily attend the Independence Day celebrations, the Collector stated. In the scrutiny related to electoral rolls, EROs, AEROs and Additional AEROs should take special care to ensure proper receipt of required documents. Applications should be examined as per norms with self-attestation and parents' documents according to date of birth, and defective applications should be corrected and resubmitted. Clear proceedings should be issued with details of officials conducting inquiries polling station-wise, those issuing notices and those issuing speaking orders, he instructed.

Pregnant Women and New Mothers Should Fully Utilise the Free Transport Facility— District Collector Dr. S. Venkateswar

Tirupati, August 11:** District Collector Dr. S. Venkateswar stated that the State Government has introduced '102 Mother-Child Express' vehicles to provide safe medical services to pregnant women and new mothers, to ensure they reach the hospital on time, and to safely take mother and child home after delivery.

As part of the statewide launch of the '102 Mother-Child Express' vehicles, the 16 Mother-Child Express vehicles allotted to Tirupati district were flagged off on Tuesday morning in the premises of the local Collectorate by District Collector Dr. S. Venkateswar, Tirupati MLA Arani Srinivasulu, former Union Minister Panabaka Lakshmi, AP Yadava Welfare Corporation Chairman Narasimha Yadav and other public representatives.

Speaking on the occasion, District Collector Dr. S. Venkateswar advised that high-risk pregnancy cases and pregnant women suffering from anaemia should specially utilise these services. He said the 'Mother-Child Express' services can be used to travel to hospitals for necessary antenatal check-ups, related medical tests, and treatments such as iron sucrose as advised by doctors. The vehicles can also be used to safely take the mother and child home after discharge from the hospital following delivery. He urged women who deliver in government hospitals and pregnant women to fully utilise this free transport facility. The Collector informed



that the 'Mother-Child Express' services can be booked by calling the 102 number through the concerned government medical officer, ANM or ASHA worker. He stated that timely availability of transport for pregnant women and new mothers will further improve their access to medical services. Continuous monitoring of high-risk pregnant women, reduction of anaemia, and ensuring that pregnant women attend medical tests at the prescribed times can help reduce the incidence of low-birth-weight babies, and thereby these services will contribute significantly to reducing maternal and infant mortality. The Collector directed health department offi-

cials and field staff to create widespread awareness so that pregnant women and new mothers in Tirupati district fully utilise this facility. Regarding inter-district borders, he said that although these services are generally available within the concerned district, since Tirupati has major medical institutions such as the government maternity hospital, pregnant women and new mothers from neighbouring districts may also come for medical services. Depending on need, the services can be utilised to reach the nearest government hospital.

Tirupati MLA Arani Srinivasulu said that the State Government is taking special measures for the

welfare of pregnant women and new mothers with the cooperation of Chief Minister Nara Chandrababu Naidu, Deputy Chief Minister Konidela Pawan Kalyan, Health Minister Satyakumar and others. As part of these efforts, the '102 Mother-Child Express' vehicles have been made available.

He informed that of the 16 vehicles allotted to Tirupati district, 15 vehicles will be available in the Tirupati area and one vehicle in the Srikalahasti area. These vehicles will help pregnant women safely reach the hospital from home, attend necessary medical tests, and safely take mother and child home after delivery. He said this facility will be highly useful in enabling women to receive medical services on time without any difficulties.

How Parliament House Outgrew its Imperial Design

The building that came to house Indian democracy was not designed as the centre of a sovereign nation. New Delhi was planned around the Viceroy, the Secretariat and the ceremonial projection of imperial authority. A separate legislative building entered the scheme belatedly, after the Government of India Act, 1919, enlarged the machinery of colonial representation. Even when it opened in 1927, the British avoided calling it parliament. "Council House" better expressed the limits of an institution in which representatives could debate while executive authority remained elsewhere. That reversal gives Sobhana K. Nair's *Housing the Republic* its animating idea. The book follows the Council House as it is occupied, altered and gradually made central to the constitutional life of independent India. Its democratic meaning did not reside in the intentions of its architects. It accumulated through political use. Nair says the book arose from "anticipatory grief" as the old parliament's active life was nearing its end. It is part biography, part institutional history and part farewell. Yet its affection is supported by extensive research, not sentiment alone. Drawing upon official correspondence, parliamentary debates, memoirs, architectural records and her experience as a parliamentary journalist, she reconstructs both the building's public history and its untidy inner life. She is at her best when entering large constitutional questions through small material details. A foul smell in the Rajya Sabha leads into sealed ventilators, forgotten passages and decades of negligent alteration. A telephone-directory entry placing federal court judges under the home department reveals how a new judiciary struggled to establish even the appearance of independence from the executive. Disputes over rooms, libraries, doors and keys become disputes over institutional authority. This movement from the apparently trivial to the constitutional is one of the book's principal pleasures. Nair approaches files with a reporter's eye for vanity, absurdity and unintended consequence. Edwin Lutyens and Herbert Baker appear not only as architects of empire but as quarrelsome men whose professional resentments affected a public monument. Bureaucratic records rarely remain bureaucratic for long. The richness of this material sometimes makes the narrative discursive. A portrait, personality or administrative disagreement may open into an extended miniature history before Parliament House reappears. But the looseness largely suits a work that presents the building as a life rather than a structure: conceived amid dispute, repeatedly altered, adapted to new occupants and burdened with memories its designers could not have foreseen. The chapters on the making of New Delhi establish the irony at the heart of that life. The legislature was subordinate within a capital organised around executive power. Baker's triangular proposal gave way to a circular building after arguments in which geometry, imperial symbolism and personal rivalry became entangled. Contemporary observers compared the completed structure to a gasometer, a bullring and a mill wheel. Nair does not claim that the circle secretly anticipated democracy. Her point is more persuasive: political history compelled an imperial building to answer purposes for which it had not been designed.

THREE ADVERSARIES BECOME 4: WHY THE SAUDI-TURKEY-PAK DEAL IS A HEADACHE FOR INDIA

On July 4, 2025, less than two months after hostilities between India and Pakistan ended following Operation Sindoor, Lieutenant General Rahul R Singh, the Indian Army's Deputy Chief, said India had effectively faced three adversaries on a single border. Pakistan was the active frontline combatant, China shared real-time satellite intelligence, and Turkey, a partner of Islamabad, had been a source of tactical and kamikaze drones that had been used against India. Now, if the Mecca Joint Defence Agreement signed between Pakistan, Turkey and Saudi Arabia on August 7 is implemented in letter and spirit, it could theoretically mean that a fourth nation - Saudi Arabia - would be treaty-bound to oppose New Delhi in the event of armed hostilities in the sub-continent. A joint statement issued post the signing of the agreement states that an armed attack against any of the three would be regarded as an attack on all.

Snub To India?

While Pakistan's Foreign Minister, Ishaq Dar, has described the agreement as being "purely defensive in nature", New Delhi would not be pleased with Saudi Arabia signing on, given the extremely close ties between Delhi and Riyadh. India and Saudi Arabia define their relationship as a strategic partnership anchored by a joint council that steers ties that have grown to include oil, security, investment and culture. Trade stands at \$43 billion, with Saudi Arabia supplying around 14% of India's crude oil.

Saudi Arabia Is A Lifeline For PakistanAt the same time, Saudi Arabia and Pakistan have already opera-



tionalised a bilateral security pact that predates the Mecca Joint Defence agreement. Between April and May this year, Pakistan sent roughly 8,000 soldiers and a full squadron (approximately 16 jets) of JF-17 Thunder fighter jets to Saudia Arabia. Some reports also indicate that Islamabad transferred two squadrons of drones and a Chinese-built air defence system as part of the Strategic Mutual Defence Agreement that it signed with Saudia Arabia in September 2025. The scale of this deployment was hardly for 'advisory and training purposes', and could be described as a form of military repayment by Islamabad at a time when Saudi Arabia found itself at the receiving end of Iranian drone attacks during the ongoing war between Israel, the United States and Iran. The Pakistan-Saudi Arabia association is not new - Saudi Arabia has been a financial lifeline for

Pakistan for decades and has helped Islamabad deal with balance-of-payments crises. Since 2018, Riyadh has repeatedly extended multi-billion-dollar deposits and deferred oil-payment facilities - including \$6 billion in 2018, \$4.2 billion in 2021, roughly \$8 billion in 2022, and continued deposit rollovers through 2026 - often tied to IMF bailout conditions. Militarily, Saudi Arabia has backed Pakistan against India since 1965 with money and diplomatic support. In 1971, Riyadh condemned India's actions and support continued during the 1999 Kargil conflict, through cash and lobbying. Reports on the direct transfer of Saudi weaponry - including the loan of military aircraft in 1971 - have, however, not been backed with substantial evidence. On the other hand, Pakistani forces have been deeply embedded in Saudi Arabia's military since the 1960s. Cooperation began under

King Faisal and President Ayub Khan, with a formal 1967 agreement with Pakistani pilots reportedly flying Saudi jets against a 1969 Yemeni incursion. Through the 1970s-80s, up to 15,000 Pakistani troops were stationed in the Kingdom at various points, including in border-defence roles. A 1982 Protocol Agreement formalised the framework for these ongoing troop deployments. Separately, during the 1991 Gulf War, about 13,000 Pakistani personnel were deployed to Saudi Arabia. Over the decades, Pakistan has also trained an estimated 8,000-10,000 Saudi military personnel; more recently, Pakistan's former Army Chief, Gen. Raheel Sharif, took command of the Saudi-led Islamic Military Counter-Terrorism Coalition in 2017, and joint army, naval and air force exercises have since become a regular fixture.

What Turkey Brings To The

Pact Pakistan's military association with Turkey is more directly linked to arms imports - Islamabad has historically benefited from Turkish platforms, including Bayraktar TB2 drones, MILGEM-class corvettes valued at around \$1.5 billion, and modernisation support for its US-built F-16 fleet. Pakistan acquired four Turkish-designed MILGEM-class corvettes for its Navy among its most technologically advanced surface platforms, with the final vessel, PNS Tariq, delivered in August 2023. Turkey has also been involved in the modernisation of Pakistan's French-designed Agosta 90B-class submarines. Pakistan received its first batch of Bayraktar Akinci high-altitude combat drones in 2023, adding to earlier TB2 acquisitions with the relationship progressing towards local production. Turkey's KAAAN stealth jet made its first flight on February 21, 2024.

Development of prototypes is ongoing, with Turkey expected to begin receiving deliveries of the fighter between 2028-2030. Pakistan is seen to be a strong prospective customer; talks began around 2023, with the Pakistan Aeronautical Complex potentially co-producing rather than just buying the jet. There is, however, no contract that has been signed, with Islamabad believed to be closer to acquiring the Chinese J-35A stealth fighter, a more mature platform. After Pakistan used Turkish drones during the 88-hour war (Operation Sindoor) in May last year, India retaliated by revoking Turkish firm Celebi Aviation's security clearance. E-commerce platforms Ajio and Myntra dropped Turkish brands, and tourism took a big hit, with travel platforms cutting Turkey promotions. Indian arrivals fell upto 38% over the summer season.

India Will Have To Watch Out

With no signs of Islamabad moving away from its policy of state-sponsored terrorism, New Delhi will be looking closely at whether the new Turkey-Saudi Arabia-Pakistan pact ends up becoming a major strategic headache in the event of armed conflict. Turkish Foreign Minister Hakan Fidan's remarks that the Mecca Joint Defence Agreement is similar to NATO's Article 5 collective-defence clause sound ominous for New Delhi. For now though, the agreement appears to primarily be a regional hedge against America's declining role as a net security provider - perhaps a political signal of realignment away from US-centric security guarantees in the Middle East.

Karnataka SIR hits 100% digitisation; 1.09 crore electors flagged under ASDDO

Bengaluru, Aug 10: Karnataka's Special Intensive Revision (SIR) of electoral rolls has crossed the 100% mark in digitisation of enumeration forms, with forms of all 5.54 crore electors in the state now digitised, according to data from the office of the Chief Electoral Officer (CEO).

The enumeration phase completed the digitisation on Sunday, August 9. Of the state's 5,54,32,314 electors, enumeration forms of 4,45,18,538 electors were signed and received by Booth Level Officers (BLOs), while 1,09,13,776 electors, or 19.69%, were marked under the Absent, Shifted, Dead, Duplicate and Others (ASDDO) category.

Of those placed under ASDDO, 15,65,838 electors (2.82%) were recorded as absent or untraceable, 65,85,791 (11.88%) as permanently shifted, 16,35,759 (2.95%) as dead, and 6,92,272 (1.26%) as duplicate or already enrolled. Another 4,27,119 electors (0.77%) were placed in the 'others' category, which includes those unwilling to sign the enumeration forms.



The digitisation data showed that 1,76,68,045 electors (31.87%) had self-mapped their names to previous electoral rolls, while 2,34,54,791 (42.31%) were mapped through their progeny. A further 33,61,876 electors, or 6.06%, fell under the 'no mapping' category, indicating that they could not find their own or their family members' names in the 2002 electoral rolls. The CEO's office has also received applications from electors seeking inclusion in the rolls, corrections and other changes

during the ongoing revision. Between June 16 and August 8, a total of 12.68 lac applications were received. Of these, 3,95,781 were Form 6 applications seeking inclusion in the electoral rolls, while 8,37,514 were Form 8 applications. Form 8 is used for requests including shifting of residence, correction of entries in the electoral roll, replacement of an Elector Photo Identity Card (EPIC), and updating a voter's status as a person with disability (PwD). Separately, 7,05,062 elec-

tors have submitted their enumeration forms, of which around 9,000 were yet to be verified by BLOs, according to the CEO's office.

Officials said electors whose enumeration forms have not been signed and submitted to BLOs will not be included in the electoral rolls. This includes those marked as absent or untraceable and those who have permanently shifted. Electors categorised as dead or duplicate will be removed from the rolls as part of the revision.

Those listed under the 'no mapping' category, including electors unable to provide their previous SIR details, will be issued notices at a later stage. They will be asked to submit the documents specified in the enumeration form to establish their eligibility.

Under the revised SIR schedule, electors have time until August 17 to verify the list of voters categorised under ASDDO, which has been uploaded on the Election Commission's website. The list has also been shared with recognised political parties and Booth Level Agents.

INCLISIRAN FOR CHOLESTEROL: DOCS CALL IT EXPENSIVE, STRESS FOR CHEAPER

Even as India is set to soon launch promising new medicine called the DCGI and US FDA-approved Inclisiran to lower cholesterol and keep it low with just two doses a year, doctors while hailing the advance contend that the drug is expensive and stressed on much cheaper versions available that should be put to better use. Inclisiran is the first and only small interfering RNA (siRNA) therapy to lower low-density lipoprotein cholesterol (also known as bad cholesterol or LDL-C) with two doses a year, after an initial dose and one at three months.

Inclisiran by Swiss multinational pharmaceutical Novartis, expected to be around Rs 1.2 lakhs, has been approved by the Drug Controller General of India (DCGI) under the brand name of Sybrava, following the successful completion of trials. The UK has also approved Inclisiran.

"There is a case for use of these injectables in India if their price comes down. As of right now even the use of appropriate doses of statins is not so common in India. These are cheap medicines which are available in generic form in India and they are still not used so at the moment, one should focus on how to use them better," Dr. Vivek Chaturvedi, Head, Department of Cardiology, Amrita Hospital, Faridabad told IANS. "The use of these injectables will only take place for those people in India who find many side effects of statins. The reason being that, for most Indians, cholesterol is controlled using statins which are much cheaper," he said.

Inclisiran is able to reduce the amount of LDL-C in the bloodstream by improving the liver's natural ability to prevent the production of a protein that plays a role in keeping circulating cholesterol levels high. It is a subcutaneous injection with an initial dose, then again at three months, and then every six months. This approach may help those who have trouble sticking to medicines that are self-administered and have greater dosing frequency. "Inclisiran is a new cholesterol lowering drug administered subcutaneously twice yearly. Being both very expensive and a very potent drug its use will initially be restricted to those patients with severely raised blood chole-

sterol levels that don't respond to current orally administered pills," Dr Atul Mathur, Executive Director-Interventional Cardiology & Chief of Cath Lab, Fortis Escorts Hospital, New Delhi told IANS.

"However, the most noteworthy fact is that we are entering an era where we will soon replace daily pills with subcutaneous shots needed once or twice a year. This is how with time we are moving ahead in the management of cardiovascular diseases," he added. Dr. Chaturvedi explained that there are several drugs which are available for effective reduction of cholesterol. "The most studied to-date and the most effective in terms of its response and cause are the statins which are readily available in India. These are the first drugs which should be given to a patient because of their long-standing record and LDL lowering capacity," he said. There are two more oral drugs available in India - one is histamine and a newer one called bempidoic acid which are used along with or sometimes instead of statins when people have statin-associated muscle symptoms. "These medicines, as of right now, are too expensive for the common Indian household. So, their use is reserved at best. Hence, even the drugs that are available like evolocumab, are still not very widely used in India," Dr. Chaturvedi said. According to a study by the Indian Council and Medical Research and Madras Diabetes Research Foundation, and published in The Lancet last year, about 213 million people in India - or almost 24 per cent of the population - have dyslipidemia, a disorder marked by abnormal levels of lipids, such as cholesterol, LDL-C, triglycerides, and high-density lipoprotein cholesterol (HDL-C), in the blood.

"Lipid lowering therapies are well-established to prevent cardiovascular events in adults with dyslipidemia and multiple risk factors. However, global clinical usage of statins remains suboptimal, with adherence to low rates mainly due to concerns about side effects and misconceptions about benefits," Dr Ashwani Mehta, Senior Cardiologist, Sir Ganga Ram Hospital, told IANS. "This new therapy is a very powerful way of reducing cholesterol and thereby taking care with the adherence issues and

The service will begin by supporting credit cards issued on global networks such as Visa and Mastercard, using the same framework Apple runs in other markets, Business Standard (BS) reported, citing three people aware of the development. Users will be able to add eligible cards to the Apple Wallet app and make contactless payments by tapping their device at point-of-sale terminals using near field communication (NFC). Apple has been readying the launch for the end of September or October, the BS quoted a source as saying. No UPI support at launch Apple Pay is not expected to support UPI-based payments initially. To offer UPI, Apple would need clearance from the National Payments Corporation of India (NPCI)



and would have to partner with a sponsor bank to route such transactions. Consequently, the service's footprint in India is likely to remain limited to NFC-enabled point-of-sale terminals and card-based online payment flows, leaving the country's QR code-driven UPI ecosystem largely unaffected. Apple has been in negotiations with the country's largest credit card issuers for months over how much of each transaction it would retain. The technology company has sought a share of 15-20 basis points (bps) of the interchange fee on each credit card transaction, while

some major issuers have pushed for a lower 10 bps. One basis point equals 0.01 per cent. Interchange is the fee paid by a merchant's bank to the card-issuing bank for processing a card payment, and forms part of the merchant discount rate paid by merchants for accepting digital payments. The fee sought by Apple would not be charged to customers or merchants but would be borne by banks out of their own earnings from card transactions. Credit card usage may rise Payments companies expect the launch to spur credit card transactions in the country.

HYDERABAD'S TRUMP TOWERS IN KOKAPET TO BE VAASTU-COMPLIANT



Hyderabad: The upcoming Trump Towers Hyderabad project will be fully vastu-compliant, said its developers, Ira Realty and Tribeca Developers, on Tuesday, August 11. Designed around Vaastu principles, the new luxury Trump housing in Hyderabad marks the brand's South India debut. The project on Golden Mile Road in Kokapet involves a total of Rs 2,000 crore investment, including land costs. The formal launch is expected to take place in October. "The first project in South India is different because the apartments had to be Vaastu-compliant. It took us about a year to get it right," said Kalpesh Mehta, founder of Tribeca Developers. Tribeca had first brought the US President's Trump brand to India in 2014. Standing 240 metres high, the upcoming project in Hyderabad will be the tallest residential complex in South India, according to Tribeca Developers.

By comparison, the country's tallest Trump tower is a 78-storey building in Mumbai. The Hyderabad project covers 22 lakh square feet and features two 65-storey towers linked by a skybridge. Housing 450 apartments—including 16 penthouses—each residence offers unblocked views. In November 2024, the Trump Organization announced plans to expand further with six new projects across Hyderabad, Bengaluru, Noida, and Pune. This will make India the only country outside the US with such a significant Trump real estate presence. Kalpesh Mehta said the company will invest between Rs 1,700 crore and Rs 1,800 crore in the project, excluding land costs. The land is valued at around Rs 250 crore at current market rates. The developers expect sales realisation of Rs 3,500 crore to Rs 4,200 crore, with apartment prices starting at Rs 5 crore.

Govt okays introduction of 1 billion polymer Rs 10, 20 banknotes

New Delhi: The government has approved the introduction of one billion polymer banknotes of Rs 10 and Rs 20 each for field trials, Parliament was informed on Tuesday, August 11. The Reserve Bank of India (RBI), with the recommendation of its central board, had sent a proposal to the government in terms of Section 25 of the Reserve Bank of India Act, 1934, for introduction of one billion pieces each of Rs 10 and Rs 20 polymer banknotes for field trials and for regular issuance of polymer banknotes in these two denominations after successful completion of field trials, Finance Minister said in a written reply to the Rajya Sabha. "The government has approved the proposal. As per the RBI, these polymer banknotes are proposed to be issued along with paper substrate-based banknotes," she said. The RBI has informed us that the procurement process is presently at an initial stage, she said. Therefore, she said that, at this point, it would not be practicable to determine the exact timeframe for the introduction of polymer banknotes or the expenditure likely to be incurred thereon.



Steady decline in average retail inflation. Replying to another question, Sitharaman said the average retail inflation, measured by the Consumer Price Index (CPI), has declined steadily from 5.4 per cent in 2023-24 to 4.6 per cent in 2024-25 and further to 2.1 per cent in 2025-26. Owing to the commodity price shock and elevated global energy prices stemming from the West Asia crisis, a seasonal pickup in vegetable prices, and the expected unfavourable El Niño conditions, retail inflation rose to 3.9 per cent in

Q1 of 2026-27, she said. However, she said, it is still below the Reserve Bank of India's inflation target of 4 per cent. "The 56th meeting of the Goods and Services Tax (GST) Council has brought in a two-rate structure with a standard rate of 18 per cent, a merit rate of 5 per cent and a special de-merit rate of 40 per cent for a select few goods and services (but inclusive of earlier compensation cess rate, and hence with no increase in overall tax burden)," she said. This resulted in rationalisation of rates on many goods and services

from 28 per cent to 18 per cent, 18 per cent to 12 or 5 per cent, and from 12 per cent to 5 per cent/nil. Govt took several measures to boost manufacturing and support consumption. In addition, she said, with a view to reduce input costs, boosting domestic manufacturing, promoting export competitiveness and supporting strategic sectors, the government announced in Union Budget 2026-27, rationalisation of Basic Customs Duty (BCD) on a host of goods with effect from February 2, 2026. Additional measures to contain price pressures in essential commodities include a reduction in BCD on crude palm oil, crude soybean oil, and crude sunflower oil; a reduction in the agriculture infrastructure and development cess on masur; and a reduction in central excise duty on petrol and diesel by Rs 10 per litre in March 2026, she said. In addition to the reforms in indirect taxes, the government has increased individuals' disposable income by exempting annual incomes up to Rs 12 lakh (Rs 12.75 lakh for salaried individuals, after the standard deduction) from income tax.

OUSTED SYRIAN DICTATOR BASHAR AL-ASSAD SENTENCED TO DEATH IN ABSENTIA



A Syrian court has sentenced ousted dictator Bashar al-Assad to death in absentia, after convicting him of committing war crimes and crimes against humanity during the country's civil war. It is the first conviction against Assad, who fled from Damascus to the Russian capital, Moscow, with his family after his regime was overthrown in December 2024, ending his family's five-decade grip on power. Assad's cousin and the former head of political security in southern Syria's Deraa province, Atef Najib, was also sentenced to death. He appeared wearing a striped prison uniform inside a cage in the courtroom as the judge read out his sentence. Deraa is widely seen as the birthplace of the uprising against Assad's rule. In March 2011, the detention and alleged torture of a group of teenagers accused of writing anti-government graffiti sparked protests in the city, which were met with a violent crackdown by security forces. That response helped ignite nationwide demonstrations

that escalated into civil war in which hundreds of thousands of people were killed. Syria's interim government began trying officials associated with the Assad regime, which ruled the country for more than 50 years, earlier this year. Najib is one of the highest-ranking officials to be put on trial. He was convicted of crimes including murder, "the intentional killing of children under 15" and "torture leading to death". The court also sentenced six former military and security officials in absentia to death, including Bashar al-Assad's younger brother, Maher. He ran the army's elite Fourth Division and also fled to Moscow when the regime fell. The others convicted include former defence minister Fahd al-Frej. Outside the courthouse after the ruling, hundreds of people of all ages gathered holding pictures of their loved ones who were killed by the regime. Crowds were clapping and chanting, while cars drove by excitedly honking their horns. A group of men passed out flags.

Trump hid in catering truck in secret plane swap over Iran threat, reports say

Donald Trump secretly swapped planes as he left a Nato summit in Turkey last month, as part of an elaborate ruse in response to a possible Iranian threat, US media report. The US president boarded Air Force One in view of television cameras before being transported to a military aircraft with the help of a catering truck, the Washington Post said. Journalists and some White House staff on board did not know he had been smuggled out. Officials told the BBC's US partner CBS News that the US had detected a credible Iranian threat to fire a missile at the plane. The White House has not confirmed the secret switch. Trump had earlier said he was Iran's "number one target" during the sum-



mit in Ankara. The clandestine manoeuvre came a day after the US renewed military strikes on Iran following a breakdown of negotiations between Washington and Tehran to end the war. Trump had arrived in Turkey aboard a newer Boeing 747-8 donated by Qatar, but announced that he would leave on the old Air Force One "for old

time's sake". On 8 July, footage showed him boarding the presidential jet at Ankara airport. But according to the Washington Post, he was then secretly taken to a smaller C-32A military aircraft - a modified Boeing 757 often used by the vice-president - via a catering truck which had been elevated to plane level on the opposite side to where he

had boarded. Defence Secretary Pete Hegseth boarded the C-32A separately using external stairs in an effort to make the flight appear normal, according to the newspaper. Journalists and some White House staff boarded Air Force One and were reportedly told to close their window shades. They were unaware the president was no longer on board. A pool producer who was on the plane said one unusual moment on the flight was the request that members of the press keep the shades down. A photographer briefly opened one and was quickly told to close it and that it was a request from the Secret Service, which guards the president.

Luigi Mangione back in court as key questions remain over case ahead of murder trial



Luigi Mangione, the man accused of gunning down UnitedHealthcare chief executive Brian Thompson, is back in court in New York ahead of his murder trial, which begins next month. A judge on Tuesday could hash out more ground rules for the trial and other aspects of the case, which has attracted national attention. It has also created an online frenzy, with both his backers - many of whom see Mangione as a symbol of the backlash against US healthcare costs - and his critics analysing everything from his intentions to his appearance. The case is likely to become an even bigger spectacle when jury selection for the trial begins on 8 September. Mangione, if found guilty, could face decades behind bars. He has pleaded not guilty to all charges, including second-degree murder and weapons-related offences. Much of what is expected at the state trial - the prosecutor's case, Mangione's defence, and obstacles both parties face - were previewed in months of court filings and arguments, but some questions remain unanswered. Will the prosecution win battle over evidence? One of the most crucial elements of the Mangione case was decided earlier this summer, after a multi-day hearing in December where the judge weighed which evidence prosecutors could present during trial. Mangione's team mounted an aggressive bid to exclude evidence recovered from his Pennsylvania arrest. It alleged that state police improperly seized and searched Mangione's possessions, and did not properly advise him of his constitutional rights before questioning him. The defence succeeded in excluding some items - a gun magazine, cell phone, passport, wallet and computer chip, found in Mangione's backpack. But Judge Gregory Carro allowed at trial a gun and notebook with Mangione's purported writings, viewed as vital to the prosecution. Prosecutors have unveiled surveillance footage showing the moment Thompson was shot from behind by a hooded individual. They also used footage to piece together Mangione's alleged movements after the shooting, and ballistics and fingerprint evidence they claim bolsters their case. What might Mangione's defence look like? As trial approaches, Mangione's team has yet to unveil its full strategy. So far, his lawyers have not offered a robust alternative theory to the one prosecutors have put forth. "We do not have, like in 'The Fugitive', the idea of the one-armed man who's the real killer," said former federal prosecutor Mitchell Epner, referencing a 1993 thriller about a man wrongly convicted of killing his wife. Earlier this summer, Mangione's lawyers proposed, then quickly withdrew, an "extreme emotional disturbance" argument.

Australia PM under fire for remarks on Japanese counterpart's melon gifts

Australia's Prime Minister Anthony Albanese is under fire for comments he made about two melons gifted to him by his Japanese counterpart Sanae Takaichi, after a former Japanese envoy called it an insult. During an appearance on the Bush Deep podcast, Albanese gestured near his chest while referring to the crown melons, calling them "pretty strange" gifts that "ended up being quite good". That episode, which aired in July, had already landed the PM in hot water because of "inappropriate" comments he made about popstar Kylie Minogue. Opposition leaders are now demanding he apologise to Takaichi, but Albanese's position is that it was the host who made the joke, not him, the BBC understands. While discussing the melons Takaichi's team had presented to Albanese during her visit to Australia in May, the host of Bush Deep, comedian Nikki Osborne, quipped: "She brought two... She just came in looking like Pamela



Anderson." "She brought two, and they are beautiful," Albanese responded. The exchange, which drew relatively little interest when the episode aired, has resurfaced after Tokyo's former ambassador to Canberra Shingo Yamagami labelled Albanese's comments a "sexist joke" and said they "betrayed the close bond" between Japan and Australia. "The last thing [Takaichi] expected was to be so casually mocked by the trusted leader of Japan's special strategic partner," he wrote in an opinion piece published by The Australian

on Monday. Crown melons are the "most prized fruit" in Japan and "treasured as something special", Yamagami added, noting that a single melon costs more than 30,000 yen (\$188). "So, prime minister, please enjoy Japan's sweet and juicy melons without thinking about a woman's anatomy, and instead focus on what our two countries must do together," he said. During his two-year stint in Australia, Yamagami had a notably frosty relationship with some members of Albanese's Labor Party over disagreements regarding

China. An opposition MP asked Albanese on Tuesday if he would apologise for the "foul-mouthed, classless comments about women", to which the prime minister said he "rejected the assertion of the question". He went on: "Australia and Japan have never been closer. My government has taken our special strategic partnership to new heights." Australia's opposition leader Angus Taylor on Monday also criticised the gaffe as "insulting", and demanded that Albanese make a personal apology. Several Labor ministers have jumped to Albanese's defence, saying the former envoy and the media have misinterpreted his comments. Finance Minister Katy Gallagher said the remarks "were not intended to be interpreted the way that our political opponents and some media outlets are reporting". Social Services Minister Tanya Plibersek called it "a completely unnecessary interpretation of what the prime minister said".

CANADA FLIGHT CANCELLED AFTER CHILD REFUSES TO WEAR SEAT BELT



The cancellation of a flight in Canada after a child refused to wear a seat belt has reignited a debate about the etiquette and safety procedures relating to children travelling on planes. The Porter Airlines flight, which was preparing to depart from Victoria to Toronto on 6 August had to return to the terminal as a "young child was standing in their seat and would not secure their seat belt", the airline said. The delay meant the flight could not depart before the runway closed after midnight so passengers had to be rebooked on a flight the following day. The incident has split opinion

about how children should be treated in such situations and how airlines should respond. Regarding the child's behaviour, Porter Airlines said "attempts by the accompanying parent and crew to address this were unsuccessful". "The aircraft could not take off in this unsafe condition, so the crew elected to return to the terminal and have the two passengers disembark," it added. Child aviation safety expert Lia Tuso told the BBC the Porter crew were protecting the safety of the passengers on the flight with their decision to stop the flight, as well as the child.

THAILAND SUSPENDS NEW GUN PERMITS AFTER MASS SHOOTING

Thailand's government will immediately stop issuing gun permits after a shooting incident last week in which a 14-year-old killed eight people and himself. Existing gun owners are already banned from carrying their weapons in public. The South East Asian country has one of the highest rates of civilian gun ownership in the region, with around 10.3 million firearms in civilian possession, and high levels of gun crime. In response to the recent shooting, the prime minister has promised to speed up tough new gun control laws with severe penalties. Last Friday, a pupil at Debsirin Nonthaburi School outside Bangkok shot his grandparents using a handgun owned by his grandfather, before opening fire at teachers and students at school, authorities say. Both



grandparents, five staff members at the school and one 12-year-old girl died. Police believe the shooter may have taught himself to use a gun via social media. They say there is evidence that the boy watched violent content online, and that he showed a strong interest in learning how to handle guns. His consumption of this

content as well as anxiety over studies and family issues might have also fuelled his actions, they add. From now on, no new permits to purchase or own guns will be issued and existing permits will not be renewed. Permits to carry guns were suspended in late 2023. Gun owners must keep their weapons at home or

at a shooting range. The government is also considering measures to persuade the owners of an estimated four million unlicensed guns to hand them in. Furthermore, the education minister has proposed screening at the entrance of schools to stop students from bringing in weapons.

IPL Player Abishek Porel Arrested In Rape And Criminal Intimidation Case

Abishek Porel, who plays for Delhi Capitals in the Indian Premier League (IPL), was arrested in connection to a criminal case registered on the complaint of a medical student alleging rape, criminal intimidation, and other serious offences. The Bengal cricketer was arrested by the police from Emami City under the Dum Dum police station, according to Hooghly Rural police SP Kunwar Bhushan Singh. Earlier in June, the victim lodged a police complaint alleging that he engaged in a sexual relationship under the false promise of marriage and subjected her to assault and criminal intimidation. The Calcutta High Court later directed the police to arrest the cricketer in connection to the case. Porel, who has in the past travelled with the India A team to the UK and Australia, denied all allegations in the past. According to the complaint, the woman alleged that she and Porel had been in a relationship for



the past three years and that differences surfaced last year, after which the cricketer allegedly started "distancing" himself from her. She further alleged that Porel had promised to marry her but is now unwilling to do so. "Abishek Porel illegally confined the complainant. He denied her food and deliberately kept her isolated. As a result... the complainant became physically weak and was unable to walk properly. Despite having a flight... she was compelled to seek immediate medical attention due to the injuries sustained," the FIR against Porel read. In her

complaint, the woman alleged that Porel had sexual intercourse with her under the promise of marriage and also accused him of assault and criminal intimidation. "We have received a complaint and started an investigation," a police official told PTI. A left-handed top-order batter, Porel has represented Delhi Capitals in the Indian Premier League since 2023. Donald Trump Warns FIFA Over Consequences OF REPLACING GIANNI INFANTINO

=Amid the growing pressure on Gianni Infantino, US President Donald Trump has come out in support of the under-fire FIFA chief, warning that world football's governing body would be making a "terrible mistake" if it decided to remove him from office. Trump's intervention, posted on his Truth Social platform, comes as pressure mounts on Infantino from major regional confederations following a controversial private investment proposal. The endorsement arrives at a delicate moment for Infantino, who faces an unprecedented backlash from football federations all across the globe over his now withdrawn proposal to sell stakes in the FIFA World Cup and Club World Cup. FIFA had publicly announced its proposal to sell shares of the World Cup to investors through a subsidiary com-



pany instantly valued at USD 20 billion. Infantino's plan, first revealed in media leaks and put forth without consulting member associations, was immediately met with heavy backlash from several confederations and high-er-ups in the soccer world, all claiming the sport's most prestigious affair

should not be "for sale." Though the proposal is now withdrawn, continental bodies in the sport have rallied against Infantino, seeking his removal as FIFA president. However, Trump feels it would be a big mistake if Infantino is removed from office. In fact, he said the World Cup would never be as profitable as it was

this year under Infantino if the Swiss administrator is forced to leave. In his post on Truth Social, Trump wrote: "FIFA would be making a terrible mistake if, for any reason, they even considered replacing President Gianni Infantino. He is fantastic, having just presided over the most successful World Cup ever presented,

four times. If he is gone, it will never be as successful or profitable again! Thank you for your attention to this matter. President DJT" Trump and Infantino have become close over several years, a relationship that itself invited backlash and controversy all summer long at the 2026 World Cup across North America. Trump's support came just days after he claimed to have no prior knowledge of Infantino's plan to sell World Cup shares. It was a surprise response given not only the pair's closeness, but also that Thrive Eternal, a venture capital firm founded and managed by Joshua Kushner, the brother of Trump's son-in-law, was pegged to "lead the proposed investor group." It was also reported at the time that the Trump administration had been consulted about the project.

With this win on Monday, Afghanistan is 2-0 up in the five-match series. The first match was abandoned without a ball bowled. In the previous ODI World Cup in 2023, Afghanistan were promising, finishing sixth in the points table with four wins and five losses, narrowly short of contention for a semifinal spot. With wins over defending champions England and former champions Sri Lanka, and Pakistan, they still had a tournament to be proud of. Afghanistan won the toss and elected to field first. Half of the Irish side was back in the hut for 89 runs in the 22nd over. Gavin Hoey (36 in 67 balls, with two fours)



and Jai Moondra (31 in 33 balls, with five fours) put up 76-runs for the ninth wicket. Afghanistan skittled out Ireland for 206 runs in 46.3 overs. Allah Ghazanfar (3/29) and Rashid (3/44) were exceptional with the ball for Afghanistan. During the run-chase, openers Rahmanullah Gurbaz and Ibrahim Zadran (12) put on a 53-run opening stand. Gurbaz kept one end steady, but he was the fifth wicket down for 71 in 77 balls,

with two fours and five sixes at a score of 149. From there, Afghanistan sank to 176/7 in the 36th over and were in a tricky situation. Rashid played a useful knock of 37* in 43 balls, with four boundaries, putting on a 31-run stand with Yamin Ahmadzai (4*) to take Afghanistan to a win in the 45th over with three wickets in hand. Rashid won the 'Player of the Match' award for his match-winning performance.

Sachin, Kohli, Rohit Contacted Retiring Ajinkya Rahane. He Told Them The Same Thing

Ajinkya Rahane ends his cricketing career as one of the stalwarts of the national team, a man whom the team banked upon in red-ball cricket, especially in overseas tours. Rahane's ability to deal with swinging deliveries on pace-friendly pitches gave him a rare skill that not many Indians have mastered. However, as the veteran batter announced his decision to quit all forms of the game, the first call he received was from the great Sachin Tendulkar. Later, messages from the likes of Virat Kohli, Rohit Sharma and Jasprit Bumrah also buzzed his phone. Speaking to the Indian Express, Rahane revealed that Tendulkar was the first one to call him, soon after he posted the retirement video on social media. The Master Blaster was quick to point out his disappointment, say-

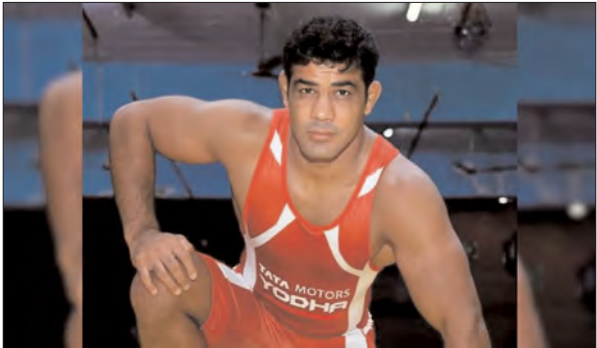

Irfan Pathan was another former player who called Rahane while current superstars - Kohli, Rohit and Bumrah - sent him text messages. "The first call came from Sachin (Tendulkar) paaji, who said he thought I would play for longer. I told him I didn't want to drag on because I was retiring without any regrets. Irfan Pathan also

called, while Pujara, Virat, Rohit and Bumrah all messaged me. I told everyone the same thing: I was satisfied because I had given everything to the game," Rahane told the paper. Be it on call or via messages, Rahane's response to everyone was the same, that he was at peace with the decision. The 38-year-old admitted that he became quite emotional after recording the retirement video. "After recording the video, I cried a lot.

Wrestler Sushil Kumar, In Jail Since 2021, Denied Bail Over Chhatrasal Stadium Murder Case

The Delhi High Court has refused to grant bail to Olympian Sushil Kumar in the alleged murder case of former junior national wrestling champion Sagar Dhankar. Justice Purushendra Kumar dismissed the celebrated wrestler's bail application on August 6, citing concerns over influencing witnesses raised by the Supreme Court when it cancelled his earlier bail, his conduct prior to arrest, the gravity of the offence and his capacity to influence the ongoing trial's outcome. The judge emphasised that while bail is ordinarily the rule and jail the exception, the offence in the present case was a "premeditated and gruesome assault resulting in death", which is corroborated by recovery of a firearm, video evidence and a large body of material yet to be tested at trial. Seeking relief, the counsel for the accused alleged that the deceased's



father, whose complaint led to the earlier cancellation of bail, has not supported the prosecution's case in the trial. It was therefore contended that the "change in circumstances", along with the fact that Kumar had been in custody for over five years and only formal

and official witnesses were left to be examined, entitled him to regular bail.

Iga Swiatek Dominates Shnaider To Set Up Toronto Semis Date With Svitolina



Former world number one Iga Swiatek cruised into the Toronto Masters semi-finals on Monday to set up a clash with Elina Svitolina who fought back from a set down to reach the last four. Poland's Swiatek, a six-time Grand Slam champion, took just 64 minutes to sweep past Russia's Diana Shnaider 6-2, 6-1. Ukraine's Svitolina, the ninth seed, beat Russia's Ekaterina Alexandrova 3-6, 6-0, 6-3. Swiatek reached just her second WTA semi-final this year after Rome and is seeking her first final appearance since winning the Korea Open almost a year ago in Seoul. "From the beginning I went for it. I felt like I could dominate," Swiatek said after dropping just three points on her first serve. "I was quite happy with the way I played. It was a tricky match with the wind. "I thought I needed to adjust to that. I just wanted to be more solid," added the 25-year-old world number eight. Svitolina won eight

consecutive games after losing the first set on the way to dispatching Alexandrova in 93 minutes. Swiatek leads Svitolina 4-3 in their WTA career rivalry, but lost both their meetings this year. "I'm gonna talk with my team to adjust a little bit for Iga's game," said Svitolina. "Of course she's a great champion. She plays really well this tournament. I have to bring my best." Swiatek established a 5-2 lead in the first set when she broke Shnaider a second time, courtesy of the Russian netting a backhand, and served out to take it in 31 minutes. The Pole broke for a 2-1 lead in the second when Shnaider netted. A forehand winner gave Swiatek a 4-1 lead and a third break sealed victory. Svitolina had more of a battle after sending a backhand long on serve to drop an evenly matched first set. It fired up the Ukrainian who reeled off four breaks to blank Alexandrova in the second set and take a 2-0 lead in the third.

LIONEL MESSI TAKES INDEFINITE BREAK FROM FOOTBALL

Argentine icon Lionel Messi has reportedly suspended his football career indefinitely following the death of his father, Jorge Messi. Jorge Messi, 68, died at a clinic in Rosario after a prolonged illness, leaving the Argentine football icon facing a deeply personal loss. His father had played a significant role throughout Messi's career, making his passing a particularly devastating blow for the legendary forward. According to French website Foot Mercato, as per Goal.com, reports in the Argentine press cited that the

eight-time Ballon d'Or winner has stepped away from his professional commitments to be with his loved ones during this difficult period. Messi has not set a date for his return to Inter Miami, underscoring the extent to which football has taken a back seat as he focuses on his family. Jorge Messi was not just Lionel Messi's father but also played an important role in shaping his football career. After Lionel Messi's football career took off, Jorge became his son's agent and strategic adviser after working for years as a supervisor at a steel

factory. Jorge was also closely involved in Lionel's early career at Newell's Old Boys. When Messi was 13, he helped facilitate his move to Spain to join Barcelona's youth academy. The Catalan club also covered the cost of his treatment for a growth hormone deficiency, a condition that affected his physical development. Messi underwent daily injections as part of the treatment, which helped him reach a final height of 1.70 metres. Jorge was married to Celia Cuccitini and had four children: Lionel, Rodrigo, Matias and Maria Sol. The interrup-

tion to Messi's season comes just as he was regaining top physical form. He had recently returned to action with a two-goal performance against Atltico San Luis in the Leagues Cup, but all sporting priorities have now been put on hold. Messi's absence halts what has been an exceptionally productive stint in North American football. Since joining Inter Miami in 2023, he has logged 92 goals in 107 matches across Major League Soccer, Concacaf tournaments, the Leagues Cup, and domestic cup play. Those figures represent an average of 0.86 goals

per match and a strike rate of one goal every 96.2 minutes since his arrival in MLS. On a broader historical level, Messi's total career tally stands at 921 goals, leaving him 79 short of the 1,000-goal milestone. For now, those career statistics remain secondary. Messi remains with his family in Rosario, with his return to Miami and subsequent availability for selection dependent entirely on his personal readiness to resume play.

Raju I know doesn’t make films relying only on horror elements. There are many more layers to his films.” Those words show how well he understands me. As he said, Aghadha is not merely about horror or frightening ele-

ments. It has several different aspects. I have portrayed an evil force that works against God in Aghadha.

Tell us about the research you did for ‘Aghadha’.

– I did extensive research for Aghadha and travelled to many places. But the audience doesn’t need to know all of that. I made the film to entertain everyone rather than turning it into an art film. I combined the reality I observed with my imagination to create a good cinematic experience. During the making of Devi, I faced several financial difficulties. Yet, I felt that some kind of power kept pushing me forward. Even during the journey of Aghadha, I felt as though a similar force was guiding me. I wanted to make a film

about an evil force in a way that would appeal to the current generation, and that is how Aghadha came about.

I wanted the film to appeal not just to single-screen audiences but also to multiplex viewers. I have made this film with complete sincerity.

You suddenly stopped producing films. Why

– Aata and Maska were good films, and I achieved commercial success with them. However, many people told me that they did not meet the standards I had set for myself. After that, I also focused on my son’s career. After several years, I made Dirty Hari, which was completely different from my usual taste.

Throughout my journey, I have always chosen to say yes to new stories.
