JAGAN ACCUSES NAIDU OF VENDETTA POLITICS, VOWS TO FIGHT 'FALSE CASES'

Hyderabad, Aug 2: YSR Congress Party president Y.S. Jagan Mohan Reddy on Sunday accused Andhra Pradesh Chief Minister N. Chandrababu Naidu of pursuing "politics of vendetta" and "authoritarian governance", asserting that his party would continue to resist what he described as the misuse of police and criminal cases against political opponents. Reiterating his demand for the resignation of Education Minister Nara Lokesh over the alleged irregularities in the District Selection Committee (DSC)-2025 teacher recruitment process, Jagan claimed the government was avoiding accountability by targeting opposition leaders. In a post on X, the former Chief Minister told Chandrababu Naidu that political power, police authority and false criminal cases were temporary, and maintained that the YSR Congress Party would continue to stand with victims, challenge injustice and oppose what he termed authoritarian rule. "You may be able to arrest individuals, but you cannot break the courage that resides in the hearts of the people, nor can you silence the questions they continue to ask," he said.

TERRORIST ARRESTED WITH ARMS IN JOINT OPERATION IN J&K'S BARAMULLA

Srinagar, Aug 2: A terrorist was arrested along with arms and ammunition during a joint security operation in the Fathagadh area of Sheeri in north Kashmir's Baramulla district on Saturday, officials said. The operation was carried out jointly by the Indian Army's 46 Rashtriya Rifles, the Jammu and Kashmir Police, and the 53 Battalion of the Central Reserve Police Force (CRPF). According to officials, security personnel apprehended one terrorist during the operation and recovered arms and ammunition from his possession. The identity of the arrested terrorist and details of the weapons seized are yet to be disclosed. An official statement is expected later. The arrest comes days after two migrant labourers were killed in a terrorist attack at a brick kiln in the Kelam area of south Kashmir's Kulgam district. The victims, Deepak Ratray and Bopinder, both in their 20s, were shot dead on Friday evening. The Resistance Front (TRF), a group considered a proxy of the Pakistan-backed Lashkar-e-Taiba (LeT), claimed responsibility for the attack and reportedly issued threats of further attacks targeting outsiders and Jammu and Kashmir Police personnel.

PM Modi launches 100-week 'Nasha Mukta Yuva' campaign to build a drug-free India

New Delhi (TSIT):

Prime Minister Narendra Modi on Saturday launched the 'Nasha Mukta Yuva for Viksit Bharat Sankalp Abhiyan', a nationwide 100-week public participation campaign aimed at creating a drug-free India by encouraging youth to stay away from substance abuse and become agents of positive social change. Launching the campaign through video conferencing, the Prime Minister said the initiative was not merely a movement for individuals but for families, society and the nation as a whole.

"The campaign we are witnessing today is for the individual, the family and society; above all, it is for the nation," Modi said, adding that a developed India could only be built with a healthy, confident and



drug-free younger generation. The Prime Minister recalled that the initiative was first introduced as a pilot project in Kashi last year and has now evolved into a nationwide mission. He said the campaign combines scientific awareness with spiritual values and has received the support of more than 125 spiritual organisations working towards a drug-free society.

Modi stressed that the fight against substance

abuse cannot be won through individual efforts alone and called for collective participation. He noted that lakhs of young people across the country had already pledged to stay away from drugs and spread awareness in schools, colleges and communities.

As part of the campaign, awareness programmes will be organised every Sunday over the next 100 weeks. Activities will include sports events, walkathons, meditation sessions, cultural programmes, street plays, discussions, art competitions and community outreach initiatives to encourage public participation.

Union Minister Mansukh Mandaviya, who also addressed the event, said healthy citizens are essential for building a developed nation.

TN to withdraw cases against students involved in NEET protests



Chennai (TSIT):

The Tamil Nadu government will withdraw all cases registered against students who participated in protests against the National Eligibility-cum-Entrance Test (NEET), School Education Minister Rajmohan announced on Sunday. The decision was taken on the directions of Chief Minister C. Joseph Vijay and is expected to benefit students booked by the police during demonstrations held across the state against the medical entrance examination.

In a post on X, Rajmohan said the government has

decided to withdraw all cases registered against students in connection with anti-NEET protests.

Further details regarding the withdrawal process and the cases covered by the decision would be announced shortly, he added. The announcement comes days after widespread protests over NEET were held in several parts of the country, with students and youth organisations raising concerns over the examination system and demanding changes. Tamil Nadu also witnessed a series of demonstrations, including rallies, flash protests and other forms of agitation. Various student organisations and political groups organised demonstrations at several locations in the state. In Chennai, protesters staged a continuous agitation at Balan Illam, the State headquarters of the Communist Party of India (CPI). Flash protests were also reported from some parts of the state.

Rahul urges Congress workers to aid Kerala rain victims

Congress leader and Leader of the Opposition in the Lok Sabha Rahul Gandhi on Sunday expressed deep sorrow over the loss of lives and widespread devastation caused by heavy rains across Kerala, extending his condolences to the bereaved families and urging Congress workers and volunteers to actively assist ongoing relief and rehabilitation efforts.

In a post on social media platform X, Gandhi said he was "deeply saddened" by the destruction caused by incessant rainfall in the state, which has claimed at least eight lives and left several people missing. "Deeply saddened by the devastation caused by heavy rains across Kerala. My heartfelt condolences to the families of the eight people who have lost



their lives. May those still missing be found safe, and the injured make a swift recovery," Gandhi said.

The Congress leader said the Kerala government was making every possible effort to support affected families and coordinate relief and recovery operations in the rain-hit areas.

"The state government is making every possible effort to support affected families and coordinate relief and recovery operations. I urge all Congress workers and volunteers to assist these efforts in

every possible way," he said.

Appealing to people to exercise caution, particularly in vulnerable areas, Gandhi urged residents to remain vigilant and follow the directions issued by the authorities. "Please remain vigilant, especially in the hilly regions, and follow the guidance of the authorities," he said.

Reaffirming his solidarity with those affected by the disaster, Gandhi said, "Kerala stands united in this difficult hour. I stand firmly with every affected family." Kerala has been witnessing heavy rainfall over the past several days, triggering landslides, flooding and widespread disruption in several districts. Rescue and relief operations are underway as state agencies continue efforts to assist affected residents and restore normalcy.

Ujh project revived after 100 years, phased rollout planned: Jitendra Singh

union Minister Dr Jitendra Singh on Sunday reviewed the status and phased implementation roadmap of the Ujh Multipurpose Project (UPP) in Jammu and Kashmir's Kathua district, which has been revived after nearly 100 years. The Minister held a detailed meeting with officials of WAPCOS Ltd and the Ministry of Jal Shakti, which has been entrusted with implementing the project.

Dr Singh emphasised the need for expeditious implementation so that the benefits of the strategically important project reach the people at the earliest.

He advised WAPCOS to explore innovative solutions and implementation strategies while maintaining the highest standards of quality, safety and efficiency. The Minister was informed that the project would be implemented in phases. Work will commence while acquisition of the remaining land is pursued simultaneously, without waiting for completion of the entire land acquisition process.

The implementing agency is also working out the project site and related requirements. Under the leadership of Prime Minister Narendra Modi, Dr Singh said, long-pending national projects are being taken forward with renewed urgency.

He noted that the Ujh Multipurpose Project, conceived nearly a century ago, had remained in limbo for decades, while the Shahpurkandi project had remained pending for about four decades.



The delay in implementation of these projects, he said, resulted in the waters of the Ravi River and its tributaries continuing to flow into Pakistan.

The Minister said that even when the Indus Waters Treaty was in force, Ravi, Satluj and Beas were India's three rivers under the Treaty, with Ravi being the major river among them. He noted that the Treaty is now in abeyance. Dr Jitendra Singh said that the revival of the Shahpurkandi project in 2019, which is now almost complete, and the revival of the Ujh Multipurpose Project in 2026 reflect the Government's resolve under Prime Minister Narendra Modi to realise long-delayed projects, optimise the use of India's water resources and deliver tangible benefits to the people.

The Ujh Multipurpose Project, located on the Ujh River, a main tributary of the Ravi River, is designed to generate around 186 MW to 212 MW of electricity. It is expected to provide irrigation to nearly 90,000 hectares of agricultural land in Kathua and Samba districts of Jammu and Kashmir and Pathankot and Gurdaspur districts of Punjab. The project will also supply drinking water to Kathua district and provide industrial water availability.

Monsoon fury: Assam flood toll rises to 82; six dead in Kerala, Odisha flood alert intensifies

New Delhi (TSIT):

The southwest monsoon continued to wreak havoc across Assam, Kerala and Odisha on Saturday, claiming more lives, displacing thousands and affecting lakhs of people as flood and rain-related emergencies persisted in several regions.

In Assam, the flood-related death toll rose to 82, while nearly 1.93 lakh people remain affected despite water levels receding in some areas, according to the Assam State Disaster Management Authority (ASDMA). Relief and rehabilitation operations are continuing in the worst-hit districts.

Kerala reported six rain-related deaths, with six others still

missing, the Chief Minister's Office (CMO) said. Search and rescue operations are underway with the assistance of multiple agencies, elected representatives and local residents.

The state has opened 65 relief camps sheltering 1,465 people. Officials said 17 houses have been completely destroyed, while 127 others have suffered partial damage due to heavy rainfall.

Although rainfall has eased in some areas, rescue operations continue. Anakkampoyil in Kozhikode recorded 340 mm of rainfall over 35 hours, while Meppadi in Wayanad received 177 mm during the same period.

Meanwhile, Odisha remains on high alert as floods affected more than 8.34 lakh people across



20 districts. Floodwaters from the swollen Mahanadi and the overflowing Salandi, Brahmani, Baitarani, Jalaka and Budhabalang rivers have inundated low-lying areas, damaged

infrastructure and submerged large tracts of agricultural land.

More than 1,300 houses have been damaged, with Bhadrak emerging as the worst-affected district, followed by Jajpur,

Balasore and Mayurbhanj.

Authorities have placed 10 districts downstream of the Mahanadi under high alert as the Hirakud Dam continues releasing excess water through 22 gates. The districts include Angul, Boudh, Sambalpur, Subarnapur, Nayagarh, Cuttack, Puri, Khurda, Jagatsinghpur and Kendrapada, with special focus on the vulnerable Mahanadi delta region.

Officials said the water level at the Hirakud reservoir stood at 625.47 feet against its full reservoir level of 630 feet. With inflows touching around 4.15 lakh cusecs, the reservoir level is expected to rise further, although discharge at the Mundali barrage near Cuttack has declined.

Komatireddy Unveils Roadmap for Model Municipal Corporation

Hyderabad TSIT: Roads & Buildings and Cinematography Minister Komatireddy Venkat Reddy on Sunday said the Telangana Government is committed to transforming the Municipal Corporation into one of the state's best urban local bodies through massive investments in civic infrastructure and public welfare.



Speaking after distributing Kalyana Lakshmi and Shaadi Mubarak assistance worth 64.07 lakh to 64 beneficiaries, the Minister said the government is implementing major infrastructure works, including CC roads, underground drainage and 24x7 drinking water supply across the town. He said Chief Minister A. Revanth Reddy recently laid the foundation stone for

an 83-crore Water Treatment Plant and subsequently sanctioned an additional 300 crore to strengthen the town's drinking water network. Komatireddy expressed confidence that the Municipal Corporation would be eligible to attract nearly 1,000 crore in Central funds for future urban development projects.

Highlighting welfare measures, the Minister said eligible families are receiving ration cards, fine rice and housing benefits, while 700 Indiramma houses have already been sanctioned. He urged eligible beneficiaries with house sites to apply for housing assistance and reiterated the government's commitment to women's empowerment through interest-free loans.

MLC Shankar Naik said the State Government's welfare programmes, including free bus travel for women, Indiramma housing and fine rice distribution, were improving the lives of thousands of families. He also appreciated the ongoing efforts to upgrade roads, drainage and drinking water facilities.

Earlier, the Minister inspected the progress of the Sai Nagar major drain works and reviewed the implementation of AMRUT 2.0 projects with Public Health Department officials, directing them to complete the works at the earliest. District Collector B. Chandrasekhar, In-charge Additional Collector Prem Karan Reddy, Deputy Mayor Ameer Ali and other public representatives and officials accompanied the Minister.

All-Party Panel Seeks MRO Office in Flood-Safe Kotha Rajoli

Jogulamba gadwal TSIT. An all-party committee from Kotha Rajoli village in Alampur Constituency of Jogulamba Gadwal district has urged the Telangana Government to construct the proposed Rajoli Mandal Tahsildar (MRO) office in flood-safe Kotha Rajoli instead of the old Rajoli vil-

Mandal MRO office. The committee appealed to the government to utilise the funds for constructing the office in Kotha Rajoli, which was developed as a rehabilitation village after the devastating floods of October 2009. The committee recalled that the unprecedented floods of October 2,



lage, citing public safety, protection of government records and the long-term interests of thousands of residents.

A delegation of the Kotha Rajoli All-Party Committee met Telangana Rajyadhikara Party (TRP) Jogulamba Gadwal District President Morugu Veeresh on Saturday and submitted a memorandum seeking his support for their demand. The committee explained the historical background of the village, the devastation caused by the 2009 Tungabhadra floods, and the need to establish all major government offices in the rehabilitated Kotha Rajoli village.

According to the memorandum, the State Government has sanctioned 2.25 crore for the construction of the Rajoli

2009, completely submerged the old Rajoli village, forcing thousands of families to take shelter in nearby villages such as Tandrapadu, Thummilla and Mulladinne. Recognising the magnitude of the disaster, the then government developed Kotha Rajoli over nearly 250 acres and rehabilitated around 3,700 displaced families by providing permanent housing.

The memorandum stated that the floods destroyed valuable government records, including Panchayat documents, school records and land-related files. Even today, residents continue to face hardships in obtaining educational certificates, land records and other official documents because of the loss of records during the floods.

Amarachinta si.Swati Jurala with special emphasis

Comprehensive Review of Government School Closures Needed to Ensure Quality Education for the Poor

Expressing serious concern over the significant decline in the number of government schools in the country over the past decade, Telangana Rajyadhikara Party Jogulamba Gadwal District President Morugu Veeresh issued a press state-



ment on Sunday. He stated that the findings of the recently released NITI Aayog report titled "School Education System - Periodic Analysis and Policy Framework for Quality Improvement" clearly highlight the challenges being faced by the country's education system. According to the report, the number of government schools across the country declined from 11.07 lakh in 2014-15 to 10.13 lakh in 2024-25, indicating that nearly 94,000 government schools have been closed.

ed cost of 10 crore to provide multiple services to visiting NRIs under one roof. The proposed facility will function as a coordination and facilitation centre for the overseas Telugu community.

Praising the Telugu diaspora for its achievements in education, technology, business and entrepreneurship, the

Minister said NRIs have continued to preserve Telugu language, culture and traditions while making valuable contributions to the development of Telangana and their native villages. He also appreciated the American Telugu Association (ATA) for its long-standing efforts to unite Telugu people in

the United States and preserve their cultural heritage.

Jupally Krishna Rao appealed to people to make greater use of government educational and healthcare institutions and advised families to avoid extravagant spending on weddings and other social functions, encouraging them instead to spend according to their means and develop a culture of savings.

Expressing concern over the growing menace of youth addiction, the Minister announced that the Telangana Government would soon launch "Prabhata Bheri," a statewide public awareness campaign to combat social evils and promote responsible social behaviour. He invited NRIs to actively support and participate in the initiative.

Khammam-Devarapalli Greenfield Highway opened to traffic

Khammam (TSIT): The long-awaited Khammam-Devarapalli Greenfield Highway has been opened to traffic, providing a major boost to road connectivity between Telangana and Andhra Pradesh. The access-controlled corridor, developed under the Bharatmala Economic Corridor programme, became operational after completion of construction.

Agriculture minister Tummala Nageswara Rao travelled on the newly opened highway to inspect the road after authorities permitted traffic from August 1. He said the project, pursued over several years, had finally become a reality. Constructed at a cost of Rs.3,573 crore, the 165-km highway begins at Tallampadu in Khammam district and connects to NH-16 near Devarapalli,



close to Rajamahendravaram. The corridor comprises 90 km in Telangana and 75 km in Andhra Pradesh. Officials said the new highway would considerably reduce travel time and distance between Hyderabad, Rajamahendravaram and Visakhapatnam by eliminating the need to travel via Vijayawada. The route is expected to save around 56 km for most travellers and nearly 100 km for

those travelling from Suryapet.

The access-controlled highway features designated entry and exit points, a closed tolling system based on distance travelled, AI-enabled traffic enforcement, CCTV surveillance, solar lighting and emergency openings. Wayside facilities, including fuel stations, restaurants and washrooms, have also been established at regular intervals.

BJP alleges criminal elements infiltrated Delhi student protests

Hyderabad, Aug 2 : Telangana BJP chief official spokesperson and Media In-charge N V Subhash on Sunday alleged that around 3,000 people with criminal backgrounds participated in the recent student protests in Delhi, claiming that genuine students were outnumbered by those with criminal antecedents.Addressing a press conference at the BJP state office here, Subhash, citing a Delhi Police report, alleged that the protesters included 101 persons involved in murder cases, 62 in attempt-to-murder cases, 60 in rape cases and 2,089 accused in dacoity and robbery cases.He claimed that criminal elements had hijacked the student agitation with the support of certain political parties to create unrest and defame the NDA government led by Prime Minister Narendra Modi. Over 800 booked for drunken driving in Hyderabad, Cyberabad weekend crackdown

Hyderabad (TSIT) Hyderabad and Cyberabad Traffic Police booked a total of 818 motorists for drunken driving during special enforcement drives conducted over the weekend, reiterating a zero-tolerance policy against the offence. According to separate press releases issued on Sunday, Hyderabad Traffic Police booked 485 motorists during a two-day drive conducted on July 31 and August 1. Those caught included 381 two-wheeler riders, 45 three-wheeler drivers and 59 four-wheeler drivers.

Most offenders registered Blood Alcohol Concentration (BAC) levels between 51 and 100 mg/100 ml, while eight motorists recorded BAC levels above 300 mg/100 ml. Meanwhile, Cyberabad Traffic Police apprehended 333 offenders, including 269 two-wheeler riders, 11 three-wheeler drivers, 51 four-wheeler drivers and two heavy vehicle drivers. Of them, 21 motorists recorded BAC levels between 301 and 550 mg/100 ml. All offenders will be produced before the court. The Cyberabad Police

warned that anyone causing a fatal accident while driving under the influence of alcohol would be booked under Section 105 of the Bharatiya Nyaya Sanhita, 2023 (Culpable Homicide Not Amounting to Murder), which carries a maximum punishment of 10 years' imprisonment along with a fine. Police also said that during the last week (July 27 to August 1), courts disposed of 232 drunken driving cases, awarding fine and jail in three cases, fine and social service in six cases, and fine only in the remaining 223 cases.

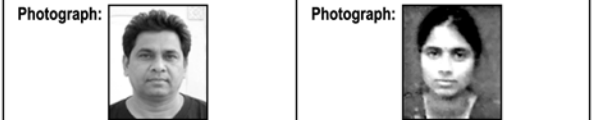

AP Government Launches Quality Rice at Rs.52 Per Kg to Provide Relief to Consumers

The Minister said the government reviewed the market situation after reports indicated that rice prices had increased by nearly Rs.10 per kg over the past month. In coordination with the Andhra Pradesh Rice Millers Association, the Civil Supplies Department introduced the subsidised sale of quality rice to ensure affordability for consumers.

South Coast Railway GM Sandeep Mathur Conducts Extensive Inspections Across New Railway Zone

Visakhapatnam (TSIT) South Coast Railway (SCoR) General Manager Sandeep Mathur has completed extensive inspections covering nearly 3,500 kilometres across the newly formed South Coast Railway Zone, reviewing railway safety, infrastructure, passenger amenities, and the progress of key development works. During the inspection tour, the General Manager visited the Ichchapuram-Visakhapatnam, Vijayawada-Gudur- Renigunta, Tirupati-Guntakal, Visakhapatnam-Rajahmendravaram, Nandyal-Guntur, and Guntur-Madhira railway

sections. He inspected 35 major railway stations, yards, running rooms, crew lobbies, signalling and telecommunication systems, track maintenance works, construction projects, and 23 Amrit Bharat Station Scheme projects.

Mathur also interacted with railway employees, local officials, and public representatives to understand regional requirements and gather feedback on passenger services and infrastructure



development. Giving top priority to railway safety, he reviewed the condition of railway tracks, level crossings, signalling systems, monsoon preparedness, and maintenance standards. He also assessed the progress of major infrastructure projects, including third-line construction, station redevelopment, yard remodelling, rail-over-rail (ROR) works, and other capacity enhancement projects.

At the New Coach Care Centre in Visakhapatnam, the General Manager inspected coach maintenance facilities and fire safety arrangements. He also held an interaction with women employees to understand their concerns and workplace requirements. In view of the forthcoming Godavari Pushkaralu, Mathur reviewed passenger management plans and special arrangements at Rajamahendravaram, Godavari, and Kovvur railway stations. He directed officials to ensure close coordination with the State Government for crowd management, operation of special

trains, and seamless passenger services during the pilgrimage.

The General Manager also reviewed the progress of road overbridges (ROBs), road underbridges (RUBs), expansion of infrastructure at the Visakhapatnam Railway Complex, and the commissioning of Amrit Bharat stations. Stressing that safety remains the highest priority, he instructed officials to complete all ongoing development works within the stipulated timelines while ensuring improved passenger amenities and operational efficiency across the South Coast Railway Zone.

'Others have mothers too': Raj Thackeray urges PM to rein in BJP's troll culture

Mumbai, Aug 2 Maharashtra Navnirman Sena (MNS) chief Raj Thackeray on Saturday said that while the abusive language used against Prime Minister Narendra Modi during the recent Jantar Mantar protest was unacceptable, the Prime Minister should also advise leaders and supporters of his own party to refrain from using similar rhetoric. Addressing the 20th anniversary programme of the Maharashtra Navnirman Vidyarthi Sena (MNVS) in Mumbai, Thackeray said he fully agreed that no individual should be subjected to objectionable language, but argued that the same standards must apply across the political spectrum."The language used against Prime Minister Narendra Modi during the protest at Jantar Mantar was inappropriate. We agree with that. I 100 per cent agree that such low-level language should not be used against anyone. I only want to tell the Prime Minister - please convey this to the people in your party as well," he said. The response follows a video shared by Prime Minister Modi on Instagram on Friday night, in which he raised objections to the offensive language used against him and his mother at Jantar Mantar. In the video, PM Modi stated that he forgives the youths involved and appealed that no legal action be taken against them. Critiquing the political culture over the past decade, the MNS chief accused the BJP of fostering aggressive online trolling. "Look at the language your team of trolls uses against everyone from Mahatma Gandhi, Jawaharlal Nehru, and Indira Gandhi to us. Many artists in Maharashtra are afraid to speak up. Teams have been set up in every state - tell them too not to abuse people," Thackeray said. He further added, "This culture of trolling started over the last 12 years."

Lucknow to host BRICS NSO meet from Aug 3, focus on quality statistics and data innovation

New Delhi, Aug 2: India will host the Meeting of Heads of National Statistical Offices (NSOs) of BRICS countries in Lucknow, Uttar Pradesh, from August 3 to 4 under its BRICS Chairship 2026, with discussions set to focus on strengthening statistical cooperation, innovation and data quality.

According to an official statement, the meeting will bring together representatives from Brazil, Russia, China, South Africa, Egypt, Ethiopia, Indonesia, Iran and the United Arab Emirates (UAE). The initiative is part of India's BRICS Chairship, which is guided by the theme, "Building for Resilience, Innovation, Cooperation and Sustainability (BRICS)." Under the BRICS Statistics Track, India has adopted the theme "Quality Statistics as Driver of Change," highlighting its commitment to improving data quality, fostering innovation, ensuring effective



dissemination and building people-centric statistical systems capable of meeting the growing demand for high-frequency, granular and reliable official data for evidence-based, sustainable and inclusive development.

The statement said robust statistical systems have become central to policy-

making within BRICS by enabling governments to monitor development, formulate policies and strengthen cooperation. Since 2010, BRICS nations have jointly published the Joint Statistical Publication (JSP), while the Snapshot BRICS JSP, introduced in 2020, provides harmonised and easily accessible statistical data. Over

the years, cooperation has expanded beyond data compilation to include harmonisation of standards, innovation and improved statistical practices for policy-makers, researchers and the public.

As part of the annual BRICS Statistics Track, two key meetings are held every year, including a technical meeting of NSOs and the meeting of heads of NSOs. The technical meeting for 2026 was held on April 16-17 to finalise the framework for the Joint Statistical Publication and Snapshot BRICS JSP 2026, allocate responsibilities among member countries and establish timelines for contributions.

The BRICS Statistics Track seeks to strengthen core statistical publications, promote reforms and innovation in national statistical systems, improve data dissemination and accessibility, and enhance macroeconomic and sectoral statistics across member nations.

DFCCIL Sets Historic Freight Record in July



Visakhapatnam (TSIT) The Dedicated Freight Corridor Corporation of India Limited (DFCCIL) has achieved a historic milestone by recording its highest-ever monthly freight performance in July 2026, registering 10,544 million Net Tonne Kilometres (NTKMs). The achievement represents a 20 per cent increase over the corresponding period in July 2025, reflecting the growing efficiency and capacity of India's dedicated freight rail network. According to DFCCIL, the record performance highlights the crucial role of the Dedicated Freight Corridor in meeting the country's rising freight transportation demands. Modern infrastructure, advanced signalling systems, efficient train opera-

tions, and enhanced network management have significantly improved freight movement across the corridor.

The dedicated freight network has reduced transit time, improved asset utilisation, and increased the reliability of rail-based cargo transportation. The improved logistics performance has benefited industries, manufacturing units, agricultural supply chains, ports, and logistics service providers by ensuring faster and more dependable freight movement. Enhanced punctuality has also strengthened domestic trade and supported India's import-export operations.

DFCCIL stated that the outstanding performance achieved in July reflects the organisation's opera-

tional excellence, expanding freight-handling capacity, adoption of advanced technology, and efficient management practices. The corporation reiterated its commitment to reducing logistics costs, accelerating freight transportation, and providing world-class rail freight services to industries across the country. The organisation further emphasised that it remains focused on developing world-class freight infrastructure and promoting environmentally sustainable rail transport to strengthen India's logistics ecosystem. DFCCIL said it would continue to enhance freight capacity and play a vital role in supporting the country's economic growth in the years ahead.

CBI files Rs 1,816 crore EPFO investment fraud case against Reliance Capital

New Delhi, Aug 2 The Central Bureau of Investigation (CBI) on Saturday said it has registered an FIR against Reliance Capital Limited in Mumbai, its former Chairman Anil Ambani, unknown public servants and other unknown persons, for allegedly causing a wrongful loss of Rs 1,007.55 crore, along with an interest liability of Rs 808.67 crore, by committing offences including criminal conspiracy, cheating, criminal breach of trust and criminal misconduct. The FIR was registered on the basis of a written complaint received from the Employees' Provident Fund Organisation (EPFO), Ministry of Labour and Employment. According to the agency, it is alleged in the com-

plaint that, during 2013 and 2014, Reliance Capital Limited (RCL) issued secured Non-Convertible Debentures (NCDs), in which the EPFO invested Rs 2,500 crore through four portfolio managers including Reliance Capital Asset Management Limited. The NCDs were due to mature during 2023 and 2024. It is further alleged that the accused persons indulged in fraudulent transactions and diversion of funds, resulting in the default in redemption of the NCDs by Reliance Capital Limited and causing a total alleged loss of Rs 1,816.22 crore to the EPFO. "Investigation has been taken up to identify the role of all persons involved, including public ser-

vants and private individuals, examine the alleged criminal conspiracy, and trace the end use of the invested funds," according to the investigative agency. The CBI statement further said that it may also be recalled that it has earlier registered seven FIRs against Reliance Communications Limited (RCOM), Reliance Home Finance Limited (RHFL), Reliance Commercial Finance Limited (RCFL) and Reliance Telecom Limited (RTL) on the basis of complaints received from various Public Sector Banks and LIC. The CBI has so far filed four chargesheets and arrested seven accused persons in the Reliance ADA Group cases.



TN CM Vijay defers Bengaluru visit, Karnataka seeks postponement of talks

Chennai, Aug 2 Tamil Nadu Chief Minister, C. Joseph Vijay, has decided to defer his proposed visit to Bengaluru on August 3 after Karnataka Chief Minister, D.K. Shivakumar, requested that the meeting be postponed amid heightened political and public tensions over the Cauvery water-sharing dispute.

The proposed visit, which was expected to mark the first direct engagement between the two Chief Ministers on the long-pending Cauvery issue, was put on hold following developments in Karnataka after the Cauvery Water Regulation Committee (CWRC) directed the State to release 3,500 cusecs of water per day to Tamil Nadu for 15 days from July 29. The directive triggered widespread protests in several parts of Karnataka, prompting the State government to seek a postponement of the talks. Before taking a final decision on the visit.

Massive landslide on tracks near Arebetta disrupts Bengaluru-Mangaluru train services

Sakleshpur, Aug 2: Due to continuous heavy rainfall in the Western Ghats region, a massive landslide occurred on Saturday night near Arebetta, between the Yedakumari and Shiribagilu railway stations in the Mysuru railway division.

Following the landslide, huge quantities of soil and massive boulders crashed onto the railway tracks. This has completely disrupted the crucial train services connecting Bengaluru to Mangaluru and other parts of the coastal region.

Prioritizing passenger safety, the South Western Railway (SWR) initially partially cancelled several services, leaving hundreds of passengers stranded at various stations. However, to facilitate passenger movement, the SWR has now announced alternate diversion routes for several major trains for journeys commencing on Sunday, August 2.

Rain hinders clearance operations
Continuous rainfall at the landslide spot is severely hindering operations to clear the soil and boulders from the tracks. Railway staff are engaged in the clearance work with the help of heavy machinery. Meanwhile, the South Western Railway has requested passengers to check the running status of their trains before commencing their journey.

DyCM Dr. G. Parameshwara Chairs Rajya Dharmika Parishad Meeting

Bengaluru : Deputy Chief Minister and Revenue Minister Dr. G. Parameshwara directed officials to purchase land in the name of 'A' and 'B' category temples across the State. He issued the necessary directions after chairing a meeting of the Rajya Dharmika Parishad at Vidhana Soudha today and holding detailed discussions with its members. "Temples have sufficient funds. Along with undertaking development works, land must be purchased in the name of the temples. Such property will remain with the temples permanently and facilitate infrastructure for devotees as well as comprehensive development," he said. Dr. Parameshwara said the Chief Minister had directed that CCTV cameras be installed to monitor temple donation boxes and prevent the misuse of offerings. "This work must be completed by the end of August. It should not be taken lightly," he said.



Pulling up officials over the lack of basic amenities at several prominent temples in the State, he said, "When I visit and inspect some temples, I am left wondering which era we are living in. No one is taking responsibility and working. How can the sanctity of temples be maintained under such circumstances?" He said there was no shortage of funds to provide basic facilities to devotees at temples and added that officials had been directed to prepare master plans. "There should be no negligence in this regard," he warned. Dr. Parameshwara said 'C' category temples should not be handed over to any organisation for adoption in the name of development. "Those who adopt temples in the name of development may later claim rights over temple properties. Therefore, 10% of the grants of 'A' category temples must be utilised for development works at 'C' category temples," he said. He said strict instructions had already been issued to clear encroachments on temple lands. "Encroached temple properties must be surveyed on a priority basis, cleared and handed over to

the Muzrai Department. The process must be completed within three months," he directed. Additional Chief Secretary to the Revenue Department Rajendra Kumar Kataria. As the academic year had begun, Dr. Parameshwara also directed officials to invite applications for scholarships for the children of priests and employees working in notified temples. Additional Chief Secretary to the Revenue Department Rajendra Kumar Kataria; Muzrai Commissioner Sharath; Rajya Dharmika Parishad members K.M. Nagaraju, Dr. A. Radhakrishna Raju, Dwarakanath, Mallika Prashanth Pakkala and Ravishankar Shetty; and others were present.

Pilot Implementation of the Enforced Easy Flow Corridor (EEFC) by the East City Corporation to Ensure Smooth Traffic Flow

Bengaluru: With the objective of reducing traffic congestion, ensuring smoother vehicular movement and enhancing road safety within the Bengaluru East City Corporation limits, BECC has successfully implemented the Enforced Easy Flow Corridor (EEFC) concept on a pilot basis at the Kaggadasapura Railway Crossing and Kaggadasapura Main Road, said Additional Commissioner Lokhande Snehal Sudhakar.

The project is an innovative traffic management model that enables smooth movement of vehicles by optimally utilizing the existing road infrastructure without undertaking major civil construction works. Under the EEFC



concept, traffic patterns at major junctions are scientifically studied, congestion-causing factors are identified, and quick, location-specific engineering interventions are implemented to improve traffic flow.

The EEFC pilot project has been implemented around the Kaggadasapura Railway Crossing, covering approximately 175 metres of roadway in three directions:
• Around 50 metres from the railway crossing towards

Kaggadasapura Main Road.
• Around 50 metres on the road towards Vignan Nagar.
• Around 75 metres on the road towards Mahadevapura.
A detailed assessment of vehicle movement in the area was carried out to identify critical congestion points, following which the traffic circulation pattern was redesigned accordingly. The barricades are interconnected through a push-pull chain system, enabling efficient traffic regulation. Special traffic signboards have also been installed at the entry points of the corridor. Additional traffic chains have been provided to the Traffic Police to regulate traffic efficiently during peak hours.

Basavaraj Bommai Urges State Government to Safeguard Farmers' Interests in Cauvery Water Dispute

Bengaluru: "Good rainfall in the Cauvery basin is nature's temporary relief to the water scarcity. However, this is only a temporary respite and not a permanent solution. The state government must present proper arguments in the Supreme Court based on comprehensive data available with it. Otherwise, if a harsh order comes from the court, the state government will face trouble again," warned former Chief Minister and MP Basavaraj Bommai.
Speaking to the media following an all-party meeting on the Cauvery river water distribution led by Chief Minister D.K. Shivakumar, he stated, "Recent heavy rainfall in Wayanad, Kodagu, Chikkamagaluru, and Sakleshpur regions has provided temporary relief from

nature for the Cauvery water crisis." However, he added, "The state government cannot afford to remain complacent. Ensuring drinking water for the state throughout the year and supplying water for farmers' agriculture remains a major challenge."
Present Strong Arguments in the Supreme Court
of the Cauvery Water Regulation Committee (CWRC) are held every 15 days, and the Cauvery Water Management Authority (CWMA) meets monthly, requiring water releases based on distress-sharing formulas. "Since DMK has already filed a petition in the Supreme Court and the hearing is scheduled for coming Monday, the state government must present valid arguments backed by solid data. Failing to do so could result in a severe



court order, putting the government in distress once again," he urged.

Not an Achievement of the Government
Bommai expressed strong

objection to the government portraying the reduction of water release from 9,500 cusecs to 3,000 cusecs as a major achievement. "If water had been released to farmers, canals, and lakes, it could have been called an achievement. Boasting about an achievement without releasing a single drop of water from the KRS dam to our farmers is unacceptable," he criticized.
Demand for Proper Compensation to Farmers
Despite the government advising against sowing due to water shortage for both Kharif and Rabi crops, farmers have completed nearly 70% of the sowing. Bommai questioned, "After asking them not to engage in agricultural activities, what compensation is the government providing to offset the loss of their entire year's

livelihood?"
He further urged the government to act cautiously so that drinking water and agricultural water supplies to Bengaluru, Mandya, and Mysuru regions remain unaffected during the upcoming summer months of January and February, when water scarcity and orders to release water are likely to recur. Support for Mekedatu Project
"They have suggested that we should all work together on the Mekedatu project, to which we have given our principle approval. We have consistently extended our support on various matters in the larger interest of the state. However, we have issued a stern warning to this government regarding the welfare of farmers and drinking water for the general public. Water management must

be handled properly; otherwise, the people of this region will not forgive you," Bommai stated firmly.
Do Not Release Water from KRS
In response to a query about the advice offered to the government, he said, "This is only a temporary relief, and the government should not sit idle assuming the problem is solved. They must continuously monitor the situation and ensure that the state's interests regarding drinking water and crops are protected—that should be the top priority. Let the excess water flow out on its own. Now that inflows into KRS have increased, no water should be released from there until it reaches full capacity. Instead, release water to our farmers, canals, lakes, and for drinking purposes."

Those silent on Cauvery & Mekedatu are real traitors, Dayanidhi hits back at Rahul

CHENNAI: DMK leader and Central Chennai MP Dayanidhi Maran on Sunday called those remaining silent on Tamil Nadu's Cauvery rights and the Mekedatu issue the real betrayers, in an apparent retort to Leader of the Opposition in the Lok Sabha Rahul Gandhi, who had called anyone supporting the BJP's proposed delimitation bill "Ettappans" (traitors).

Dayanidhi Maran didn't name anyone in his statement, but it contained enough keywords to link it to the recent State visit of Rahul and his 'Ettappans' remark, made yesterday during an interaction with the media in Chennai, as the DMK parliamentarian also dragged NEET into it. Rahul's press meet was held after an interaction with medical aspirants in Mahabalipuram. Those who spoke only about alleged irregularities in NEET without demanding the examination's

Tamil Nadu: Despair-hit farmers burn silkworms

CHENNAI: Hit by the despair of suffering heavy losses due to poor-quality silkworm eggs and weak larvae, which severely affected cocoon production, sericulture farmers in Dindigul district have resorted to the extreme step of burning silkworms that failed to spin cocoons.

Mulberry cultivation and silkworm rearing are key sources of livelihood for farmers in Palani, Ayakudi, Kanakkampatti, Sathirapatti, Thalaiyuthu, Thoppampatti, and Shanarpatti. Despite facing climatic challenges in recent years, farmers have continued cocoon production in the hope of sustaining their income.

Jibe at NDA, but more could join: TNCC president Manickam Tagore

This season, however, farmers said substandard eggs and underdeveloped young silkworms have resulted in poor cocoon formation, leading to a sharp decline in production and mounting financial losses, said a Daily Thanthi report.

In Kanakkampatti near Palani, a farmer was forced to dump silk-



worms that failed to produce cocoons after suffering significant production losses. Similar incidents have been reported from other cocoon-producing areas, where farmers have either discarded the worms or burned them as they could no longer be reared.

Farmers said the current setback is largely due to the poor quality of silkworm eggs and larvae rather than prevailing sum-

mer temperatures.They have urged officials of the central and State Sericulture Departments to inspect the affected farms, identify the reasons behind the failure of the worms to develop properly, and provide technical assistance to prevent further losses.

They have also appealed to the authorities to revise the existing insurance scheme to provide better protection against production failures and financial distress.

Meat-based low-carb diet may not aid in weight loss

Chennai Hot on the heels of a deadly Covid-19 pandemic, the recent pneumonia outbreak reported in China is a concern for the rest of the world as our interconnected world still poses risks, said experts on Thursday, while calling on the need for preparing for the worst. A recent post on ProMED Mail, the online reporting system of the International Society for Infectious Diseases, reported that China was experiencing a major pneumonia outbreak with no known cause in children.It said that the outbreak, causing symptoms such as high fever, and some developing pulmonary nodules is overwhelming paediatric hospitals in the country.

Upon request, Chinese officials informed the World Health Organisation (WHO) that no new pathogens were detected in the outbreak, and instead the illnesses were caused by known seasonal viruses such as the flu and RSV, along with the bacteria Mycoplasma pneumoniae.

Netherlands and Denmark have also reported a similar uptick in pneumonia cases among children. While there is currently no report of a spread, it may be too early to say whether it can spread, said health experts calling for

increasing surveillance.

"While the risk of the new China flu threatening India is currently low, the potential for spillover remains. Implementing proactive preventive measures and strengthening public health infrastructure are crucial to safeguard India's health security," Dr Tushar Tayal, Consultant, Internal Medicine, CK Birla Hospital, Gurugram, told IANS."In the wake of the pneumonia outbreak in China, vigilance becomes our greatest shield. Although, there is no imminent threat to India, given our robust preparedness. Drawing from our past encounters with novel viruses, our readiness is evident. The lessons learned have fortified our capabilities to effectively address potential challenges posed by emerging infectious agents. However, our interconnected world still poses risks, and in such a case awareness and precautions are potent tools," added Dr Nidhin Mohan, Consultant, Internal Medicine, Narayana Health City, Bengaluru.

A new paper in the Lancet journal shows a significant resurgence of Mycoplasma pneumonia cases post Covid in several countries including Singapore and Sweden since April.

AI can reliably detect emotions at par with psychotherapist

AI systems can reliably determine the emotional states of patients as accurately as a psychotherapist, according to research. The face reflects a person's emotional state. The interpretation of facial expressions as part of psychotherapy or psychotherapeutic research, for example, is an effective way of characterising how a person is feeling in that particular moment. But the process of analysing and interpreting recorded facial expressions as part of research projects or psychotherapy is extremely time-consuming, which is why psychiatry specialists often use less reliable, indirect methods such as skin conductance measurements, which can also be a measure of emotional arousal.

Researchers at the University of Basel in Switzerland said AI could become an important tool in therapy and research. AI systems could be used in the analysis of existing video recordings from research studies in order to detect emotionally relevant moments in a conversation more easily and more directly. This ability could also help support the supervision of psychotherapists, they noted in



the study published in the journal Psychopathology.To determine whether AI systems can reliably determine the emotional states of patients in video

recordings, they used freely available artificial neural networks that were trained in the detection of six basic emotions (happiness, surprise, anger, disgust,

sadness and fear) using more than 30,000 facial photos.This AI system then analysed video data from therapy sessions with a total of 23 patients with borderline personality pathology. The high-performance computer had to process more than 950 hours of video recordings for this study. The results were astonishing: Statistical comparisons between the analysis of three trained therapists and the AI system showed a remarkable level of agreement, the researchers said.

The AI system assessed facial expressions as reliably as a human but was also able to detect even the most fleeting of emotions within the millisecond range, such as a brief smile or expression of disgust. These types of micro expressions have the potential to be missed by therapists or may only be perceived subconsciously. The AI system is therefore able to measure fleeting emotions with an increased level of sensitivity compared to trained therapists. "We were really surprised to find that relatively simple AI systems can allocate facial expressions to their emotional states so reliably," said Dr. Martin Steppan, psychologist at the University's Faculty of Psychology.

Eat your breakfast, dinner early to reduce heart attack risk

London: Are you one of those people who skip their first meal of the day or eat a late breakfast and dinner? Beware, you may be at risk of heart attack, warns a study. The study suggested eating the first meal of the day at 8 a.m. and dinner by 8 p.m. to avoid risk of cardiovascular disease. Cardiovascular diseases are the leading cause of death in the world according to the Global Burden of Disease study, with 18.6 million annual deaths in 2019, of which around 7.9 are attributable to diet. This means that diet plays a major role in the development and progression of these diseases.

The study by French research institute INRAE - National Research Institute for Agriculture, Food and Environment showed that having a first meal later in the day (such as when skipping breakfast), is associated with a higher risk of cardiovascular disease, with a 6 per cent increase in risk per hour delay. For example, a per-



son who eats for the first time at 9 a.m. is 6 per cent more likely to develop cardiovascular disease than someone who eats at 8 a.m.

When it comes to the last meal of the day, eating late (after 9 p.m.) is associated with a 28 per cent increase in the risk of cerebrovas-

cular disease such as stroke compared with eating before 8 p.m., particularly in women.Finally, a longer duration of night-time fasting -- the time between the last meal of the day and the first meal of the following day -- is associated with a reduced risk of cerebrovascular disease, supporting the idea of eating one's first and last meals earlier in the day. For the study, published in Nature Communications, the scientists used data from 103,389 participants to study the associations between food intake patterns and cardiovascular disease. The findings, which need to be replicated in other cohorts and through additional scientific studies with different designs, highlight a potential role for meal timing in preventing cardiovascular disease. The team suggest that adopting the habit of eating earlier first and last meals with a longer period of night-time fasting could help to prevent the risk of cardiovascular disease.

*To Those Who
Stood When I Did
Not, I am Sorry*

Some debts cannot be repaid with money. Some debts cannot even be repaid with apologies. They remain, quietly gathering weight over the years, until one day they become too heavy to carry in silence. This is about one such debt. I am a Hindu retired Army officer. For decades I wore the uniform of India, believing that every Indian life was equally worthy of protection, irrespective of religion, caste or language. That belief was not merely professional. It was deeply personal. Yet somewhere after taking off the uniform, I failed to live up to it. Over the last decade, there were many moments when several lakh Indian Muslims stood up in public against what they believed was an assault on constitutional values. Whether every slogan they raised was perfect is beside the point. Whether every political opinion they held was correct is also beside the point. What matters is that they stood. I did not. Neither for the cause, nor for them. That sentence has become increasingly difficult for me to live with. Like many others from the majority community, I watched, I analysed, I discussed. I found reasons to wait. I told myself that someone else would speak. That the institutions of the republic would eventually correct themselves. That perhaps this was not my battle. But silence is not neutral. Silence has benefits. Today, when I look back at Shaheen Bagh, I no longer see merely a protest. I see thousands of fellow citizens, mostly vulnerable womenfolk, standing in the open while people like me remained safely behind closed doors. I often ask myself a painful question. Had lakhs of us stood beside them – not because we agreed with every demand, but because we believed that no Indian community should ever have to defend constitutional liberties alone – would history have unfolded differently? No one can answer that with certainty. But my conscience has already answered it. It tells me that our absence mattered. It tells me that when citizens from the majority community fail to stand beside a vulnerable minority, the minority becomes easier to isolate, easier to caricature and easier to dismiss. That's the difference between the fate of Umar Khalid and Kanhaiya Kumar, Shaheen Bagh and Jantar Mantar. There is no other difference. That thought haunts me. That is not a legal conclusion. It is a moral one. And it is directed not at the State, but at myself. I have often admired courage in uniform. It took me 73 years to realise that another kind of courage is rarer still – the courage to stand beside fellow citizens when they are unpopular, misunderstood or feared. A scene from A Few Good Men haunts me on some nights. When the two young marines were dismissed from service for applying 'Code Red', one of them cried out, 'But we did nothing wrong. We did it under orders.' His senior solemnly reminded him, 'Yes, we did. We were supposed to fight for people who couldn't fight for themselves.' This lesson has nothing to do with being in the army. It has everything to do with the values of a good citizen, particularly a good Hindu. That is the courage I lacked. Many people tell me that one person could not have made a difference. Perhaps. History is not changed by one voice. But history is changed by millions of individuals each deciding that their own voice is too small to matter. I was one of those millions. I regret deeply that..

MODI AND HIS DESIRE TO
CONTROL THE MINDS OF CITIZENS

What's the worth of democracy if it can't protect personal liberties? If the state controls citizen's political consciousness, compelling them to do only what suits the ruler's interests, what's the purpose of individual freedom and rights? Liberty isn't an ornament to embellish the individual; it empowers people to decide their choices, question the government's unconscionable acts and dissent against injustice. British historian Lord Acton whose timeless dictum – power tends to corrupt and absolute power corrupts absolutely – reverberates across the world, also said, "Liberty is not a means to a higher political end; it is itself the highest political end." Liberty bleeds when the police hunt down citizens who participated in protests against Narendra Modi. Reports suggest that the government identified protesters through sophisticated surveillance techniques and started chasing them across cities. Young boys and girls, who wrote placards, shouted slogans and, in some cases, crossed the line by heaping abuses on the prime minister are now treated like the enemy of the state. Their homes have been raided, parents threatened and even FIRs registered against a good few. This happened despite a formal deal between the organisers of the protest and the government that no coercive action would follow. No government can dream of constructing a citizen of its own liking. Citizens are not toys running on batteries gifted by governments. They have a mind and a heart of their own. Politicians win elections with the limited mandate to govern; electoral victory doesn't make them the authorised arbitrator of morality and righteousness. Giving free ration to the poor doesn't mean the government has earned the right to ration their freedoms. People who



think differently, whose vision doesn't align with the philosophy of the incumbent rulers will differ and dissent. A confident nation and a genuine leader allow citizens to freely express themselves. Ideas emerge through this social churning, challenging status quo and triggering political renewal. Modi occasionally pays lip service to democratic ideals and invites citizens to criticise his policies but such a performative flair is meant only to steal some personal legitimacy against the ill-effects of his undemocratic deeds. He revels in sycophancy. If he were truly democratic, he would have faced questions from independent media instead of fooling the world with orchestrated conversations. Even a rickshaw-puller knows the little girls who shouted slogans at Jantar Mantar are hounded by the police as well as the Sangh Parivar goons. If Modi created a constitutional culture in governance, the police

would never indulge in surveillance and persecution of children. True to his character, Modi slipped into the slumber of silence and apathy for several days before waking up to declare that he was willing to forgive and move ahead. The troll army threatening and abusing Modi's opponents He condemned the abusive trait among the younger generation, without acknowledging that the troll army threatening and abusing his opponents and critics on social media functioned under his government's patronage. He follows some of the most abhorrent X handles. The gang that runs the campaign to vilify the Nehru-Gandhi family is dominated by his followers. In achieving this objective, truth becomes irrelevant and propaganda reigns." Isn't it scary to be in a situation where truth becomes irrelevant? Poet Ummeed Fazli warned, "Aasmanon se farishtey jo utaare jayen/ wo bhi iss daur mein sach bolen toe maare jayen (Even if angels are sent down from the skies, they too will be killed if they speak the truth in this era)." Protesters do abuse. The state has force – mild or lethal. They can warn,

threaten, use water cannons, resort to lathicharge and, in exceptional cases of madness, fire pellet guns and AK-47 rifles. Protesters can taunt, scream, cry and abuse. Filthy abuses, at times. That's how they give vent to their frustration and helplessness. It's undesirable. But that's how democracy lives. We have heard contemptuous yells of – F**k Trump – from the high podium of Oscar awards. All kinds of mischievous elements join mass protests. At the Anna Hazare-Arvind Kejriwal protest, pamphlets carrying wildest allegations and abuses against Sonia Gandhi were distributed by some people. A few went so far as to abuse Mahatma Gandhi, declaring that he was solely responsible for all the ills Indian polity was afflicted with. Manmohan Singh government never chased down anybody. Language of revolution is not defined. Even in normal times, people abuse the prime minister and the

chief ministers at parks, petrol pumps, grocery shops and vegetable markets when prices soar savagely. Nothing is recorded; no facial recognition, no witch-hunt. Prime ministers or ministers are not emperors. Nobody expects special immunity from criticism in a democracy. Modi said he is a chowkidar; a servant. Pradhan Sevak, in his own words. Society knows how chowkidars are treated when they are suspected of conniving with thieves. Filthiest abuses rain from all sides. Abuses are undesirable but it's a social reality. Anybody familiar with literature, in any language, knows conversations aren't devoid of profanities. Normal conversations contain expletives. When public opinion turns hostile, language often acquires a tempestuous tenor. In protests, particularly after such sacred means like fast-unto-death fails to draw governmental response, it becomes a weapon to hurt. In case of extreme anger and cynicism, when unbridled youth energy is flowing, criminalizing expletives is uncivil. After all, their primary method and intent of the protest were peaceful. India has suffered outfits which rejected the Tricolour and the Constitution for decades. India saw intellectuals describing freedom as fake and meaningless. India tolerated the assassination of Mahatma Gandhi. India, under Modi, saw a minister in Parliament describe the political contest as a battle between Ram-zaade and Haram-zaade. India, after such a vast and painful experience, should show tolerance for dissent and anger. The state will firmly deal with criminals but the tendency to criminalise dissent has to be opposed. After all, students crossed the line in participation. They didn't fire pellet guns and AK-47. They were not fighting for power.

This is the Bharatiya Janata Party (BJP)-Rashtriya Swayamsevak Sangh (RSS) method at its most refined. Every element performs a distinct function for a distinct audience. In the process, unleashing another cycle of hate, intimidation, and ridicule at the young who protested, delegitimising the protest, while ostensibly posing to appeal for harmony. The disdain for Parliament and democracy is written large in the prime minister's appeal, who refuses to address Parliament and talks on Instagram. No explanation, no remorse, no questions, just patriarchal patronage. No accountability, no acknowledgement of anything gone wrong, just an assessment that propaganda tools have changed, moved on to Instagram. For him, Instagram was the problem, Instagram is the solution! The agitation that sat for over a month at Jantar Mantar, the protests that the Congress youth wing and student organisation carried to scores of cities across two months, was absolutely peaceful. The only day of violence was on the day the police cracked down. Not before that. Not after that. And it is that single



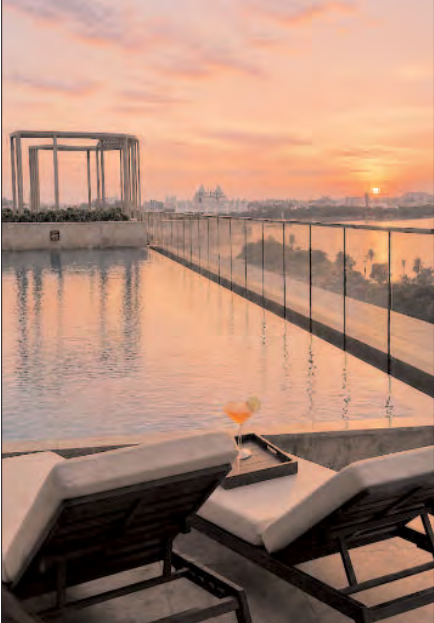
day, that is now being held up as the true face of the protest. A month of restraint is erased; an afternoon of confrontation is promoted to the headline. Regardless of who actually threw the first stone, who was in disguise, and who instructed them, both the government and, curiously, some protestors like Wangchuk reached for the same phrase: national security threat. And that preface is now being used to pit police families against young protestors. BJP is not merely deflecting blame. It may be noted that there is yet no investigation into the indiscriminate use of weapons on protesters. No inquiry into how a stone-laden truck and a van slipped out of police custody and materialised at the protest site, ready-made props for a narrative of citizen savagery. No action against the officers in whose custody those vehicles sat. No questions about who authorised the deployment of pellet guns in Delhi, or the AK 47s in Bihar. The Modi-Shah government is remarkably incurious. It is not at all concerned with any such criminal irregularities. BJP is not merely deflecting blame; it is busy drawing

another hate-filled dividing line in society. Families of police are being pitted against citizens who protested. A new demarcation line is being drawn, where the police community is separated from the rest of society. Police is no more the protector; police is the victim. " A profession is being quietly severed from the public it serves and handed a grievance against it. Notice what this does to the police themselves. An officer's injury in the line of duty was once a matter of professional hazard and, yes, of pride too, the risk a uniform accepts. It is now repackaged as emotional evidence in a political trial, proof of assault by hostile citizens. The pride of sacrifice is being reduced to lament and a call for pity. That is no honour. It is a demotion dressed as a tribute. The state under the BJP has discovered a bold new principle of jurisprudence: that a pellet gun and a slipper are the same weapon, provided the slipper is thrown at the government. That a nail-driven lathi unleashed on a protesting citizen is somehow a lesser violence, while the protester who flinches or fights back is the

aggressor. We are asked to weigh the injury of the man holding the tear-gas gun against the injury of the boy he was aiming it at, and to find them, somehow, morally identical. This is called balance. In every other context it is called changing the subject. Apparently, a narrative is being set by BJP that the difference between the armed and the unarmed is a technicality, which only ungrateful citizens keep raising. The same establishment that could not spare its men and women a name badge or a uniform is now outraged that the crowd failed to recognise them. One does admire the ambition of expecting protestors to identify police men and women in civil clothes. And there is no consternation or objection by aggrieved police families that their men and women in duty were asked to dress up in civil clothes and posted anonymously. This effectively took away the protection of law available to police forces. They were on duty as common individuals. Protection of law is available to police only when he or she is in uniform and with name badge.

Petrol, diesel sales soar on weak monsoon; LPG demand shifts

New Delhi: Petrol and diesel sales by India's three state-run fuel retailers rose sharply in July as below-normal monsoon rainfall boosted fuel demand from farmers and motorists, preliminary industry sales data showed. Petrol sales by Indian Oil Corp (IOC), Bharat Petroleum Corp Ltd (BPCL) and Hindustan Petroleum Corp Ltd (HPCL) climbed 9.7 per cent to 3.45 million tonnes during July, compared with 3.14 million tonnes in the corresponding period a year ago. The volume was also 15.1 per cent higher than 2.99 million tonnes sold during July 2024 and 36.1 per cent above the level recorded in the same period of 2023. Petrol sales fell 1.1 per cent from 3.48 million tonnes. Diesel sales, a key indicator of economic activity in India, rose 10.7 per cent year-on-year to 7.12 million tonnes in July from 6.43 million tonnes a year earlier. Diesel is India's most widely used fuel, powering freight transport,



agricultural machinery and irrigation. Below-normal monsoon rainfall boosted irrigation demand during the peak sowing season. The volume sold in July was 11.5 per cent higher than in the corresponding period of 2024 and 12.7 per cent above the July 2023 consumption. On a month-on-month basis, diesel sales declined 9.2 per cent from 7.85 million tonnes in June. Late arrival of monsoon affects fuel sales. Fuel sales typically moderate with the onset of the mon-

soon, which reduces demand for running agricultural irrigation pumps as well as slows vehicular movement. But this year, the monsoon rains arrived late, which led to farmers using diesel to run pumps to irrigate farms. Month-on-month, sales in July remain lower because in June holiday travel picks up due to school and college holidays. Jet fuel (ATF) sales inched up by 2.9 per cent to 659,900 tonnes during July — volumes that were 2.3 per cent more than the consumption

of 641,300 tonnes in July 2024 and 16.5 per cent more than 566,600 tonnes of July 2023. Month-on-month, the consumption fell 4.6 per cent from 691,700 tonnes of June. LPG sales continue to drop. Liquefied petroleum gas (LPG) sales continued to fall, dropping 17.4 per cent to 2.37 million tonnes. Industry officials said this was largely because some volumes have shifted to piped natural gas since the West Asia crisis. LPG sales have been declining since the onset of the West Asia crisis disrupted supplies, leading to the imposition of consumption restrictions in sectors like hotels and restaurants. The curbs were lifted last month, and sales saw an 8.6 per cent rise to 2.18 million tonnes consumed in June but were lower year-on-year as some industrial and commercial users are now using piped natural gas for their needs, they said. The July LPG consumption was 13.3 per cent lower than 2.73 million tonnes of July 2024 and 1.1 per cent lower than 2.39 million tonnes of July 2023.

FIVE DEAD, 41 MISSING, AFTER
INDONESIA FERRY
CATCHES FIRE



Five people have been found dead and 41 are missing after an Indonesian ferry carrying at least 250 people caught fire while at sea, officials say. The captain of the ship reported the fire - off Madura island - as the vessel sailed from the country's second-largest city, Surabaya in East Java, to Makassar in South Sulawesi, according to Basarnas, the National Search and Rescue Agency. Footage played by local Indonesian news outlet iNews shows large numbers of people in life jackets on what appears to be a lifeboat. Other clips show people climbing down from the ferry that has flames and plumes of smoke coming from the top of the vessel. Basarnas posted a video to its TikTok, with a statement saying at 08:24 (02:24 GMT) the Surabaya Search and Rescue office received information that passenger ship KMP Mutiara Sentosa 2 was on fire. "Based on information from the shipping company, the fire occurred at

around 06:00-07:00 (00:00-01:00 GMT)." Later, Basarnas said it got confirmation the ferry "was almost entirely engulfed in flames" as "passengers held on in the ship's bridge and bow while awaiting rescue". It was unclear how the fire caught, the statement said. In some of the footage, can be seen jumping into the sea, with crowds of people in life jackets gathering and lifebuoys being thrown to some before they are carried into a rescue ship. Authorities later determined the ferry's location, about 19 nautical miles (35km) north of Buruan Sapudi Island, after establishing communication with a nearby cargo vessel. The ship, however, was unable to approach the burning ferry because it was carrying flammable cargo. Footage released by Basarnas of the incident showed thick black smoke billowing from the ferry as passengers wearing life jackets gathered on deck awaiting rescue.

TRUMP CANCELS IRAN STRIKES SUBJECT TO DEAL BEING MADE 'RAPIDLY'

Donald Trump says he has cancelled strikes against Iran, provided a deal is struck "rapidly" with the country. In a post on Truth Social, the US president said he had been asked by Iran and other countries in the Middle East to "hold off" on any attack as the "perimeters" of a deal had been agreed. Trump's comments came after reports that the US and Israel may have been planning new, intense strikes on Iran. It is not the first time that Trump has issued apocalyptic warnings, only to subsequently insist that diplomacy was being given a chance. Iran's semi-official Mehr news agency denied that Tehran had asked the US to hold off on further military action, saying Trump's claims were "nothing but a new lie". Iran's act-



ing Defence Minister Majid Ibn al-Reza said Tehran viewed every threat from its adversaries as "real and credible" even if it formed part of psychological warfare. "We will neither be caught off guard nor remain passive," he added. The raised tones followed reports in the US media that the US and Israel were planning what would be one of the harshest bombing campaigns to date against energy

infrastructure targets in Iran. The plan came up during Trump's cabinet meeting on Friday, sources told CBS News, the BBC's news partner in the US. The US government had also urged Americans across the Middle East to be alert and ready to leave "should there be escalation" in the region. In his post on Saturday, Trump said the US was "locked and loaded and ready to go against the

Islamic Republic of Iran, at levels of Military Terror, Strength, and Power not seen since World War II". He said cancelling the attack would be "for the future benefit of the world and, likewise, the survival of a successful and prosperous Iran". Back on 7 April, the US president warned that "a whole civilisation will die tonight" if Iran refused to engage in peace talks. He threatened to destroy civilian infrastructure and power plants, a move that many said would be a war crime. That threat did result in historic face-to-face talks in Pakistan, led by Vice-President JD Vance. For supporters of the president, it was vindication. Bellicose threats - often referred to as the "Madman Theory" - resulted in talks with the Iranians.

ITALY PUTTING NEARLY ALL MAJOR CITIES ON HIGHEST HEAT ALERT



Italy is putting nearly all of its major cities on the highest "red" alert for high temperatures, as a new heatwave grips the country. Health officials say 19 cities from north to south - including the capital Rome, Milan, Venice and Naples - are already at red alert, and by Monday all but two cities will be. Temperatures hit mid-30s C in many places on Saturday, and authorities are warning of risks to even healthy and active people - not just groups including the elderly, very young children and people with chronic illnesses. The warnings come as several European nations battle devastating wildfires after a succession of heatwaves that have created favourable conditions for blazes. In its latest heatwave bulletin published on Saturday, the Italian health ministry says that by Monday, some 25 of the country's 27 major cities will be on red alert. It says it expects only two - Reggio Calabria in the southern tip of Italy's "boot" and Messina, facing it across on the island of Sicily - to be on the second-highest "amber" alert. The ministry urges residents in the affected areas to avoid exposure to heat and direct sunlight during the hottest hours between 11:00 and 18:00, stay indoors and drink plenty of fluids. The extreme heat is being caused by a subtropical anticyclone from North

Africa that is now strengthening over the Mediterranean. Meanwhile, firefighters in Greece, France, Portugal and Spain are still tackling blazes spanning thousands of hectares. In France, some 2,500 people were evacuated in the south-eastern Var region on Friday evening after a blaze - which had been contained for several days - reignited, local officials said. But a massive fire in the south-western Gironde region is now under control, and some 200,000 local evacuated residents have been able to return to their homes. In Greece, hundreds of people - mostly tourists - have been evacuated by sea from a coastal town of Viotia hemmed in by one of the many wildfires raging across the country. And in Spain, more than 200,000 hectares of land has burnt in 2026 - roughly five times above the average by this point in the year - while the burnt land in Portugal is also higher than usual, EU data shows. Climate change is driving up temperatures around the world, and Europe is the fastest warming continent, heating up twice as fast as the global average, according to the Copernicus Climate Change Service. This is causing increased summer heatwaves, greater pressure on Europe's water supply, and more intense wildfires.

How Spain's migrant crisis created a political storm - whipped up by social media

Most of the tens of thousands of migrants who swam into the Spanish enclave of Ceuta on Thursday have now returned to Morocco, escorted to the border by Spanish soldiers and police. But the extraordinary surge of arrivals has left at least 72 people dead, their bodies pulled from the sea where they floated alongside abandoned rubber rings and flippers. This week's events have also shaken Europe politically, once again exposing divisions over the sensitive issue of migration. And they've left lingering questions about what sparked the sudden influx: whether social media posts promising an easy path to Europe just went viral or this was something more deliberate, even organised. The politics Whatever the cause, Spain's socialist prime minister is angry with the response. Pedro Sanchez has hit out at some in the EU for "attacking" Spain in this crisis, playing politics instead of showing support. He meant Italy, above all. Fratelli d'Italia, the hard-right party of Prime Minister Giorgia



Meloni, had been quick to post images of migrants racing through the streets of Ceuta. "This is the Sanchez model the Italian left wing likes so much," the caption crowed. Meloni then announced she was suspending Italy's Schengen agreement with Spain that allows for the free movement of people, citing a security threat. Madrid is fuming. The way Spain sees it, the crisis has been contained and Ceuta is not in the Schengen zone so Moroccan migrants were never going to head for mainland Europe, unchecked. Meloni knows that. But she faces elections next year with her coalition losing ground to

a new and virulently anti-immigrant party. This was a chance to sound tough herself and claw back votes and she leaped on it. Italy is not the only country to see Spain as soft on migration, though. Meloni's call for an urgent meeting of interior ministers to be held on Tuesday was signed by almost two dozen EU heads of state, calling for the elimination of all policies that could be "pull factors" to Europe. Above all, they mean Spain's controversial move to allow hundreds of thousands of undocumented migrants apply for residence and work permits and "regularise" their status. The government's pragmatic: Spain is

ageing and needs workers. But those who flocked to the beaches of Ceuta this week were not heading to sign up for a campaign that's already closed. Sanchez himself points instead to a recent ruling by Spain's Supreme Court: it said those who enter by sea cannot be pushed back immediately. The prime minister argues that was misrepresented by smugglers to promise an easy path to Europe. The crowd heading for Ceuta didn't need to pay smugglers, though, because most were Moroccan and the route is well known. The message was actually spread online. Migrants have shown social media posts to reporters with people shouting that "Spain is Open" and jumping into the sea. Multiple accounts we've checked ourselves show young people in wetsuits and flippers, or filming themselves already swimming, mixed with pictures from inside Ceuta itself. Some have only been active for weeks. Several have tens of thousands of likes. All their promises were false.

Young guns for hire - the teenage hitmen recruited to kill across Europe



In a Stockholm suburb a man dressed in black appeared out of the winter night. Carrying a handgun, he approached 20-year-old Murad Abdelkader, a student on his way back from a shift at McDonald's. The gunman opened fire, shooting again and again as he approached his target. He fired the last shot into his victim's head as he lay helpless on the ground. The killer was 18-year-old Atilla Azimov. On that February night last year, he had killed the wrong man. He had done it for money - hired by the Foxtrot Network, an

organised crime group with links to the Iranian regime which has become notorious for its violence-as-a-service (VaaS) tactics. Since 2022, the Foxtrot Network is thought to have been responsible for about 35 murders as well as a number of attacks and attempted attacks on Israeli targets in Europe including two involving explosives and hand grenades. The gang recruits teenagers to carry out the attacks for cash, but it almost never has to pay out as they often get caught. Like Johannes Natland, a Norwegian teenager who was convicted of conspiracy to murder by a jury at the Old Bailey in London on Wednesday for a planned killing in West Yorkshire. According to Operational Taskforce (OTF) GRIMM, the Europol group set up to tackle the problem, the teenage hitmen are recruited on social media, and are given their instructions in a "gamified" way, imitating how computer games work.



At least 13 killed in Israeli strikes on Gaza after Hamas agree disarmament deal

Ukraine says major Russian oil refinery and airfield hit, as Moscow reports eight deaths

Ukraine has said it carried out overnight strikes deep inside Russia, hitting a major oil refinery and an airfield that houses Russian strategic aviation. President Volodymyr Zelensky said the Engels airfield and the refinery, both in the Saratov region some 600km (373miles) from Ukraine's border, were hit. An oil depot was also struck in Kaluga region and a drone launch site in Bryansk. Russia said eight people were killed in the Ukrainian strikes, and 635 drones shot down or intercepted. It also reported yet another strike on a warehouse of Russia's biggest online retailer Wildberries. Meanwhile, Moscow said its forces attacked overnight two Ukrainian ports and two vessels in the Black Sea. Later



on Sunday, Ukraine said one person was killed in a Russian strike on a postal terminal near the north-eastern city of Kharkiv. Both Russia and Ukraine have recently intensified attacks focusing on major cities, energy facilities and warehouses, as the vast front line remains virtually static and US-led mediation attempts to

end the war have shown no breakthrough. Russian President Vladimir Putin launched a full-scale invasion of Ukraine in February 2022. In Sunday's post on social media, President Zelensky described the latest Ukrainian strikes as "our long-range sanctions" against Russian facilities that he says finance

Moscow's war. He said the Engels airfield and Saratov oil refinery were "strategic facilities". The Ukrainian military said in a separate statement that its attack triggered a blaze at the airfield - one of the main bases of Russia's strategic aviation. It said Tu-95MC and Tu-160 bombers were regularly using Engels to launch missile strikes against Ukraine. Saratov regional Governor Roman Busargin admitted that "a drone attack caused damage to civilian infrastructure in Saratov and Engels". He later said that two people were killed. Separately, three people were reported killed in a Ukrainian drone attack on a civilian vehicle in Russia's Udmurtia region, and another three in the Belgorod region bordering Ukraine.

25 SIXES, 13 FOURS: ABHISHEK SHARMA SETS INTERNET ON FIRE WITH 233 OFF 91 IN LOCAL MATCH

Abhishek Sharma shone with a stunning knock in a Punjab Inter-District Senior match. He smashed 233 runs off 91 balls with the help of 15 fours and 25 sixes. It had a strike rate of 256.04. The southpaw played the innings for his Amritsar senior team against Tarn Taran. His sensational knock has come at a time when he is going through a lean patch in international cricket. Pictures of the scorecard, as well as Abhishek's batting, are going viral on social media. The ICC's No. 3-ranked T20I batter, who began the year at No. 1, returned from Zimbabwe with 11 runs in three innings at an average of 3.66. That is not an isolated failure. It is the latest chapter in a slump that has stretched for months. Against England, he scored 131 runs in five T20Is at an average of 26.2. Against Ireland, he managed 49 runs in two matches at an aver-



age of 24.5. Across his last 10 T20I innings, there has been just one fifty. More worrying than the runs is the manner of the dismissals. Blessing Muzarabani dismissed him in all three games against Zimbabwe. The first time, Abhishek threw his hands at a wide delivery and sliced a simple catch into the deep. The second time, he poked at a rising ball and chipped it straight to backward point. The third time, he tried to manufacture room against the angle, edged behind and

walked off shaking his head. These were three different shots, but the same mistake. He never looked in control against pace outside off stump. This was Zimbabwe, not Australia or South Africa. If this series was designed as a confidence-builder, it achieved the opposite for Abhishek. Zimbabwe had clearly done their homework. They began with Sikandar Raza's off-spin, the same type of bowling that exposed Abhishek repeatedly during the T20 World Cup.

Judo Heartbreak: Ishroop Narang Misses Out On Bronze Medal At Commonwealth Games 2026



Judoka Ishroop Narang gave her all in the bronze medal play-off but lost to Canadian Coralie Godbout by yuko as India's judo campaign ended at the Commonwealth Games without any medal on the concluding day of the quadrennial event Sunday. The hopes to add one more medal in the Indian tally were riding on Ishroop after she jumped into medal contention following her tremendous win over Cameroon's stronger and taller Georgika Wesley Djengue Moune in the repechage round of women's -78 kg. The 19-year-old won by waza-ari after her oppo-

nent scored two yukos. However, an aggressive Godbout proved a tough nut to crack for Ishroop, who received two shidos in the regulation time and eventually lost in the golden score time. Yash Ghangas and Avtar Singh, the other Indian judokas in the fray on the final day, faded in the round of 16. India have so far won 39 medals, including 13 gold and 17 silver, with just one contender left in the Games in Lisha Das who will compete in women's C4C5 1000m Time Trial Final. Judo contributed four medals, including two historic gold.

Lovlina Borgohain Points Out Missing Northeast On India Map At Glasgow Restaurant. Owner Responds

Assam boxer Lovlina Borgohain on Sunday said she felt "hurt" after noticing that India's Northeast was missing from a map printed on the napkins and displayed outside a popular Indian restaurant in Glasgow. The owners acknowledged the mistake and promise to rectify it. The incident occurred when the Indian boxing contingent visited Mister Singh's India, The Home of Curry for a celebratory dinner after scripting history with an unprecedented haul of 10 medals - seven gold and three silver -- at the ongoing Commonwealth Games. Lovlina, who won a silver medal, noticed that the map of India used in the restaurant's branding omitted the Northeast and immediately brought it to the attention of the management. "Please don't take this the wrong way. I felt a little hurt by this. In the map of India, our



North East is missing. Yes, even outside, the map that's displayed has cut off the North East. As someone from the North East, that really hurts us. That's all I wanted to say. Please keep this in mind next time. Thank you so much," Lovlina said during an online interaction. Boxing Federation of India president Ajay Singh, who was present at the restaurant, said there was no confronta-

tion. "There was no confrontation. It was an aberration and we pointed that out, me and Lovlina. They accepted their mistake and assured us that it will be corrected," Singh told PTI. The restaurant, a well-known Indian dining destination in Glasgow, has hosted several touring sports teams and dignitaries over the years.

Sunil Chhetri Urges Tata Group To Reconsider Jamshedpur FC Exit From ISL: "Punch To The Gut"

Former India captain Sunil Chhetri has made an emotional appeal to the Tata Group to reconsider its decision to shut down Jamshedpur FC's first-team operations, describing the development as "a punch to the gut" and warning that Indian football cannot afford to lose one of its strongest institutional supporters. Reacting to the club's decision in a post on X on Sunday, Chhetri reflected on the difficult state of Indian football and the importance of long-term stakeholders. "It takes a lot to be a stakeholder in Indian football. It has been like that for some time now. But when everything around looks like it will crumble, you bank on family to hold on to each other. And more often than not, it is the elders in the house that you turn to for assurance," Chhetri wrote. Paying tribute to the Tata Group's contribution to the sport through the Tata Football Academy and later Jamshedpur FC, the veteran striker added, "All of you at the TATA Group, through TFA first, and then @JamshedpurFC, have been one of



our pillars." Expressing his disappointment over the club's withdrawal, Chhetri said, "To know that Jamshedpur has folded first team operations is a punch to the gut." He also highlighted the immediate impact of the decision on players and staff, noting that while many may eventually find new opportunities, Indian football stands to lose much more. "The players and staff will be without clubs, and they might find one by the end of

it all. The League will have a team less, but the season will go on. However, not having the TATA group involved in the top tier of Indian football - that would be a disaster with no alternative," he said. Acknowledging that sporting decisions are often influenced by commercial realities, Chhetri nevertheless appealed to the Tata Group to reconsider. "I understand that some tough decisions in sport are down to what makes sense in

the board room. But I can only request and hope that the think tank at TATA picks their heart over head and reconsiders this call. It might be a poor business decision, but it will be the one Indian football needs the most at this hour," he added. Jamshedpur FC had announced on Friday that it would withdraw from the Indian Super League (ISL) from the 2026-27 season onwards. The decision was confirmed by Jamshedpur Football and Sporting Private Limited (JFSPL), the Tata Steel-owned entity that operates the club. While confirming its exit from the ISL, JFSPL said it would continue contributing to Indian football through grassroots development and youth programmes, reiterating its commitment to identifying and nurturing young talent across the country. Founded ahead of the 2017-18 ISL season, Jamshedpur FC spent nine seasons in India's top-flight league. The club's greatest achievement came in the 2021-22 campaign when it won the ISL League Shield under head coach Owen Coyle.

Alexandra Eala Stuns Naomi Osaka To Book Washington Final Against Jessica Pegula



Alexandra Eala stunned former world number one Naomi Osaka 6-4, 6-2 on Saturday to reach the women's final of the WTA and ATP Washington Open, where she will face third-ranked Jessica Pegula. The 21-year-old Philippines left-hander delivered an impressive victory over the four-time Grand Slam winner from Japan to reach her second WTA final, having lost her first last year at Eastbourne. "I'm super proud of my performance," Eala said. "I played really well and I had a great mentality and I stayed locked in until the end." Eala, set to jump to a career-best 24th in the world rankings, had previously ousted second seed Elina Svitolina for her sixth top-10 victory of the year after dethroning 2025 Washington champion Leylah Fernandez. It was the first meeting of the Asian stars, Eala facing one of the idols of her youth. "She definitely has an aura and she definitely has power," Eala said of Osaka. "I remember watching her finals in the Australian Open and US Open, so really a great experience to share the court with her."

Jasprit Bumrah Ruled Out Of Sri Lanka Test Series Due To Knee Injury: Report

Premier pacer Jasprit Bumrah is set to miss India's two-Test tour of Sri Lanka as he is yet to recover from his knee injury. The swelling in his knee seems to be more serious than it initially looked and the Sports Science team at Bengaluru's Centre of Excellence doesn't want to rush the seasoned pacer to the grind of international cricket, keeping in mind a packed calendar ahead. The Sri Lanka series begins August 15 in Galle. The 32 year old had missed out on the third ODI against England at Lord's after sustaining an impact injury. He recently reported at the Centre Of Excellence in Bengaluru and was expected to be match-fit by the time series begins in two weeks. However it has been learnt that Bumrah is still feeling



some discomfort and even if he gets fit before August 15 or the second Test starting August 23, the medical team isn't sure if Test match is correct format due to a massive workload on the docile tracks. It will be interesting to see of selectors pick Jammu and

Indian boxers returned with a record haul of 10 medals from the CWG, including seven gold and three silver, a first in the history of the Games for the

country. "We had an exceptional and historic last two days. Winning seven gold and three silver in boxing is the biggest performance in the last 100 years history of Commonwealth Games," Singh said during an online interaction from Glasgow. "This is also a preparation for future events, the Asian Games and 2028 Olympics. We can replicate such a performance in Asian Games, we are top 3 in Asia in boxing but for that we need to

prepare hard from now and be focussed to produce a strong performance." The BFI chief said those boxers who have won medals at the CWG have automatically booked their Asian Games berths. "We had already announced that boxers who are going for CWG and enter medal rounds will automatically be selected for Asian Games," Singh said. "We are very hungry for a historic performance in Asian Games. But we need to become stronger, better in many weight categories. A lot of work has to be done, this was just a stepping stone. "We are an athlete-centric federation and our programme is ready till 2028. We want to restart league format or professional format domestically this year to give more exposure to boxers."
