34 ill as school uses detergent instead of salt in meal

Patna: As many as 34 children fell ill in Bihar's Nalanda district after they were served a mid-day meal in which the cook allegedly mixed detergent powder instead of salt "by mistake." The incident occurred on Tuesday, August 18, at Parsa Middle School when some students complained of a burning sensation in their throats and stomach pain. The students were served a midday meal comprising rice with a potato-soybean vegetable dish, supplied by a Non-Governmental Organisation (NGO), as per the prescribed menu.

Minor raped by father; fake papers used for delivery

Raipur (TSIT): A minor girl was allegedly repeatedly raped and impregnated by her father, who later arranged her delivery at a hospital by using forged documents to show her as an adult and married, in Chhattisgarh capital Raipur, police said on Wednesday, August 19. The newborn son of the 16-year-old girl, who had also allegedly been forced to undergo an abortion on one occasion, was later sold to another person, they said. After the matter came to light on Monday, eight persons, including the teenager's father, aunt and a nurse, have so far been arrested in connection with the case, they said. The alleged abuse began in 2023 after the minor's mother separated from her husband, leaving their three daughters with him, a police official said.

Cong criticises Modi govt at CWC meeting

**New Delhi (TSIT)**

The Congress on Wednesday announced a broad political offensive against the Prime Minister Narendra Modi led Centre government, deciding to take its 'Chhatron Ki Goonj' campaign against paper leaks to nearly 800 cities, launch a nationwide agitation over alleged "chanda chori" at the Ram Temple in Ayodhya and raise the issue of Chinese incursions in Arunachal Pradesh. The party also demanded a Prime Ministerial apology over the Haldwani incident involving Congress president Mallikarjun Kharge, demanded to freeze 543 Lok Sabha seats and backed implementation of women's reservation from the 2029 Lok Sabha elections.

The decisions were taken at the Congress Working Committee (CWC) meeting at Indira Bhawan in the national capital, where the party reviewed the political situa-

tion and discussed paper leaks, education, donations, China, delimitation, Vande Mataram and organisational strengthening, said general secretary (organisation) K C Venugopal while addressing a press conference along with Jairam Ramesh and Pawan Khara.

The CWC also flagged worsening unemployment among educated youth, saying the crisis had become a systemic failure after 12 years, with unemployment among graduates and postgraduates higher than among those without formal education.

Venugopal said that the 'Chhatron Ki Goonj' programme will now be held in nearly 800 cities, with Leader of Opposition Rahul Gandhi participating in several programmes. He said that the education cannot be held hostage to privatisation, centralisation and the "regressive shackles" of the RSS-BJP.

CM Revanth Reddy attends Congress Working Committee meeting in presence of top leadership

Hyderabad (TSIT): Telangana Chief Minister A. Revanth Reddy attended the Congress Working Committee (CWC) meeting held under the chairmanship of AICC President Mallikarjun Kharge.

The meeting was attended by senior Congress leaders, including former party presidents Sonia Gandhi and Rahul Gandhi, and party general secretary Priyanka Gandhi Vadra. CWC members and senior leaders, including K.C. Venugopal, P. Chidambaram, Veerappa Moily, Ambika Soni, Jairam Ramesh, Sachin Pilot, Damodar Rajanarsimha,



Digvijaya Singh, N. Raghuvendra Reddy and Pallam Raju, also participated in the

meeting. Chief Ministers of Congress-ruled states and other senior party functionar-

ies were present. The meeting brought together the top Congress leadership to deliberate on key political, organisational and national issues. Discussions also focused on the party's strategy and future course of action in the coming period.

The participation of Chief Minister Revanth Reddy assumes significance as Telangana remains an important state for the Congress, with the party leadership continuing to focus on strengthening the organisation and implementing its political agenda.

Rajnath Singh to meet Japanese counterpart on defence ties

New Delhi (TSIT): Defence Minister Rajnath Singh will hold a bilateral meeting with his Japanese counterpart, Shinjiro Koizumi, in New Delhi on Thursday to further strengthen defence cooperation between the two nations and promote peace in the Indo-Pacific region.

Shinjiro Koizumi arrived in Mumbai on Wednesday for his maiden visit to India. Upon arrival, he inspected a Guard of Honour at the Western Naval Command in Mumbai. The Japanese Defence Minister also laid a wreath at the Gaurav



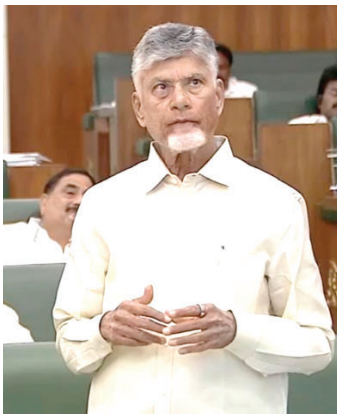
Stambh at the Naval Dockyard. Additionally, he paid a visit to the indigenous ship INS Chennai. Koizumi held discussions with Indian Navy Chief Admiral Krishna Swaminathan and Flag Officer Commanding in Chief, Western Naval Command, Vice Admiral Sanjay Vatsayan.

CM Naidu Alleges Unprecedented Irregularities in APPSC Group-I Exams

Visakhapatnam (TSIT)

Chief Minister N. Chandrababu Naidu has alleged that unprecedented irregularities took place in the APPSC Group-I examinations conducted during the previous government's tenure. He said established procedures were violated in the recruitment of Group-I officers, whose services are crucial to the administration and future development of the State. Speaking during a special discussion in the Legislative Assembly, the Chief Minister said the APPSC is a key institution responsible for selecting senior officials and criticised the previous government for undermining its credibility.

He alleged that the evaluation process involved serious violations and that unqualified personnel were engaged in handling and evaluating answer scripts. Recent reports on the SIT investigation have also pointed to serious procedural violations in the evaluation of Group-I Mains answer scripts. Chandrababu Naidu said the same answer scripts were sub-



jected to multiple rounds of evaluation despite rules restricting re-evaluation. He questioned how such irregularities could have occurred in the selection process for senior government officials.

The Chief Minister also challenged the Opposition to face the people and answer questions in the Assembly instead of resorting to what he described as conspiracies and political campaigns. He said the government was prepared to discuss the issue openly and present the facts before the Legislature and the people.

Uttam Directs Speedy Completion of 2,160 Houses



Hyderabad TSIT: Irrigation and Civil Supplies Minister N.Uttam Kumar Reddy on Wednesday directed officials to accelerate housing works across Telangana and ensure that poor and eligible families receive houses without delay.

Reviewing housing programmes through a video conference with Revenue and Housing department officials, Uttam said providing a dignified home to every deserving poor family was a major welfare priority of the Congress government.

The Minister particularly reviewed the 2,160-house residential colony at Ramaswamigutta in Huzurnagar, which he has been closely monitoring. He directed officials to complete all pending works on a war footing and prepare the colony for inauguration in the first week of September.

Uttam instructed officials to inspect each of the 2,160 houses and ensure that doors, windows, electricity, water supply, bathrooms, drainage and other essential facilities were in place before beneficiaries moved in. Pending works should, wherever possible, be completed within seven to 10 days, he said.

Congress protests Kumaraswamy's remarks against Sonia Gandhi, demands public apology

Bengaluru (TSIT): The Karnataka Pradesh Congress Committee (KPCC) staged a protest in Bengaluru against Union Minister H.D. Kumaraswamy over his



alleged derogatory remarks against senior Congress leader Sonia Gandhi and demanded that he immediately withdraw the statement and publicly apologise.

KPCC General Secretary S. Manohar, who led the protest, con-

demned the remarks and said political differences should be addressed through political criticism rather than personal attacks. He alleged that questioning the personal background, family and origins of a respected woman amounted to "low-

level politics" and said the Congress party strongly condemned such statements.

Manohar said Sonia Gandhi was not only the wife of former Prime Minister Rajiv Gandhi but also a senior political leader who had contributed to public life in India for several decades. He alleged that Kumaraswamy had lowered the standards of political discourse by making personal remarks against her.

Ought to have resigned: Bombay Bar Association on BCI Chairman

Mumbai (TSIT) The Bombay Bar Association has condemned Bar Council of India Chairman Manan Kumar Mishra for his letters to the National Academy of Legal Studies and Research (NALSAR) University in Hyderabad.

The BCI Chairman had issued an order on August 13, directing all State Bar Councils asking them not to enrol any 2026 passouts from NALSAR University after they protested against the invitation extended to Chief Justice of India (CJI) Surya Kant for their convocation.

The order was quickly withdrawn on the same day following backlash. The Chairman also tendered an apology on August 15.

While appreciating Mishra for apologising, the Bombay Bar Association issued a statement on Tuesday, August 18, saying the apology was "clearly belated and nothing but an attempt to merely assuage the situation" and his conduct



"failed to uphold the dignity of the legal profession".

"The apology sought to be tendered by Mr Mishra, however, cannot be considered as an expression of true remorse, since he continues to hold the position as Chairman despite his conduct, when in the fitness of things, he ought to have already resigned," the statement added.

On Mishra's August 13 letter, the Association said, "The contents of the communication were a direct attempt by the learned Chairman to cause grave prejudice to the professional careers of students of NALSAR. Such communication was uncalled for

and reflects that the learned Chairman took an extreme step against the students, without regard to the principles governing the right to protest and freedom of speech and expression. A large section of the students were condemned unheard. The issuance of the said communication by Mr Mishra is an abuse by him of the office of the Chairman, Bar Council of India." The All India Young Advocates Association has called a protest outside the BCI office in New Delhi on August 20 at 10 am to demand Mishra's resignation. Cockroach Janata Party spokesperson Saurav Das has also voiced his support for the protest.

Cabinet approves Rs.9,450-cr railway multitracking projects across 4 states

New Delhi (TSIT)

The Cabinet Committee on Economic Affairs, chaired by Prime Minister Narendra Modi, has approved four railway multitracking projects with an estimated cost of ₹9,450 crore. The projects, scheduled for completion by 2030-31, will add around 410 km to the Indian Railways network across West Bengal, Odisha, Tamil Nadu and Andhra Pradesh. The approved projects include the 173-km fourth line between Kharagpur and Bhadrak (Ranital) covering West Bengal and Odisha; the 75-km fourth line between Bhadrak and Haridaspur in Odisha; the 90-km third and fourth lines between Gummidipundi and Gudur cover-



ing Andhra Pradesh and Tamil Nadu; and the 72-km third and fourth lines between Cuttack and Paradeep (Badabandha) in Odisha. The projects are expected to increase rail capacity, reduce congestion and improve operational efficiency and service reli-

ability. Planned under the PM Gati Shakti National Master Plan, they will strengthen multimodal connectivity and improve logistics efficiency through integrated planning. The four projects will cover eight districts and improve connectivity to around 6,448 villages with a combined population of nearly 60 lakh. They will also strengthen rail access to several tourist destinations, including Bhitarkanika National Park, Kuldiha Wildlife Sanctuary, Chandipur Beach, Pulicat Lake, Nelapattu Bird Sanctuary, Lalitgiri and several prominent temples. The routes are important for transporting commodities such as coal, iron ore, cement, iron and steel, containers, auto-

mobiles and food grains. The capacity enhancement is expected to facilitate additional freight traffic of around 76 million tonnes per annum. According to the government, the projects will also contribute to environmental sustainability by reducing logistics costs and oil consumption by around 13 crore litres. The initiative is expected to reduce carbon dioxide emissions by approximately 65 crore kg, equivalent to the environmental benefit of planting around 2.60 crore trees. The projects are aimed at providing seamless movement of people, goods and services while supporting economic activity, employment and regional development.

NAARM workshop stresses stronger agri-media collaboration for effective science communication

Hyderabad : The National Academy of Agricultural Research Management (NAARM) organised a workshop on “Agri-Media Synergy: Enhancing Collaborative Communication” on Wednesday to strengthen collaboration between agricultural research institutions and the media and improve the communication of scientific developments to farmers and other stakeholders. The workshop brought together media professionals and communication functionaries to discuss ways to strengthen collaboration, ensure the flow of credible and timely information, and enhance public communication on agriculture and rural development.

Dr. R.M. Sundaram, Director, NAARM, inaugurated the workshop and stressed the need for a well-defined communication roadmap to bridge the gap between researchers, farmers and other stakeholders. He said scientific developments and technologies developed by agricultural research organisations must be communicated from the right perspective and in an accessible manner. Dr. Sundaram highlighted strategic communication, transparency and innovation as key elements of effective



public communication and called upon media and communication professionals to demystify science and break institutional silos to make scientific knowledge accessible to a wider audience. Dr. Kurmanath, Consulting Editor, Business Line, delivered the keynote address and emphasised the importance of using data, facts, figures and infographics in news reports to improve public understanding of scientific discoveries. He also stressed the need for newsrooms to adopt emerging multi-format communication practices, including quality photographs and short videos supported by clear explanations of scientific terms. Dr. Venkat Kumar, Head,

Extension Systems Management Division, NAARM, outlined the Academy’s activities in strengthening human resources under the National Agricultural Research, Education and Extension System (NAREES). He also explained the significance of the ICAR Science Communication Policy in strengthening institutional communication. The workshop provided a platform for discussions on effective communication strategies, emerging media practices, information dissemination mechanisms and the role of stakeholders in addressing the information needs of farmers and the wider public.

Participants also discussed operational challenges and ways to strengthen professional collaboration between agricultural research organisations and media representatives. G. Aneja, CTO, NAARM and Workshop Director, welcomed the participants and outlined the objectives of the workshop. Around 35 participants from print and electronic media, including agriculture bureau chiefs, senior reporters, Public Relations Officers and other communication professionals, attended the programme.

Telangana banks record Rs.12.77 lakh crore advances; Deputy CM urges alignment with Telangana Rising 2047

Hyderabad, August 19, 2026: The State Level Bankers’ Committee (SLBC), Telangana, held its 50th Quarterly Review Meeting for the quarter ended June 2026 at Praja Bhavan, Hyderabad, on Wednesday to review the performance of banks and assess progress in priority-sector lending and financial inclusion. Deputy Chief Minister and Finance Minister Bhatti Vikramarka Mallu, senior officials of the Telangana government, Reserve Bank of India (RBI), NABARD, State Bank of India (SBI) and representatives of public and private sector banks, Regional Rural Banks, Small Finance Banks and other financial institutions attended the meeting. Presenting the banking sector’s performance for the first quarter of 2026-27, SBI Hyderabad Circle Chief General Manager and SLBC Telangana Chairman Neelesh Dwivedi said total



bank deposits increased by Rs.49,522 crore during the quarter to Rs.9,92,947 crore. Total advances grew by Rs.42,891 crore to Rs.12,76,748 crore, while the Credit-Deposit ratio stood at 128.58%. Banks disbursed Rs.20,069 crore in short-term production loans during the quarter, achieving 34.51% of the Kharif target. Investment credit to agriculture and allied sectors, agricultural infrastructure and ancillary activities stood at Rs.32,268 crore, representing 38.36% of the annual target.

Lending to the MSME sector stood at Rs.91,374 crore, achieving around 40% of the annual target. Banks also extended Rs.1,46,096 crore under various priority-sector categories, achieving 33.66% of the annual target. Priority-sector lending included Rs.134 crore in education loans and Rs.1,402 crore in housing loans. Addressing the meeting, Deputy Chief Minister Bhatti Vikramarka Mallu urged banks to align their lending activities with the Telangana Rising 2047 vision, which targets a \$1 trillion economy by 2034

and \$3 trillion by 2047. He said banking performance should be assessed not only through financial targets but also through outcomes such as rural income growth, women’s entrepreneurship and job creation. He reviewed agriculture and MSME lending and expressed concern over high agricultural NPAs. He called for timely and proactive credit to farmers and MSMEs, reactivation of inactive Business Correspondents and a shift from welfare-oriented financing towards enterprise-based finance for Self-Help Groups. Principal Secretary (Finance) Sandeep Kumar Sultania urged banks to align their Annual Credit Plans with the State’s Vision 2047. He said Telangana was currently growing at 10-11% and called for stronger and targeted lending to support the State’s objective of achieving a 13% growth rate.

Mosquito Threat Doesn’t End With the Monsoon, Warn CARE Doctors

Hyderabad, August 19, 2026: With the monsoon in full swing, fever cases are once again bringing dengue, malaria and chikungunya into focus. Doctors at CARE Hospitals say the immediate concern is not only the seasonal increase in mosquito-borne infections, but also the tendency among people to dismiss early symptoms as a routine viral fever and delay seeking medical advice.

rains, high humidity and accumulation of stagnant water create favourable conditions for mosquito breeding. In cities such as Hyderabad, breeding is not limited to large areas of waterlogging. Water collected in coolers, flowerpot trays, buckets, discarded containers, tyres, construction sites, terraces and uncovered tanks can also become breeding grounds.

India continues to face a significant dengue burden. According to the National Centre for Vector Borne Diseases Control (NCVBDC), the country reported 2,33,519 dengue cases and 297 deaths in 2024. Telangana alone reported 10,077 cases during the year. The numbers underline the need for continued vigilance, particularly during the monsoon and post-monsoon period.

Speaking about the current



monsoon scenario, Dr. Syed Mustafa Ashraf, Senior General Physician, CARE Hospitals, Malakpet, said, “During the monsoon, we see a noticeable increase in patients coming with fever, headache, severe body pains, weakness, nausea and vomiting. The challenge is that dengue, malaria and chikungunya can initially look very similar to a routine viral fever. Many patients wait for two or three days expecting the fever to settle or start taking medicines on their own. If the fever is persistent, symptoms are worsening or the patient is becoming unusually weak, it is better to get evaluated rather than continue waiting.

“What we look at as physicians is not just the temperature, but the overall clinical condition of the patient. Repeated vomiting, severe abdominal pain, unusual bleeding, increasing weakness, drowsiness, breathing difficulty or reduced urine output are warning signs that should not be ignored. In dengue particularly, the fever coming down does not always mean the patient has completely recovered. Timely clinical assessment, appropriate investigations, adequate hydration and monitoring are important to identify patients who may be developing complications.”

Highlighting why prevention

should continue beyond the rainy season, Dr. Chaitanya Challa, Senior Consultant – General Medicine, CARE Hospitals, Banjara Hills, said, “We have traditionally associated dengue, malaria and chikungunya with the monsoon and immediate post-monsoon months. The rains certainly create favourable conditions for mosquito breeding, but we should not assume that the risk disappears once the rains stop. Mosquito-borne illnesses can occur outside the traditional seasonal window as well, particularly when warm temperatures, humidity and local breeding conditions continue.

“In an urban environment, mosquitoes do not need large areas of waterlogging to breed. Water left in a cooler, flowerpot tray, bucket, discarded container, tyre or an uncovered tank can be enough. That is why mosquito control should not end with the monsoon. Families need to make it a routine habit to check their homes and surroundings for stagnant water, keep water-storage containers covered and take precautions against mosquito bites. The larger message this World Mosquito Day is that prevention has to be continuous, not seasonal.”

AINU Vizag Performs First Robotic Boari Flap Reconstruction Surgery in Vizag, Restoring Kidney Function

Vizag, August 19th 2026: In a significant milestone for advanced urological care in the region, the Asian Institute of Nephrology & Urology (AINU), Vizag, has successfully performed Vizag’s first robotic Boari flap reconstruction surgery to treat a complex long-segment ureteric stricture, restoring normal kidney function in a 50-year-old woman suffering from a severe ureteric stricture. The patient, a resident of Kakinada, Andhra Pradesh, initially presented with a ureteric stone that could not be treated successfully at another hospital due to significant narrowing of the ureter. Following this, she developed urinary obstruction and infection, requiring immediate intervention.

Upon admission at AINU Hospital Vizag, the medical team first stabilized her condition by placing a percutaneous nephrostomy (PCN) tube to relieve obstruction and manage infection. The stone was later successfully removed. However, the patient continued to experience recurrent infections due to a long segment ureteric stricture, which left her dependent on an external drainage system. After comprehensive evaluation, the urology team opted for a robotic reconstructive approach to restore normal urinary flow and preserve kidney function.

During surgery, the team encountered a more extensive ureteric defect than anticipated, making conventional proce-



dures such as ureteric reimplantation or psoas hitch unsuitable. The surgeons therefore performed a robotic Boari flap reconstruction, a specialized technique in which a flap from the urinary bladder is used to reconstruct the damaged ureter.

Unlike traditional open surgery—which involves a large incision and prolonged recovery—the procedure was carried out using minimally invasive robotic technology through just a few keyhole incisions. This resulted in minimal blood loss, reduced postoperative pain, faster recovery, and excellent functional outcomes. The patient recovered well, had the kidney tube removed prior to discharge, and was discharged within three days.

Speaking about the case, Dr. Amit Saple, Senior Consultant

Urologist, Transplant, Laparoscopic & Robotic Surgeon said: “This was a highly complex reconstructive case. The ureteric narrowing involved a long segment located close to major pelvic blood vessels, making the surgery technically demanding. Robotic technology allowed us to perform the reconstruction with exceptional precision while minimizing surgical trauma, resulting in quicker recovery and excellent outcomes.” He further added “The robotic platform has significantly enhanced our ability to perform complex reconstructive urological surgeries. It enables meticulous dissection and precise suturing in difficult anatomical locations, ensuring better clinical outcomes and improved patient recovery.”

Dr. G. Ravindra Varma,

Managing Director & Sr. Consultant Urologist, Andrologist, Uro-Oncologist, Laparoscopic & Robotic Surgeon, AINU Hospital Vizag, said, “Managing long-segment ureteric strictures is particularly challenging, as they can significantly compromise kidney function if not addressed with precision. In this case, we adopted a robotic Boari flap reconstruction—a highly advanced, minimally invasive technique that utilizes bladder tissue to restore ureteral continuity and ensure normal urine flow. This approach not only allowed us to effectively bridge the damaged segment but also helped preserve the patient’s kidney function. Robotic technology provides enhanced precision, better visualization, and faster recovery, making it a game-changer in complex reconstructive urology.”

The advanced procedure was expertly led by Dr. Amit Saple, Senior Consultant Urologist, Transplant, Laparoscopic & Robotic Surgeon, along with Dr. G. Ravindra Varma, Managing Director & Senior Consultant Urologist, Andrologist, Uro-Oncologist, Laparoscopic & Robotic Surgeon, and Dr. P. Sridhar, Consultant Urologist. This success also highlights AINU Hospital Vizag’s broader expertise in robotic urology, where other complex procedures, including Radical Prostatectomy and Radical Cystectomy, are routinely performed with excellent outcomes.

Hyderabad: 18th August 2026: CREDAI (Confederation of Real Estate Developers’ Associations of India) Hyderabad, NAREDCO (National Real Estate Development Council) Telangana, and FSAI and (Fire and Security Association of India) Hyderabad Chapter, in coordination with the Telangana State Disaster Response and Fire Services Department, Government of Telangana organized a workshop aimed to eliminate regulatory bottlenecks while upgrading life safety infrastructure across high-rise residential, retail, hospitals, hotels, schools, and commercial developments. Key real estate bodies, architects, structural engineers, MEP consultants, fire safety experts, auditors and government officials gathered in Hyderabad for an intensive industry workshop focusing on ‘Streamlining Provisional No Objection Certificates (NOCs) framework and advocating adoption of New Age Advanced Fire Safety Technologies.’

The workshop follows the withdrawal of the National Building Code of India 2016 and the introduction of the advisory National Building Construction Standards (NBCS) 2026. In response, the Department has formulated draft Provisional NOC documents featuring practical checklists for Residential, Business, Mercantile, and educational occupancies. A major highlight of the session was the introduction of a new service allowing a Single Provisional NOC for Multiple Blocks within a single project, significantly streamlining the approval process for large developers. This risk-based framework aims to establish uniform, practical fire and life safety requirements while removing repetitive and non-essential provisions to enhance the ‘Ease and Speed of Doing Business’ in the state. The department also showcased innovative IoT-based health monitoring sensors that provide real-time data on fire pump status, water levels,



and generator readiness, alongside presentations on pressureless aerosols and advanced smoke management systems.

The workshop served as a crucial platform for dialogue between government officials and real estate leaders to eliminate regulatory bottlenecks while upgrading life safety infrastructure across residential and commercial developments. Discussions centred on establishing transparent online processing timelines for Provisional NOCs, standardizing early-stage safety protocols, and mandating the adoption of modern fire mitigation technologies, including IoT-based smoke detection, early-warning suppression systems, and automated flame-dampening devices.

Speaking about the workshop Sri Vikram Singh Mann, IPS, Director General, Telangana Disaster Response & Fire Services Department said “Provisional NOCs are not merely administrative formalities; they are critical roadmaps designed to ensure fire safety is built directly into the architectural DNA of a residential, commercial or retail real estate project . Our objective is twofold: simplifying approval mechanisms through digital transparency and strictly enforcing modern safety standards. By integrating real-time sensor monitoring and early-warning technologies, we aim to transform Telangana into a benchmark state for urban fire resilience and zero-preventable fire casualties.”

Bengaluru (TSIT) AICC National Coordinator, SC Department & In-charge of Maharashtra said that, Rajiv Gandhi was a builder of modern India. As a pilot, technologist, architect of the telecommunications revolution, and political statesman, he left a lasting mark on Indian politics. Today is his birth anniversary. The transformation of the telecommunications sector was a major turning point. India, where people once had to wait for years to obtain a telephone connection, has today reached the age of mobile phones, the internet, digital payments, and artificial intelligence. The early seeds of this transformation were sown by former Prime Minister Rajiv Gandhi.

In his press statement he said that, When Rajiv Gandhi became Prime Minister in 1984, he had a strong desire to take India into the 21st century. He considered science, technology, and modern communication systems to be

important instruments of national development. C-DOT, established in 1984, became an important platform for developing indigenous telecommunications technology. With the support of technologists such as Sam Pitroda, efforts were made to develop telephone systems that could reach rural India as well. Public telephone centres, STD and PCO systems expanded rapidly across the country. The idea that telephone services should not be a privilege limited to the rich or government offices, but should be accessible to ordinary citizens, gained strength. This was the initial stage of building the infrastructure required for the mobile and internet revolution.

The Rajiv Gandhi government also gave special emphasis to computerisation. Discussions and experiments relating to the use of computers gained momentum in several sectors, including government offices, banking, railways and education. However, this



transformation did not take place without opposition. There were concerns that computers would take away jobs. The BJP strongly opposed computerisation. At that time, the late Ananth Kumar is still remembered for leading a protest in which a replica of a computer was burned at Anand Rao Circle. Despite this, Rajiv Gandhi continued to believe that the econ-

omy of the future would be technology-driven. The fact that India later emerged as a major force in the global IT sector makes the significance of the technological transformation of that period even clearer.

Through the National Education Policy of 1986, Rajiv Gandhi worked towards modernising the education system. Through Jawahar Navodaya Vidyalayas, he sought to ensure that talented students from rural areas received quality education. He believed that the development of knowledge, science and human resources was essential. He also worked towards giving greater powers to Panchayati Raj institutions and initiated efforts to provide constitutional status to local bodies. Although Rajiv Gandhi's political career was relatively short, his influence will endure for a long time.

Several leaders from the Nehru-Gandhi family have made their

own distinct mark. Rahul Gandhi, the Leader of the Opposition in the Lok Sabha, is bringing the changing questions of India to the forefront in a new way. The political eras of Rajiv Gandhi and Rahul Gandhi are different. The India that Rahul Gandhi faces is one dealing with the digital revolution, artificial intelligence, unemployment, social inequality, educational pressure and concerns regarding democratic institutions. Therefore, following his father's path does not mean repeating the same politics; it means adapting the vision of modernity of that era to the problems of today. Rahul Gandhi has been continuously fighting on issues concerning employment, education, the examination system, social justice, the future of young people and economic opportunities. Rajiv Gandhi had served as the Leader of the Opposition in the Lok Sabha. Rahul Gandhi today stands as the face of the Opposition.

The organisations have requested the authorities to verify the circumstances surrounding the incident and examine whether any rules and regulations governing the protection of trees in Bengaluru were violated.

Quarry and Crusher Owners to Stage Massive Protest at Freedom Park on August 20

Bengaluru : The Karnataka State Quarry and Stone Crusher Owners Federation will stage a massive protest at Freedom Park in Bengaluru on August 20, opposing the collection of royalty from quarry and crusher owners at two different stages.

Around 5,000 quarry and crusher owners from across Karnataka are expected to participate in the protest, demanding an immediate end to what the Federation has termed the government's discriminatory and exploitative royalty collection policy.

Speaking at a press conference, Federation President D. Siddaraju said quarry and crusher owners are legally producing essential construction materials such as jelly and M-sand after obtaining all required permissions from the concerned depart-



ments, including environmental clearances.

“While other sectors are not subjected to such double royalty collection, the quarrying sector alone is being unfairly targeted. This is a clear case of discrimination and injustice,” he said.

He alleged that the government is collecting 70 to 80 per cent royalty on jelly and M-sand supplied for various government

works undertaken by the Public Works Department (PWD), PRDE, Land Army and other departments and activities. Royalty is deducted before contractors receive their payments.

He further said that at the end of the financial year in March, officials from KRSRAAC visit quarries, measure the areas where mining has been carried out and subse-

Even if he gets a clean chit from the court, the ED and CBI raids are not politically motivated: Opposition Leader R. Ashok

This is a case of directly dipping hands into the treasury and stealing; give the ministerial post to other Scheduled Caste legislators Bengaluru : Minister B. Nagendra has not received a clean chit in the ED and CBI investigations. He should at least get a clean chit from the people's representatives' court. Until then, he should not continue in the ministerial post, said Opposition Leader R. Ashok.

Speaking to reporters, he said that the Enforcement Directorate and CBI have existed for fifty years. But Minister B. Nagendra claims that their raids are politically motivated. If that is the case, how did the 187 crore scam take place in the Valmiki Development Corporation? 1.2 crore was directly credited to Nagendra's bank account. Money was also credited to his relatives' accounts. Looking at the CBI chargesheet, his relatives



have admitted it. When the corporation's money has gone to 600 accounts, it means the minister's consent is there. Money has also come into the account of the minister's assistant Nagaraj, he said. This money went to a cooperative bank in Andhra Pradesh and then to Ballari district. It did not go to any other district in the state. This is a pre-planned theft. The CBI has filed three chargesheets, in

which he is the main accused. Former CM Siddaramaiah had admitted in the House itself that irregularities of 89 crore had taken place. They formed an SIT and obtained a clean chit. But the remaining CBI and Enforcement Directorate must also give a clean chit. During the BJP tenure, when allegations came against K.S. Eshwarappa, an investigation was conducted. Even after getting a clean chit, he was not reappointed as a minister. If he gets a clean chit from the people's representatives' court and is then appointed as a minister, we have no objection, he said.

This is the money of Scheduled Castes, and it must be protected. This is a case of directly dipping hands into the treasury and stealing. This is not just a question of one Nagendra. This is a case where action must be taken against those who looted. Leave Nagendra and appoint

other Dalits as ministers, he said.

How is it possible for Nagendra to go to jail without investigation? If there was no investigation, how was it possible to file a 9,000-page chargesheet? Even when the Eshwarappa incident happened, investigation against Congress people was going on. At that time, Eshwarappa's resignation was obtained. But Eshwarappa had never received money by cheque. Nagendra has directly received money by cheque. Earlier, we struggled and made him resign. We will do the same now. If he resigns soon, discussions can be held on issues like drought, Bidadi Township, NICE, Cauvery, etc. CM D.K. Shivakumar talks about being corruption-free. There is confidence that he will first obtain the minister's resignation and create an opportunity for discussion, he said.

US Envoy Signals
Possible Review of
Kashmir Travel Warning

During his first visit to the Union territory, United States India Ambassador Sergio Gor today (August 19) pointed to a possibility of Washington reviewing its travel advisory for Jammu and Kashmir, citing “improvements in the security situation”. Speaking to reporters briefly following his meeting with the Jammu and Kashmir Chief Minister Omar Abdullah, Gor said the US would consider whether its travel warning for the region should be downgraded, and described Kashmir as “an important part of India”. He said that Americans would enjoy visiting the region. “I cannot make any big announcement [on a revision of the travel advisory].” Gor told reporters outside Abdullah’s residence in Gupkar, Srinagar. “New Delhi, the chief minister here, the government here, we believe, have made some incredible steps toward keeping this area safer and making it more secure,” he said. “And so we will be looking at whether the travel warning that is recommended by the United States is something that should be downgraded,” Gor added. “This is a beautiful area. I think a lot of Americans would enjoy coming here and seeing the beauty,” he said. Earlier in the day, Peoples Democratic Party (PDP) president and former chief minister Mehbooba Mufti had urged Gor to withdraw the US travel advisory, saying it was hurting an economy in which thousands of families depend on tourism. “For Kashmir, where thousands of families depend on tourism, the travel advisory on Kashmir is more than a warning; it is a wall between Kashmir and the world.” Mufti said in a post on X. “Lifting it would send a powerful message of confidence, help bring back international tourists and give much-needed relief to countless families whose livelihoods depend on tourism,” she added. Mufti urged the US ambassador to at least review and withdraw what she described as the highest-level travel advisory against visiting Kashmir. ‘Kashmir important part of India’ Gor, who is also US President Donald Trump’s special envoy for South and Central Asia, made his comments after his meeting with Abdullah. “Kashmir is an important part of India. I am visiting the place for the first time. It is an incredibly beautiful place,” Gor told reporters in Srinagar. “We had a very warm meeting and we look forward to building on our relationship,” he added, with Abdullah standing alongside him. The visit is Gor’s first to Kashmir since Operation Sindoor last year and comes amid heightened strategic developments in the region. His remarks on the travel advisory are particularly significant to Jammu and Kashmir’s efforts to expand its international tourism footprint and attract visitors from the United States and other Western countries. The meeting was also attended by Ian Michael Dick, an official from the US Embassy in New Delhi, Gary Applegarth, First Secretary at the US Embassy, Lisa Grace Alkins, a US Embassy official, Hemant Joshi, another embassy official, and Jammu and Kashmir National Conference leaders Nasir Aslam Wani, Tanvir Sadiq and Sakeena Itoo. Before meeting Gor, Abdullah said he would not raise the issues Jammu and Kashmir faces to the US envoy and stressed that the solution of internal issues rested with the Government of India. “The solution to our problems will not come from Washington. Our problems have to be resolved by our central government,” Abdullah said.

Why The Congress-Samajwadi 'Merger' Fantasy
Could Be Opposition's Biggest Self-Goal

Political Delhi has a weakness for grand solutions. When alliance talks are tedious, seat-sharing becomes rancorous, and local leaders refuse to yield, a merger can appear seductively simple. Why negotiate every election if two parties can simply become one? That is precisely why the suggestion that the Congress and the Samajwadi Party (SP) should merge deserves scrutiny. The argument is that Rahul Gandhi and Akhilesh Yadav are increasingly occupying the same terrain of caste justice, representation, and inclusive politics, and that a merger could turn this convergence into a new national political formation. It is an interesting proposition. But it also solves the wrong problem. The challenge before Rahul Gandhi and Akhilesh Yadav is not that their parties are insufficiently alike. It is that they must cooperate without destroying the differences that make each useful. In politics, two plus two is not necessarily four. Votes carry memory, caste, class, community, local loyalties, ideological inheritance, and, importantly, the ambitions of party workers. A merger may look like a consolidation from Delhi. In Uttar Pradesh, it could become subtraction. Parties Are Constituencies, Not Containers The case for a merger rests substantially on the argument that the Congress and the SP are moving towards the same social terrain: caste justice, representation, minorities, Dalits, and backward classes. There is truth in the observation, but the conclusion does not follow. Political convergence is not political sameness. The Congress in Uttar Pradesh was historically an umbrella formation. At its strongest, it brought together a coalition of Brahmins, Dalits, and Muslims, alongside other groups, under a broad national platform. That old social compact eventually came apart under the



pressures of Mandal, Mandir, and the rise of parties representing more sharply defined social constituencies. The Samajwadi Party grew out of a very different political genealogy - the socialist tradition associated with Ram Manohar Lohia, backward-caste assertion, and a pronounced streak of political and organisational independence. The party itself describes Lohia as its "guiding light" and defines its ideological inheritance in explicitly socialist terms. Its traditional social architecture has also been different: Yadavs, sections of other backward communities, and Muslims formed its core, even as Akhilesh now attempts to widen that coalition substantially. The fact that the Congress and the SP today seek Dalit, OBC, and minority votes does not mean that they command the same voters, or that those voters see them as interchangeable. Even the

'Muslim vote', so casually spoken of in political shorthand, is no single transferable bloc. Ashraf and Pasmanda communities, biradari networks, class, locality, and the standing of individual candidates, all influence political preferences. There is another constituency that political arithmetic habitually forgets: the aspirant. Every district has leaders who have spent years building a claim to a ticket, an organisational post, or a local following. Merge two organisations and one may not get twice the energy. One may get twice the number of claimants for half the available political space. Rebellion, sabotage, and migration are not academic possibilities in Indian elections, but daily mechanics of party politics. UP Has Tested This Already There is no need to conduct this experiment in a laboratory. Uttar Pradesh has supplied enough evidence. In 2017, the SP and

the Congress fought the Assembly election together amid enormous publicity around the Rahul-Akhilesh partnership and the catchy promise that Uttar Pradesh liked their coming together. The electorate proved considerably less sentimental. The SP won 47 seats and the Congress seven, while the BJP swept 312. That election demonstrated an elementary truth: leadership chemistry does not automatically produce cadre chemistry. A friendly photograph at the top does not guarantee vote transfer at the booth. The 2019 mahagathbandhan between the SP and the Bahujan Samaj Party supplied another warning. On paper, their previous vote shares promised formidable arithmetic. In practice, those votes did not transfer mechanically; the alliance finished with 15 seats. Ironically, the argument in favour of a Congress-SP merger itself acknowledges

this inconvenient fact. Then came 2024, and that result should lead to precisely the opposite conclusion. The Congress-SP arrangement worked because it was an alliance of recognisable political entities, not an act of political self-liquidation. The SP won 37 Lok Sabha seats, and the Congress six; together, the INDIA grouping took 43 of Uttar Pradesh's 80 seats. Both retained their symbols, leadership structures, cadres, and political personalities while preventing destructive competition across most of the State. Why should the success of a coalition be converted into an argument for abolishing coalition partners? The lesson of 2024 was simpler and more useful: intelligent seat-sharing, a resonant common campaign, and disciplined accommodation can make distinct social coalitions complementary. The political genius lay in addition without erasure. The Janata

Warning Indian politics has seen a much grander merger in the name of defeating a dominant leader. In 1977, the Congress (Organisation), Bharatiya Lok Dal, Bharatiya Jana Sangh, and socialist streams surrendered their separate identities to come together as the Janata Party after the Emergency. Anti-Indira sentiment and the extraordinary public reaction to the Emergency gave the formation a historic victory and India its first non-Congress government at the Centre. But what was powerful enough to win an election proved inadequate to manufacture a durable political identity. Old ideological disputes resurfaced. Leadership rivalries sharpened. The tensions between the socialist and erstwhile Jana Sangh components became impossible to paper over. Morarji Desai's government collapsed in 1979, barely halfway through its mandate. The lesson is not that Opposition unity is futile. It is considerably subtler: a negative common denominator can be a campaign instrument; it cannot, by itself, become an organisational philosophy. 'Defeat Modi' cannot be the constitution of a new political party any more than 'Defeat Indira' could hold Janata together. A Congress-SP merger would immediately raise questions that an alliance instead can negotiate without creating an existential crisis. Who controls the Uttar Pradesh organisation? Who selects candidates? What happens when the Congress's national calculations clash with the SP's provincial imperatives? Does the Congress abandon its long-term ambition to rebuild independently in India's largest State? Does the SP trade the autonomy that gives Akhilesh Yadav his political weight for a place within a national hierarchy? These are not minor details to be worked out after a merger.

6 Years After A Dramatic Break-Up, Are
BJP-Akali Dal Set To Join Hands Again?

The corridors of power in the capital are abuzz about the 'gharwapasi' of the Shiromani Akali Dal (SAD) into the National Democratic Alliance (NDA) fold before the Punjab elections next year. Sukhbir Badal and Prime Minister Narendra Modi's meeting a few days ago has fuelled speculation. The two parties ran a successful coalition in Punjab for almost 25 years, winning the 1997, 2007, and 2012 elections. It was a natural alliance representing the majority Sikh (SAD) and minority Hindu (BJP) population, respectively. Sikhs account for 58% of Punjab's population, and Hindus 38%. However, the controversial farm bills in 2019 led to a strain in the relationship, as farmers, particularly from Punjab, opposed the law. The SAD, fearing a loss of support from its key Jat Sikh vote, exited the alliance in September 2020. The SAD had urged the BJP-led central government not to bring the bills to Parliament till "all reservations" expressed by farmers were "duly addressed". But when the Centre did not pay heed, Harsimrat Kaur Badal resigned from the Union Cabinet in protest against the bills. Punjab's Unique Situation The duality of the Sikh community - a minority in India but a majority in Punjab - is a continuing source of political conflict and tension between Sikh-majority Punjab and Hindu-majority India. Resentment towards the Centre, especially after the Golden Temple incident in 1984, hasn't waned fully. Regionalism is integral to Sikh culture; Punjabis don't want their fate to be remote-controlled by Delhi. Post-split,



however, both the BJP and the SAD have suffered electoral setbacks. The 2017 Vidhan Sabha Verdict From 15 seats in 2017, when it had contested in an alliance, the SAD collapsed to just three in 2022 as a lone player. The BJP also dropped from three to two seats in an election that was swept by AAP, which ended up bagging 80% of the seats. Vote share numbers tell a similar story. While SAD fell sharply from 25.2% to 18.5%, a loss of 6.7 percentage points, the BJP actually gained slightly, from 5.4% to 6.7%, a climb of 1.3 percentage points. The SAD bore the brunt of the split as it lost its core Jat Sikh and panthic Sikh votes, while the BJP's standalone vote share held up better than its seat count would suggest. The BJP consolidated Hindu support significantly. Its Hindu Upper caste vote jumped from 7% in 2017 to 20% in 2022, in elections it contested alone. The Hindu OBC vote also climbed from 6% to 16%, while the Hindu SC vote showed a moderate rise from 9% to 10%. The SAD, on the other hand, lost not only Jat Sikh support, which fell from 38% to 26%

votes, but also Dalit Sikh backing, whose vote share dropped to a mere 18% from 35%. Similar But Sharper Patterns In Lok Sabha While the SAD managed to hold on to just one of the two seats it had won in 2019, the BJP lost both its constituencies in a five-cornered contest. The SAD vote share dropped steeply from 27.5% to 13.5% - twice the Vidhan Sabha erosion as it lost further panthic support to Independents, later rechristened as Akali Dal (Waris Punjab De). On the other hand, the BJP's vote share surged from 9.6% to 18.7%. This is explained by the "national character" of Lok Sabha polls, anti-incumbency against the AAP government, and the consolidation of Hindu voters behind the BJP - even if the saffron party's seat count didn't reflect these shifts. Hindu upper caste support jumped from 20% in 2022 to 56% in 2024. In terms of assembly segments, while the BJP led in 23 seats (21 more than in 2022), the SAD led in nine (six over 2022). In total, they led in 32 segments, leading to calls for patching up and forming an alliance for the 2027 state

polls. What If The Two Had Remained Allied? In the 2022 Vidhan Sabha elections, had there been a 100% vote transfer, the SAD-BJP combine would have won 16 seats against the actual combined tally of five. AAP would still have dominated the elections, winning around 86 of the 117 seats. The alliance wouldn't have changed the overall outcome, but it would have certainly eaten into the AAP-Congress numbers slightly. Even at 50% vote transfer, the alliance would have won nine seats, a gain of four. In the 2024 Lok Sabha elections, with a 100% vote transfer, the SAD-BJP combine would have won six out of 13 seats, a gain of five. They would have emerged as the single largest alliance, gaining largely at the cost of Congress. Even at just 50% vote transfer, the alliance would have won five seats against the one it actually won. Is An Alliance Practical Now? The 2020 split hurt the SAD far more than the BJP in vote share terms, in both state and national elections. The BJP's Hindu-consolidation strategy paid off in terms of vote share - even if it failed to turn into seat gains - as Punjab's Hindu population is a minority. Rejoining forces would have mathematically recaptured many lost seats, particularly in 2024, though AAP's continued strength, especially in 2022, means an alliance wouldn't have changed who governs the state. The SAD, to be fair, is facing an existential crisis today. A section of party old-timers have expressed a lack of confidence in Sukhbir Badal's leadership, claiming he is no match to his late father, Prakash Singh Badal.

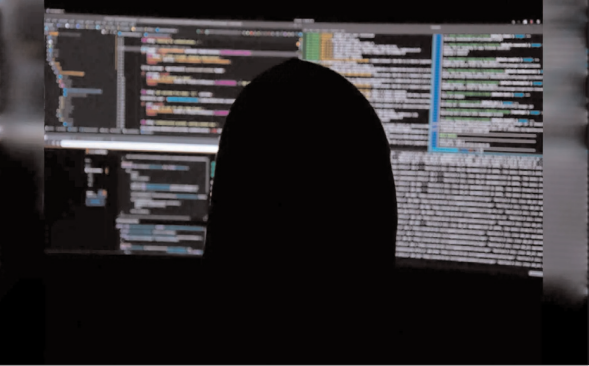

CYBERSECURITY FIRM PROOFPOINT SETS UP AI COE IN HYDERABAD



New Delhi: Global cybersecurity firm Proofpoint on Wednesday, August 19, said it has set up an AI Security Engineering Centre of Excellence in Hyderabad and looks to hire over 200 engineers over the next 12 to 24 months to meet the growing demand for AI-driven security solutions in India. The move comes as the company's India business tripled over the past year, driven by double-digit growth in new customer acquisitions, according to a company statement. "Proofpoint has been serving customers in India for several years through our APJ organisation, supported by regional sales teams and channel partners. In March 2025, we established a dedicated local team...a decision that reflected the scale and momentum we were already seeing in the market...". "We are now expanding fur-

ther with a new AI Security Engineering Centre of Excellence in Hyderabad, a new Delhi office, and continued investment in sales, customer success, technical support and our partner ecosystem. These cumulative investments, combined with strong market demand, underpin the growth we've seen over the past 12 months," Proofpoint CEO Sumit Dhawan said. The new Hyderabad facility will focus on advancing next-generation AI security technologies. The firm plans to recruit more than 200 engineers over the next 12 to 24 months to staff the Centre. The expansion also includes a new office in Delhi to bolster its go-to-market presence, supplementing the existing hub in Bengaluru and a Centre of Excellence in Pune, which currently houses over 550 team members.

NEW MARKETS FOR INDIA'S BUFFALO MEAT AID DAIRY ECONOMY

New Delhi: Among India's agricultural export items, buffalo meat has shown a massive 25.6 per cent growth in 2025-26 to USD 5.1 billion. "We crossed USD 5 billion for the first time last fiscal year and are on track to do USD 6 billion in 2026-27," a Commerce Ministry official said to The Indian Express. That's not all; the value realisation, or simply put, the money made on the sale per tonne of buffalo meat, is remarkable. If one looks at the numbers, in 2014-15, India exported 14.8 lakh tonnes (lt) of buffalo meat worth USD 4.8 billion, which is an average value of USD 3,240 per tonne. The next few years saw a drop in value realisation and exports, but since 2024-25, there has been no looking back. In 2024-25, exports touched USD 4.1 billion at a unit value of USD 3,236 per tonne. The unit value increased to USD 3,591 in 2025-26 and USD 4,392 during April-June 2026. The official said that the higher unit value realisation shows that Indian buffalo meat has been better accepted. "This has been enabled by government



policy, allowing exports only from plants registered by the Agricultural and Processed Food Products Export Development Authority (APEDA), which is conditional upon their meeting stringent safety, hygiene and infrastructure requirements," the official said. 'Global brand, not alternative to cattle beef' Fauzan Alavi, secretary of the All-India Buffalo and Sheep Meat Exporters Association, explains what worked. "In the last couple of years, we have consciously worked at making Indian buffalo meat a global brand and not a number two alternative to cattle beef. The world too is recog-

nising our product quality and safety standards." India is the world's third-largest bovine meat exporter. Trailing behind Brazil at 42.8 lt and Australia at 21.6 lt, its projected volume is 17 lt for 2026, according to US Department of Agriculture data. Our top three exporters are the Mumbai-based Allanasons Private Ltd, the LuLu Group-owned Fair Exports India, and HMA Agro Industries, Agra. Buffalo meat, also called carabeef, is used for processed industrial foods such as burger patties and ready-to-eat products. The focus now is on raising value realisation by pushing retail

sales in smaller packages as well. Since last October, APEDA has been imposing a Rs 250/tonne levy on exports of all frozen and chilled buffalo meat. The proceeds go towards a Meat Export Development Fund meant for promoting exports. The efforts are showing in how diverse the market has become. In 2025-26, of the USD 5.1 billion, 10 countries imported over USD 100 million worth of meat each. These are Vietnam, Egypt, Malaysia, the UAE, Saudi Arabia, Uzbekistan, Indonesia, Iraq, the Philippines and Jordan. "Uzbekistan is a new market. So are Russia, Georgia, Oman and Senegal," said the Commerce ministry official. Boost to dairy economy Here's how buffalo meat exports have helped India's livestock and dairy economy. The export of beef (cattle meat) is not allowed here. Carabeef that is exported is from buffaloes that do not produce enough milk, are infertile, have damaged udders or are males. Maintaining such animals is uneconomical for farmers.

A court has heard claims Meta intentionally hooked a generation of children on Facebook and Instagram, as the biggest legal challenge faced by the social media platform began. A jury in Oakland, California will spend the next six weeks wading through claims by top attorneys from several US states and lawyers for the social media company. A lawyer for California claimed Meta found "millions" of 11 and 12-year-olds were on Instagram and "did little to keep them off" as the trial opened on Tuesday. Meta's representative said just over 100,000 such users were found, and argued that social media addiction does not exist. California's lawyer said Meta knew its platforms hurt teen mental health, while Meta said it was being ignored how many more teens had good experiences. The trial stems from a lawsuit filed in 2023 by 29 US states, including California and New York. They claim there have been numerous violations of federal and state privacy laws for children. The states are seeking billions of dollars from Meta and are demanding it make changes to Instagram and Facebook, including ending "like" counts and infinite scroll. In her



opening arguments Megan O'Neill, a lead attorney for California, relied heavily on information found in millions of documents provided in the case from Meta. They included internal research, employee emails, and chat logs that went all the way up to Zuckerberg. One piece of internal research on Instagram stated: "Teens have an addict's narrative about use." In another that O'Neill pointed the jury to, Meta found "product features designed to increase time spent are inherently at odds with well-being and take away from people's ability to focus on activity that adds

value to their lives". Despite Meta's awareness of potentially negative impacts, O'Neill argued that Meta targeted young people as users of Facebook and Instagram. Meta, she said, went out of its way to "assure the public that its platforms were safe for kids". O'Neill outlined to the jury how Meta's business model could be summed up. "Hook the users; hold them for as long as they can; harvest their data; hide the truth from the public when making public statements," she said. She said that throughout the trial it would become clear that what Meta said

publicly about its platforms and what its internal research showed were very different. "Meta said it put safety over profits, but hid the reality that, time and again, when it came to make a decision, profits won." Paul Schmidt, a lead attorney for Meta, directly addressed the internal research report O'Neill used in her opening arguments. The Meta document O'Neill showed the jury found that "1 in 5 teens says Instagram makes them feel worse". Schmidt said: "That sounds pretty bad." "What else does the document say?" Schmidt went on. "That 41% of teens said it made them feel better and another 41% said it had no effect." Schmidt also worked to poke holes in the states' argument that Meta had not only failed to stop users under the age of 13 from using its platforms, but that it intentionally "hooked" teens and children as users of Facebook and Instagram, or that they were designed to be addictive. As for Meta being able to verify the age of every user on its platform, Schmidt argued that the very privacy laws Meta was being accused of violating had prevented it from saving and using data it needed to track underage users effectively.

Hyderabad logistics company plans USD 50 million expansion



Hyderabad: Hyderabad-based logistics firm Jassper Shipping on Wednesday, August 19, announced plans to invest USD 50 million over the next three years to expand its project logistics, breakbulk, bulk cargo and industrial supply chain operations, betting on India's growing infrastructure and industrial build-out. The growth capital, to be infused by the company in phases, will go towards expanding project logistics infrastructure, strengthening bulk and breakbulk cargo handling, building technology-led logistics planning capabilities and scaling operations across key industrial and port-led corridors, the company said in a statement. The first tranche of USD 10 million will be deployed to expand the company's B2B project logistics business, with a focus on sectors such as power, steel, petrochemi-

cals, heavy engineering, manufacturing and large infrastructure projects. It will also fund specialised transportation, port-to-plant logistics, vessel chartering and multimodal freight solutions for oversized and critical cargo, the statement said. Pushpank Kaushik, the Chief Executive Officer (CEO) and Head of Business Development for the subcontinent, Middle East and Southeast Asia at Jassper Shipping, said India's infrastructure and industrial sectors were entering a multi-year growth cycle that was creating unprecedented demand for specialised project logistics capabilities. The USD 50 million investment reflected the company's long-term commitment to building stronger capabilities across project cargo, breakbulk logistics, vessel chartering and integrated industrial supply chains.

SAMSUNG'S NEW FOLDABLE SMARTPHONES MAY GET COSTLIER IN INDIA

New Delhi: Samsung is likely to increase the prices of its latest foldable smartphones in India, including the Galaxy Z Fold8 Ultra, Galaxy Z Fold8 and Galaxy Z Flip8, as rising memory chip costs put pressure on smartphone makers, leading retailers and industry analysts said. The new Samsung foldables, priced between Rs 1.25 lakh and Rs 2.6 lakh, have received an unprecedented response in India. Samsung India said nearly 2.71 lakh consumers pre-ordered the three devices within just 72 hours of their launch, marking record pre-orders for the company's foldable smartphone portfolio. Retailers now expect the strong demand for memory chips, a critical component in smartphones, to push up device costs further. Analysts also believe Samsung may eventually pass on part of the higher component costs to consumers after absorbing a significant portion of the increase so far. The latest foldables represent Samsung's most advanced foldable lineup yet, with improvements across hinge design, displays, durability and performance, along with purpose-built Galaxy AI features. The Galaxy Z Fold8 Ultra measures just 4.1mm when unfolded, making it the company's thinnest Galaxy Z Fold device, while the Galaxy Z Fold8 weighs 201 grams, making it the lightest Fold model from Samsung. Samsung President and CEO, Southwest Asia, JB Park, recently said



the company has been absorbing a substantial portion of the rising smartphone costs to protect consumers from the full impact of price increases. "If you compare how much they (competition) have increased the price, Samsung's increment is relatively lesser than competition because we have been absorbing the cost," Park said in London at the launch of the new Galaxy foldables. He added that the cost burden being absorbed by Samsung in 2026 is "humongous", while stressing that the decision was driven by the company's focus on providing premium devices rather than simply protecting or expanding market share. Samsung has also introduced long-tenure zero-cost EMI options for buyers of the Galaxy Z

Fold8 Ultra, Galaxy Z Fold8 and Galaxy Z Flip8 in India, potentially helping cushion the impact of higher upfront prices for consumers. Industry analysts expect the broader memory shortage to affect smartphone shipments in the second half of 2026. Abhilash Kumar, Lead Research Advisor (Director) at Smart Analytics Global (SAG), said the Indian smartphone market could see annual shipment declines in the third and fourth quarters as memory shortages drive up component and retail prices. "The smartphone market in India will continue to see annual shipment decline in Q3 and Q4 2026, given the global memory shortage in the smartphone industry leading to prices increase," Kumar said.

SACKED UKRAINIAN
DEFENCE MINISTER
CALLS FOR PRESIDEN-
TIAL ELECTION



Ukraine's popular ex-defence minister Mykhailo Fedorov has called for wartime elections, in what is widely seen as the biggest challenge to Volodymyr Zelensky's presidency since Russia's full-scale invasion four and a half years ago. "Democracy cannot be held hostage by Russia," said Fedorov, 35, in a video posted to YouTube on Tuesday, adding that Ukraine is fighting "precisely because we want to remain a free European state". Since the war broke out in 2022 Ukraine has been under martial law, meaning elections are suspended. Fedorov, who did not mention Zelensky by name in the video, was unexpectedly fired from his role as defence minister last month, just six months after his appointment. Zelensky is yet to respond to the video from Fedorov, whose dismissal sparked protests across the country. However, a source in the presidential office told the

BBC it was "highly bizarre to plan elections amidst missiles and drones. This demonstrates a complete lack of realism". In a separate development, Ukraine's two anti-corruption agencies said they were conducting a special operation targeting current and former MPs as well as an unnamed official in the presidential office. Hours later, Zelensky's office said its deputy head Iryna Mudra had been dismissed, amid local media reports of a raid on her premises. There was no immediate comment from Mudra, although MP Vadym Stolar, whose home was searched as part of the operation, said he was co-operating with anti-corruption officials. In his video, Fedorov complained that corruption was depriving the military of weapons and equipment and making it harder for Kyiv to win the war. He spoke of Ukraine facing a "systemic crisis of governance" and being "scared of change".

TRUMP PAUSES NEW TARIFFS ON CANADA
FOR THREE DAYS, SAYING DEAL CLOSE

US President Donald Trump said he will delay imposing new tariffs on a wide array of Canadian goods for three days as the countries firm up a trade deal. "I have paused the 50% Tariffs against Canada, that were scheduled to kick in tomorrow morning for a three day period, based on the fact that Canada and the U.S.A., subject to the finalization of documents, have a DEAL," Trump said in a social media post. The announcement came less than two hours before a 50% levy on nearly \$20bn (£14.8bn; C\$28bn) of Canadian imports was set to go in place. The two sides have been at an impasse on several issues, including US tariffs on autos and many Canadian provinces banning American liquor sales. Trump and Canadian Prime Minister Mark Carney spoke twice this



week, and trade negotiators have been engaged in intense talks since July, after the US president threatened the new levy with a deadline of 19 August. "Substantial progress has been made, although there is important work still to be done," Carney said in a letter posted on X. In his post, Trump also said a final trade deal could allow the revival of the Keystone XL pipeline. The oil pipeline, which would con-

nect Alberta to the US, was blocked by both the Obama and Biden administrations. Environmentalists and indigenous groups have long opposed the pipeline but Trump has said multiple times he would like to revive the project, which would carry 830,000 barrels of oil a day. "The great Keystone XL Pipeline, long ago killed by Sleepy Joe Biden, may be awoken from the grave!"

Trump wrote on Truth Social. "The deal will include comprehensive market access for all American goods, economic security commitments, digital trade alignment", US Trade Representative Jamieson Greer's office posted on X. It will also include "many important provisions that will continue to protect our market and American workers, along with our Canadian partners", it added. The extension is welcome news for Canadian negotiators and for businesses on both sides of the border, who have warned that the new tariffs would be harmful to both countries. Tensions have mounted between the two major trading partners since Trump returned to office in January last year and he unleashed a wide-ranging global programme of tariffs.

Thai teen found in suitcase died from suffocation, police reveal



A 17-year-old girl whose body was found in a suitcase in Thailand died from suffocation, according to authorities. Police in the coastal city of Pattaya previously said they had found Tunchanok Donhomla's naked body in a bag near a railway track in the early hours of 27 June. This was just 15 minutes after they had arrested 45-year-old Australian man Simon Peter Carman, who was allegedly "preparing to flee the country", they said. On Wednesday, Pattaya City police chief Anek Srathongyoo told the BBC that Tunchanok's autopsy results "showed she died from suffocation". "She also suffered some brain injury but that was not the cause of death," he added. "It could have happened after she died as the accused moved her body in a suitcase before dumping it." Anek further revealed that the DNA found on Tunchanok's body matched Carman's, and suggested that it "likely came from when he put her body in the suitcase". Police are pressing four charges against Carman: murder; concealing or moving the body; kidnapping a child over 15 but under 18; and taking away a child over 15 but under 18 for an indecent act. "[Carman] did not completely deny all the charges initially," Anek said. "He admitted to taking her out. That said, even if he pleads not guilty in court later, I believe we have collected all the evidence thoroughly and closed every loop-

hole in the case in order to prove it to the court that he has committed those crimes." Police will be ready to submit the case to prosecutors by Friday, according to Anek, who noted that the deadline for them to indict Carman was 18 September. Previously released CCTV footage allegedly showed Carman entering a condominium with Tunchanok at 03:34 local time on 25 June. Later that evening, he emerged alone "carrying a large suitcase", according to a police statement. The statement said Carman loaded the bag onto a motorbike before driving towards a railway line. Following his arrest, Carman denied the charges against him and claimed he had acted in self defence. He reportedly told police he had agreed to pay Tunchanok 1,000 baht (\$30; £23) for sexual services, but they had had an argument when they returned to his apartment and he had offered only 500 baht. In a video recorded while he was in custody, the suspect issued a message to Tunchanok's family, saying: "I feel bad for what happened to your daughter. It was out of my control." "I know you'll be very sad, upset... same [as] me," he added. "Please tell other girls... just to be careful." Tunchanok's family previously told the ABC she was an only child who lived with her father and step-mother in the province of Kalasin, about 480km (298 miles) north-east of Pattaya.

SOUTH KOREA SHORTENS WAR GAMES
WITH US, CITING WASHINGTON REQUEST

South Korea's annual joint military drills with the US will be cut short by six days at the request of Washington, its defence ministry has announced. Seoul said that the "period and scale" of the 2026 Ulchi Freedom Shield exercise had been adjusted due to a "proposal of the US side". The drill will now conclude on 21 August, rather than 27 August as planned. It comes after Donald Trump announced plans to curtail exercises with South Korea, citing his "very good" relationship with North Korea's Kim Jong Un. South Korean Foreign Minister Cho Hyun told a parliamentary hearing that neither South Korean nor US officials had been aware in advance about Trump's plans. The combined field training exercise component of the drills will also be "partially reduced in scale", Seoul said, noting that the "specific details" of that reduction are still under discussion. The unprecedented



curtailing shakes South Korea's confidence in America's commitment to come to its aid, under a defence pact that is the foundation of their relationship. It also sends a signal to other US allies in the region like Japan and Taiwan. The announcement comes after US officials told the Wall Street Journal that Trump is pushing his aides for a meeting with Kim Jong Un. Over the weekend, Trump wrote on Truth Social: "These exercises are not only costly, with much of these costs paid for by the

United States of America (as usual), but send a signal that is totally inappropriate and hostile." He added: "While somewhat unrelated (?), I recently asked the President of South Korea if they would like to join us in the Denuclearization of the Islamic Republic of Iran, and they said, 'No thanks!'" Speaking to reporters in the Oval Office on Monday, the president again explicitly linked his decision to South Korea's refusal to "give us a little hand" with Iran. "We have 39,000 soldiers over there guarding

you from Kim Jong Un, your next door neighbour, and you're not going to help us on a very easy military operation in Iran," he said. "That's strange". US and South Korean military leaders announced the Ulchi Freedom shield in a joint press conference last week. At the time, they said the event would be similar in scale to previous years, with about 18,000 South Korean soldiers participating. About 28,500 American military personnel are stationed in South Korea. During the news conference, military leaders also mentioned North Korea's deployment of troops to aid Russia's war against Ukraine. US military spokesperson Ryan Donald said "our training accounts for that threat", referring to North Korean soldiers returning from the battlefield. Following that press conference, North Korea's foreign ministry condemned the joint military drills as "a rehearsal for an aggressive war".

Apparent human remains found in US reservoir as water levels hit record low



Potential human remains, including a jaw with teeth still attached, have been recovered from the largest reservoir in the US, officials said, as an ongoing drought causes water levels to drop across western states. The US National Park Service said it received reports of apparent skeletal remains at Boulder Beach on Lake Mead, Nevada, on 16 August. "National Park Service rangers and the Las Vegas Metropolitan Police Department responded to the scene," the service said in a statement seen by the BBC's US partner CBS. The service added that the incident "remains under investiga-

tion, and no additional information is available at this time". A woman and her friend spotted the bones while visiting the Nevada side of the reservoir, which is located on the border with Arizona. Dianelis Molina Cruz told CBS affiliate KLAS: "My friend was playing with the rocks in the lake, and then he grabbed the jaw. And when he looked, he saw the teeth and everything." Her friend Noel De Leon suggested the low water levels at Lake Mead contributed to the recovery of the potential human remains. "The water looks very low compared to where it should be," he said.



US condemns 'unnecessary escalation' after Israeli airstrikes on Syrian airbase

Mushroom murderer trial undermined by 'catastrophic' hotel mix-up, appeal court told

Lawyers for Australian mushroom murderer Erin Patterson say her conviction was undermined by a "catastrophic" mix-up that led to the jury staying at the same hotel as prosecutors and a key witness. Patterson is serving a life sentence after killing three of her relatives and trying to kill another by serving them a beef Wellington containing death cap mushrooms at her Victoria home in 2023. Her lawyers also argued some evidence in the trial was too speculative, while evidence crucial to their own case was wrongfully excluded. At the same hearing, Victoria's Director of Public Prosecutions is appealing against the sentence, arguing a 33-year parole period is "manifestly inadequate".



Patterson's victims include her in-laws Don and Gail Patterson, both 70, and Gail's sister Heather Wilkinson, 66. Patterson, 51, did not attend the Court of Appeal in Melbourne in person, opting to watch via video link from prison. Also not present was Patterson's estranged husband Simon Patterson, who was meant to attend the deadly lunch but cancelled at the

last minute, in part due to his belief that his wife had been trying to poison him for years. Heather Wilkinson's husband Ian, the only surviving guest of the lunch, was in court. During Wednesday's hearing, the appeal judges heard that while deliberating their verdict, jurors stayed in the same hotel as members of the prosecution team, a key police witness, and journal-

ists. Patterson's barrister Richard Edney said this "catastrophic" situation had "undermined the integrity of the verdicts and requires the quashing of the convictions". He said a retrial was required "so that justice can not only be done but be seen to be done". Director of Public Prosecutions Brendan Kissane accepted it was regrettable but "happened, as far as we can tell... by accident". "The issue is whether there was communication between this jury and any other person," he said. "The evidence as it stands points towards there being no communication. Once the court accepts that, there's no irregularity in this situation, let alone a fundamental irregularity that goes to the root of the trial."

Updated WTC Points Table After India's Huge Win Over Sri Lanka In Galle

In a major boost to their World Test Championship (WTC) final hopes, India on Wednesday beat Sri Lanka by 165 runs in the first Test in Galle. Chasing a target of 372, Sri Lanka were bowled out for 206 on the final day at the picturesque Galle International Stadium. For India, Manav Suthar claimed a six-wicket haul, his second five-for in as many matches. Suthar finished with figures of 6/55 in the innings and match figures of 10/131. While India remained fifth in the WTC points table, their PCT rose from 48.15 to 53.33. Sri Lanka, meanwhile, stayed sixth, but their PCT dropped to 33.33. India couldn't improve their position despite the big win, as Bangladesh, who are fourth in the WTC standings, beat Australia in the opening Test of their series in Darwin last week. Apart from the second Test in Colombo, which starts on August 23, India have seven Tests remaining in the ongo-



ing WTC cycle. Having already lost four of their 10 Tests so far, every remaining game is virtually a knockout for the Shubman Gill-led side. After the series against Sri Lanka, India will travel to New Zealand for a two-Test series in November later this year. To conclude the current WTC cycle, India will host Australia for a five-Test series next year before the Indian Premier League (IPL) window. India must win every remaining Test to have a realistic chance of reaching the WTC final, especially after

Bangladesh's historic victory over Australia in Darwin. If India win seven of their remaining eight Tests, they will finish with a PCT of 68.52. Meanwhile, six wins and two losses would see their PCT drop to 62.96. These scenarios are only possible if India are not docked any penalty points. Therefore, the Shubman Gill-led side have very little margin for error for the remainder of their WTC campaign.



Aryna Sabalenka breezes through as Medvedev loses cool in defeat

World number one Aryna Sabalenka needed just 54 minutes to reach the Cincinnati Open fourth round - but Daniil Medvedev could not hide his frustration after missing three match points in a surprise defeat. Sabalenka did not face a break point in a 6-1 6-3 win over China's Wang Xinyu. The Belarusian lost only six points in eight service games and committed just five unforced errors to 17 winners in a composed performance. It was Sabalenka's easiest win for some time following her fourth-round Wimbledon exit and an early loss in Canada

last week. "To get this win in under an hour [is] an insane result and I'm so happy to be through," the 28-year-old said. "I think I really trusted myself and I was going for my shots without overthinking. "That was the weapon of tonight's match." Sabalenka is the two-time defending champion at the US Open, which begins on Sunday, 30 August. No woman since Serena Williams in 2014 has won the New York title three times in a row. Sabalenka's position as world number one is also under threat from Australian Open champion Elena Rybakina. Four-time major singles champion Sabalenka had a 354-point gap over Rybakina going into Cincinnati. Rybakina must reach the final to have a chance at surpassing Sabalenka. If Sabalenka reaches the quarter-finals, Rybakina would need to win the title to become world number one.

Sabalenka will face Czech Sara Bejlek for a place in the last eight. Earlier, fourth seed Medvedev lost his cool after squandering a match-winning position against Brandon Nakashima. The Russian had fought back from 5-2 down in the first set to take it on a tie-break and had three match points on the American's serve at 5-4 in the second. However, Nakashima saved them and won a subsequent tie-break - then ran away with the third set to win 6-7 (3-7) 7-6 (7-4) 6-1. Medvedev hurled his racket at the electronic boards at the back of the court - briefly breaking it - after missing the match points. He also kicked the screen and knocked over several microphones after committing 51 unforced errors in a poor display. "Down match points, I was just trying to tell myself to keep fighting for every point," Nakashima said. "I'm super happy with the level in the third."

What India Women Need To Do Against England To Qualify For Hockey World Cup Second Round

Unbeaten and brimming with confidence after a strong start to their campaign, India will look to seal a place in the second round of the FIH Women's Hockey World Cup when they take on a desperate England in their final Pool D match on Thursday. A draw will be enough for India to progress as pool toppers, but the team would prefer to secure its passage with another strong performance after holding world number four and Olympic silver medallists China to a 2-2 draw before thrashing South Africa 6-1. India and China are locked on four points each, but India sit atop the pool on a superior goal difference, having scored eight goals and conceded three. England, on three points, have no such cushion and need a victory to keep their campaign alive. That makes Thursday's contest a study in contrasting stakes — India can afford to be cautious, while England have everything to lose. India's biggest strength so far has been their attacking variety. Six different players



scored in the 6-1 demolition of South Africa, underlining the depth in a team where 11 players are making their World Cup debuts. Deepika and Navneet Kaur have already scored twice each, while Lalremsiami and Sunelita Toppo have provided pace and penetration in the forward line. The defence, too, has looked considerably more assured. Led by Sushila Chanu, India conceded just two

penalty corners against South Africa, while goalkeeper Bichu Devi and veteran of more than 300 international appearances Savita Punia have provided solidity at the back. But England represent a different proposition. They have already beaten India 2-0 in the World Cup qualifiers in Hyderabad earlier this year and possess the ability to dominate possession before hitting on the counter.

Their 4-0 win over South Africa underlined their attacking threat, although they subsequently lost 2-4 to China. India coach Sjoerd Marijne knows his team cannot afford to get carried away by its flying start. "We shouldn't rest easy after holding China to a draw and defeating South Africa. England are a very good team and gave China a tough challenge. They are ranked higher than us and have already defeated us this year, so we need to play cautiously," Marijne said. "The quality of passing should be better. We always talk in India about individual skills, but international hockey is all about passing. We were a little bumpy today in passing, not efficient with the direction or receiving," the coach said. For India, the challenge will be to retain the freedom and attacking flair that produced six goals against South Africa while tightening the areas Marijne believes still need work. The team's confidence, meanwhile, stems from more than just results.

Former Wimbledon Finalist Nick Kyrgios Says He Tested Positive For Cocaine

Former Wimbledon finalist Nick Kyrgios revealed on Wednesday he tested positive for cocaine and was provisionally suspended from tennis. The 31-year-old Australian was beaten by Novak Djokovic in the 2022 singles final. He's now ranked 919th after a series of injuries. Kyrgios posted details of the case on social media. "I recently failed a drug test in Mallorca after testing positive for cocaine," he wrote. "I made a huge mistake and take full responsibility for it." Kyrgios said he had difficulties coming to terms with being near the end of his career after two years of injuries. "At times I've felt helpless and alone. None of that excuses what I did," he

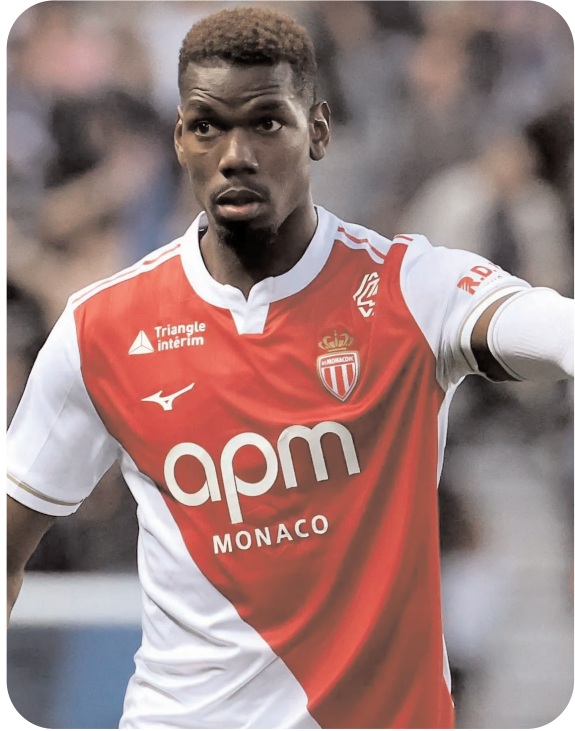


said. Kyrgios got a wild card to play doubles at Wimbledon last month and lost in the first round with partner Alexander Bublik.

Former Manchester United and Juventus midfielder Paul Pogba will be released by Monaco after a series of injuries, the French club said on Wednesday. Monaco said in a statement that the objectives they had set for Pogba were "only partially achieved" and the Ligue 1 club were therefore ending his contract that would have run until June 2027. Pogba is currently sidelined with a thigh injury, just after returning from a knee problem.



Egypt's FIFA World Cup 2026 Coach Hossam Hassan Collapses After Alleged Fight Between Two Wives

Egypt coach Hossam Hassan is back in the news. At the FIFA World Cup 2026, the coach made headlines around the world after his aggressive gesture following Egypt's loss to Argentina. Now, according to multiple reports, Hassan was taken to hospital after an alleged fight involving his wife and ex-wife. The incident reportedly took place at a café in Marina El Alamein on Egypt's North Coast. Hassan's first wife, Howaida Al-Gharbawi, and second wife, Dina Mustafa, were involved in a heated verbal exchange before a physical altercation broke out. A video circulating on social media appears to show the incident, though its authenticity and context remain unclear. According to Spanish outlet Cadena SER, Hassan attempted to defuse the tension



but later collapsed. Egyptian outlet Al-Arabiya subsequently reported that Hassan had divorced his first wife, with whom he has three children, following the incident. "He officially signed the divorce papers at a legal registrar's office in Cairo. Hassan had been with Howaida for decades prior to their sudden split, and the pair have three children," the report said. According to Sky News Arabia, his lawyer

denied rumours that Hassan had suffered a health crisis and stated that he was in good health. Hassan is not only Egypt's coach but also the country's all-time leading scorer, with 69 goals in 177 appearances. The Egyptian Football Association announced in July that national men's team head coach Hossam Hassan's contract had been extended following a solid outing at the FIFA World Cup.

F1'S ALEX ALBON RE-SIGNS WITH WILLIAMS FOR 2027



Formula One constructor Williams announced Tuesday it was extending the contract of driver Alex Albon for next season. The 30-year-old Thai finished eighth in the drivers' standings last year, securing Williams' best result since 2016. Albon joined the British team four years ago and will now stay with them to the end of 2027. "Alex is one of the best drivers on the grid and knows better than anyone the enormous improvements we have made in recent years," Williams' team principal James Vowles said in a statement. "Resigning him shows the belief we both have in the direction we are heading." The deal comes in the wake of Albon bringing up a century of race starts for Williams. In inter-

views with AFP in February, Vowles stated it was "not realistic" for Williams to win the world championship this season or next, before Albon said Williams had started the 2026 campaign "on the back foot compared to our rivals". However, in a statement released by Williams on Tuesday, Albon said: "One tough year doesn't tell the full picture, and it only gives me more motivation to keep building and pushing together with the factory and our fans to achieve great things. "Our story is not over yet, so my full focus now is on doing whatever it takes to get us back up the grid." Coco Gauff Finds A Way Into Cincinnati Masters Fourth Round

Coco Gauff needed to battle following a sizzling first set on Tuesday to complete a 6-1, 7-6 (7/3) victory over Ann Li to reach the fourth round of the ATP-WTA Cincinnati Masters. The 2023 champion had it all her own way in the opening set against her 29th-ranked American compatriot, but it proved more difficult to close the match out in a tight second set. After Gauff swept the first in 30 minutes, the pair exchanged early breaks in the second on the way to a tie-breaker. Gauff sprinted to a 4-1 lead and closed out victory on her third match point. "She

played better in the second set and I missed a couple of break opportunities," Gauff said. "I tried to forget about those. "It was hard to control the ball for both of us and it was my first time playing a day match on this center court so I had to adjust to that." Mirra Andreeva's French Open reigning champion status counted for little as the fifth seed struggled to close out a 6-1, 7-6 (7/5) victory over Janice Tjen. The Indonesian challenger ranked 37 was bowled over in the first set but made Andreeva work to finally advance. Tjen saved two

match points as Andreeva served for the win leading 5-4 and another in the tie-breaker before putting a return wide. "It was two completely different sets," Andreeva said. "In the first I was in command and she had unforced errors here and there. "But in the second after a couple of games I started getting nervous, she made fewer mistakes. "It turned into a match of mentality and physicality. It was not easy -- I had a lot of opportunities to close it out earlier, but even like this I'm super happy." Madison Keys, the 2019 winner, dispatched

Katerina Siniakova 6-1, 6-3 as the American polished her record against the Czech to 3-0. Eighth seed Elina Svitolina was forced to withdraw before her match against Wang Xiyu with an ankle injury. "Unfortunately I tried my best to recover but the injury I sustained in Toronto and also pushed by the second round match, I didn't recover as I wish I could to get ready for my next round," the Ukrainian said in a statement. "I've been advised by the doctors to take a little bit of time to rest and recover completely."
