Indian Navy joins search for three fishermen missing after boat mishaps in Kerala

THIRUVANANTHAPURAM: The Indian Navy on Sunday joined the search operations for three fishermen who went missing following separate boat mishaps in Kollam and Thiruvananthapuram districts, officials said. INS Kalpeni sailed out from Kochi on Saturday night for the search operation, a defence spokesperson said in a statement. The vessel was anchored one nautical mile off Neendakara on Sunday morning, the statement said. "A specialised Indian Navy diving team is onboard the ship. Marine Enforcement Wing was contacted for localising the diving position further. A Marine Enforcement boat is maintaining its presence in the vicinity of the ship," the statement said. The search involving Indian Navy divers commenced around 10 am off INS Kalpeni, officials said.

6TH ROUND OF TALKS BETWEEN JHARKHAND GOVT, STUDENTS PROTESTING EXAM IRREGULARITIES BEGINS

RANCHI: A fresh round of talks between the Jharkhand government and students protesting the alleged irregularities in recruitment exams began on Sunday. The sixth round of talks is being held at the state guest house in Ranchi as the protest entered its 16th day with six demonstrators on indefinite hunger strike. A five-member delegation from the Left-backed students' union AISA is also taking part in the talks. "We are hopeful of a positive outcome over our demands of cancelling the 14th Jharkhand PSC Civil Services Examination and reforms in the Jharkhand Public Service Commission and the Jharkhand Staff Selection Commission (JSSC)," a student leader said.

'TRICOLOUR IS OUR PRIDE': PM Modi calls for public participation in 'Har Ghar Tiranga' campaign

New Delhi (TSIT):

As the nation prepares to celebrate the 80th Independence Day, Prime Minister Narendra Modi on Sunday urged citizens to actively take part in the Centre's 'Har Ghar Tiranga' campaign, terming the Tricolour as 'pride' and 'source of motivation'. This year, the campaign has been organised under the theme of 'Vande Mataram'.

Taking to X, PM Modi reposted a Ministry of Culture post, saying "Our Tricolour is our pride and a constant source of inspiration to always give our best for the nation."

"Let us participate enthusiastically in the 'Har Ghar Tiranga' movement and renew our collective resolve to contribute towards building a Viksit Bharat, he said while underlining this year's theme as that of the national song 'Vande Mataram'."

The Prime Minister mentioned: "Glad that this year's efforts are dedicated to Vande Mataram and that too at a time when we are marking its 150th anniversary." Meanwhile, the Ministry of Culture stated that for 150 years, the call of Vande



Mataram "has stirred the soul of a nation". In a post on X, the ministry said: "This Independence Day, let that same spirit move through every street and every home as India comes together for Har Ghar Tiranga through Tiranga Yatras, Tiranga Rallies, Tiranga Concerts, and mass singing of Vande Mataram."

We are not having any negotiations with the US right now: Iran FM

Tehran (TSIT): Iranian Foreign Minister Seyyed Abbas Aragchi on Sunday stated that there are currently no ongoing negotiations with the United States.

The Foreign Minister's stance came while speaking to reporters at the Centre for Political and International Studies of the Ministry of Foreign Affairs, Iran's semi-official Tasnim News Agency reported. "We currently have no negotiations with the United States.



Intermediaries are still making efforts to find ways to resume negotiations. From our perspective, there can be no resumption

of talks until the United States ends its violations of the Memorandum of Understanding (MoU) and makes amends for the breaches it has committed," Aragchi said.

"Until the violations of the memorandum of understanding by the United States are ended and the United States does not make amends for what it has violated, in our opinion, there is no possibility of resuming negotiations," he noted, according to Tasnim.

He also said that they are in the final stage of negotiations with Oman about determining a new sea route in the Strait of Hormuz.

Experts are working on new routes which will replace the old routes. "Of course, this does not mean the opening of the Strait of Hormuz. This agreement may be reached, but the opening of the Strait of Hormuz is subject to a series of conditions," the Foreign Minister emphasised.

‘Quit Vote Chori’ movement needed against vote theft: CM Shivakumar

Bengaluru (TSIT):

Karnataka Chief Minister and Congress leader D.K. Shivakumar on Sunday called for a statewide 'Quit Vote Chori' (Quit Vote Theft) movement, urging party workers to protect citizens' voting rights amid the ongoing Special Intensive Revision (SIR) of electoral rolls.

Addressing Congress workers at Bharat Jodo Bhavan, the KPCC office, during a programme marking Quit India Day, Shivakumar said the right to vote was fundamental to democracy and urged party workers and Booth Level Agents (BLAs) to ensure that eligible voters were not left out of the electoral rolls.

He asked citizens to complete and submit enumeration forms and urged those who had recently turned 18 to register as voters through Form 6. "Without the right to vote,

you will have no voice," he said, stressing the need to safeguard every eligible citizen's voting rights. Recalling the Quit India Movement, Shivakumar said the slogan today should be "Dictatorial Mindset, Quit Power", while reiterating that the Congress would continue to fight for democracy, constitutional values and national unity.

"The Congress party will

never bow, bend or back down," he said, adding that the party's targets were the 2028 Karnataka Assembly elections and the 2029 Lok Sabha elections. He said the strength and history of the Congress were closely linked with the country's democratic journey. Shivakumar also announced plans to construct 100 Congress offices across Karnataka and said 100 senior

Congress leaders aged above 70 would be honoured for their long-standing service to the party.

10,000 BHARAT JODO YUVA SHAKTI SANGHAS
The Chief Minister said the government was moving ahead with plans to establish 10,000 Bharat Jodo Yuva Shakti Sanghas across gram panchayats and wards in Karnataka. Registration is

expected to begin this month, with youth aged 16 to 40 years eligible to join for a nominal fee of Rs.10.

He said the associations would promote sports, cultural activities, leadership and women's participation among youth. The government would allocate Rs.1,000 crore for the initiative, he added.

Shivakumar further said the government was working to fill 72,000 government vacancies, stressing that greater transparency in recruitment was necessary to create employment opportunities for young people. Highlighting the Congress government's welfare programmes, he cited monthly assistance of Rs.2,000 to 1.21 crore women, free electricity of up to 200 units to 1.61 crore households, distribution of 10 kg of rice to more than 4 crore people, and free bus travel for women across the state.

New criminal laws built on tech, timeline and trust: Amit Shah

Puducherry (TSIT):

Union Home Minister Amit Shah on Sunday said the three new criminal laws introduced by the Narendra Modi government are founded on three key pillars – technology, timeline and trust – and are aimed at ensuring faster and more effective delivery of justice to citizens. Addressing a ceremony after presenting the President's Colour to the Puducherry Police at the Police Training School ground in Gorimedu, HM Shah said the new legal framework marked a significant shift from the colonial-era criminal justice system.

He said greater use of technology and clearly defined timelines for investigation and judicial procedures would help make the criminal justice system more efficient, transparent and citizen-centric.

Building public trust in the justice delivery mechanism was equally important, he added. The three laws – the Bharatiya Nyaya Sanhita,



Bharatiya Nagarik Suraksha Sanhita and Bharatiya Sakshya Adhinyam – replaced the Indian Penal Code, Code of Criminal Procedure and Indian Evidence Act respectively. Congratulating the Puducherry Police on receiving the President's Police Colour, HM Shah described the honour as one of the proudest moments in the history of any disciplined police force.

Despite having a strength of fewer than 5,000 personnel, the Puducherry Police carry the responsibility of maintaining law and order, ensuring internal security and protecting the Union Territory and its people, HM Shah said.

RANCHI: Jharkhand Chief Minister Hemant Soren on Sunday pledged to deliver justice with transparency to youths protesting alleged irregularities in recruitment exams while asserting that dialogue, not batons, can solve all problems at home.

Alleging that vested interests were working at full force to disrupt democracy in the state, he said the students' stir should not be politicised and warned those harbouring political ambitions against misguiding youths.

Soren said the youths' concern was his concern and those involved in exam irregularities will face strict action.

"Unable to accept the state's self-reliance, vested interests are working at full force in Jharkhand to disrupt democracy here. Samvad and not 'lati-danda-bandook' (dialogue, not batons), can solve all problems. "Weapons are meant for enemies at the border. I promise the exam protesters that justice will be delivered with full transparency," the chief minister said, addressing Jharkhand Adivasi Mahotsav here.



Referring to the protest against NEET exam paper leak in Delhi's Jantar Mantar, the chief minister said, "All saw how youths were tortured, had to face pellet guns, baton charges, and were declared traitors." Apparently referring to the BJP, Soren accused rival political parties of trying to mislead Jharkhand's youth by spreading lies and misinformation, and added that intellectuals were also involved in this.

"The stir should not be politicised; I warn those harbouring political ambitions against misguiding youths," he cautioned.

The chief minister asserted his government's commitment to providing justice to the protesting youths and said, "Those guilty of irregularities will face strict action. We caught

theft, will deliver justice." "I urge youths not to seek political patronage (for their stir); justice is your right," he added.

The protests by agitation by the students protesting against alleged irregularities in recruitment exams entered its 16th day on Sunday with six demonstrators on indefinite hunger strike. A sixth round of talks between the government and the agitators is being held at the state guest house in Ranchi. Besides reforms in the Jharkhand Public Service Commission (JPSC) and Jharkhand Staff Selection Commission (JSSC), the protesters are also seeking an independent probe into the alleged irregularities, either by the CBI or by a panel of retired high court judges from outside the state.

US Vice President Vance dials PM Modi, discusses ways to expand India-US partnership

NEW DELHI: US Vice President JD Vance dialled Prime Minister Narendra Modi on Saturday to discuss expanding the India-US comprehensive global strategic ties in trade, defence and energy security amid rising tensions in West Asia.

The two leaders also reaffirmed their commitment to strengthening cooperation in emerging technologies and critical minerals.

Vance's call to the prime minister came days after Turkiye, Saudi Arabia, and Pakistan signed a mutual defence pact that was widely seen as a reflection of a new regional alignment amid the West Asia conflict.

During the conversation, PM Modi extended his congratulations to Vance and Second Lady Usha on the birth of their son.

"Received a phone call from US Vice President JD Vance. We discussed ways to further deepen India-US Comprehensive Global Strategic Partnership across key areas," Modi said on social media.

"Warmly congratulated him and the Second Lady



on the birth of their son and conveyed best wishes to the entire family," he said. An Indian readout said Modi and Vance reviewed progress in the India-US comprehensive global strategic partnership.

"They noted the sustained momentum in the high-level engagements and reaffirmed their commitment to further strengthening cooperation in trade, defence, critical and emerging technologies, energy security and critical minerals," it said.

"They also exchanged views on regional and global developments of mutual interest," it added.

The American side has not yet provided any details of the conversation. It is not immediately known whether the proposed trade deal between India and the US figured in the talks.

PM Modi and US President Donald Trump, during their meeting in France in June, instructed their officials to work towards a balanced, mutually beneficial and com-

mercially meaningful trade agreement at the earliest. The relations witnessed a major downturn after Washington imposed punitive tariffs on India last year and Trump made assertions regarding his role in de-escalating the India-Pakistan military clashes of May 2025 that drew sharp reaction from Indian officials.

Over the next few months, the US president repeatedly and publicly claimed that he had resolved the military conflict between the two neigh-

bours and saved millions of lives as it was heading toward a full-scale war. New Delhi stoutly maintained that the cessation of the hostilities was a result of talks between India and Pakistan and the US had nothing to do with it. Washington's new immigration policy and its decision to increase the H1B visa fee also contributed to the slide in India-US ties. However, both sides made efforts in the last few months to repair the ties and even moved forward to firm up the trade deal soon.

NIA arrests key accused in Kerala illegal explosives seizure case

NEW DELHI: The National Investigation Agency (NIA) has arrested another accused in connection with the seizure of a huge consignment of illegal explosives in Kerala's Malappuram, taking the total number of arrests in the case to ten, officials said on Sunday. The accused identified as Haris TA was arrested on Saturday from Manjeri in Malappuram district, they said. The accused, who is the main conspirator, was involved in the illegal procurement of the explosives seized in the case, a statement issued by the NIA said. The case relates to the seizure of 89,600 explosive sticks and 10,500 shock tubes (NONEL) from a lorry parked in the compound of Farha Hollow Bricks Company on the Chemmad-Thalappara Road in Malappuram on February 7, 2026.

PUDUCHERRY: Union Home Minister Amit Shah presented the President's Colour to Puducherry Police on Sunday and praised the force for its commitment and dedication in ensuring the country's internal security. Referring to the government replacing the British-era criminal laws, including the Indian Penal Code (IPC), Shah said its replacement, the Bharatiya Nyaya Sanhita (BNS) was enacted with the intention of ensuring justice to citizens.

technology, timeline and trust." Underlining Centre's commitment for the UT's growth, he said Prime Minister Narendra Modi's vision over the last 12 years has been to strengthen it.

To make Puducherry strong, a number of many development

initiatives, including investments to the tune of Rs 39,000 crore in the last nine years and road expansion activities worth thousands of crores of rupees have been taken up, he said.

While the UT received about Rs 3,500 crore in Central fund

allocation between 1950 and 2014, the NDA government provided Rs 13,762 crore during the 2014-26 period to it, he added. Various government initiatives, including Lakhpati Didi, Ujjwala and PM Awas schemes, direct benefit transfer and construction of toilets have benefited seven lakh citizens in Puducherry, he said. "Puducherry police has received the Nishaan (President's Colour). In this golden hour, let me assure on PM Modi's behalf, the government is committed to the union territory's development," Shah underlined. Mamata faces protest, mud, slippers, 'chor' slogans during visit to family of deceased TMC worker

KOLKATA: Former West Bengal chief minister Mamata Banerjee faced a hostile reception at Halisahar in North 24 Parganas district on Sunday when protesters surrounded her vehicle, shouted 'chor' (thief) and 'dakait rani' (queen of thieves) slogans, and allegedly hurled mud, slippers and stones at her car as she went to meet the family of a deceased TMC worker. Banerjee, who was visiting the family of a TMC worker who allegedly died in police custody, was forced to pass through a police cordon as the demonstration briefly turned the road into a charged political theatre, with the rival sides trading allegations of conspiracy, provocation and administrative failure. "My car has been attacked with stones, shoes and mud. This is nothing but a conspiracy. I had informed the police that I would be coming, but despite that, no security measures were taken," Banerjee told reporters after reaching the area.

The former chief minister alleged that large bricks were also thrown at her vehicle. "My head could have been smashed. I could have died here," she said, accusing the BJP-led state government of using "goons" to target her. Banerjee also trained her guns on Chief Minister and Home Minister Suwendu Adhikari, saying she had no particular anger against the police but alleging that the force was being used at the behest of the state government.

"The police are protecting the lumpens. Bengal has gone into the hands of lumpens," she said, adding that her party would pursue the matter legally.

MP Prabha Mallikarjuna Inspects Crop Damage in Katanayakanahalli



Davangere: Davangere MP Dr. Prabha Mallikarjuna on Sunday visited Katanayakanahalli village and inspected crop damage in the fields of several farmers. Andhra medico's death: Accused duo booked for attempt to culpable homicide

Amaravati, Aug 9 : Police in Andhra Pradesh's Rajamahendravaram have registered a case of attempt to commit culpable homicide against Suravarapu Daswanth and Andrew Joseph Edwards, who rammed their car into a two-wheeler, critically injuring a medico, at a private mall in the city last week, an official said on Sunday.

The incident had occurred on the night of August 3 when the two youths, who were allegedly under the influence of alcohol, rammed the car into the scooter, causing grievous injuries to PG medical student K. Priyanka, who was pillion-riding.

Dr Priyanka is on a ventilator at a hospital in Hyderabad, and doctors have already declared her brain-dead. East Godavari district Superintendent of Police D. Narasimha Kishore told the media that a case under section 110 (Attempt to commit culpable homicide) of the Bharatiya Nyaya Sanhita (BNS) has been registered against the accused. Dr Priyanka, who was pursuing the Doctor of



Medicine (MD) course at the GSL Medical College, was coming out of the mall with her friend Umesh, a PG student at the same college.

Police investigation revealed that the accused hit the scooter with their car thrice while trying to flee after assaulting mall staff. The SP said the mall staff had not allowed Daswanth and Joseph into the mall as they were found drunk. The accused had an argument with the staff and assaulted them. When the mall security personnel tried to catch them, they tried to escape. They drove the car in a rash manner and at a high speed, ramming the scooter at the mall's gate. After running over the medico with

their car, the accused fled the scene.

An injured Priyanka was rushed to a local hospital. The police received the information from the hospital at 10 p.m.

Based on the statement of Umesh, police registered a case and arrested the accused. The SP said that considering the gravity of the case, they altered the sections to invoke BNS Section 110. He stated that depending on the situation, the police will invoke more stringent provisions to seek the harshest punishment for the guilty. The SP made it clear that there is no political pressure on the police. He said on the direction of Chief Minister N. Chandrababu Naidu, police were investigating the case in an impartial manner. Earlier, Priyanka's father Venkatesh met the police officers and sought stringent action against the accused. He told the media that the assurances given by the police cleared his doubts. He said they have full faith in the police investigation and judiciary and hoped that they will get justice.

Lokesh must quit before CBI probe into DSC scam: YSRCP

Amaravati, Aug 9 : YSR Congress Party MLC Parvathareddy Chandrasekhar Reddy has demanded an immediate CBI investigation into the Mega DSC-2025 'scam' and said Andhra Pradesh Education Minister Nara Lokesh must first resign to ensure a transparent and independent probe.

He clarified that YSRCP was neither seeking cancellation of the DSC (District Selection Committee) exam nor removal of candidates already appointed, but only a comprehensive investigation into the irregularities and justice for deserving candidates.

Speaking at the YSRCP central office at Tadepalli, Chandrasekhar Reddy said the Purama Naveen episode was central to the DSC scam. Naveen, an outsourcing employee in SCERT—the institution involved in question-paper preparation—secured first rank in one category and sixth rank in another, while candidates are now producing evidence that question



papers circulated among students and coaching centres. Similar links are emerging from Madanapalle, Ongole and other districts involving persons connected with question-paper preparation, coaching centres and high-ranking candidates.

He said the Sports Quota recruitment had become a hub of irregularities, with Government Orders designed to bypass examinations, preferential treatment to federations and associations, participation certificates being used for appointments,

misplaced highest-achievement and backup certificates, certificates belonging to different persons being combined, and documents without proper signatures being accepted.

He further charged that Sports Quota certificates uploaded after

YSRCP president and former Chief Minister YS Jagan Mohan Reddy exposed the issue were subsequently tampered with on the government website.

Chandrasekhar Reddy said serious distortions also occurred in TET eligibility, vertical and horizontal reservations and normalisation, with marks increased by as much as six in some sessions even when fractions of a mark could determine selection. He said candidates who questioned these irregularities were instead being targeted with cases, even for songs sung during peaceful protests.

He announced that the DSC irregularities would be raised forcefully in the upcoming Legislative Council session. The MLC reiterated that YSRCP is asking only for a CBI probe. “If there was no wrongdoing, the investigation will clear everyone. Lokesh must resign first and allow the truth to come out,” he added.

EDITORIAL

IT'S THE SMALL THINGS

I do not think about my rights every morning. I wake up, get ready for the office, complain about traffic, answer client emails, think about deadlines, plan week-ends and worry about making it at the gym. My official documents are usually used when I board a flight, book a hotel or file my taxes. They have never been used as documents of survival; they have been documents of convenience. Being born in a Hindu family, I have never wondered whether my name alone would make a landlord hesitate before renting me a home. I have never had to prove that I belong in the country of my birth. My struggles, like those of countless women, have revolved around safety, expectations and the quiet negotiations that accompany everyday life. I have parents who believed my education mattered, a family that respects my career, and the opportunity to build a life I want. I lead a normal life and in the society and country we are in, I have understood my quiet privileges. We often associate privilege with something extravagant. A luxury car, sprawling house, international trips. Perhaps the greatest privilege in India today is much simpler. It is not wealth or luxury. It is not having to think of the institution standing by us. It is the privilege of believing that institutions will continue to function without ever having to test them. To trust that the police will protect you before you need them. To trust that the courts will hear you before you enter one. To trust that expressing an opinion will remain an act of citizenship rather than an act of courage. Democracy, when it works well, disappears into the background of ordinary life. Like drinking water or electricity become known only when interrupted. We inherit rights the way we inherit old buildings. We admire and use them. We forget who laid the foundations. The eight-hour workday did not emerge because employers suddenly discovered compassion. Weekends were not gifts from industry. Restrictions on child labour, workplace safety and countless other protections that shape modern life were granted by decades of revolution and refusal to accept that exploitation was inevitable. History remembers legislation. It often forgets the movement. Every generation enjoys victories that were secured by people willing to become inconvenient. Today, we inherit the outcome so effortlessly that we mistake it for inevitability. India became a constitutional democracy because of generations of resistance and sacrifice. The constitution was an attempt to answer a difficult question: how could a nation of immense diversity remain one community? Its answer begins with the words we were first taught in our history & civics book: The Preamble! “WE, THE PEOPLE OF INDIA, having solemnly resolved to constitute India into a SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC and to secure to all its citizens..” Those words demand more from us than elections do every five years. They ask us to recognise that citizenship precedes ideology, that constitutional values must outlast governments, and that the rights we defend for ourselves become meaningful only when we are willing to defend them for those with whom we disagree. I sometimes wonder when we stopped returning to those words. We remember campaign slogans more easily than constitutional promises. Our disagreements have become sharper than our shared commitments.

The very leader whom political opponents tried to dismiss for years by labeling him 'Pappu' is now holding sessions where young people sit and ask questions. There can hardly be a greater irony in politics than this. However, it would be premature to attribute this solely to a sudden surge in Rahul Gandhi's personal popularity. The real question is: what has changed to make Rahul Gandhi's conversations, Q&A sessions, and education-centric politics appealing to students, the youth, and a segment of Gen-Z? In reality, a generational shift in politics does not come merely from a change in the leaders' ages. Change occurs when the new generation transforms the language, issues, and style of dialogue in politics. India's Gen-Z represents precisely this kind of change. This is a generation that has grown up in an environment of the internet, social media, digital technology, and instant information. They seek direct answers rather than long speeches; they want facts over slogans and results over assurances. That is why today's youth are asking: Why is education expensive? Why are employment opportunities limited? Why do controversies repeatedly arise in competitive examinations? Why do recruitment processes drag on for years? Why must one wait months for results after taking an exam? And most importantly—why does the voice of the youth fail to reach the policy-making table? Over the past few years, Rahul Gandhi has attempted to bring about a significant shift in his political style. He no longer wishes to remain merely a leader who delivers speeches from a stage. Engaging in dialogue with

colleges, universities, students, the youth, teachers, and various social groups has become an integral part of his politics. On numerous occasions, he is seen sitting among young people, listening to their questions, and providing answers. It is perhaps this 'politics of substance' that is attracting Gen Z to some extent. However, it is important to understand one thing here: assuming that the entire Gen Z has rallied behind Rahul Gandhi would be political hyperbole rather than political analysis. India's youth is not the exclusive property of any single political party; they might support the BJP, the Congress, or regional parties—or none of them at all. The youth of today can question a leader just as quickly as they might come to admire them.

To understand Rahul Gandhi's politics, one must also look at the evolution of his public image. For a long time, his opponents tried to portray him as a leader who need not be taken seriously; political epithets like 'Pappu' were part of this very campaign. However, political images are not static. If a leader consistently changes their style, engages with the public, and raises new issues, their old image can gradually fade. Through 'yatras' (marches), dialogues with students, and direct interactions with the youth, Rahul Gandhi has attempted to project himself as a leader who asks questions. While elections will ultimately determine the success of this strategy, a shift in his political presentation is certainly visible. Today, it does not take hours for a leader's speech to reach millions. A video goes viral, sparking both support and opposition; memes are created, debates ensue, and a political message quickly permeates dif-

ferent parts of the country. There can be a vast difference between popularity on social media and electoral success. Therefore, it would be premature to assume that Rahul Gandhi's growing visibility among the youth will automatically translate into electoral support. While there is talk about Rahul Gandhi's 'class' or style, the biggest challenge facing Gen-Z is employment. A student spends years preparing for competitive exams, and their family invests money in their education. Young people dedicate the most crucial years of their lives to the hope of securing a job. Yet, they are often confronted with allegations of irregularities in the examination system, news of paper leaks, stalled results, or recruitment processes that drag on indefinitely.

At such moments, the youth do not merely want to hear political speeches; they want answers. This is precisely where any political party faces its true test. Young people will ask: How long will the recruitment process take? How transparent will the examination system be? When will vacant posts be filled? What will education fees be? How many government jobs will be created? How will employment be generated in the private sector? How will skill development training translate into actual jobs? It is not just the ruling party that must answer these questions; the opposition, too, must provide an answer. This is because, while it is easy for the opposition to raise an issue, presenting a practical solution to it is far more difficult. The issue of the Constitution has become significant in Rahul Gandhi's politics. He has consistently raised topics such as the Constitution, democracy, social justice, and the independence of

institutions. For the younger generation, the Constitution is no longer merely a subject for competitive examinations; they view it in the context of their rights, freedom, equal opportunities, and their future. However, the Constitution is not the exclusive preserve of any single political party. Whether in power or in opposition, the responsibility to safeguard the Constitution rests with everyone. The Constitution's greatest strength lies not in speeches, but in the practice of its values. Therefore, the most effective 'class' on the Constitution for the youth is one where institutions are respected, there is space for dissent, and citizens who ask questions are not treated as enemies. By making the Constitution a central theme of political discourse, Rahul Gandhi is sending a message. His supporters view this as a defense of democratic values, while his detractors see it as a political strategy. The public will judge the truth of the matter.

A defining characteristic of today's youth is their refusal to become permanent followers of anyone. They ask questions. They make comparisons. They watch videos. They seek out data. They listen to the opinions of different leaders on the same issue. And most importantly—they are not afraid to change their minds. This is why it is not easy for any leader to influence Gen-Z. If Rahul Gandhi's 'class' is attracting the youth today, those same young people might well ask him tomorrow: "How do you intend to implement what you have promised?" This represents a healthy form of democracy. In politics, a young person should not remain a permanent student of any single leader; rather, they should be a citizen who questions every leader. Engaging in

dialogue with the youth is a positive step. Sitting among students is commendable. Discussing education, employment, the Constitution, and social justice is also essential. However, the ultimate test of politics lies not in dialogue, but in results. If the Congress party and Rahul Gandhi wish to make the issues facing the youth central to their politics, they must move beyond mere speeches. They need to articulate clearly: how will employment be increased? What changes will be brought to the education system? How will transparency be ensured in competitive examinations? What will be the timeline for the recruitment process? How will entrepreneurial opportunities for the youth be expanded? How will new jobs be created in the era of technology and artificial intelligence? How will skill development be linked to actual employment? Only concrete answers to these questions can transform a 'class' into a political movement, because the public looks at a report card rather than applause. If the Congress truly wishes to advance Rahul Gandhi's youth-centric politics, it must move beyond the strategy of relying solely on him. Continuous dialogue with youth in colleges and universities, understanding the evolving needs of the job market, reaching out to young people in the startup and technology sectors, grasping the issues faced by rural and agrarian youth, and developing a new political language for the digital generation—all these will be essential. Therefore, the fundamental question is not whether Gen-Z liked Rahul Gandhi's 'class'; the core issue is far more significant: has Indian politics finally begun to understand that the

youth are not merely a vote bank? The youth represent the future of the nation's economy. They will become scientists, teachers, farmers, entrepreneurs, soldiers, journalists, and the elected representatives of tomorrow. If their education is weak, employment insecure, faith in the examination system eroded, and the distribution of opportunities unequal, the impact will extend beyond the youth to affect the entire democracy. In this context, the significance of Rahul Gandhi's 'class' could transcend the leader himself—provided it transforms young people into questioning citizens rather than mere supporters of a leader. In a democracy, the ideal scenario is not for the youth to blindly accept what any single leader says; rather, it is for them to question every leader. Thus, Gen-Z need not become permanent students in any single leader's 'class'. Instead, they should attend the broader 'class' of democracy—where the teacher is the Constitution rather than a politician; the textbook consists of the nation's actual challenges rather than a party manifesto; and the examination takes place daily through the public's questions, rather than just once every five years. If Rahul Gandhi's politics is inspiring the youth to think in this direction, it is not merely a signal for Rahul Gandhi or the Congress; it could also mark a significant shift for Indian democracy. For the true strength of democracy emerges when the youth, before applauding, ask a question: "You have said a great deal; now tell us—what will you actually do?" It is precisely this question that marks the true test for any leader—and the real trial for democracy itself.

How Tribal Culture Is Reduced to a Spectacle at Government Events

New Delhi: During Prime Minister Narendra Modi's recent visit to Andhra Pradesh, the traditional Dhimsa dance of the tribal community was performed on a massive scale. More than 13,000 tribal women and schoolgirls took part in the performance, with speculation rife that it may even earn a spot in the Guinness Book of World Records. This large assembly of artists was not organised for an event focused on tribal issues, but rather for the inauguration of an international airport close to Visakhapatnam. Showcasing tribal art and culture at government events is not a recent phenomenon. However, this trend has seen significant growth in the past few years. Tribal folk dances have become an almost mandatory feature of election rallies, official ceremonies, visits by the prime minister and ministers, as well as major political events. The Gaur, Madar, and Rela dances of Chhattisgarh; the Jhumar and Paika of Jharkhand; the Dhimsa of Andhra Pradesh and Odisha; Santhal dances; traditional dances from the Northeast; and various tribal folk dances from Central India often serve as the opening performances for significant political events. However, a recurring question emerges: Is tribal culture being honoured within its social and historical context, or is it merely being exploited as an 'exotic' spectacle to entertain 'others'? The straightforward answer is that the presentation of tribal dances in front of government officials and ministers is directly associated with a colonial mentality. In the British colonial period, tribal commu-



nities were perceived as distinct from the 'mainstream'—regarded as primitive and mere 'curiosities.' Their attire and artistic expressions were displayed akin to an 'exhibition.' Even in contemporary times, the practice of having thousands of tribal individuals don uniform costumes to greet ministers and VIPs at major government events is merely an extension of that colonial mindset. This phenomenon is less about cultural representation and more about serving as entertainment for the ruling class. Part of the Culture The Dhimsa dance is integral to the community identity of tribal groups – specifically the Bhagata, Kondh, Valmiki, Porja, and others – who inhabit the Alluri Sitarama Raju and Parvathipuram Manyam districts of Andhra Pradesh as well as the neighbouring tribal regions, and the Malkangiri and Koraput districts of Odisha. This dance transcends mere entertainment; it serves as a profound cultural expression intricately linked to their history, agricultural practices, connection with

nature, community life, and social relationships. The melodies and rhythms of Dhimsa articulate a life philosophy that emphasises how the community and the natural world are two inseparable entities. Many people from Odisha and Andhra Pradesh criticised the Dhimsa dance performance at the prime minister's event. Retired IAS officer P.V. Ramesh objected to the move, arguing that it was inappropriate to transform a revered cultural tradition into a political spectacle. He alleged that diminishing this tradition to merely a ceremonial welcome for political leaders amounted to an insult to tribal culture. Tribal communities prefer to engage in their dances voluntarily and spontaneously within their villages and among their own people – inspired by love and respect for nature, society, and all facets of their lives. However, the dance has now been commercialised to such an extent that these events can easily be arranged for a modest sum of money. In 2023, I had the opportunity to visit the Araku

Valley, situated on the border between Odisha and Andhra Pradesh. During my visit, I saw tribal women performing the Dhimsa dance, entertaining tourists in exchange for a mere pittance. Tourists danced along, taking photos and recording videos. However, the performance did not convey that this dance was not just an artistic expression for the performers, but a vital component of their cultural and communal lives. This phenomenon does not exclusively plague our country. Tribal culture is showcased in this manner globally. During a trip to the Philippines last year, I attended an exhibition called the 'Butterfly Eco Garden-Tribal Village' in Puerto Princesa, where tribal men, women, and children from Palawan were entertaining tourists while dressed in traditional tribal attire. The Tribal Museum located in Araku, Andhra Pradesh, offers another perspective on this phenomenon. It highlights the life, traditions, and culture of tribal communities, drawing visitors from within the country and abroad.

EDUCATION, FREEDOM AND THE SANGH PARIVAR

The gravest political mistake any authoritarian outfit or leader makes is to start a debate on education. Their entire efforts are usually designed to subvert education and to create an anti-intellect society. Their obsession with education is for destruction of true understanding, they distort history, hype up myths about a great past, inculcate chauvinism and sectarianism in students, resort to falsification and erasure of established facts and devalue rational thinking. Far-right Hungarian nationalist Viktor Orban, who lost power earlier this year, condemned educational institutions as “sites for liberal indoctrination”. The Gen-Z protest has now compelled Rashtriya Swayamsewak Sangh (RSS) chief Mohan Bhagwat to enter the debate on education. That's like stepping on a landmine for RSS. Bhagwat looked desperate not to rub the younger generation up the wrong way and tried to align himself with their sentiment. Conceding that the education system needed reforms, he offered bizarre solutions, arguing that improvement depended on people's mercies and patronage. “Society should bear the financial burden”, he suggested, instead of asking the government to initiate structural changes and reach the desired budgetary allocation of 6% of the Gross Domestic Product (GDP) for education. He didn't utter a word on rising cost of education, autonomy of institutions, academic freedom and reckless ideological interventions. The RSS wants students to conform to a set pattern of ideas. The purpose of

education is to allow students to clear the cobwebs in the mind, step out of seclusion and orthodoxy, and freely wander in the uncharted realms of creativity and knowledge. The RSS doesn't want students to revolt against the existing order and be respectful to tradition and authority. Obedience for them is a greater virtue than reasoning and inquiry. Education shapes a student's outlook to life, creating an integrated thought on society, politics, philosophy and history. But RSS wants students to know what it has concocted. Shouldn't students correctly know who won the battle of Haldighati – Akbar or Rana Pratap? Shouldn't students know about the RSS's role in the freedom struggle? What will an RSS-trained professor teach about Jawaharlal Nehru, one of the greatest freedom fighters and the architect of modern India? Shouldn't students know what ideology led to the assassination of Mahatma Gandhi? Shouldn't students know that Hindutva icon V.D. Savarkar propagated a toxic communal ideology and M.S. Golwalkar felt India could learn racist pride from Nazi Germany? Adolf Hitler used to tell Germans, “We must distrust intelligence and conscience and must place our trust in our instincts.” Bhagwat should clearly tell Indians whether they should place their trust in their instincts or history must be based on credible evidence and objective reality? To put an impressionable young mind into a groove is not education. The RSS succeeded in fooling one generation with its duplicity

and hypocrisy. But the Gen Z can't live with the dichotomy of constitutional principles and communal politics. Bhagwat should clearly tell students whether the principles of equality, liberty, fraternity and justice are to be honoured or not. If yes, how will political or cultural outfits violating the principle of equality be respected by anybody? How can the prime minister who behaves like the chief priest of Hinduism in a secular country be acceptable? An inquisitive mind is bound to ask: What's the worth of an ideology that leads to division, conflict and misery? These children will ask: What's criminal in falling in love with a Muslim or a Christian? If the Constitution allows freedom of choice in personal matters, what's this nonsense of love-jihad? If a citizen is free to eat whatever he wants and do any business, how can the sale of non-vegetarian food be banned during navratri and kanwar yatra? How can chief ministers and ministers take oath of the Constitution and run a divisive agenda? All these aspects of life are linked to education and it is unlikely that the Gen-Z will tolerate this fraud on the Constitution. Lies & double-speak When the RSS chief was saying the Gen-Z protest was not anti-constitutional and anti-national, toxic expressions of his colleagues and followers must have flooded his mind. It was his government that fired pellet guns and teargas shells on students. It was Atul Limaye, third in the RSS hierarchy, who hurled the anti-constitutional and anti-national slur on the young protesters.

Another RSS ideologue from Kerala, T.G. Mohandas said the type of girls who assembled at Jantar Mantar like being gang-raped. Kangana Ranaut, a Bharatiya Janata Party (BJP) MP, called them “Generation Gutter”. Delhi BJP leader Ramesh Bidhuri said the majority of protesters were “aulaad” of puncture-wallah, alluding that they were Muslims. Farmers were also called terrorists and Pakistani agents when they were protesting against the Modi government. Any journalist or politician who questions the RSS-BJP is branded an anti-national and Soros-funded destabiliser. Bhagwat should introspect why such filth comes out of Sangh Parivar ecosystem in any crisis? Is it because of the intrinsic nature of sectarianism or they are trained to malign opponents and dissenters? Does Bhagwat think his soft-soaping the Gen-Z, calling them intelligent and honest, will impress anybody? The younger generation has demonstrated their deep insight and the ability to see through the pretenses. This generation, honest as acknowledged by Bhagwat, will demand honest responses. An honest response is dismissal of Union home minister Amit Shah and strict action against the police officers who crossed the line and allowed goons to assault students. An honest response is a public confession that India is being led in the wrong direction as so much time and energy get wasted on religiosity and artificially created social discord. Lies and double-speak can't override lived experience.

Sensex could eye 79,700, Nifty 25,200 on breakout: Analysts

Mumbai: The near-term technical outlook for Indian equities remains constructive, with analysts expecting the Sensex to target 79,300-79,700 and the Nifty to move towards 25,200 if key resistance levels are decisively breached. However, analysts said markets could see renewed profit booking if crucial support zones are broken. On the Sensex, the index maintained a positive technical structure and closed comfortably above the 78,000 mark. Analysts said the 78,800-79,000 zone will be the immediate resistance area to watch in the coming sessions. "On the downside, the 77,300-77,200 zone remains the immediate support area, followed by the 77,000 psychological level. Holding above these levels will be important to maintain the improving technical structure, while a decisive break below 77,000 could invite renewed selling pressure," an analyst stated. "Overall, the near-term technical outlook remains constructive, with sustained buying above the immediate



resistance zones required to confirm further upside," the analyst added. The Nifty also continued to hold its broader bullish structure despite heightened volatility and intermittent profit booking during the week. "From a technical perspective, the broader structure remains constructive as Nifty continues to trade above all the key weekly exponential moving averages, reinforcing the strength of the medium-to-long-term trend," an analyst said. "The overall chart structure continues to favour a positive bias, although the ongoing consolidation suggests that a decisive breakout is still

awaited. 24,900-25,000 is expected to act as the immediate resistance zone, while 24,100-24,200 remains the key support area," a market expert stated. Meanwhile, Indian markets ended the week with moderate gains despite elevated volatility, as investors assessed the implementation of the new Closing Auction Session (CAS) framework for F&O stocks, the Reserve Bank of India's monetary policy decision and ongoing geopolitical uncertainties. For the week, the Sensex gained 0.52 per cent to close at 78,499.17, while the Nifty advanced 0.77 per cent to settle at 24,570.65.

Bajaj And Hero Flag Entry-Level Motorcycle Weakness As India's Two-Wheeler Boom Turns Uneven



India's two-wheeler industry is growing at its fastest pace in years, but the entry-level motorcycle segment that has traditionally driven volumes is showing clear signs of strain, according to first-quarter FY27 earnings commentary from Bajaj Auto and Hero MotoCorp. Bajaj Auto's joint managing director Rakesh Sharma was the most direct on the trend, telling analysts that the 100cc and 125cc segments were growing at "low-single digit numbers" even as the 150cc-250cc range expanded over 20%. He linked the divergence to income inequality within the customer base, saying "the upper half of the society are economically much, much stronger and the people down the pyramid have weakened," a dynamic he said was now visible in how different engine-

capacity segments were performing. Sharma said Bajaj was prepared to let its 100cc market share erode rather than compete purely on price. The segment's share of the overall motorcycle market has fallen from 55% to around 46% over the past five to seven years, he said, adding that Bajaj would "participate in it at our own terms" and was willing to accept share losses "when growth and profitability... start getting into a conflict situation." The company's strategic focus, he said, has shifted to the 125cc-plus range, where Bajaj plans to launch two new Pulsar models and roughly ten variant refreshes within six weeks, alongside two entirely new brand nameplates in the 125cc segment later in the fiscal year. Hero MotoCorp described a more mixed picture.

Beed Oil Scam Busted: FDA Raids 5 Units, Seizes Over 1 Lakh Kg Substandard Oil

The Maharashtra Food & Drugs Administration (MFDA) seized loose edible oil worth Rs 1.94 crore from multiple establishments in the Beed district on Aug.6 and Aug. 7, according to a press note from the organisation on Sunday. Shrikant Karkale, Joint Commissioner and Nitin Mohite, Assistant Commissioner supervised these operations which targeted establishments that allegedly engage in oil repacking and selling loose oil. The FDA, under the leadership of Commissioner Tukaram Mundhe, suspended the food licences of many famed Mumbai-based culinary fixtures such as Parsi Dairy Farm, K Rustom Ice Cream, Shalimar restaurant, Noor Mohammadi Hotel and Rehmania restaurant, and more recently, various notable sports clubs across the city. The food safety body advised citizens to avoid purchasing loose edible oil and to ensure that it is verified with FSSAI clearance along with a manufacturing and expiry data. "Citizens are advised to purchase edible oil only from licensed vendors and to verify the FSSAI license number, manufacturing and expiry date, and proper labeling on the package," the press not stated. Industries saw 66,653 Kg of edible oil valued at Rs. 1.05 crore seized from its premises by the FDA. Ot flagged "misleading packaging" of soybean oil noting that they were taken from single tank labelled 'Refined' and 'Ultra Refined'. They also allegedly found large-scale use of reused tins, unhygienic premises, no in-house lab, no Certificate of Analysis, no food grade certificates, no medical/pest control records and no technical personnel. Doge overstated claims to have saved Americans \$110bn, watchdog finds



Some estimates made by Doge, the body charged with reducing US government spending, that it saved billions of dollars are "incorrect or lack supporting evidence", a watchdog has found. A report released on Thursday by the Government Accountability Office (GAO) has given an extensive review of Doge's claims about its so-called "Wall of Receipts", which reported savings of \$110bn (£82bn) across contracts, grants and leases. "Several issues limit the transparency and reliability of these reported savings," the report stated. Asked for comment, a White House official said the administration told the GAO that all employees had to complete ethics training and follow financial disclosure requirements. Doge, the Department of Government Efficiency, was not an official government department. It launched at the start of President Trump's second term but closed last month. Its Wall of Receipts was a way of showing its purported savings in taxpayer money online. Elon Musk, the billionaire boss of Tesla and SpaceX who formerly led Doge but left in May 2025, initially promised to save as much as \$2tn a year by slashing federal jobs

and shuttering government programmes, among other cost-cutting measures. Even by Doge's own estimates, it fell short of that goal, as its website claims to have saved an estimated \$214bn. "While Doge provided some information about estimated savings, several issues limit the transparency and reliability of these reported savings," the GAO report stated. It said Doge had not been transparent regarding the methods it used to calculate savings, highlighting it "did not provide sufficient information to verify the method used to calculate 96% of Doge-reported sav-

ings". Among its specific findings was that 108 of the 264 leases identified by Doge for termination were already in the process of ending before the body was established. That accounts for about \$15.3m of the total \$53.5m in savings Doge claimed. "The Wall of Receipts does not include an explanation of how the savings from terminated leases were calculated," the GAO said. Claims were also made about savings that were not achieved, like \$1.7bn for ending a defence department contract for IT services. However, the contract was never terminated and thus no savings were

achieved, according to the congressional watchdog's report. "While the Wall of Receipts includes some information about the data and sources underlying reported savings, it does not sufficiently disclose limitations affecting data quality," it assessed. The GAO audit, which was carried out at the request of Democratic Senators Gary Peters and Richard Blumenthal, covered savings data reported from 20 January 2025 through 7 July 2026. "Everyone supports rooting out waste, fraud, and abuse in the federal government, but Doge was a slapdash and deceptive effort that misled the American people while doing real damage to the government's ability to serve them," Senator Peters said in a statement on Thursday. Under Musk, Doge pushed for massive reductions in the federal workforce, as well as the shuttering of programmes and even agencies such as the US Agency for International Development (USAID). Some of Doge's moves were met with legal fights, or were reversed. When the group's cost-cutting resulted in bird flu officials at the US Department of Agriculture being fired, the Trump administration looked to re-hire them days later.

MOCA Orders Aircraft Accident Investigation Body To Look Into Air India Phuket-Delhi Incident



The Ministry of Civil Aviation of India (MOCA) ordered the Aircraft Accident Investigation Bureau (AAIB) to investigate the Air India Phuket-Delhi flight incident, sources told on Sunday. The development comes after flight AI 2379, operating from Phuket to Delhi, experienced a brief in-flight turbulence-related event during its cruise in the previous week, resulting in injuries to some passengers and crew members, though there were no serious injuries. The aircraft landed safely in Delhi and all passengers and crew have safely disembarked, the airline said, as per reports. The airline said the flight "experienced a brief in-flight turbulence-related event during cruise, resulting in a momentary change in altitude." A minimum of 17 people, including four cabin crew members, suffered injuries in the inci-

dent, according to Civil Aviation Minister K Rammoohan Naidu. He added that some of the crew members have suffered spinal and neck injuries. The DGCA (Directorate General of Civil Aviation) further suspended the two pilots involved with the incident regarding the turbulence-hit aircraft from Phuket to Delhi in the previous week. Both pilots underwent prescribed psychoactive substance screening tests as per sources, with further action to be taken once the results' outcome is known. Further action will be taken based on the outcome of the investigation and confirmatory test results. The screening test in respect of the Pilot-in-Commands (PIC) indicated a result requiring confirmatory testing with the samples being sent to the designated laboratory for confirmatory analysis.

Citing a Telangana study and other examples, the World Bank urged developing countries to expedite the adoption of small, low-cost artificial intelligence tools to improve the lives of millions. The World Development Report 2026: The Promise of Artificial Intelligence, released on Tuesday, August 4, said among economic impacts, AI can help millions of small businesses and farmers become more productive. "In the Indian state of Telangana, for example, an AI weather forecasting system enabled smallholder farmers to alter their behaviour in response to specific risks, causing some to increase farm expenditures by as much as one-third and others to reap net savings of as much as USD 560 per farmer," the report said, citing a 2025



study conducted in Medak and Mahbubnagar districts of Telangana. It said among social impacts, predictive AI analytics and decision support for back-office administrative work in government can have large payoffs. AI helped farmers make better production and investment choices. The report highlighted that AI-generated weather forecasts helped farmers who relied little on information from the government and extension agents—make better production and investment choices. The report is the first comprehensive assessment of AI's implications for developing countries, revealing

how businesses and governments in these countries have begun to use AI. It finds that AI is already helping people, businesses, and governments solve problems, analyse information, improve forecasts, and deliver services at a larger scale. The report suggests that governments could use AI to improve tax collection, social programmes, disaster response, health care, and education. "Today's developing economies missed the first Industrial Revolution and spent the next two centuries paying the price. They cannot afford to miss this one," said Indermit Gill, Senior

Ashmita Chaliha's Big Claim After Korea Masters Triumph

Ashmita Chaliha's breakthrough moment on the BWF World Tour left her struggling to put the achievement into words as the 26-year-old Indian overcame China's fourth-seeded Han Qian Xi 14-21, 21-14, 21-14 in 53 minutes to win the Korea Masters women's singles title on Sunday. "I feel really great; it's unbelievable. I'm still trying to digest it," Ashmita said in a video by Olympics.com after completing a comeback victory that earned her a maiden BWF World Tour crown and moved her closer to a place among the world's top 40. The Indian, ranked No. 50 before the tournament, had to negotiate challenging conditions as she recovered from a slow start in the final. Ashmita initially led 9-5 but was unable to maintain her advantage and surrendered the opening game 14-21. The conditions, however, played a significant



role in how the match unfolded, and Ashmita found her rhythm once she switched sides. "First set was a little bit tricky because of the drift conditions, so I wasn't able to manage it. But then the second set, the other side is more comfortable, and it's a little bit less drift. So I was able to control it. In the third set, when I changed again after 11 points, I was on the good side...so I'm glad that I could pull off." That adjustment proved decisive. Ashmita steadily took control of the

second game before carrying the momentum into the decider, where she kept Han under pressure to close out the biggest title of her career. The triumph also made Ashmita the first Indian to win the Korea Masters, adding another milestone to a season in which she has made significant progress after returning from a three-month injury layoff in May. Her run in Asan was particularly notable given the quality of opposition she overcame.

BRETT LEE SNUBS SACHIN TENDULKAR AS CRICKET'S GOAT



Sachin Tendulkar is the best batter to have ever played the game, and there are very few who doubt that. Even for Australia's pace bowling legend Brett Lee, that remains the case. However, when it comes to picking the greatest cricketer of all time (GOAT), Lee has another name in mind. For him, while there is no denying Tendulkar's prowess with the bat, it is Jacques Kallis, the South African icon, who is the ultimate GOAT in the sport. Speaking on the Beer Biceps podcast, Lee doffed his hat to Tendulkar,

admitting that there has not been a better batter to play the sport. Yet, when evaluating all-round skills, it is Kallis who tops the charts for him. "I've always said that I think that the best batsman to ever play the game is Sachin Tendulkar. But the best cricketer is Jacques Kallis. He's got the best numbers in the world. If you look at his stats, the stats don't lie. He's incredible." Lee and Kallis were rivals on the international circuit, but they became teammates for a brief period in the Indian Premier League.

From Olympic Bronze With PV Sindhu To Back-To-Back Super 300s, Park Tae-Sang's Next Act Takes Shape

Two Super 300 titles. Two different players. Two consecutive weeks. For Park Tae-Sang, it is not just a fortnight of good results. It offers a glimpse of his work that he has been putting in Indian badminton, building players who, he hopes, can become the next generation of Indian stars. Last Sunday, 17-year-old Tanvi Sharma won the Taipei Open. Seven days later, 26-year-old Ashmita Chaliha made a stunning comeback from a career-threatening knee injury to win the Korea Masters. "It's been an amazing two weeks. Last week, Tanvi was also amazing. She is only 17 and won her first BWF-level title. Today, I was even happier because it was Ashmita's first final and she won the title. As a coach, I'm really happy," Park told PTI from Asan, Korea. Park spent four years with PV Sindhu in Hyderabad, a stint that culminated in the Tokyo Olympics bronze medal. After that association ended, he was approached by the Badminton Association of



India about working with younger players. "When I started working with Sindhu, she was already a world champion and had a group of good senior players around her. This time, I thought to myself, 'Okay, let's start from the beginning. I will build these players myself, with my own hands.' The idea was to create a new generation of Indian players." Bigger goal is Olympic qualifying race for 2028 LA Games Three years in National Centre of Excellence, Guwahati and the results are beginning to

show. However, Park sees the two titles as stepping stones to bigger achievements. "I think winning two BWF 300-level titles in the last two weeks is a good achievement, but they are only 300-level tournaments. The players are now looking towards the 500, 750 and 1000-level tournaments," he said. "Our bigger goal is the same for both Tanvi and Ashmita. From May 1 next year, the Olympic qualifying race for the 2028 Los Angeles Games will begin, so next year is going to be very important.

INDIA'S HOCKEY WORLD CUP JOURNEY: FROM GLORY IN 1975 TO YEARS OF NEAR MISSES

India's men's hockey team has had a roller-coaster journey in the World Cup, from winning the inaugural bronze in 1971 to lifting the title in 1975 and then enduring a long wait for another podium finish. The eight-time Olympic champions' only World Cup triumph came in Kuala Lumpur in 1975, when Ajit Pal Singh's side defeated arch-rivals Pakistan 2-1 in the final. Pakistan remain the most successful team in the tournament with four titles, while the Netherlands, Australia and Germany have won it three times each. Belgium are the other champions. Here is a look at India's World Cup journey through the 2023 edition: 1971 Barcelona The World Cup was conceived after India and Pakistan jointly proposed a hockey tournament on the lines of football's World Cup at the FIH Council meeting in 1969. Pakistan were initially awarded the hosting rights, but political tensions between the two countries forced the inaugural edi-



tion to be shifted to Barcelona. India topped Pool A after beating France, Argentina, Kenya and West Germany, but lost 1-2 to Pakistan in the semi-finals. Pakistan went on to beat Spain in the final to become the inaugural champions, while India defeated Kenya 2-1 to take the bronze medal. 1973 Amsterdam India reached the final of the second World Cup in Amsterdam but

missed out on the title after a dramatic finish against hosts the Netherlands. The Indian team finished second in Pool A behind West Germany before beating Pakistan in the semi-finals, with B P Govinda scoring the decisive goal. The final ended 2-2 after extra time before the Netherlands prevailed in the penalty shootout to claim their maiden World Cup title. 1975 Kuala Lumpur

March 15, 1975 remains the defining date in Indian hockey's World Cup history. Led by Ajit Pal Singh, India defeated Pakistan 2-1 in the final to win their only World Cup title so far. Pakistan took the lead, but Surjit Singh equalised in the 44th minute before Ashok Kumar scored the winner in the 51st minute. Seven time Olympic champion India had topped their pool before defeating Malaysia in the semi-finals. 1978 Buenos Aires India's title defence ended in disappointment as the defending champions failed to qualify for the semi-finals and finished sixth. India won three of their six pool matches but suffered two defeats, including a heavy 0-7 loss to West Germany. Pakistan regained the title by defeating the Netherlands 3-2 in the final, while Australia finished third. 1982 Mumbai India hosted the World Cup for the first time in Mumbai but could not make it to the final four, finishing fifth.

Chaos erupted on the Portuguese island of Madeira on Saturday as a bride and groom were mobbed by thousands of fans, who mistook them for football icon Cristiano Ronaldo and his partner, Georgina Rodriguez. The huge crowd had gathered around the Funchal Cathedral amid speculation that Ronaldo and Georgina were set to tie the knot.

Sarfaraz Khan Likely To Replace Injured Sai Sudharsan For Sri Lanka Tests

India batter Sarfaraz Khan is likely to replace injured Sai Sudharsan in the upcoming Test series against Sri Lanka, according to BCCI sources. Sudharsan is understood to have sustained an injury, which could rule him out of the forthcoming series. According to the source, Sarfaraz is likely to be brought into the squad as his replacement. The final decision on the squad is expected to be taken by the Board of Control for Cricket in India (BCCI). "Sarfaraz Khan is likely to replace injured Sai Sudharsan in the upcoming Test series against Sri Lanka," a BCCI source told ANI. Sudharsan has been undergoing rehabilitation at the Centre of Excellence (COE) in Bengaluru and has also participated in batting and fielding drills. However, the batter was unlikely to



regain full fitness in time for the opening Test against Sri Lanka, scheduled to begin in Galle on August 15. Sudharsan also did not take the flight when the Indian team departed for Sri Lanka and thus missed the ongoing three-day warm-up match against Sri Lanka Cricket XI in Colombo, which began on Friday (August 8). Meanwhile, Indian skipper Shubman Gill also sustained an injury to his right ring fin-

ger during a practice session ahead of the first Sri Lanka Test. BCCI posted on X, "Update: Captain Shubman Gill sustained an impact injury to his right ring finger during India's practice on Thursday. As a precautionary measure, he will not take the field on Day 1 of the warm-up game against SLC XI. The BCCI Medical Team is monitoring his progress. KL Rahul will lead the team in Gill's absence."

"DON'T USE THE WORD 'BLAME'":

VVS Laxman Counters Criticism Of Team India's Growing Injury Crisis

The Head of Cricket at the Board of Control for Cricket in India (BCCI) Centre of Excellence (COE), VVS Laxman, attended a press conference along with the board secretary, Devajit Saikia, amid the team's growing injury concern. The likes of Jasprit Bumrah and B Sri Sudharsan are the latest to join a growing injury list, and both are set to miss the upcoming 2-match Test series against Sri Lanka. As critics put the 'blame' on the way CoE is functioning, with some arguing that unfit players are being released to the national team. However, Laxman has rejected suggestions of an accountability breakdown within Indian cricket's medical and selection framework. Addressing queries regarding the clearance processes for



key stars such as Bumrah and Sudharsan, both of whom were initially picked for the Sri Lanka series, Laxman emphasised that player rehabilitation remains strictly objective, data-driven, and player-centric. In response to sharp scrutiny over whether the COE cleared players prematurely or if selection panels picked individuals with-

out complete fitness guarantees, Laxman pushed back firmly against point-scoring. "I think we don't like to use the word 'blame', because when you are using 'blame', then you are finding someone as a scapegoat. I don't think... so maybe I don't know what you all feel, and you start blaming because of this and because of that. But there is a brilliant coordination between the COE, between the team management of both the teams, and the SSM (Sports Science and Medicine) staff of both the teams, and the selection committee."

Top-Ranked Aryna Sabalenka, Jessica Pegula Stunned In Toronto Fourth Round



World number one Aryna Sabalenka and Jessica Pegula were both upset in fourth-round matches on Saturday at the Toronto Masters. Four-time Grand Slam winner Sabalenka suffered a blow to her preparations for a tilt at a third consecutive US Open title, beaten 7-6 (7/3), 4-6, 6-4 by Russian 16th seed Ekaterina Alexandrova. "I wasn't trying to think about the score or anything like beating number one," said Alexandrova after ousting the Belarusian in 2hr 29min. "I was just trying to do my best. I just tried to play every single point as if it was the last one because with her, you don't get a lot of chances during the match." Alexandrova said. "I had a lot today, but I couldn't realize some of them. I'm super

happy that I could win because after the second set, I thought (winning) was already past me." Alexandrova moves on to a quarter-final against Ukraine's Elina Svitolina, who dispatched American Amanda Anisimova 6-2, 6-4 in 78 minutes. Russian 15th seed Shnaider upset world number three Pegula 6-3, 6-3 to book a last-eight date with Poland's Iga Swiatek. The 22-year-old left-hander took only 73 minutes to defeat Pegula. "This week I've been very comfortable on both defending and just firing some winners," Shnaider said. "It was working well. I was choosing a bigger target today but sometimes ripping the ball." Sabalenka dropped the first set on a tiebreak as her Russian opponent won five of the last six points.

Rodrigo de Paul's Beautiful Tribute For Lionel Messi After Scoring For Inter Miami

Rodrigo De Paul, Lionel Messi's teammate for both Argentina and Inter Miami, scored for the Major League Soccer side on Saturday. De Paul picked up the ball outside the penalty area in the 31st minute and unleashed a long-range strike. Monterrey goalkeeper Luis Cardenas was left helpless despite a diving attempt to keep the ball out. After scoring, De Paul removed his shirt to reveal a Messi No. 10 shirt underneath. The gesture appeared to be a tribute to Messi and his

family following the death of the Argentina star's father, Jorge Messi. Jorge Messi had reportedly been admitted to a hospital in Rosario, where he passed away. During the 2026 FIFA World Cup in North America, Messi was noticeably distressed by off-field matters. De Paul, who is said to be one of Messi's closest friends, stood by the Argentina captain during the World Cup and made sure he wasn't forgotten at the club level too. Jorge is survived by his

wife and four children: Lionel, older brothers Rodrigo and Matias, and younger sister Maria Sol. When Messi's emotional distress made headlines during the World Cup, media reports prompted his family to release a statement confirming that "Jorge is experiencing a health issue," without specifying the nature of his condition. "A person's health and the peace of mind of their loved ones should not be the subject of speculation or irresponsible media interest," the statement

read, expressing "discomfort at the lack of sensitivity, respect and scruples with which some people have treated a strictly private family matter." Jorge Messi was a chemical technician and steelworker. He played football as a midfielder, reaching the youth ranks of Newell's Old Boys before having to leave the sport to complete mandatory military service in Argentina. He played a pivotal role in his third son's career, acting as his agent and managing his business affairs. He accompanied a

y o u n g Messi to Barcelona in the early 2000s for the trial that secured his place at La Masia, the club's youth academy. Lionel Messi made his senior professional debut in 2005, going on to win eight Ballon d'Or awards and lead Argentina to the 2022 World Cup title. Lionel Messi's Inter Miami teammate Rodrigo de Paul paid a beautiful tribute to the Argentina icon, who recently lost his father.

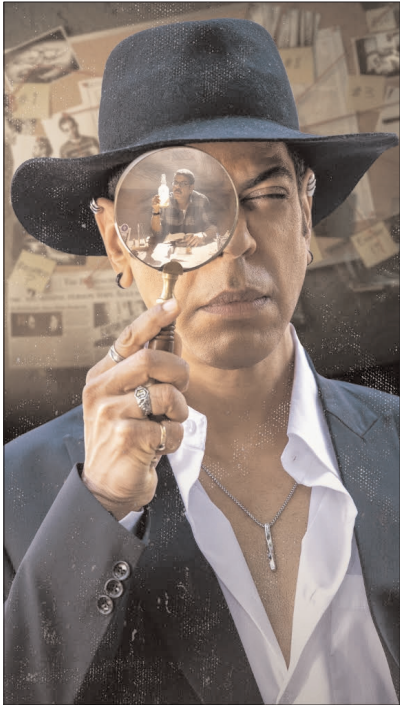

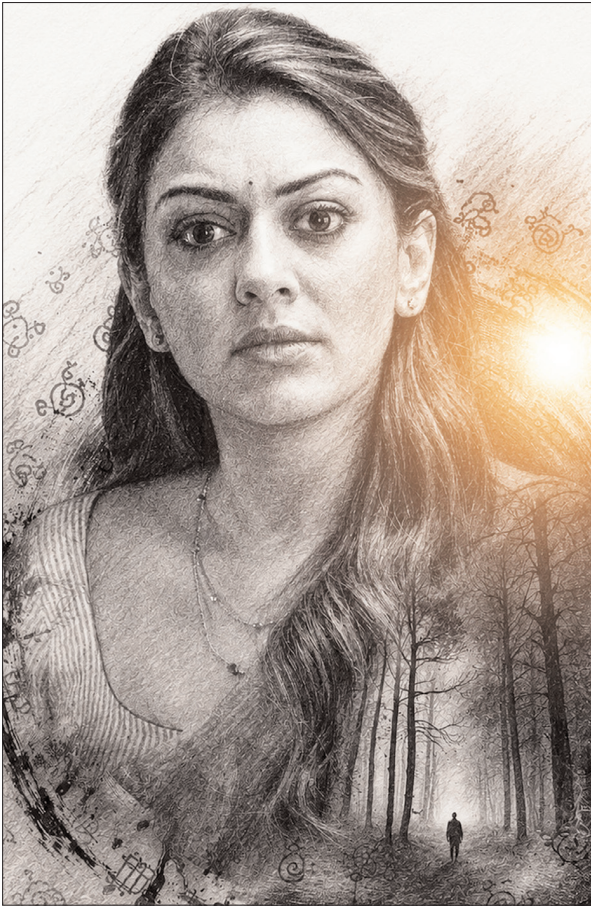
Murali Sharma to Entertain as Detective Jeevan in Sudheer’s Joker

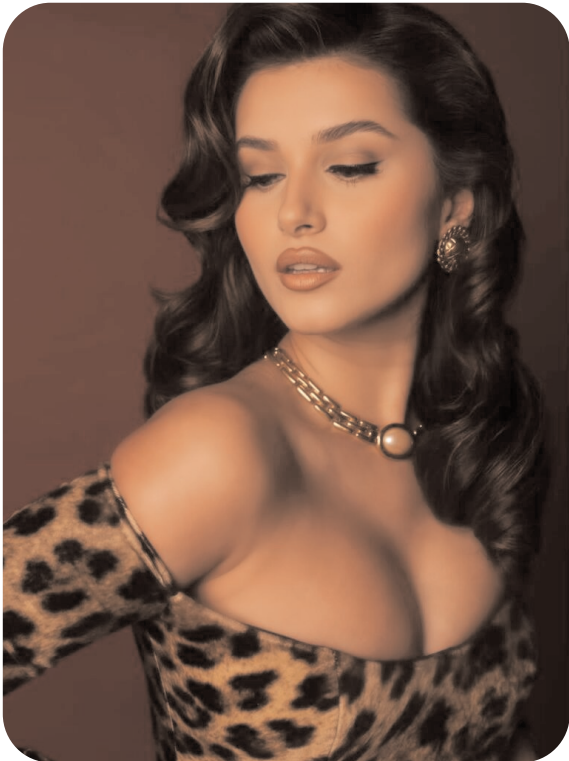
