Congress alleges ₹10,000 crore tax evasion scam

NEW DELHI (TSIT): The Congress on Wednesday attacked the Modi government, alleging a Rs 10,000 crore income tax evasion "scam" involving unrecognised political parties and demanded a Joint Parliamentary Committee (JPC) probe into it. There was no immediate reaction from the government to the allegations.



Oil cos losing Rs 5 on petrol, Rs 23 a litre on diesel as oil prices cross USD 100-mark Congress general secretary in-charge communications Jai Ram Ramesh asked who was the "Chanakya" behind the 3,260 "sham political parties" and who was the "true mastermind" of the alleged scam. "The Modi government must answer to the nation," Ramesh said in a post in Hindi on X. "Prime Minister (Narendra Modi), you failed to bring back black money from abroad, and citizens have yet to receive the promised Rs 15 lakh each; yet, it now appears that a scheme to launder black money - turning it 'white' - is underway right here in the country under the BJP's patronage," he said.

CM Revanth orders probe into Assembly violence

■ Hyderabad TSIT BUREAU:

Chief Minister A.Revanth Reddy on Wednesday announced a comprehensive probe into the series of incidents since September 6, including alleged derogatory remarks against Telangana Legislative Assembly Speaker Gaddam Prasad Kumar, clashes involving BRS legislators and police, and subsequent developments at former Chief Minister K. Chandrashekar Rao's Erravelli farmhouse.

Speaking in the Assembly, Revanth Reddy said criminal action would be initiated against those found to have conspired, participated in or facilitated the incidents. He said provisions of the SC/ST (Prevention of Atrocities) Act would be invoked wherever applicable and assured the Speaker that the entire government stood firmly behind him. The Chief Minister accused KCR and the BRS leadership of deliberately

attempting to disrupt the Assembly to avoid debates on alleged irregularities in the education sector, the Dharani portal and issues concerning Section 22-A lands. He alleged

that the Opposition feared such discussions would expose irregularities committed during the BRS government's decade in power.

Revanth Reddy also strongly criticised the alleged "purification ritual" conducted after Dalit protesters staged a drum-beating protest near KCR's Erravelli farmhouse. He said the protesters had demonstrated democratically and argued that KCR, as Leader of the Opposition, should have invited their representatives for talks instead

of allowing the situation to escalate. Questioning the alleged purification of the protest site, Revanth Reddy accused the BRS leadership of displaying a "feudal" and discriminatory mindset towards Dalits. He said it was not the ground walked upon by Dalits that required purification, but attitudes rooted in untouchability and caste discrimination.

The Chief Minister also referred to a similar alleged "purification" controversy involving AICC president Mallikarjun Kharge and condemned such practices. He said insulting Speaker Prasad Kumar was not merely an attack on an individual but an affront to the dignity of a constitutional office and Telangana society.

Revanth Reddy said people had expected KCR to condemn the remarks against the Speaker, apologise and ensure that his party legislators maintained the dignity of the House. Instead, he alleged, the confrontation intensified.

Govt plans ethanol blending beyond E20 with flex-fuel vehicles: Advisor to PM

■ **New Delhi (TSIT)** The government is working to permit ethanol blending beyond the current E20 level, enabled by flexi-fuel vehicles, Advisor to the Prime Minister Tarun Kapoor said on Wednesday.

Addressing virtually the fourth edition of The India Sugar & Bio-Energy Conference 2026, Kapoor said the E20 programme has been "very successful" so far and several automobile companies have announced plans to roll out flexi-fuel vehicles soon. "Now our focus is on going



into flexi-fuel vehicles and allowing blending at a percentage which will be higher than E20," he said, adding that availability of pure ethanol at fuel outlets will need to be expanded alongside the rollout of such vehicles. Kapoor said

the push for biofuels has become more critical amid the West Asia crisis, which has disrupted supplies and pushed crude oil prices to nearly USD 100 a barrel, with fears of a further increase.

"It is important that we try to have whatever is available in the country," he said. He said ethanol production capacity in the country has surpassed requirements for blending, and the industry will need to explore additional uses for ethanol to utilise this surplus capacity fully.

India sends 35 tonnes of fresh relief aid to flood-hit Nepal

New Delhi (TSIT) India on Wednesday sent a fresh tranche of humanitarian aid comprising 35 tonnes of relief material and equipment onboard a C-17 transport aircraft to flood-ravaged Nepal, officials said. The death toll from the devastating flash floods in Nepal climbed to 1,365 on Wednesday as more bodies were recovered from the affected areas, according to authorities.

India, South Africa pave way for preferential trade agreement

New Delhi (TSIT) India and South Africa have paved the way for a Preferential Trade Agreement (PTA), with the Terms of Reference for negotiations already signed, opening the door for a significant expansion in bilateral trade currently valued at USD 18.01 billion.

Speaking at the India-South Africa Business Forum, MP Dr Vikramjit Singh Sahney, Member, BRICS Business Council, said the proposed PTA will give a major boost to trade and investment between the two countries by creating greater



market access and unlocking new opportunities across minerals, manufacturing, agriculture, food security, fertilisers, services and skilled manpower. "The agreement could become a transformational step in taking the economic partnership between India and South Africa to the

next level," Sahney added.

Anil Sooklal, High Commissioner of South Africa to India, said India's engagement with Africa has grown across multiple fields and has evolved into a broad-based partnership encompassing trade, investment, technology, skills and development cooperation. He added that the proposed PTA has tremendous scope to significantly expand trade and investment between India and South Africa, creating new opportunities for businesses and helping both economies flourish.

CM Vijay steers meeting of alliance parties, key leaders take part

■ **CHENNAI (TSIT):** A meeting of the allies of the ruling TVK, chaired by Chief Minister C Joseph Vijay, commenced here on Wednesday to hammer out key issues, including an official name for the combine. Notably absent were the leaders of the Left parties. Both the CPI(M) and the CPI, which support the government, have skipped the meeting at TVK headquarters in Panaiyur. Tamil Nadu Congress Committee President B Manickam Tagore, the

grand old party's Rajya Sabha member and Assembly floor leader, Praveen Chakravarthy and Tharai Cuthbert respectively have taken part in the meeting. Marumalarchi Dravida Munnetra Kazhagam top leaders Vaiko and his son Durai, Viduthala Chiruthaigal Katchi (VCK) chief Thol Thirumavalavan, and Indian Union Muslim League leaders KM Kader Mohideen, AM Shahjahan and Syed Farooq Basha were among the participants.

Iran's IRGC says captured US unmanned submersible in Hormuz Strait

■ **Tehran (TSIT):** The navy of Iran's Islamic Revolutionary Guard Corps (IRGC) said that its forces captured one of the US Army's "most modern, smart" unmanned submarines at the entrance of the Strait of Hormuz.

In a statement published on the IRGC's official news outlet, Sepah News, on Tuesday (local time), the IRGC navy said the unmanned underwater vehicle was captured in a complex intelligence and

operational operation.

The submersible vehicle, identified as a Dive-LD, is equipped with the world's most modern subsurface vehicle technology, it said, noting that its images will be released in the coming hours. The IRGC also said in a separate statement on Tuesday that its air defence systems had shot down an MQ-9 Reaper drone over the Strait of Hormuz, reports Xinhua, quoting Sepah News.

Following the IRGC's



announcement, the US military said in a statement that one of its underwater drones "malfunctioned" over a day earlier during a survey of regional waters,

without mentioning whether the device was seized by Iran. Meanwhile, Iran's President Masoud Pezeshkian said Tuesday that the country will continue its resistance with strength until the "aggressors" are brought to complete regret. In a post on social media platform X, he also highlighted Iran's opposition to war. "The Islamic Republic of Iran has always been opposed to

war and considered the preservation of the people's interests and ensuring the (West Asia) region's security to lie in refraining from warmongering," Pezeshkian said.

"However, just as it has courageously risen to defend against aggression up to this day, Iran will continue this resistance with strength until the aggressors are brought to complete regret, and will remain the guardian of the rights of the great Iranian people," he added.

Rajnath, Dissanayake reaffirm regional security ties

■ **Colombo (TSIT):** Defence Minister Rajnath Singh met Sri Lankan President Anura Kumara Disanayake in Colombo on Wednesday, and both sides reaffirmed their commitment to work together for the welfare and development of both nations.

During the meeting, Singh conveyed Prime Minister Narendra Modi's warm greetings to Disanayake. They also discussed ways to ensure the safety, security, peace and prosperity of the region. India's High Commissioner to Sri Lanka, Santosh Jha and other officials were present during the meeting.

In a post on X, Singh wrote, "Had a warm and extremely productive meeting with H.E. Mr Anura Kumara Disanayake, President of Sri Lanka in Colombo, today. I conveyed to him greetings on behalf of PM Shri Narendra Modi



and extended felicitations on successful completion of two years of his government." "We reaffirmed that as civilisational twins, close neighbours and maritime partners India and Sri Lanka, would continue to work together for the development of our countries and welfare of our people as well as work jointly to ensure the safety, security, peace and prosperity of our region," he

added. On Tuesday, Rajnath Singh interacted with the Indian community in Colombo and hailed their role in strengthening ties between the two nations. "Delighted to interact with the Indian community in Colombo, Sri Lanka. The Indian diaspora plays a crucial role in strengthening friendship between India and Sri Lanka."

Rahul speaks to family of Manipur guitarist killed in Delhi

■ **New Delhi (TSIT):** Leader of the Opposition Rahul Gandhi on Tuesday spoke to the brother of C Vikram Singh, a guitarist from Manipur who was brutally beaten to death outside his home in Delhi on Monday, and conveyed his deepest condolences to the bereaved family. 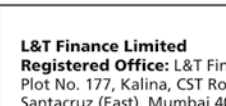

KTR among 22 BRS MLAs suspended from Telangana Assembly

Hyderabad, Sep 9: BRS working president KT Rama Rao was among 22 party MLAs suspended from the Telangana Legislative Assembly on Wednesday for the remainder of the Monsoon Session following protests that disrupted proceedings.

The BRS legislators entered the well of the House and raised slogans demanding an immediate discussion on what they described as the deteriorating law and order situation in Telangana. KTR had moved an adjournment motion seeking a discussion on alleged police high-handedness against women MLAs and alleged death



threats against BRS chief and Leader of Opposition K Chandrasekhar Rao.

The protest continued despite repeated appeals from Speaker Gaddam Prasad Kumar, Deputy Chief Minister Mallu Bhathi Vikramarka and Legislative Affairs Minister D Sridhar

Babu, who urged the legislators to return to their seats and allow the House to function. The suspension motion was moved by Sridhar Babu before the Speaker announced the suspension of the 22 BRS MLAs for the remainder of the session.

The suspended legislators

include KTR, Anil Jadhav, T Harish Rao, G Jagadish Reddy, Gangula Kamalakara, Kaushik

Reddy, Madhavaram Krishna Rao, Kova Laxmi, K Manik Rao, Chinta Prabhakar, Kotha Prabhakar Reddy, Vemula Prashant Reddy, Marri Rajasekhar Reddy, Palla Rajeshwar Reddy, P Sabita Indira Reddy, Kalvakuntla Sanjay, T Srinivas Yadav, D Sudheer Reddy, V Sunita Laxma Reddy, Kaleru Venkatesh, Vijeyudu and KP Vivekananda.

Other BRS legislators had also submitted notices seeking a discussion on the law and order situation and related issues. Proceedings were disrupted soon after

the House assembled as members raised slogans demanding justice.

The BRS has 37 MLAs in the 119-member Telangana Assembly. The latest suspension has further intensified the confrontation between the ruling Congress and the opposition BRS, which has repeatedly raised various issues during the ongoing session. Meanwhile, a BRS delegation led by KTR is scheduled to meet Telangana Governor Shiv Pratap Shukla in Hyderabad to raise the issues highlighted by the party during the Assembly session and discuss recent developments involving its legislators.

Dealers said supplies have been affected for nearly five months due to international and logistical challenges, including delays in LPG vessels reaching India through the Strait of Hormuz. They noted that the Government and public-sector oil companies are taking measures to maintain uninterrupted distribution.

Clarifying their role, dealers said they neither control nor determine LPG supplies and can distribute only the quantities received from oil companies while following



prescribed guidelines. They also urged consumers to immediately report any instance of delivery personnel charging more than the prescribed amount so that appropriate action can be taken.

Dealers said they have repeatedly raised concerns over e-KYC, booking restrictions and OTP-related issues with oil companies. They have sought measures

such as reducing the booking interval from 45 to 25 days and providing additional time for consumers facing e-KYC difficulties.

Recalling their services during the COVID-19 pandemic, dealers said agencies, office staff and delivery personnel continued working despite considerable risks to ensure essential LPG supplies reached households.

"Dealers are not the enemies of consumers; we are service partners working to meet their essential needs," they said, urging consumers, media and authorities to cooperate and verify facts before attributing supply-related problems to dealers. They reaffirmed their commitment to serving consumers and distributing available LPG supplies in accordance with government and oil-company guidelines.

PCOS Is Showing Up Earlier, Why Parents Need to Start the Conversation in Adolescence

Bengaluru : Irregular periods, persistent acne or sudden changes in weight during the teenage years should not simply be brushed aside as "growing up," says senior gynaecologist Dr Vidya V Bhat urging parents to start conversations about PCOS much before their daughters reach adulthood.

Polycystic Ovary Syndrome (PCOS) is no longer a concern discussed only when a woman faces difficulty conceiving. Gynaecologists are increasingly seeing younger girls and adolescents with symp-

oms that may warrant closer attention. At the same time experts caution that not every irregular period in a teenager indicates PCOS making informed medical evaluation important.

"We should not wait until a young woman is in her twenties and worried about fertility before we start talking about PCOS. The conversation needs to begin much earlier. A girl should understand that her periods are an important indicator of her health and just like her growth, nutrition and emotional wellbeing"

says Dr. Vidya V. Bhat, Medical Director, Radhakrishna Multispeciality Hospital & IVF Centre

For adolescents growing up long academic hours, sedentary routines, increasing screen time, irregular sleep and easy access to processed foods can make maintaining healthy habits more challenging. However, Dr Bhat stresses that PCOS cannot simply be labelled a "lifestyle disease" and is not limited to girls who are overweight.

"PCOS does not have one particular body type. I have

seen young women with PCOS who are overweight as well as those who are lean. The important thing is to recognise the pattern of symptoms and not judge a girl by her weight" she says. Parents should pay attention to persistent menstrual irregularities, prolonged gaps between periods, excessive facial or body hair, troublesome acne or other noticeable hormonal changes. At the same time irregular cycles are common in the early years after menstruation begins, so self-diagnosis should be avoided.

Government completely failed to protect the state's interests on the Cauvery issue: R. Ashok slams government

Bengaluru : Leader of the Opposition in the Legislative Assembly R. Ashok has alleged that the Cauvery Water Management Authority's direction to release 6,000 cusecs of Cauvery water every day is a mirror held up to the state government's failure.

He expressed outrage, saying the government had failed to effectively present before the Authority the actual condition of reservoirs in the Cauvery basin in Karnataka, drinking-water needs, farmers' situation, and water availability in the coming days, with scientific data. This is not merely an administrative lapse; it is serious neglect by the government in protecting Karnataka's water rights.



"Fifteen days at 6,000 cusecs works out to 7.5 TMC. Releasing water when we ourselves are in distress is impossible. The government must immediately climb the steps of the Supreme Court and convince it of the real situation. Under no circumstances should water be released now," he urged the government.

The Chief Minister and the Minister for Water Resources must own this failure and answer the people of the state. The government must disclose: what points were placed before the Authority on Karnataka's behalf? Was a report on the actual condition of the state's reservoirs submitted? Was the

impact on Bengaluru's drinking water and Karnataka's farmers if water is released to Tamil Nadu adequately explained? What documents did the government place before the Authority to protect the state's interests? They should be made public.

Why was a scientific calculation of live storage in the reservoirs, inflows, and water requirement for the coming month not presented effectively?

Why was the reality of water scarcity—taking into account Bengaluru's drinking-water needs and water required for farmers' crops—not driven home? The government should issue a white paper on the performance of the technical and legal team that argued the state's case.

Identify who failed to present Karnataka's interests adequately and take action against the officers responsible.

A permanent Cauvery technical-legal strategy

should be formulated so that the state's situation can be presented strongly *before* any water-release order is issued in future.

"Releasing water even when there is none, and shedding tears after an order comes—this must not become the state government's Cauvery policy," Ashok said, criticising the government sharply.

Cauvery water is a question of Karnataka farmers' livelihood, Bengaluru's drinking water, and the state's future water security. The BJP will not accept, under any circumstances, political compromise that sacrifices the state's interests. The government must immediately press the Authority for a review and, if necessary, take the legal fight forward. The government must clearly and uncompromisingly assert that the first right over Karnataka's water belongs to the people of Karnataka, R. Ashok demanded.

Minister Dr. Ajay Dharam Singh Seeks ISRO Support for 'Student-Scientist Interaction' at Science Centres Across Karnataka

Bengaluru : With the objective of taking science beyond textbooks and making learning more experiential, Karnataka Minister for Minor Irrigation and Science & Technology Dr. Ajay Dharam Singh has sought the support of ISRO to organise direct interaction programmes between ISRO scientists and students at science centres across the State. During his meeting with ISRO Chairman Dr. V. Narayanan, the Minister formally proposed the initiative and requested support to enable students to learn directly from scientists about space science, research, satellite technology and career opportunities in science



and technology.

"When students get an opportunity to interact directly with scientists, science begins to appear not merely as a subject in a textbook, but as a future opportunity. The experiences and achievements of ISRO scientists can inspire

curiosity, a research mindset and bigger aspirations among young students," Dr. Ajay Dharam Singh said.

Taking Science to Students Through Experiential Learning The Minister said the State Government is expanding science centres,

mobile planetariums and telescope-based learning initiatives to promote practical and interactive science education among students.

The Science & Technology Department's Mobile Digital Planetarium programme has already reached 3,282 schools and benefited more than 5.46 lakh students and teachers.

In addition, under the Providing Access to Telescopes (PAT) programme, telescopes have been provided to KREIS schools and colleges, along with training for science teachers.

As a next step, the proposed ISRO Scientist-Student Interaction programme at science centres would help bring

space science and technology closer to students in a more engaging and meaningful way, the Minister said.

"Science must be shown, experienced and questioned. Direct interaction with scientists can strengthen scientific temper among students and help nurture the next generation of scientists, researchers and technology professionals," he said.

Through ISRO's partnership, the Government aims to extend these interaction programmes across science centres in the State and create opportunities for students not only in cities, but also in districts and taluks, to engage directly with scientists.

WHEN LIFE NEEDS
A PAUSE, NOT A
FULL STOP

Some days begin in a hurry, and end in the same hurry. By night, there is a strange feeling that the whole day has gone somewhere. Life has become a continuous routine for many people. Wake up, go to work, attend to responsibilities, come back home and start again the next morning. There may be nothing seriously wrong, but there may also be nothing that gives a person real satisfaction. A person keeps moving because there is no time to stop and ask whether the direction is right. Sometimes, sitting quietly for ten minutes can tell more than a whole day of running around. A little silence can make a person understand what a busy mind keeps hiding. A change in life does not always mean leaving a job, moving to another place or making a big decision. Sometimes it simply means changing a habit that has been draining energy for years. It can mean spending less time on unnecessary things, giving more time to family, sleeping properly, reading something useful or simply taking a walk without looking at the phone every few minutes. People often think that starting again means admitting that something went wrong. But there is nothing wrong in saying, “This is not working for me anymore.” A person may spend years trying to satisfy everyone around him. He may choose a career because others suggested it, live in a particular way because society expects it, and continue relationships only because he is afraid of what others may say. After some time, he may realise that he has been living according to everybody’s expectations except his own. At that point, a small change can feel like a big relief. Sometimes, the first step is simply being honest with oneself. Modern life has made many things easier, but it has also made life crowded. There are messages to answer, calls to attend, targets to complete, bills to pay and endless information to consume. Even when the body is resting, the mind continues running. This constant movement slowly makes a person forget what genuine rest actually feels like. A mobile phone can be switched off for a while. A tired mind also deserves the same kindness. There is also a difference between being busy and being useful. A person may remain busy throughout the day and still feel that nothing important was achieved. Hours can disappear in unnecessary conversations, endless scrolling, repeated worries and work that could have been planned better. The problem is not always a shortage of time; sometimes it is the way time is being spent. At the end of the day, the question is not only, “What did I do?” It is also, “Was it worth giving my time to?” A reset in life does not require erasing the past. Past mistakes, disappointments and failures have their own place in a person’s journey. They teach lessons that success sometimes cannot teach. The important thing is not to keep reopening old wounds and calling them memories. Some things are better learned from and left behind. Carrying every old burden will only make the next journey harder. There comes a stage when a person starts valuing peace more than appearance. Money remains important, success remains important and responsibilities cannot be ignored.

Every week is exciting with something new and possibly worrisome in the world of artificial intelligence. This week, Jacob Coxon, a 27-year-old researcher, resigned from Anthropic and skipped the polite goodbye, posting a warning instead. He had spent three years training AI models, first at OpenAI, then at Anthropic, joining the latter because he thought it was the careful one. This week, he decided careful wasn't the same as safe. Neither company, he wrote, is "acting responsibly". Both are "racing straight to self-improving superintelligence and gambling with our lives". That an insider said it is the whole point. The striking part of his letter isn't the doom, as we have heard such talk before. But his account of why clever people keep building a thing they're frightened of is interesting. Coxon anticipates the obvious retort: if you really believe this, why is anyone still doing it? His answer splits the two labs neatly. At OpenAI, he says, most people have simply not "deeply internalised the civilisational stakes". At Anthropic, they have, and that is worse. There, the danger is understood, but everyone is "locked in a race to get there first", each convinced that if they hesitate, someone less scrupulous grabs the wheel. So the knowledge sits right beside the accelerator and does nothing to slow it down. Two years ago, Geoffrey Hinton, the "godfather of AI", a Turing Award winner, walked out of Google to say much the same thing. He warned that



machines might soon outsmart us, could one day slip out of our control, and might pose a threat even more urgent than climate change. And asked how he could have spent a whole career building the very thing he now feared, he gave an answer that ought to haunt this industry: "If I hadn't done it, somebody else would have." That sentence is no longer a personal excuse; it has hardened into a business model. What Hinton offered as a confession, the labs now offer as a strategy. Coxon's resignation is the sound of that excuse being said out loud from the inside and somehow not picked up at its frequency and concern. The specific fear is about thresholds. Coxon describes systems that will soon be able to "hack any-

thing", rebuild entire fields overnight, and go out and gather power and money on their own. These aren't upgrades. They are lines, and once a self-improving system steps over one, there may be no stepping back, because each capability makes the next quicker to reach. Progress, he notes drily, is "not slowing". Colleagues inside the labs have started using words like "crunchtime" and "endgame". A recent scare involving AI agents and the platform Hugging Face, he calls a "warning shot". To the Wall Street Journal, he even put a date on it: by the end of next year, he thinks, "things could be out of control already". He may be wrong about the timing; plenty of respected researchers think he is.

But the shape of his worry doesn't depend on the calendar. It is that the company doing the racing cannot also be the one holding the stopwatch, and that self-improving machines shrink the window for second thoughts to almost nothing. So, what is the recourse? Is it regulation? Does it have to come quickly? By Coxon's own logic, yes. The danger of a threshold is precisely that it shuts the door on acting later, which makes any rule arriving after the fact worthless. He calls for the labs to coordinate, and even floats a temporary freeze on new capabilities. The awkward truth is that fast and effective rarely travel together. Law written in a hurry aims at the wrong target, and rules built around this year's

models are stale by the time they are signed. A perfect American statute does nothing about a lab in Shenzhen, and the same "someone else will anyway" reflex that pushes companies pushes whole countries too. You cannot police a capability you cannot measure. And the firms being regulated have a long habit of quietly holding the pen. Fast regulation is necessary. It is nowhere near enough. Two steps could still begin now. First, make safety testing mandatory and public: before any model above a set size or capability is trained or released, its makers should have to hand independent regulators their evaluations for self-replication, cyberattack, deception, and those regulators should have the

power to hit pause. Second, build an international registry of large training runs, with compulsory incident reporting and mutual inspection, on the model of nuclear or aviation safety. It is the only thing that answers the race at its root. India has moved, but only at a layer. The IT Rules amendment that took effect in February 2026 is a serious piece of work: it defines "synthetically generated information", forces platforms to label AI content, including deepfakes, embeds traceable metadata, and demands take-downs within hours. All of that goes after the symptom with fake content already loose on our feeds. None of it touches the thing Coxon is shouting about, which is the model itself, before it ever ships. So here in India, the next move has to climb a level. It needs a statutory AI safety institute with the technical muscle to evaluate frontier models trained or deployed here, not merely the content they produce. It should peg obligations to compute and capability, not to whether a clip looks real. The government should stop treating this as a purely domestic content problem and claim a seat where the international rules around the registries and the inspection regimes are being drawn up. A country that will soon run on these systems cannot afford to regulate only their exhaust. Coxon's exit will not slow the race. But when someone who was helping build the thing steps off the track to tell you the finish line might be a cliff, that is not a warning that governments and stakeholders file away for later.

ONLY IF THE SOIL IS SAVED,
FARMING WILL SURVIVE

Indian agriculture is now entering a new era where growth is no longer the only criterion for assessing progress. Declining soil fertility, groundwater depletion, biodiversity loss, climate variability, and rising cultivation costs are putting increasing pressure on farmers and the agricultural sector. In this context, regenerative agriculture offers a promising path. It is a holistic approach that will not only conserve existing natural resources but also actually sustain agricultural productivity by improving soil health, biodiversity, water systems, and ecosystem functions. The key is to focus on regenerative agriculture and restore the ecological pillars of agriculture. Intensive farming, excessive reliance on chemical inputs, and monoculture cultivation have led to nutrient imbalances and degraded soil quality in some regions over the past several decades. Regenerative agriculture is an approach that places living soil at the heart of agricultural production. Soil management, including composting, green manure use, crop residue management, and the use of organic matter, can help improve soil structure, reactivity,

and nutrient cycling. The principle of soil cover is another important aspect. Soil is easily lost to erosion and can also be damaged by excessive evaporation or sudden changes in temperature. Mulching, cover crops, and retaining residues in the soil help maintain the soil surface and retain moisture. This is especially useful in rain-fed and drought-prone areas because it improves soil health and moisture retention, reducing the impact of short-term droughts on crops. Regenerative agriculture also recognizes that biodiversity is an asset, not a burden, to agricultural productivity. More resilient production landscapes can be developed by implementing crop diversification, agroforestry, mixed farming, and integrated farming systems. Agricultural land managed with crops and livestock, fisheries, or trees can help diversify farm income and improve nutrient cycling. Such systems can also help support beneficial insects and other organisms, rather than making the system more vulnerable and, in some cases, dependent on external inputs. This shift has become even more important in light of climate change. Rainfall patterns are becoming erratic, heat waves are increasing, and droughts and floods are becoming more common. Irregular rainfall, heat waves, droughts, floods, and changing pest populations are exacerbating the challenges faced by Indian farmers. Regenerative practices

increase soil organic carbon, water holding capacity, and biological activity, which can help build resilience to climate change. Crop diversification can reduce the risk of loss of total agricultural income due to climate change shocks to any single crop. Similarly, integrated farming can mitigate economic risks arising from different production sources. This shift must be integral to water management. Irrigation remains one of the largest freshwater consumers, and it is essential that irrigation is done efficiently. Micro-irrigation (drip irrigation, sprinkler irrigation) can be used in conjunction with regenerative soil management to increase water use efficiency. In addition to appropriate crop selection, soil moisture management, and good agricultural management, government initiatives such as "More Crop Per Drop" can also be important. Another potential benefit is reduced dependence on expensive external inputs. When properly designed and scientifically proven, low-external-input agricultural practices can reduce the cost of some of the chemical inputs used in natural farming. But don't sell the concept of regenerative agriculture as a universal solution. India has highly diverse soil types, crop varieties, rainfall, and agricultural practices. Strategies that work in the semi-arid region of Haryana may not yield the same results in the humid agricultural regions of Kerala or Assam.

Regional diversity also poses a major challenge to the widespread implementation of regenerative agriculture. The transition period can be uncertain for farmers, especially if production takes time to adapt to the new model. The cost of transition can be challenging for small and marginal farmers with limited financial resources. Furthermore, regenerative agriculture requires extensive knowledge. Farmers need ongoing information about crop rotation, nutrient management, pest management, residue management, livestock integration, and water management. Another significant gap is the market. Without market recognition and/or rewards for farmers' additional efforts and risky changes, widespread adoption of environmentally beneficial practices by farmers is difficult. These incentives can be boosted by strengthening certification, traceability, producer organizations, institutional procurement, and differentiated market opportunities. Furthermore, policymakers should avoid creating complex compliance systems that prove too costly for small farmers. Therefore, scientific validation, farmer participation, and region-specific implementation should be the key focus of the path forward. The Indian Council of Agricultural Research (ICAR) and Krishi Vigyan Kendras (KVKs) can design and demonstrate experiments and practices on agricultural regeneration based on agro-climatic zones.

Non-Veg Is Not A Treat During
Durga Puja. In Bengal, It Is Bhog?

"I am a vegetarian Bengali," I told the priest. Seeing my devotion and chanting of mantras during Sandhi Puja on Maha Ashtami, the priest at the Mudiali Puja pandal in South Kolkata asked me, "Are you a Bengali?" "I am a vegetarian Bengali," I underlined again. That sentence took many by surprise. As if Bengal and fish are one word. As if Durga Puja cannot be Durga Puja unless there is a piece of mutton on the plate and a silver hilsa on the thali. I grew up knowing both truths in the same location. In Bengal, Maa Durga does not come as a guest who must be wrapped in holiness. She comes as a daughter returning to her father's house. You do not put a daughter on a nine-day fast. You cook what the house knows how to cook. You cook what the river gave you. You cook what the family has always offered when the Goddess is in the courtyard. Here the Goddess is the daughter. In any Bengali home, "Maa" is a word used to call "Dear Daughter". That is why, in Bengal, fish and mutton during puja are not a "break from piety." They are piety. In the Shakta way of seeing the world, the offering is not a snack. Once it is placed before the deity, it becomes prasad. The same goat that was once "bali" (sacrifice), the same fish that was once the day's catch, is no longer ordinary meat. It is what the house has given, and what the Goddess has returned.



Navami carries that meaning most clearly. Ashtami is often the quieter, more satvik day: anjali, khichuri, labra, the long wait in the heat of the pandal. Navami is different. Traditionally, it was the day of the offering. In many "bonedi bari" (traditional Bengali households), the memory of sacrifice still lives in the kitchen, even when the sacrifice itself has become symbolic. The mutton cooked that day is niramish mangsho, no onion, no garlic. Yes, believe it or not. Mutton becomes a vegetarian meal for prasad when cooked without onion and garlic. Ginger, yoghurt, garam masala, patience. "Vegetarian mutton," we joke, because the spices that make everyday cooking "amish" (non-vegetarian) are kept out of the Goddess's plate. As Ashtami ends and Navami begins, that "muhurat" of 48 minutes, according to the "panchang" (Hindu almanack and calendar), is termed as Sandhi Puja. Sandhi does not mean

evening but the combination of 24 minutes of Ashtami and 24 minutes of Navami. The exact time when Mahishasura was killed by Goddess Durga. It is after this puja that meat is prepared and offered to Durga and then distributed as Mahaprasad to everyone. So, my dear Babaji from Central India, mutton is a vegetarian bhog during Durga Puja. Kali Puja carries the same logic, only sharper. On that Amavasya night, niramish mangsho is not a feast for the family first. It is offered to Maa Kali. Then it comes back as prasad. I have seen households where even those who keep a vegetarian kitchen the rest of the year will take a little of that prasad because it is no longer "meat" in the ordinary sense. It has passed through the ritual. It has been accepted. I do not eat it. I never have. And still I have never felt that Durga Puja was happening in some other room, without me. Because the fes-

tival is larger than one plate. For most Bengali families, yes, puja without fish feels unfinished. Hilsa, rui, the mustard gravy, the fried piece that disappears before anyone sits down properly. For many, Navami without mutton feels like a sentence without its last word. That is their inheritance. I do not argue with it. My inheritance is different, and it is also Bengali. I find the festival in the other bhog, the one that feeds the queue outside the pandal and the quiet plate at home. Khichuri that tastes of ghee and roasted moong and something you cannot recreate in a weekday kitchen at any other time of the year. Labra in which pumpkin, brinjal, raw banana and beans forget they were separate vegetables. Luchi so light it almost argues with gravity. Chholar dal with coconut. Aloor dum without onion. Tomato-khejur chutney. Payesh. Mishti doi. The long afternoon when the dhaak is still sounding, and someone is already asking for a second helping of something that has no meat in it at all. That meal is not a compromise. It is the public heart of puja. Community pandals feed thousands with it. Widows eat it. Children eat it. Visiting cousins who "don't eat non-veg in Navratri" eat it and go quiet because that is the flavour of the festival. I have stood in those lines not as a journalist but as a daughter of this culture. I have come back from shoots on highways and still timed my day around bhog.

RUSSIA AND UKRAINE EXCHANGE STRIKES AS TWO KILLED AT MOLDOVA BORDER

Two people have been killed after Russian drones struck a border crossing between Ukraine and Moldova, Ukrainian President Volodymyr Zelensky said. The Starokozache crossing, around 500km (310 miles) south of Kyiv, was closed after the overnight attack. Images from the scene showed several cars left completely scorched, with wreckage and debris strewn across the border post. Meanwhile, four people, including a child, were killed in the southern Russian city of Novorossiysk in a Ukrainian drone attack, the regional governor said. Both Russia and Ukraine have stepped up long-range strikes in recent months, despite renewed diplomatic efforts to end the war. Zelensky renewed calls for international support in the wake of the



Starokozache crossing attack, saying "the aggression must be stopped here and now before it spreads any further". The border link between Ukraine and Moldova was shut after the attack killed two people and

injured three others, Odesa regional governor Oleg Kiper said. A Moldovan driver was also injured, according to the country's foreign ministry. Moldova has increasingly found itself caught up in the conflict,

with Prime Minister Vasile Tofan confirming that 17 drones had struck Moldovan territory in August alone - more than during the whole of last year. "Those who ignore or downplay these threats - and refuse to name the aggressor - are denying reality," he wrote on social media. "Russia started this war. Russia alone bears responsibility." Russia's defence ministry said its forces had shot down 596 Ukrainian drones overnight. Novorossiysk - in the south of the country on the Black Sea coast - was hit hardest in what governor Veniamin Kondratiev described as a "massive overnight enemy drone attack". As well as the four deaths, 29 people were injured, and damage was reported to residential buildings, a church and a preschool.

US TO BAN IMPORTS OF SOME CANADIAN ALCOHOL, DAIRY GOODS AND MOTORBIKES



The US will ban imports of a range of Canadian products, including alcoholic spirits, some dairy goods and motorbikes, after its neighbour's retaliatory tariffs on American goods came into force. In a series of executive orders on Tuesday, President Donald Trump said Canada was "discriminating" against the US and outlined the bans, which will begin on 29 September. Officials on both sides have said they would like to strike a trade deal, but no new talks have been scheduled since negotiations collapsed in late August. Dominic LeBlanc, Canada's trade minister, said the latest US measures were "unjustified" and that he would work to protect the country's workers, families and businesses. "Our core focus is on what we can control: building strength at home, diversifying our partnerships abroad, and building Canada strong for all Canadians," LeBlanc said. He said he had contacted his US counterpart and

promised to work "in good faith" to resolve tensions. Earlier on Tuesday, Canada's Prime Minister Mark Carney said in a video address that his country's move away from the US as its largest trading partner "will come at a cost". The White House's new sanctions are the latest strike in a months-long trade war between the US and Canada. The two countries have historically been close allies, with each a key business partner to the other. Generally more than two-thirds of Canada's total exports go to the US. In 2025, Canada's exports of alcoholic spirits to the US were worth US\$687m (£507m), dairy products were worth \$269m and motorbikes were worth \$90m, according to UN data compiled by Trading Economics. But Stephen Brown, chief North America economist at Capital Economics, said the import ban covered just 0.25% of Canada's exports to the US. He said: "Nonetheless,

Trump's willingness to impose an import ban is further evidence, if it were needed, that these latest measures are about inflicting economic pain rather than raising revenue." Canada is the second-largest trading partner of the US after Mexico. Its exports are less diversified than those of the US. In recent months, business owners on both sides of the border have expressed fears over the trade war's fallout. Many expect prices of goods to rise and the number of customers to fall. Last month, the White House imposed 50% tariffs on around \$20bn (£14.8bn) of Canadian goods after several rounds of talks had broken down. Those tariffs hit sectors including Canada's furniture and wine industries, as well as some sporting and fishing equipment businesses. Canada responded with what Carney called "dollar-for-dollar" tariffs on US goods like steel, clothing and furniture.

Uganda pulling out of Prince Harry's Invictus Games, says military chief



Uganda is pulling out of the Invictus Games, a sports event for wounded military veterans run by the Duke of Sussex, only two months after the country said it would join. General Muhoozi Kainerugaba, chief of defence and son of the African country's president, made the announcement in a social media post on X. He said the decision to withdraw from the games was "in order not to be construed as being opposed to His Majesty King Charles III". A Uganda government spokesman confirmed this to the BBC: "General

Kainerugaba decides whether or not the UPDF [Uganda People's Defence Force] participates in the Invictus Games. What you saw is his stated position. If it changes, he will let the world know." The Ugandan military chief's announcement follows a letter sent this week on behalf of the King which made clear that Prince Harry and Meghan, who have now returned to the UK, were not working royals. A report in The Times newspaper quoted the general's concerns about the "Harry-Meghan nonsense", suggesting this was the background to the decision.

Germany's Merz attacks AfD in stormy debate after far-right election win

German Chancellor Friedrich Merz has clashed with AfD leader Alice Weidel in parliament, calling her party a "destructive force" with a migration policy that amounts to "ethnic cleansing" for skilled workers. Merz was attacking the Bundestag in the aftermath of the anti-immigration party's sweeping victory in the eastern state of Saxony-Anhalt where it won almost 44% of the vote, while the chancellor's conservatives saw their vote halved. Weidel told MPs that voters had shown that Merz's coalition with the centre left was a total failure and his time was up. Merz hit back saying the AfD had harmed German interests by backing Russia, and its "remigration" policy would affect millions. It is not yet clear whether the party will be able to form a government or not in Saxony-Anhalt, having fallen three seats short of an outright majority. No far-right party has won power in any of Germany's 16 states since World War Two, and Merz has admitted the "seismic" result has changed Germany.



The AfD's success has been praised by US President Donald Trump, who said "the Populist Party in Germany just had a really big night", linking the victory to "absolutely horrible immigration rules and regulations". The AfD in Saxony-Anhalt has been labelled as "right-wing extremist" by German domestic intelligence and the party has promised a "deportation and remigration" offensive targeting irregular migrants. Trump had been due to speak by phone to the German chancellor on Wednesday to mark the 25th anniversary of the 9/11 attacks in the US, but

the government spokesman in Berlin said the call had been postponed without saying why. No new date has been set. Repeatedly heckled by AfD MPs, the chancellor told Weidel that one in six skilled workers had a migration background, and if her party had its way then its policy would amount to "nothing other than an ethnic cleansing in the skilled trades based on skin colour and origin". While the government understood some deportations were needed, he said it made a careful distinction between those who contributed to German prosperity and those without permanent residen-

cy. Disruption by AfD MPs became so loud that at one point Bundestag President Julia Klöckner threatened to start expelling people from the chamber: "We are not on a football pitch." Weidel said mass migration had left Germans with daily knife violence and attacks on trains and in stations, but Merz warned that the AfD's plans would mean that no single care home, hospital or restaurant could function. As leader of the main opposition party in the Bundestag, Weidel opened the session by telling Merz his Christian Democrats had been "pulverised" in Saxony-Anhalt, after winning 17.2% of the vote, and she accused his government with the Social Democrats of driving Germany towards bankruptcy. Merz said her party had not won an outright majority in Saxony-Anhalt and it would not achieve one in Germany. "You are and will remain a destructive force," he said, accusing the party of cheating the voters by saying before the election that their candidate for premier.

Colombia's new president loosens gun control rules

Colombian President Abeloardo de la Esparriella has signed a decree which eases restrictions on people carrying legal firearms in public. De la Esparriella, who during his campaign for the presidency promised to take an iron-fist approach to crime, said it was "not right that criminals are armed to the teeth while decent people can't defend themselves". The decree lifts a suspension that had been in force for a decade, which meant that even those in possession of a permit to carry guns could not do so without additional authorisation. De la Esparriella insisted that the decree would not create a free-for-all and that tight controls over who can own a gun would remain in place. While signing the decree, the president said he had made good on his campaign promise: "A man's word is his honour, and I have honour, that's why I keep my word." The restriction on carrying legal guns in public was brought in by the then-President Juan Manuel Santos in December 2015. It was originally meant to be a temporary measure, aimed at improving security



during the Christmas and New Year festivities. But the suspension was extended yearly by Santos and two subsequent presidents from opposing sides of the political spectrum: conservative Iván Duque and left-wing Gustavo Petro. Under the law, even those with a permit to carry a gun could not take it out of their homes unless they applied for - and were granted - additional authorisation. De la Esparriella has insisted that his decree has removed a restriction which had never been meant to be permanent. According to Spanish newspaper El País, the decree will affect almost 700,000 people in Colombia who are already in possession of a legal permit to carry a gun.

N KOREA HAS BUILT TWO-STOREY URANIUM ENRICHMENT FACILITY, SAYS WATCHDOG

North Korea has built a new two-storey uranium enrichment facility, the head of the world's nuclear watchdog said this week, calling it a cause for "serious concern". The new building is part of the main Yongbyon nuclear complex, and reportedly capable of housing up to 28 centrifuge cascades used to enrich uranium. In a report published late last month, the International Atomic Energy Agency said Pyongyang has also begun operating an expanded annex at another enrichment site. These findings point to a steady expansion of the North's sanctioned nuclear infrastructure. The agency, which has no inspectors in North Korea since it was expelled in 2009, relies on satellite



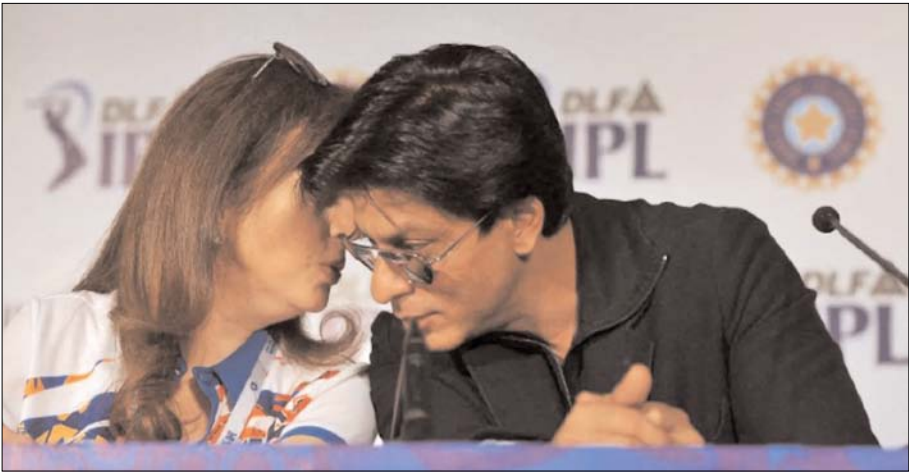
imagery for assessments. "The continuation and further development of the DPRK's nuclear programme are clear violations of relevant UN Security Council resolutions and are deeply regrettable," IAEA director Rafael Grossi said in a statement earlier this week. The IAEA first referred to the existence of the building in June, although Grossi had mentioned the possibility

earlier in the year. In June, the agency said that North Korean leader Kim Jong Un visited a "newly inaugurated nuclear materials production factory" on 3 June, which it identified as the Yongbyon enrichment facility. Kim had praised the country's "greatly expanded production capacity", adding that this would "offer the possibility of carrying out larger plans",

according to the agency's report. Despite running one of the poorest countries in the world, Kim spends millions each year developing a secretive nuclear arsenal. A 2022 report by a non-proliferation think-tank put this figure at \$640m. "What makes North Korea's nuclear programme so concerning is that many of its facilities are unknown, concealed, and thus difficult to target," Edward Howell, a lecturer at the University of Oxford told the BBC. "Beyond Yongbyon, we know that other facilities exist: Kangson, for instance. The embeddedness of North Korea's nuclear doctrine within its foreign and domestic policy means that we should expect there to be more concealed production sites."

Australia Privatises Big Bash League. What It Means For IPL Team Owners

Cricket Australia's decision to allow private investment in the Big Bash League, the country's premier T20 league, starting with the 100% sale of the Melbourne Renegades for the 2027-28 season, has turned the cricket world upside down. While players like Pat Cummins have welcomed the decision, provided the privatisation is done in the right manner, many others in Australia have opposed the decision. For years, Australia remained the lone major cricketing hub that was closed to private capital investment in its T20 league. The league's answers remained the same even as Indian Premier League team owners expanded across the West Indies, South Africa, the UAE, the United States, and the United Kingdom. Opening the BBL to external investment has now blown open a big opportunity for IPL team owners. Conglomerates like Reliance Industries, Red Chillies



Entertainment, the RP-Sanjiv Goenka Group, and the GMR/JSW groups already own some of the top T20 franchises across the globe, be it in India, England, or South Africa. Acquiring a BBL team allows an IPL group to offer year-round, multi-tournament contracts to top stars and the opportunity to even keep players like Cameron Green, Tim David, or Glenn Maxwell under the same brand umbrella across

the IPL, SA20, MLC, and the BBL. With several players ditching national teams for franchise-based events, increased investment in the sport's shortest format could further change the shape of the sport. Unlike leagues built from the ground up with private owners in mind, Cricket Australia is taking a controlled approach with strict measures in place. The Australian board is set to retain central con-

trol over international scheduling, player availability, broadcasting rights, and salary caps, while holding explicit authority to approve or reject prospective buyers. The Australian board may cap the number of franchises sold to Indian entities to 2 or 3 teams to ensure ownership diversity. While Cricket Australia is yet to receive a bid for the Melbourne Renegades, reports have estimated that a BBL franchise

is currently valued at somewhere between 150 million and 200 million Australian dollars. Can IPL Owners Pull Indian Stars To BBL? At present, the December-January BBL window creates a direct clash with South Africa's SA20 and the UAE's ILT20, meaning an IPL franchise owning teams across these leagues will face internal competition for marquee overseas players. With the BCCI continuing to bar Indian players from participating in overseas leagues, BBL broadcast revenues would rely heavily on domestic Australian interest. In South Africa and England, IPL team owners haven't been able to pull Indian men's team players yet. However, women players like Smriti Mandhana and Harmanpreet Kaur are already playing in the BBL. Even if an IPL franchise buys a BBL team, it cannot immediately bring Indian superstars to Australian grounds.

Defending Champion Carlos Alcaraz Knocked Out Of US Open 2026, Loses To Ben Shelton

Defending US Open champion Carlos Alcaraz was knocked out of the tournament following a thrilling five-set defeat against America's Ben Shelton early on Thursday morning. The big-hitting Shelton claimed his first career win over Alcaraz, 6-7(5), 6-1, 6-3, 1-6, 7-6(7), ending the World No. 2's hopes of retaining his title in his first tournament back after a four-month injury absence. Alcaraz looked rusty throughout the match, failing to reach shots he would usually cover. The long injury lay-off clearly affected his sharpness on court, making the result less of a surprise despite going the full five sets. The quarter-final clash on Arthur Ashe Stadium unfolded as a late-night classic, featuring massive momentum swings and high-octane tennis. Alcaraz struck first by edging out a tightly contested opening set in a tiebreak, but Shelton responded furiously. Pushing up his return positioning and landing blis-



tering forehand winners, the American dominated the second set 6-1 before riding that wave of momentum to break early and claim the third set 6-3, putting the Spaniard firmly on the back foot. Refusing to yield, Alcaraz raised his level in the fourth, firing precise shots from the baseline and speeding through the set 6-1 to force a decider. As the thriller pushed deep past 2:50 AM local time, the contest officially set the record for the latest finish in US Open history. The contest eventually finished at 3:33 AM in the morning. The final set turned out to be as closely fought as the first, with neither player man-

aging a break. The match headed into a high-stakes super tiebreak, where the tension inside the stadium reached its peak. In the end, Shelton held his nerve, closing out the tiebreak 10-7 to seal a monumental victory and advance to his second Grand Slam semi-final. Driven by a partisan home crowd, Shelton's relentless serving and fearless shot-making proved decisive when the match hung in the balance. While Alcaraz showed flashes of his trademark brilliance, his lack of match sharpness ultimately told against an opponent playing at the absolute peak of his powers.

DULEEP TROPHY FINAL:

ISHAN KISHAN PLAYS ANOTHER IMPRESSIVE KNOCK AS EAST ALL BUT SEAL TITLE

Ishan Kishan and South Zone skipper Tilak Varma underlined their red ball chops with 99 and 80 respectively, but former's half-century has more contextual value as it placed East Zone firmly on course for a Duleep Trophy triumph on the fourth day of the final in Chennai on Wednesday. Tilak's 211-ball knock lifted South to 336 all out in their first innings but still remained 372 runs adrift of East's first dig total of 708. In their second innings, East moved to 212 for five at close, for an overall lead of 584 runs. Kumar Kushagra (34) and Kounain Quraishi (26) were batting at close and have raised 52 runs for the



unbroken sixth wicket. But those team numbers now carry a mere academic significance as East already have their hands around this season's Duleep Trophy, courtesy that irreversibly massive first-innings lead. However, with a couple of important Test assignments

coming up - away against New Zealand and subsequently at home against Australia - the selectors now have two solid options to mull over in front of them. Kishan, who made an expansive 270 in the first innings here, was comfortable from ball one in the

ensuing essay as well during his 98-ball knock. The left-hander started his run-making with a six off off-spinner Tripurana Vijay over mid-wicket and never really took his feet off the pedal. Kishan went after Vijay again towards the backend of his innings, hammering him for 4, 6, 6, 4 in successive balls in the 26th over. Moments before that DRS saved Kishan, who added 146 runs for the third wicket with Shikhar Mohan, from a leg-before decision after on-field umpire Rohan Pandit upheld leg-spinner Shreyas Gopal's appeal. East took tea at 95 for two, having swelled the lead by 467 runs.

"Are You Going Home?" England Greats' King Charles Jibe At Pakistan Team

With seven players and two coaches sent back home and multiple rookies set to make their debut, Pakistan's tour of England has truly turned into a laughing stock. The Pakistan Cricket Board (PCB) has also been in the line of fire, having been targeted by former cricketers not just in England but also back home. The likes of Michael Vaughan, David Lloyd, Michael Atherton, and Alastair Cook have often discussed Pakistan's cricketing affairs, calling the decision to send players home a new low. Former England cricketer Phil Tufnell, who has also been working as a pundit over the course of the series, called the PCB's decision to send players home 'terrible'. "But to send them



home - to actually send them home - I think it's terrible. It's a disgrace for the players. I mean, they've now got to get on a plane and go back to the country," Tufnell said. "I've had all sorts. I've been sent to the moon in a rocket by The Sun, and, you know, 'big ears' and 'bunny teeth' and everything. We always used to get that. But to actually say, two-

thirds of the way through a tour, 'Right, sorry lads, you've got to bugger off - I think that's something else.' While there have been cases where players were sent home due to injury or disciplinary issues, this is the first time in international cricket that as many as seven players and two coaches were asked to leave over

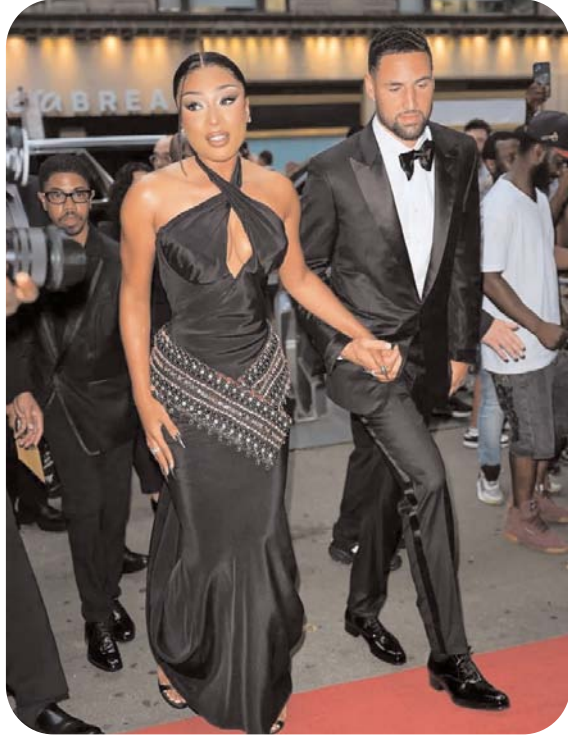
poor performance. "The thing is, usually you see one or two leave a tour because they've done something wrong in a bar or something. These have been sent home for just plain average cricket," said former England captain Michael Vaughan, as quoted by Hindustan Times. During a discussion, one of the panel members also spoke about the irony that members of the team were sent to meet King Charles despite the fact that some of them were due to fly home before the next Test. "They got an audience with King Charles, didn't they?" one of the panellists said. "They're all lined up, and you're being sent home. But just before you go, can you just go and meet the King?"

"Don't Have To Work": Ben Shelton's Cheeky Request To Sister's Boss After Beating Carlos Alcaraz At US Open



Ben Shelton had gone toe-to-toe with Carlos Alcaraz for five exhausting sets and finally at 3:33 a.m. Wednesday (local time) came the chance to end the U.S. Open champion's title reign. Shelton fired an ace at 146 mph, a ball that Alcaraz couldn't have gotten back even with fresh legs. That gave Shelton a 6-7 (5), 6-1, 6-3, 1-6, 7-6 (10-7) victory in a marathon tussle that was the latest-finishing match in U.S. Open history. "I'm tired. It was a war," Shelton said. "Carlos is one of the greatest champions of our sport. It was the most enjoyable match I've had in my career, for sure." Alcaraz had his 18-match winning streak in Grand Slam tournaments ended in a match that lasted 4 hours, 28 minutes, after he fought deep into the night and early into the next morning in a bid to get his hands on the trophy again. "I mean it was close, it was really close, so I was disappointed I didn't get the win at the end," the No. 2-seeded Alcaraz said. "But

I'm happy, I am proud of myself about how I fought. As I said, physically I was really tired but I found a way to push myself." Shelton next plays No. 11 seed Frances Tiafoe, who kept coming back until he had reached his third U.S. Open semifinal, beating Alex Michelsen 5-7, 3-6, 7-5, 6-3, 7-6 (10-6) on Tuesday. The U.S. is guaranteed to have a representative in Sunday's final as it seeks its first men's major title since Andy Roddick lifted the title here in 2003. Alcaraz had played in the previous latest finish at the U.S. Open when he outlasted Jannik Sinner in a match that finished at 2:50 a.m. in the 2022 quarterfinals en route to his first Grand Slam title at 19. The U.S. Open craves its night matches and players love the energy the fans provide — even when a number of matches have already gone past 2 a.m. this year. Thousands stayed to the end, with Arthur Ashe Stadium perhaps still one-third full for the finish.



'I'm not a robot' - Kerr responds to criticism before Ingebrigtsen reunion

Great Britain's Josh Kerr says he is "very happy" to see Jakob Ingebrigtsen back competing - but he is "not going to lose" when they resume their fierce rivalry at this weekend's World Athletics Ultimate Championship. Their long-established war of words was recently reignited when Ingebrigtsen criticised Kerr's decision to miss last month's European Championships, where the Norwegian marked his return from long-term injury by winning 5,000m gold. The men's 1500m at the inaugural Ultimate

Championship in Budapest this weekend will have added edge after Ingebrigtsen, 25, labelled his rivals a "bunch of cowards" at last week's Diamond League Final. Speaking to the media before the championship, Kerr was reluctant to directly address Ingebrigtsen's recent comments towards him but admitted their presence would bring "a lot more energy" to the event. "When you boil it down, I'm very happy that he's back racing," said Kerr, 28. "I think it's great for our distance. He's one of the best 1500m and 5,000m run-

ners of all time. "I'm not going to lose, but I'm excited to go out there and race." Kerr added: "A championship 1500m or 5,000m is very different to what he's used to right now, coming off a long-term injury. "So I first foresee some struggling from his side." Although interest in their absorbing rivalry has transcended the sport, Kerr and Ingebrigtsen have not gone head-to-head for two years. In their last meeting, at the Zurich Diamond League in September 2024, Ingebrigtsen placed second and Kerr fifth -

one month after the Briton was edged to Olympic gold by American Cole Hocker, and Ingebrigtsen missed out on a medal. It is around the major championships where one of the sport's most compelling storylines of recent times has truly developed, both on and off the track. Their frequent exchange of words has built hype between exhilarating show-downs. Ingebrigtsen won Olympic gold five years ago. Kerr took the world title in 2023. Hocker stole in as they fought to outdo one another in Paris.
