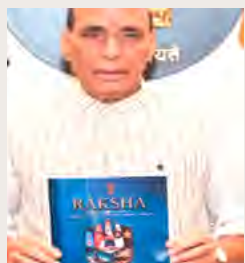

RAJNATH SINGH UNVEILS 'RAKSHA' DEFENCE DIPLOMACY DOCUMENT



New Delhi (TSIT): Defence Minister Rajnath Singh on Thursday released the 'Raksha' document on defence diplomacy that provides an actionable vision for the next decade and ensures India remains an anchor of peace, stability, and rule-based order in an evolving global landscape. The document focuses on Strategic Partnerships, Capacity Building, Indigenous Defence Manufacturing and Exports and Maritime Security, an official statement said. The 'Raksha' document outlines India's strategic roadmap and vision for global defence partnerships over the next 10 years, the statement said. As defence diplomacy is a core pillar of India's foreign policy, the document provides a clear, actionable vision for the next decade, ensuring that India remains an anchor of peace, stability, and rule-based order in an evolving global landscape, the statement said. The document marks a shift in India's strategic engagement, aligning national security objectives with proactive global cooperation, fostering long-term stability and mutual growth.

CM Revanth unveils Old City infra push



HYDERABAD TSIT: Chief Minister A. Revanth Reddy on Thursday announced a series of infrastructure, education and welfare initiatives for Hyderabad's Old City, describing it as the city's "Original City".

Addressing a public meeting after inaugurating the Chanchalguda-Santosh Nagar Steel Flyover, the Chief Minister said the Congress government had provided funds for the project and ensured its completion. He directed officials to consider development works proposed by AIMIM president and Hyderabad MP Asaduddin Owaisi.

Responding to MLA Ahmed Balala's request for Rs.20 crore for college development, Revanth Reddy announced Rs.25 crore for the project and said the MLA would be responsible for completing the works within one-and-a-half years.

The Chief Minister announced

plans for a three-km cable bridge at Mir Alam Tank and said the Metro Rail stretch from Gowliguda to Chandrayangutta would be completed before the next Assembly elections. He also outlined plans to extend Metro connectivity from Nagole through LB Nagar, Chandrayangutta and Rajendranagar to Shamshabad.

Revanth Reddy said one lakh Indiramma houses would be constructed in Hyderabad and reiterated welfare measures including free power up to 200 units for eligible households and LPG cylinders at Rs.500.

On the Musli Riverfront project, the Chief Minister alleged that BJP and BRS leaders were obstructing the government's plans. He said the government would continue with the project and promote a night-time economy to generate employment.

India, Seychelles discuss key cooperation

New Delhi (TSIT): Vice President C P Radhakrishnan met Seychelles' National Assembly Speaker Azarel Ernesta and the visiting parliamentary delegation in New Delhi on Thursday, with discussions centred on deepening the India-Seychelles partnership across key sectors.

"Vice President Shri C P Radhakrishnan warmly welcomed the Parliamentary Delegation from Seychelles headed by H.E. Azarel Ernesta, Speaker of the National Assembly of Seychelles at Parliament House today. The discussions focused on strengthening the India-Seychelles partnership in maritime security, renewable energy, seafood cooperation and capacity building," the Vice President's office said in a post on X. Radhakrishnan also expressed India's readiness to share its AI expertise with Seychelles for parliamentary functioning, including translation and digital archives, while reaffirming the enduring India-Seychelles friendship rooted in shared democratic values and welcoming closer parliamentary engagement.

On Wednesday, Lok Sabha Speaker Om Birla also met Ernesta and the accompanying



parliamentary delegation, holding discussions on deepening parliamentary exchanges and cooperation in capacity building, digital parliament, Artificial Intelligence (AI), technology, infrastructure, renewable energy and healthcare. Birla expressed confidence that the continuous parliamentary engagement between India and Seychelles will give fresh momentum to the bilateral partnership and further strengthen close ties. "It was a pleasure to welcome H.E. Ms. Azarel Ernesta, Speaker of the National Assembly of Seychelles, and the distinguished Parliamentary Delegation to the Parliament of India. Our discussions reaffirmed the enduring India-Seychelles friendship, rooted in shared democratic values, deepening parlia-

mentary exchanges and cooperation in capacity building, Digital Parliament, AI and technology, healthcare, infrastructure and renewable energy," Om Birla mentioned in a post on X after the meeting.

"As we celebrate 50 years of Seychelles' Independence and 50 years of diplomatic relations, we reaffirmed our shared commitment to strengthening the voice of the Global South. Seychelles remains an important partner in advancing India's Vision MAHASAGAR in the Indian Ocean region. I am confident that sustained parliamentary engagement will give fresh momentum to our partnership and further strengthen our close and enduring ties," he added. India and Seychelles share close friendship, understanding and cooperation.

Dipke challenges Modi over degrees



Chandigarh (TSIT) Cockroach Janta Party (CJP) founder Abhijeet Dipke has challenged Prime Minister Narendra Modi to make their educational degrees public, reigniting a controversy over Dipke's educational credentials at Boston University. In a post on X on Thursday, Dipke said he was willing to show his degree from the US university if Prime Minister Modi also agreed to disclose his educational qualifications.

"People are really running out of patience waiting to see my degree. Makes me wonder how they've managed for 12 years without seeing the Prime Minister's," Dipke said. He then directly challenged Modi, writing, "Let's both show our degrees and put an end to this."

The latest exchange comes amid renewed questions on social media over Dipke's claim that he studied at Boston University.

US envoy Sergio Gor's 'Piyush will arrange it' remark sparks row

New Delhi (TSIT): A light-hearted exchange between US Ambassador to India Sergio Gor and Commerce and Industry Minister Piyush Goyal over their friendship has triggered a political row, with Opposition leaders taking exception to the envoy's remark that those unable to reach him could approach Goyal to "arrange" it.

Speaking at an event, Gor described Goyal and his wife as "dear friends" and singled out the Commerce Minister among his favourite Cabinet colleagues, alongside External Affairs Minister S. Jaishankar.

"Since I have arrived in New Delhi, I have two favourite Ministers. One is Honourable Dr Jaishankar



and the second one is my friend Piyush Goyal. So you have somebody who cares deeply about the relationship between the United States and India," Gor said.

He then turned to Goyal's role in facilitating access to the US Embassy.

"Piyush and his wife have truly become dear friends. So a lot of you here have asked me, as I was walking in, about different items related to the US Embassy. If

you can't get a hold of me, reach out to Piyush and he'll arrange it," Gor said. Goyal responded with a joke about the possible consequences of the envoy publicly offering him as a point of contact.

"I'm now worried to call you a friend. If you make such comments, I'll have half of them at my office looking for visa appointments in the US," he said. Goyal has previously credited Gor with playing a "very important role" in the conclusion of the framework for the India-US interim trade agreement, describing the envoy as a friend and well-wisher of the bilateral relationship. The exchange, however, drew criticism from Opposition circles.

Tejashwi slams Centre over Bihar floods

Patna (TSIT) : Bihar Leader of Opposition Tejashwi Yadav on Thursday launched a scathing attack on both the state and Central governments over the worsening flood situation, alleging their failure to devise a permanent solution to a crisis that comes every year. He said the situation on the ground was extremely serious and called for all possible measures and robust arrangements to ensure the safety and rescue of flood-affected residents. He alleged that neither the Bihar government nor the Centre was serious about finding a permanent solution to the recurring flood crisis. He said the governments have failed to adopt a long-term vision, leaving people to face the same disaster year after year. Tejashwi Yadav announced that he would visit flood-affected areas of his assembly constitu-



ency, Raghopur, to assess the situation on the ground and meet residents affected by the floods. He said he would subsequently review relief and rescue operations after discussions with local officials and the concerned ministers. He also vowed to raise the issue strongly before the government and press for effective measures to address the difficulties faced by flood-affected people. Targeting the ruling Janata Dal (United), Tejashwi predicted that the party would cease to exist in the near future.

CM Vijay announces 29,108 police posts

CHENNAI (TSIT): Chief Minister C Joseph Vijay on Thursday (September 3) announced that 29,108 police personnel positions will be created in the police department, including the appointment of 10,000 police personnel this year. He also made other announcements related to the Police, Fire and Rescue services in the Assembly.

- 29,108 personnel to be inducted in Tamil Nadu Police in a phased manner in the next five years.
- Women representation in police force to be increased to 30% from the existing 22%
- Drug Free Tamil Nadu: Every year, 50 Village panchayats in the state that successfully curb drug abuse to get Rs 10 lakh cash reward.
- Rs 212 crore for Police modernisation
- Rs 1 crore solarium for family of police personnel who for valorous



- death while on duty

Free Training Can Help Unemployed Youth Secure Jobs: Seethakka

MULUGU, September 3, TSIT: Panchayat Raj and Rural Development Minister Danasari Anasuya Seethakka urged unemployed youth to make consistent efforts to achieve their career goals, saying free coaching and study material can help them secure government jobs.

Five UP Youths Arrested in Ganja Case in Toopran



TOOPRAN, September 3, TSIT: Toopran police arrested five youths from Uttar Pradesh for their alleged involvement in a ganja case in the Shabashpally area and seized around 100 grams of the contraband.

According to police, Alauddin, Lavkush, Hansraj, Dinesh and Yastamikumar had come to the area seeking employment at a private company. During checks based on credible information, police

allegedly found that Alauddin and Lavkush had brought ganja with them. During the subsequent investigation, police identified three more persons allegedly linked to the case. A case was registered against all five, and they were arrested and produced before a court.

The operation was conducted under the supervision of Toopran CI Venkataraja Goud, with SIs Gangaraju and Yadagiri and other police personnel participating. Police said stringent action would be taken against the illegal transportation, possession and consumption of ganja and other narcotic substances. CI Venkataraja Goud warned that those involved in such activities would face legal action.

TTD reviews medical arrangements for Brahmotsavams



Tirumala, 03 September 2026: In view of the annual Srivari Salakatia Brahmotsavams to be held in Tirumala from September 15 to 23, TTD Additional EO Sri Ch. Venkaiah Chowdary conducted a review meeting at his camp office in Tirumala on Thursday evening on medical services, transport arrangements and police security. On this occasion, TTD Chief Medical Officer Dr. Kusuma Kumari briefed the Additional EO on the medical facilities to be made available to devotees. She informed that Ashwini Hospital and Apollo Cardiac Centre in Tirumala will function round the clock throughout the Brahmotsavams to provide medical services to devotees. Six dispensaries will be set up at Vaikuntam Queue Complex-I and II, Gali Gopuram, ATC, Kalyanakatta and PAC-5. In addition, 10 first-aid centres will be established at PAC-2, Bhashyakarla Sannidhi, Alipiri Rajagopuram, 1,500th Step, Seventh Mile, Srivari Mettu 1,200th Step, Matrusri Tarigonda Vengamamba Annaprasadam Complex, Srivari Temple, Narayanagiri sheds and the darshan queue lines. One mobile clinic will also be stationed between Krishnateja Circle and Gogarbhram Circle. Six new medical camps will be established at Ram Bagicha, Sila Thoranam, Papavinasanam, Srivari Seva Sadan, Srivari Mettu and Alipiri Padala Mandapam. She further informed that, in addition to the existing 11 doctors and 139 paramedical staff, another 75 doctors and 60 paramedical staff will be deployed during the Brahmotsavams. A total of 16 ambulances will be made available in Tirumala for emergency medical services.

Andhra Pradesh High Court Dismisses 50 Petitions Challenging Ward Delimitation



Amaravati: The Andhra Pradesh High Court has dismissed all 50 petitions challenging the delimitation and reorganisation of wards in municipal bodies across the state. The petitions were filed opposing the proposed redivision of wards in municipalities. The petitioners argued that carrying out the ward delimitation while the Special Intensive Revision (SIR) process was underway was not appropriate. The State government, however, told the court that it was not altering the extent or geographical limits of the wards arbitrarily and that the entire

exercise was being carried out strictly in accordance with the provisions of the law. After hearing the arguments from both sides, the High Court on Thursday dismissed all the petitions challenging the delimitation process. With the court's decision, the way has been cleared for the conduct of local body elections across Andhra Pradesh based on the increased number of wards resulting from the delimitation exercise. Melstarr Aviation Keen to Invest in AP Aviation Sector

Company representatives meet Minister B.C. Janardhan Reddy

Visakhapatnam (TSIT) Melstarr Aviation has expressed keen interest in investing in the aviation sector in Andhra Pradesh and developing aviation-related infrastructure in the state. A delegation led by Melstarr Aviation Director Tarun Kashyap met Minister for Investments and Infrastructure B.C. Janardhan Reddy at the Secretariat in Amaravati and discussed investment opportunities in the state. The company representatives briefed the minister on the progress of the Melstarr Aviation Learning Academy (MALA) being established at Kurnool Airport as a pilot training centre. They said the academy was receiving an encouraging response from students. The company also expressed interest in establishing Aircraft Maintenance Engineering (AME) facilities at Vijayawada Airport.



Melstarr Aviation further proposed setting up full-fledged Maintenance, Repair and Overhaul (MRO) facilities at Bhogapuram, Kurnool and Vijayawada airports. Responding to the proposals, Minister B.C. Janardhan Reddy asked the company representatives to come forward with comprehensive proposals for the projects. The company representatives appreciated the new aviation policy introduced by the coalition government under the leadership of Chief

Minister N. Chandrababu Naidu. The minister assured that the state government would extend full support for the development of the aviation sector and creation of the required infrastructure. Minister Janardhan Reddy said the coalition government was taking steps to transform Andhra Pradesh into a major aviation hub. Demand for aviation-related services was growing rapidly in the state, while global-level investments were also showing increasing interest in Andhra Pradesh. He said that under the stable government led by Chief Minister Chandrababu Naidu, Andhra Pradesh was emerging as a preferred destination for investments. The development of MRO and AME facilities would create significant employment and skill-development opportunities for local youth in the aviation sector.

Greenery is the Foundation for the Safety of Future Generations: AP Green Chairman Nagababu



Bapatla, September 3, 2026: Andhra Pradesh Green Executive Committee Chairman Nagababu stressed the need for large-scale promotion of greenery to maintain ecological balance, protect biodiversity and safeguard the survival of various species. Speaking to the media after planting palm saplings with students at Suryalanka Beach in Bapatla district on Thursday, he said environmental protection

AP High Court Pulls Up Police Over Missing Class X Girl



AMARAVATI, September 3, TSIT: The Andhra Pradesh High Court on Friday expressed strong displeasure over the failure of police to trace a Class X girl from Guntur who has reportedly been missing for nearly 80 days. The Bench had directed the Director General of Police (DGP) on Thursday to trace and produce the girl before the court on Friday. However, police failed to locate her within the stipulated time, prompting the court to question whether the DGP had understood its directions. The government informed the court that a Special Investigation Team (SIT) had been constituted to trace the girl. The Bench

questioned whether the SIT indicated the failure of the Pattabhipuram police and also raised concerns over the inclusion of officials who had allegedly failed to trace her earlier. The government sought time until Monday, assuring the court that the girl would be traced and produced. The High Court directed the DGP to appear personally on Monday and warned that token measures would not be accepted. The Bench stressed the need for concrete action to trace the missing girl and accountability for the delay, while expressing concern over the uncertainty faced by her parents.

Key Decisions of AP Cabinet Meeting Held on September 3

TSIT, Visakhapatnam.

The State Cabinet, chaired by Chief Minister N. Chandrababu Naidu at the Secretariat on Thursday, approved several important proposals concerning agriculture, irrigation, Amaravati development, energy, rural drinking water supply, poultry, industries and policing. Information and Civil Relations Minister Kolusu Parthasarathy briefed the media on the decisions. Among the major decisions, the Cabinet approved a new veterinary dispensary at Aechammakunta village in Macherla mandal, benefiting around 12,648 livestock and poultry within a five-kilometre radius. It also approved Rs.94 crore in price-deficiency support to tobacco farmers and extended permission to AP MARKFED to raise funds for implementing support prices for Totapuri mangoes. In



the irrigation sector, 78 flood restoration works worth Rs.6.24 crore were approved for Krishna, NTR, Guntur and Bapatla districts. The Cabinet sanctioned 21 regular posts for the Additional District and Sessions Court at Mangalagiri and approved the

upgradation of the Rajamahendravaram ESI Hospital from 50 to 100 beds. For Amaravati, the Cabinet approved flexible bituminous pavements for Type-B, C, D and E LPS roads and endorsed recommendations relating to new land allotments. It also

approved the Rs.759.793-crore Amaravati Sangamam project at Shakamuru, comprising the Andhra Pradesh State Public Library, an auditorium and the Global Institute of Good Governance. Further, approval was given for land pooling of 6,212.50 acres in Guntur district for the Inner Ring Road and associated grid roads linked to the Errupalem-Namburu railway line. Several land transfers were approved for industrial parks, an integrated collectorate complex and renewable energy projects in Chittoor, Markapuram, YSR Kadapa and NTR districts. In the energy sector, the Cabinet approved exemption of APGENCO's Sileru power stations from the Fire Precautionary Fee for obtaining Fire NOCs, a Rs.950-crore government guarantee for an APTRANSCO loan

from PFC and cancellation of the 800-MW Avuku Pumped Storage Project allotted to RVR Projects Pvt. Ltd. It also approved capacity interchange for a 300-MW wind-solar hybrid project in Anantapur district and corporate guarantees relating to APPDCL's loans. For the Polavaram Hydro Electric Project, the Cabinet approved consideration of Rs.472.86 crore excluding GST, or Rs.557.97 crore including GST, towards price variation as per the NHPC methodology. The Cabinet also approved the Andhra Pradesh Poultry Development Policy 2026-29, proposing financial incentives of Rs.657.18 crore to modernise the poultry sector, promote environment-controlled sheds, improve disease surveillance and biosecurity, encourage backyard poultry, strengthen processing and cold-chain infrastructure, and

Officials were also instructed to coordinate with State and district administrations and make advance arrangements at locations expected to witness heavy passenger crowds during festivals and fairs.

No dissent will be tolerated Revanth Reddy asserts authority, emerges stronger after Telangana shake-up



Hyderabad: Telangana Chief Minister A. Revanth Reddy appears to be consolidating his position as the undisputed leader of the Congress in the state. His latest decisions dropping Konda Surekha from the Cabinet and removing Dr. G. Chinna Reddy as Vice Chairman of the State Planning Board mark a clear message that dissent will not be tolerated. Surekha's ouster follows weeks of controversy triggered by her daughter's public attack on the Chief Minister. Despite appeals, Surekha refused to back down. Revanth, however, stood his ground, took the matter to the Congress high command and secured their approval to act.

Sudharani, a BC leader from Warangal, as Chairperson of the Kakatiya Urban Development Authority (KUDA), the same district where Surekha holds sway. The move is widely seen as a political masterstroke neutralising local backlash while rewarding alternative leadership.

Rahul Gandhi's 2029 PM Dream: The Allies He Cannot Take For Granted

For Congress leader Rahul Gandhi, the road to 7, Lok Kalyan Marg (formerly Race Course Road), or, more accurately, the Prime Minister's Office in a new India, is becoming a little more complex with every passing year. The Congress has been steadily building the case that Rahul Gandhi should be the natural Prime Ministerial face of the INDIA bloc in 2029. Yet, the biggest obstacle to that ambition may not be the BJP. It may again be the very allies whose support Rahul Gandhi will need to reach the top. The latest flashpoint is Tamil Nadu. Congress leaders in the state have now claimed that Tamil Nadu Chief Minister and TVK (Tamilaga Vетtri Kazhagam) leader Vijay has backed Rahul Gandhi as the INDIA bloc's Prime Ministerial candidate. Congress leader Tharaiharai Cuthbert has even dismissed reports of a rift and maintained that Vijay and Rahul share mutual respect. But politics is rarely as simple as public reassurance. Only days earlier, the Congress-TVK alliance was under considerable strain over reports of a 'Vijay for PM' campaign. A Congress minister went so far as to threaten resignation if TVK refused to endorse Rahul Gandhi for 2029. That itself exposes Rahul Gandhi's fundamental problem - even when an ally eventually supports him, the support cannot necessarily be assumed to be unconditional. False assumption of the bloc The INDIA bloc was never created as a conventional political party with one leader, one ideology and one command structure. It was an electoral coalition of parties with sharply different regional interests and ambitions. That makes Rahul Gandhi's claim to the top job particularly difficult. Mamata Banerjee had demonstrated that the Trinamool Congress had its own national ambitions and did not necessarily see the Congress as the unquestioned leader of the opposition. Arvind Kejriwal's AAP had similarly sought political space independent of Congress. Akhilesh Yadav's Samajwadi Party, meanwhile, has emerged as a powerful player in Uttar Pradesh and has its own calculations about who should lead the opposition nationally. This is the central contradiction Rahul Gandhi faces- Congress wants the INDIA bloc to behave like a coalition led by the largest national opposition party, while several regional parties see the alliance primarily as a vehicle for defeating the BJP-not necessarily for making Rahul Gandhi Prime Minister. That distinction could become decisive in 2029. Bargaining power The Congress' continuing love for its scion never lets the party lose hope in Rahul and they point out to his positive transformation since 2014. His political communication has become sharper, his parliamentary interventions have acquired greater visibility and the 'Bharat Jodo Yatra' gave him an image that was markedly different from the caricature of the reluctant politician that his opponents had successfully constructed. The 2024 Lok Sabha election also gave Congress a psychological boost. The party improved substantially on its 2019 tally, while Rahul Gandhi emerged as the Leader of the Opposition. But a stronger Congress does not automatically translate into Rahul Gandhi becoming the consensus Prime Ministerial candidate. For that, Congress must answer a more difficult question - how many seats can it realistically win on its own, and how dependent will it remain on regional allies? The answer to that question will determine the bargaining power of Rahul Gandhi.

Tim Cook inherited a company built on the cult of Steve Jobs and made it less theatrical, less unpredictable and, yes, boring. But he also made it vastly bigger, richer and harder to dislodge. Perhaps, boring was Apple's greatest innovation after Jobs. In August 2011, an ill Steve Jobs summoned Tim Cook to his home and told him he was the next Apple CEO. Cook protested. He still believed Jobs would be around for years. Jobs, however, had been thinking about succession rather more deeply. Jobs told Cook a story about Disney. After Walt Disney died, the company had fallen into a peculiar kind of paralysis. Executives would sit around asking themselves: What would Walt have done? Jobs wanted no such thing at Apple; he told Cook: "Just do what's right." This may have been the most consequential piece of advice Steve Jobs ever gave Tim Cook. Because over the next 15 years, Cook did something that is extraordinarily rare in business: he succeeded an icon without becoming his weak imitation. He did not try to manufacture Jobs's charisma. He did not recreate his mercurial management style. He did not attempt to turn every product launch into another iPhone moment. Slowly, almost deliberately, Cook made Apple less dependent on drama, personality and the occasional bolt of technological lightning. He made Apple boring. And in doing so, he built something even Steve Jobs could not: an institution capable of becoming vastly bigger than its founder. The scale of this transformation is measurable. Apple's annual net sales rose from \$108.2 billion in fiscal 2011 to \$416.2 billion in fiscal 2025; services revenue reached \$109.2 billion in 2025; full-time employees increased from about



60,400 in 2011 to about 166,000 in 2025; and the installed base surpassed 2.5 billion active devices by January 2026. The Inheritance Problem Cook inherited perhaps the greatest handover in corporate history. The iPhone was already four years old. The iPad had been launched. The App Store existed. Apple had its retail network. The ecosystem was taking shape. Jobs had already made the gigantic strategic bets. And the contemporary reaction to Cook's appointment captures the problem beautifully. In 2011, the debate wasn't really whether Cook was competent. It was whether Apple could remain Apple without Jobs. Harvard Business Review described the prevailing sentiment at the time as essentially: Cook may be good, but he is no Steve Jobs. It is a criticism worth taking seriously, because there has been no product of the Cook era that has rearranged our lives quite like the iPhone did. Apple Watch became a formidable business. AirPods became ubiquitous. Apple silicon was a remarkable technological achievement. But

nobody stood outside an Apple Store overnight because Tim Cook had reinvented the mobile phone. But that is the wrong way to measure him. While Jobs's genius was to repeatedly imagine the next great Apple product, Cook's was to understand that Apple itself could become the product. The iPhone would no longer simply be a device that Apple sold you every few years. It would become the front door to an expanding universe of watches, headphones, payments, music, television, cloud storage, apps and services. Each addition was relatively unexciting compared with the arrival of the iPhone. Together, however, they changed the economics of Apple. The revolutionary product became an ecosystem. The ecosystem became an annuity. And somewhere along the way, Apple stopped needing to astonish us every few years to become vastly more valuable. Cook's Playbooks Three playbooks came to define Cook's Apple: be best, not first; own the bottlenecks; and monetise the installed base, buying what-

ever capabilities were needed to strengthen it. The first gave Apple the luxury of patience. Smartwatches existed before the Apple Watch, wireless earbuds before AirPods and streaming services long before Apple TV+. Cook was perfectly comfortable arriving at a party after everyone else, provided Apple could eventually own the room. In a technology industry addicted to the cult of the first mover, Apple institutionalised the advantages of being a very rich, very powerful late mover. But there is a fine line between "best, not first" and missing the future. Cook spent 15 years walking it. But as he steps away, AI is poised to be the biggest challenge to this Cook playbook. Critics point to how Generative AI is proving that Apple's legendary patience stopped looking like discipline and started looking like delay. But this story is still playing out, and the jury is still out. The second playbook was pure Cook. Own the bottlenecks. Cook is often described as an operations man, which has always sounded faintly like a conso-

lation prize next to Jobs's designation as a visionary. But operations at Apple's scale was not about getting boxes out of factories on time. It was strategy. Apple learnt to exert extraordinary control over suppliers, components, manufacturing capacity and logistics without having to own most of the factories that made its products. With Apple silicon, that instinct moved deeper still: another critical layer of technology came inside the walls. Jobs obsessed over controlling the user experience. Cook extended that obsession down the value chain. It made Apple extraordinarily resilient. It also created one of Cook's greatest vulnerabilities. The supply-chain genius became deeply dependent on China, and Cook, the operations maestro, increasingly had to become Cook the diplomat - navigating Washington and Beijing while slowly building manufacturing alternatives in countries such as India and Vietnam. But it is the third playbook that perhaps changed Apple most profoundly. Cook understood that Apple's

greatest asset was no longer merely the device in the box. It was the person carrying one. An iPhone owner could buy AirPods and an Apple Watch. They could pay for iCloud, Music and TV. They could buy apps through the App Store, pay using Apple Pay and protect the hardware with AppleCare. Every additional product made the ecosystem more useful; every additional service made the relationship more lucrative; and every additional connection made leaving a little less attractive. By 2025, Services was generating \$109.2 billion a year. More strikingly, its gross margin was 75.4 per cent, against 36.8 per cent for Apple's products. Cook had discovered something potentially more valuable than selling another spectacular device: selling more things, repeatedly, to people who already owned one. Jobs built products people desperately wanted to buy. Cook built a relationship Apple could continue monetising after the product had been bought. And when pieces of that machine were missing, Apple generally did not go shopping for corporate trophies. It bought capabilities - technology, talent, intellectual property - and folded them into the ecosystem. The best Cook-era acquisitions often disappeared. There was a fourth Cook playbook, perhaps the least Apple-like of them all: turn abundance into discipline. Steve Jobs had left behind a company rapidly accumulating an enormous mountain of cash. Cook treated that cash not as a monument to Apple's success but as capital that had to justify its existence. In March 2012, barely seven months after Cook became CEO, Apple announced that it would begin paying a dividend and buy back \$10 billion of its shares.

Beyond peacock feathers and flutes: an opportunity to instill Krishna's values in children's minds

In fact, dressing a child as Krishna is not merely an external adornment, but an opportunity to sow the seeds of life values within him. This occasion teaches us that Krishna is not only a religious symbol, but also a symbol of love, friendship, compassion, courage, wisdom, and hard work. When a child takes on the role of Krishna, it becomes equally important to explain Krishna's character and his life message. The child form of Krishna has been a special favorite in the Indian psyche for centuries. His mischievousness exudes the joy of life, his flute exudes the sweetness of love and conversation, his friendships embody intimacy, and his struggle against Kansa embodies the courage to stand up to injustice. This is why Krishna's stories naturally appeal to children. These tales offer both entertainment and profound life lessons. The need for this learning has only increased in today's times. Childhood has changed. Courtyards, community halls, and open fields have been replaced by mobile phones, computers, video games, and social media. Technology has opened

new doors of knowledge and possibilities for children, but it has also brought a challenge: children are increasingly disconnected from their cultural roots and authentic social connections. At such a time, festivals like Janmashtami can be an important way to connect children with their culture. But we must be careful that the festival doesn't become limited to taking photos, dressing up in attractive costumes, and sharing images on social media. If a child wears the costume of Lord Krishna but doesn't practice love, truth, compassion, and courage, the true purpose of the festival remains unfulfilled. Krishna's stories hold many life lessons for children. His childhood pranks of stealing butter convey the message of simplicity and joy in life. The story of Mount Govardhan teaches collectivism, leadership, sensitivity to nature, and responsibility. The friendship between Sudama and Krishna demonstrates that true relationships are not based on wealth or social status, but on love and intimacy. Krishna's message in Kurukshetra teaches that one should not shirk duty even in difficult circumstances. These same values need to be integrated into children's lives in today's context. A modern Kanha isn't just someone who knows how to operate a smartphone, but one who understands how to use technology judiciously and responsibly. He or she should gain knowledge from the internet, but also learn to protect themselves from misinformation and negative content. He or she should be active on social media, but should not ridicule or insult anyone. He or she should stand up to cyberbullying rather than participate in it. A modern Kanha is also one who doesn't remain silent in the face of injustice. He opposes gender discrimination, supports the weak, and helps those in need. He has the courage to ask questions, but also the humility to respect the opinions of others. He competes, but never loses his sensitivity. Teaching children the qualities of Krishna can begin at home. Along with dressing them in costumes on Janmashtami, parents should tell them a short Krishna story and explain its meaning. The flute

can be seen as a symbol of love, music, and communication, not just decoration. The crown can be seen as a symbol of responsibility, not just royal splendor. A peacock feather can connect us with nature and beauty, while a yellow robe can remind us of simplicity and purity. Janmashtami is also an opportunity to promote sensitivity to nature. Krishna's life is intertwined with the natural world of Govardhan, the cow herds, the Yamuna, and Vrindavan. Children can be taught that nature is not merely a commodity, but the foundation of our lives. Instead of plastic and unnecessary artificial decorations, clay, cloth, paper, and other environmentally friendly materials should be used during festivals. Even small initiatives can foster greater environmental awareness in children. We also need to understand that values are developed less through teachings and more through behavior. If we tell children the story of Krishna's friendship, but then act selfishly and bitterly in our own relationships, the message will be weakened. If we preach the importance of truth but compromise on it in our own conduct, children will learn from actions rather than words. Therefore, the primary responsibility of creating "My Krishna" lies with the family and society. For me, "My Krishna" isn't just a child adorned with a peacock feather and a crown. My Krishna is a child with innocence in his mind, compassion in his heart, humility in his behavior, and the courage to stand up against injustice. He works hard to fulfill his dreams, not being disheartened by failure or arrogant in success. He is rooted in his own culture, but also respects the culture and ideas of others. Krishna means both loving life and facing its hardships. His flute brings us sweetness, but his message also gives us the courage to act. Therefore, it is not enough to introduce children only to the charming child form of Krishna; they must also be introduced to his thoughts and vision of life. This Janmashtami, let's not just adorn our children with peacock feathers, crowns, and flutes. Let us also give them the ornament of love, a heart of compassion.

JAUHAR: NOT ASHES, BUT THE FIRE OF IDENTITY

Jauhar is one of those events in Indian history whose memory still lives deeply in the soil, folklore, and heroic traditions of Rajasthan. To consider Jauhar merely an act of self-immolation in fire would be to limit its historical and social context. Behind it lay war, power struggles, women's insecurities, fears of defeat, and the complexities of contemporary social conditions. Therefore, Jauhar should be discussed with not only emotions but also a sense of history and human sensitivity. In Rajput history, bravery wasn't limited to simply raising the sword on the battlefield. Along with the valor of men, stories of women's sacrifice, courage, and self-respect have also been passed down from generation to generation. Whether it's the folk memory of the Jauhar of Queen Padmavati of Chittor or the tales of other brave women of Mewar and Rajasthan—these stories have created an image of Rajput identity in which self-respect is considered the highest value. Powerful lines like "The flames of Jauhar have awakened, to dry up the entire Sindhu"—are expressions of this collective memory. They reflect the pain, anger, and self-respect of that period of history. However, while understanding these sentiments today, it is also important to remember

that historical events should not be used as a means to incite hatred or animosity against any community in current society. The most important aspect of jauhar is linked to women's identity. In medieval wars, women of defeated states faced threats of abduction, violence, enslavement, and forced control. The social structure of that era lacked the legal protections, institutional safeguards, and modern options for independent decision-making that women enjoy today. It was in this environment that incidents like jauhar emerged. To understand them, it is necessary to examine the circumstances of that time in contrast to current social and legal norms. But understanding the tragedy of history and blindly glorifying it are two different things. Jauhar cannot be a path for us to emulate today. In a modern democratic society, a woman's dignity should be protected not through death, but through law, education, social awareness, and just institutions. Our goal should be to create a system in which no woman is forced to end her life to protect her identity. Honoring the memory of Rajput women warriors would be more meaningful in this context. Associating their courage solely with death would be limiting their struggle and individuality. It is more important to understand their inherent self-respect, courage to

make decisions in times of crisis, and mental fortitude in the face of adversity. The sacrifices recorded in history can inspire us to ask what we are doing today to ensure the safety and respect of women. Similarly, the tales of swordplay and sacrifice of Rajput heroes are not merely tales of war and adventure. They were part of the political circumstances of their time, the struggles to protect regional autonomy and honor. Lines like "The lions who watered the earth, shedding blood from their chests" commemorate the heroic tradition that profoundly influenced the history and folk culture of Rajasthan. Historical memory is healthy only when it combines pride with conscience. We should remember the sacrifices of our ancestors, but we must avoid turning history into present-day hatred. Blaming entire communities today based on the actions of individuals or groups involved in a historical conflict is neither historically accurate nor socially just. The role of literature and poetry, in particular, becomes crucial here. Heroic poetry can instill a sense of self-confidence, courage, and patriotism in society. However, if the same poetry begins to promote hatred towards a community, its creative purpose is weakened. Therefore, slogans like "Jai Bhavani" and "Jai Mata Padmavati" should be viewed as cultural memory and reverence, not as political slogans of hostility

towards anyone. The memory of Jauhar teaches us another important lesson—self-respect is a crucial value in human life, but in modern society, self-respect and life should not be made contradictory. Today, it is our responsibility to ensure that every woman has access to education, economic independence, legal rights, a safe environment, and the freedom to choose her own life. This may be the most humane message that can emerge from that historical suffering. The fragrance of bravery that permeates the soil of Rajasthan must live on, not just in the ashes of the past, but also in the responsibilities of the present. The need is not to rekindle the flames of Jauhar today, but to understand its history. Saluting those brave women will only be meaningful when we create a society where a woman's dignity is not compromised, where her wishes are paramount, and where she need not sacrifice her life to protect them. History gives us pride, but it also gives us responsibility. The story of Jauhar must be read with the same balance—neither blind glorification nor disrespectful oblivion. It is a painful memory of our past, embodying courage, self-respect, and tragedy. Salute to the courage of the brave women, tribute to the sacrifice of the heroes and by learning from that history, resolve to create such a present – where the protection of honour is along with life, not against life.



Karnataka Cabinet to hold special Assembly session from Sep 21; approves Global Investment & Overseas Affairs dept

Bengaluru, Sep 3 : The Karnataka Cabinet has decided to convene a three-day special Assembly session from September 21 to discuss the Kasturirangan report and the drought situation in the state, Deputy Chief Minister G. Parameshwara said on Thursday after the Cabinet meeting at Vidhana Soudha.

The Cabinet also took a major decision to establish a new department for Global Investment and Overseas Affairs, aimed at facilitating foreign investments, strengthening international partnerships and collaborations, and addressing the concerns of Non-Resident Indians (NRIs).

Explaining the objective, Parameshwara said foreigners were increasingly visiting Karnataka in search of business and employment opportunities.

"The proposed department would coordinate the reception and hosting of foreign delegations, facilitate partnerships and collaborations, and promote investments in the state."

He added that foreign investors often come to Karnataka with proposals for partnerships, collaborations and investments, and there was a need for a dedicated mechanism to receive their proposals, facilitate meetings with the Chief Minister D.K. Shivakumar and forward them to the con-



cerned administrative departments for necessary action.

"This particular factor is very important. The objective is to ensure that foreign investors do not have to wait without anyone attending to their proposals," Parameshwara said.

He noted that there had been instances where investors, after failing to receive an adequate response to their proposals, became disappointed and eventually moved to other states or countries to make their investments.

"To address this issue, the state government has taken this as a major decision," he said.

The new initiative will also focus on global research and development, innovation and R&D facilities, global cultural exchanges and cultural diplomacy, soft power and intangible exchanges, global sports diplomacy and collaboration, sister-city and inter-city

partnerships, and global healthcare, medical and tourism initiatives.

A State Facilitation Council will be established for the purpose, with the Chief Minister Shivakumar as its Chairman and the Deputy Chief Minister Parameshwara as its Vice-Chairman.

The Council will include Ministers handling Industries, Agriculture, Horticulture, IT/Biotechnology, Urban Development, Bengaluru Development, Higher Education, Power, Health, Sports and Medical Education, among other departments.

Parameshwara said the initiative would also work towards the welfare of NRIs, facilitate employment opportunities abroad and provide coordination and support to foreign delegations and investors.

The State Cabinet also decided to withdraw its earlier decision to dismiss B.

Padmanabha, a Superintending Engineer, from government service.

It gave in-principle approval for Karnataka to participate in the Centre's revised Regional Connectivity Scheme, RCS-UDAN 6.0, and approved signing an MoU in this regard.

The Cabinet also approved reconsideration of measures to improve air connectivity between Tier-2 and Tier-3 cities.

The state government agreed to continue its guarantee for a Rs 2,000-crore loan to be availed by the Karnataka State Cooperative Agriculture and Rural Development Bank through NABARD.

The State Cabinet also approved a programme for the development of SC/ST colonies under the Kabini and Taraka reservoir projects, along with Rs 61 crore for development works in rehabilitation villages.

A Rs 115-crore project to fill 137 lakes in Byadgi and Hanagal taluks with water was also approved. In addition, the Cabinet cleared a Rs 56-crore project to lift water from the Bori River in Kalaburagi district and fill 12 lakes. With the special Assembly session scheduled from September 21, the Kasturirangan report and the drought situation are expected to be among the key issues taken up for detailed discussion.

Recover Rs. 5 Lakh Grant Given Illegally to Madrasa and Submit Report on Action Taken Against Fraudulent Institution: High Court Division Bench Orders

Bengaluru : The Division Bench of the Karnataka High Court has directed the Department of Minority Welfare to submit a status report on the action taken against the organisation running a madrasa at Thanisandra, under the Samaar International Islamic School, which had its recognition cancelled by the Education Department, including the recovery of the Rs. 5 lakh grant provided to it. The court directed the department to submit, at the next hearing, details of the status of the investigation against institutions allegedly functioning fraudulently and a report on the action taken against them. The Director of the Minority Welfare Department has also been directed to remain personally present before the court during the hearing concerning the framing of charges against the accused institutions. The significant order was passed by a Division Bench comprising Justice Jayant Banerji and Justice T.M. Nadaf while hearing a petition filed by Abdul Hameed Pasha, Pradeep Singh and others. The Bench adjourned the matter to September 24. Earlier, in September last year, a Division Bench comprising Chief Justice Vibhu Bakhru and Justice C.M. Joshi had heard a petition concerning the issue and directed the Principal Secretary of the Minority Welfare Department to examine the grant released to



the madrasa and take appropriate action. Now, M.N. Moolimani, Assistant Director of the Minority Welfare Department, has filed an affidavit before the Bench stating that the Commissioner of the Education Department had conducted an inquiry and cancelled the recognition of educational institutions being run by the respondents in Bengaluru under different names. An appeal filed by them challenging the cancellation of recognition was also dismissed. The Assistant Director informed the court that the allegations made in the complaint were found to be true upon verification. He further stated that permission had been sought to initiate appropriate action as per the rules and to recover the Rs. 5 lakh already released to the

institution and return the amount to the government. The Samaar International Islamic School at Thanisandra is not registered as a public trust. In this regard, the Education Department constituted a three-member committee, which subsequently submitted its report.

Based on the report, the Commissioner for School Education cancelled the recognition of the organisation on May 30 on the grounds of violation of Section 39(F) of the Karnataka Education Act, 1983. However, the Rs. 5 lakh grant released to the institution had not been recovered. The petitioners had urged the authorities of the Minority Welfare Department to take immediate steps to recover the amount granted to the institution.

The Chief Minister, who pays more attention to real estate, should pay attention to the food supply of this country at least 25 percent of his time. He demanded that the farmers' plight be addressed. The SCP and TSP money that should be used for the develop-



ment of Dalits is being used for different departments. He criticized that they are doing injustice to the Dalit communities. He objected that this is a government that has not responded to the plight of the food supply. In the 3 years of the Congress government's rule, 3655 farmers have committed suicide in Karnataka.

About 294 farmers have committed suicide in Kalaburagi district, more than 160 in Raichur district, more than 220 in Bidar, more than 80 in Koppal district, and 937 farmers have committed suicide in the Kalyan Karnataka region. Priyank Kharge said that this matter should be looked into. 145 crores outstanding for jowar He drew attention to the statement of Raitha Morcha President Nadahalli that there is a balance of 145 crores for jowar purchased in Raichur area. The previous BJP government led by Yediyurappa used to provide subsidy for dairy farming. He criticized the Congress government for not providing even that subsidy and adding insult to injury to the suffering farmers.

Tamil Nadu CM Vijay challenges opposition DMK in House, don't walk out, hear my reply on September 7

CHENNAI: Tamil Nadu Chief Minister C Joseph Vijay on Thursday (September 3) threw down the gauntlet to the Opposition DMK in the Assembly, asking its members to remain in the House on Monday (September 7) for his detailed reply to their allegations, rather than stage a walkout. Intervening during a debate, the Chief Minister requested Speaker J C D Prabhakar to elicit a firm promise from the DMK members that they would remain in their seats throughout his address.

Assuring a comprehensive response, Vijay said he would provide a clear and point-by-point explanation to every question raised by the Opposition during the ongoing session. The exchange came amid a heated debate on state administration's handling of law and order, where the Leader of the Opposition Udhayanidhi Stalin sought to corner the



ruling TVK government. Leading the charge, Udhayanidhi Stalin questioned the TVK's frequent critiques of the previous DMK administration's handling of drug proliferation. Pointing to current administrative decisions, the DMK leader argued that if the previous regime's drug control efforts had truly been ineffective, the present government would not have promoted two senior police officers who headed those very departments during the DMK's tenure. He specifically named the two IPS officials.

He alleged that there

was a rise in POCSO (Protection of Children from Sexual Offences) cases in the state, and also an increase in crimes, and highlighted that his government established special committees and standard operating procedures (SOPs) to support victims and ensured swift justice.

Regarding drug enforcement, he questioned why certain police officers who served during the previous DMK rule were promoted to high-ranking positions by the current TVK government if their previous efforts were allegedly insufficient.

Manickam Tagore condemns 'pushing' of tribal students from Pudukkottai bus, demands probe and compensation

CHENNAI: Tamil Nadu Congress president and MP Manickam Tagore has condemned the incident in which tribal school and college students were allegedly pushed from a government bus in Pudukkottai district, calling it an "inhuman and cruel act".

In a statement, Tagore said the incident involving students from the Narikuravar community in Rangamma Chathiram, who were allegedly pushed from a government bus and injured, had shocked people across the State. He condemned the alleged discrimination and negligence faced by the girl students while travelling to educational institutions.

Following the incident, Pudukkottai district Congress president Bennett visited the area on behalf of the Tamil Nadu Congress Committee and met the injured students, their families and local residents to assess the situation, he said.

Tagore alleged that margin-



alised communities, including tribal people and Scheduled Castes, continue to face social and psychological discrimination, said a Daily Thanthi report.

He also accused the RSS ideology of promoting such discriminatory attitudes and called for efforts to counter caste-based prejudice and protect social justice and equality. Calls for additional buses, dedicated transport

The students reportedly

depend on bus services to travel the four to five kilometres between Rangamma Chathiram and Pudukkottai for school and college. Tagore said there were allegations that government buses did not regularly stop at the designated bus stop.

He alleged that students attempting to board buses had been humiliated and that incidents such as knocking away their hands from the grab rail and operating automatic

doors while they were boarding had put them at risk.

Tagore further alleged that a special vehicle facility arranged earlier by the district administration had been discontinued due to a dispute between the School Education and Revenue departments over which department should bear the expenses.

"The lack of coordination between government departments has contributed to the situation in which 10 students are now undergoing treatment for injuries," he said.

Demands action under SC/ST Act

He held the district Collector responsible for the alleged administrative lapses and urged the authorities to take immediate steps to resolve the issue. He called for additional buses to be operated on the Rangamma Chathiram route during school and college hours or for the dedicated transport facility for students to be restored without delay.

Body of pregnant woman recovered from well in Salem

COIMBATORE: A 23-year-old woman who had gone missing a few days ago was found murdered, with her body stuffed into a sack and dumped in a farm well in Salem district on Thursday (September 3). The deceased, identified as Gokila, was from Konasamudram village in Konganapuram. She was unmarried and had been staying at home after completing her college education.

On August 20, Gokila complained of severe abdominal pain and was taken by her family to a nearby Primary Health Centre. A medical examination revealed that she was seven months pregnant. Following a complaint from her family, police from the All Women Police Station (AWPS), Sankagiri, questioned M

Ammasi (26) from the same locality.

"During the inquiry, Ammasi agreed to marry Gokila after the ongoing temple festival. He subsequently took her to his residence," police said.

However, on August 31, Ammasi informed Gokila's parents that she had gone missing from his house. After a futile search, her family lodged a missing complaint with the Konganapuram police. A search was subsequently launched. On Thursday, a woman who owns a farm in Vellalapuram village noticed a sack floating in her well after detecting a foul smell emanating from it. She alerted the police, who rushed to the spot and retrieved the sack, which had the decomposed body of Gokila.

TVK member seeks shutdown of non-existent factory

CHENNAI: The TVK member I Thahira demanded the closure of a non-existent JK Tyre factory, claiming that the unit operating in Ranipet was causing severe pollution in her constituency. Thahira raised the issue during Question Hour in the Assembly on Thursday, prompting netizens to point out that no such manufacturing unit exists in Ranipet and to suggest she might have been referring to tyre vulcanising units operating in and around



Ranipet. Amid a rebuttal from former minister TRB Raajaa over the issue, pointing out that no such factory functions in Ranipet, Industries Minister S Keerthana issued a clarification on X. However, the damage was already done.

Public trust key to India's nuclear push

RADIOACTIVE WASTE, WITH ITS MILLENNIA-LONG HAZARD PROFILE, IS A PERSISTENT WORRY.

IN his Independence Day speech, Prime Minister Narendra Modi laid stress on the critical role of nuclear power in building a truly self-reliant India and achieving energy independence. The importance of nuclear energy is also reflected in this year's Budget, subsequent policy statements and efforts to open the sector to private sector participation.

An interim target of achieving 100 GW (gigawatts), which includes both large and small reactors, by 2047 has also been envisaged. Small Modular Reactors (SMRs with a capacity of 300 MW or below), are gaining special attention these days as they can play a key role in decarbonising hard-to-abate industries, providing a stable power supply to remote areas, serving captive power requirements and producing hydrogen. Hard-to-abate industries — such as cement, steel, power, oil and natural gas, chemicals and fertilisers — are difficult to decarbonise due to high energy requirements and emissions from chemical processes.

Three types of SMRs — 200 MWe (megawatt electrical) Bharat Small Modular Reactors, 55 MWe SMRs and five MWth (megawatt thermal) High Temperature Gas Cooled Reactors — are being designed and developed indigenously. These augur well for realising India's nuclear vision. The road ahead, however, is not that rosy. There are hurdles to be crossed, the main one being ensuring public acceptance by addressing apprehensions about human safety and environmental impacts. Public unease around nuclear energy is deeply shaped by history. Memories of Chernobyl (1986) and Fukushima (2011) continue to loom large, fuelling perceptions that a nuclear accident is both catastrophic and inevitable. The core fear is the uncontrolled release of radioactive material in the event of severe accidents that could cause long-term environmental damage and health impacts. Radioactive waste, with its millennia-long hazard profile, is another per-



sistent worry. Questions are often raised about the long-term storage safety, risks of leakage and economic costs.

For SMRs, these general fears are compounded by their limited operating experience, potential siting closer to population centres, fuel supply chains and waste management. As private sector participation grows, questions may also arise about adequate availability of trained operators. The regulatory framework in India is fairly strong. The public concern thus seems to be based on limited public exposure to factual safety records and modern reactor safety features.

India's nuclear fleet has operated for decades with an enviable safety record. As documented in reports, radiation exposure to plant workers has consistently been well below global regulatory limits, with public exposure averaging less than 10 per cent of the prescribed thresholds. The country's plants follow a "defence-in-depth" approach — multiple, redundant safety barriers, robust heat removal systems, emergency core cooling and airtight containment structures. After the Fukushima disaster, Indian reactors under-

went significant safety upgrades: hydrogen recombiners to prevent explosions, filtered containment venting systems to limit radiological release and enhanced flood protection measures. Every site also has Severe Accident Management Guidelines (SAMGs) in place, supported by emergency power backup and mobile equipment for extreme events.

India's operating nuclear power plants have demonstrated a commendable safety record. The International Atomic Energy Agency, in its latest safety review, has acknowledged the strong commitment and professionalism of India's Department of Atomic Energy (DAE)/Atomic Energy Regulatory Board (AERB) in ensuring nuclear and radiation safety in the country. Building on this foundation, emerging technologies like SMRs incorporate advanced safety features to further enhance reliability and public confidence.

The SMR concepts incorporate passive safety systems that function without human intervention or external power, relying instead on natural forces such as gravity. This inher-

ent resilience makes them particularly robust in the face of extreme events, including station blackout scenarios. Their design offers multiple advantages: smaller reactor cores containing less fissile material, thereby reducing the potential radiological source; and lower operating pressures in certain configurations.

Furthermore, factory fabrication of modules ensures stringent quality control and reduces variability associated with on-site construction. These combined features not only strengthen overall safety but also make it possible to consider smaller Emergency Planning Zones, opening opportunities for siting reactors closer to demand centres such as industrial hubs or urban microgrids.

It is heartening to note that the DEA and the AERB are looking into this matter with requisite urgency. Nonetheless, regulatory bodies emphasise that emergency planning will continue to be rigorous for all nuclear facilities to safeguard against security-related contingencies. Building public trust is a major prerequisite for ensuring successful deployment of nuclear power plants. India's own experience — local opposition in some cases — shows that even the best-engineered plant can face hurdles if safety is not understood and accepted by those living nearby. It would also be desirable that the Nuclear Power Corporation of India (NPCIL) and the AERB involve a few other reputed organisations to ensure wider outreach with no information bias. The communication strategy must be proactive right from the site selection stage and address all safety concerns. Sharing of success stories in India and other countries would also be helpful. By embedding such outreach into the project timeline, SMR development can move beyond a technology-first approach, making public trust and acceptance a parallel pillar to engineering excellence, and projecting the plant as a shared community asset from the outset.

Addressing investors, Sitharaman said that "despite global disruptions and against all odds, India continues to be the fastest-growing major economy in the world, recording a remarkable growth of 7.8 per cent in Q1 of FY 2026-27," the Finance Ministry said in a post on X. Sitharaman arrived here after participating in the G20 finance ministerial meeting in Asheville, North Carolina. Sitharaman added that with its strong reform orientation,



India has also provided greater regulatory certainty through a range of reforms, including the Insolvency and Bankruptcy Code. "Such reforms have contributed to ensuring ease of compliance and reducing paperwork, which has remained a prime focus of the Government of India since it assumed office over a decade ago," the post on X said. She added that among the key areas on which the government has

focused are creation of capital assets and providing sustained support to industry through infrastructure development, particularly aviation; fostering a friendly and conducive investment climate; promoting the development of AI and data centres; supporting global capability centres; ensuring credit availability to MSMEs; and reducing non-performing assets (NPAs) of banks. These measures have helped create a

more enabling business environment for banks and industry to thrive, grow and emerge stronger, the finance minister said. Sitharaman further said that India has consistently remained committed to the path of fiscal prudence and fiscal discipline over the past several years, despite the ongoing challenges confronting the global economy since the onset of COVID-19. She highlighted the investment climate in

India that has improved significantly, with both the central government and state governments demonstrating greater keenness and competitiveness in attracting and facilitating investments in their respective regions. Such efforts are part of the larger national endeavour towards achieving the vision of Viksit Bharat 2047, the minister said. Earlier, in his welcome address, India's Ambassador to the United States Vinay Kwatra said that the GDP numbers for the first quarter manifest the resilience of the Indian economy. He said both India and the US can benefit from India's fast-growing economic trajectory by creating stronger linkages between trade and investment between the two countries, according to the Finance Ministry's post on X. Govt dismisses 2.6 pc growth claims Earlier in the day, the government dismissed a claim that first-quarter economic growth was closer to 2.6 per cent.

Air India Phuket-Delhi Incident: Preliminary Probe Report Due Tomorrow, Aviation Minister Says



The current Union Minister of Civil Aviation in India Kinjarapu Ram Mohan Naidu stated that investigation into the Air India Phuket-Delhi flight accident is underway with the preliminary report expected to be produced by tomorrow, as per a statement to the press on Thursday. Naidu said that further action will be taken based on the findings of the report. He further stated that a proposal to ramp up dope-testing and test all pilots at random points during the year is being discussed with the DGCA (Directorate General of Civil Aviation) and airlines. "We are considering expanding the existing mandatory dope-testing requirement from 10% to 100%, with random testing conducted throughout the year," Naidu said. "We need to strike a balance between safety and smooth operations. Safety remains our priority, and we

will take every possible step to strengthen it," he added. Air India's A320 flight from Phuket to Delhi, abruptly plummeted 300 feet in altitude, injuring 17 people in the process on Aug. 4. The flight's pilot-in-command had gone through confirmatory testing after an initial psychoactive substance screening indicated that the result requires further analysis. Air India ordered mandatory screening of all pilots on Aug. 13 across the group for substances and medications that are not permitted under prevailing aviation regulations, tightening its internal safety checks following the recent Phuket incident, sources said. The airline said the move is an additional safety measure and stressed that it already fully complies with all regulatory requirements prescribed by the Directorate General of Civil Aviation (DGCA).

KPHB GENERATES RS 47.14 CRORE THROUGH AUCTION OF 16 PLOTS



Hyderabad: The Kukatpally Housing Board (KPHB) generated a revenue of Rs 47.14 crore through a public auction of 16 plots on Wednesday, September 2. Telangana Vice Chairman VP Gautam said that while the minimum price was set at Rs 1.60 lakh per square yard, one plot was sold for Rs 2.7 lakh and another was purchased for Rs 2.36 lakh. The average price per square yard in Wednesday's auction stood at Rs 1.79 lakh. A total of 19 bidders took part in the auction. Raidurg land auction On August 28, the

Telangana Industrial Infrastructure Corporation (TGIC) had generated Rs 1,447.22 crore through the auction of a 5.38-acre plot in Raidurg. This set a new record for Hyderabad, fetching Rs 269 crore per acre. Before that, the TGIC auction of another Raidurg plot had fetched Rs 264 crore per acre, generating Rs 1,386 crore in revenue. Together, the two auctions generated Rs 2,833.22 crore from 10.63 acre, at an average realisation of Rs 266.53 crore per acre. The minimum price was set at Rs 1.60 lakh per square yard.

Trump \$1 coin makes him first living president on US currency in a century

Donald Trump's portrait has made its way on to a US coin - the latest move by the president to put his personal stamp on American institutions. On Wednesday, the US Mint launched the \$1 (£0.74) coin with a portrait of Trump alongside the words "Liberty" and "In God We Trust", to celebrate America's 250th anniversary. The Mint said the coins, which are being marketed as a collectable, were not being put into circulation for daily use. The law bans living presidents from appearing on US currency, but a design clause in legislation for the anniversary was used to overcome this. The coins - priced at \$61 for a roll of 25 and \$154.50 for a bag of 100 - were "not currently in stock" on the mint's website within hours of going on sale but it said more are being made. The coins were also being sold in vending machines at the US Mint store in Washington DC. The BBC has contacted the US Mint, the Treasury and the White



House for further details. The coin has been "created to celebrate this historic national milestone" with a "once-in-a-generation anniversary design destined to become a standout addition to modern collections", the US Mint said. The coins have a golden colour but do not contain any actual gold. According to the US Mint, they are 88.5% copper with the balance being made up of zinc, nickel and a manganese brass outer layer. While they are not in circulation, they can be used as legal

tender to pay off debt and taxes, although federal law states that businesses can decide whether or not to accept them. In May, Treasury Secretary Scott Bessent said his department was planning to issue a new \$250 bill bearing a portrait of President Trump. At the time, Bessent highlighted that another living US president has previously appeared on the country's currency. A half-dollar that was issued to commemorate America's 150th anniversary in 1926 featured then-President

Calvin Coolidge. The Trump administration has also cited the Circulating Collectible Coin Redesign Act of 2020, from Trump's first term. While this statute prohibits portraits of living people on the reverse (tails side) of coins, it does not explicitly cover the obverse (heads side), where Trump's likeness appears on the new \$1 coins. In March, the Treasury announced that US paper money would soon bear Trump's signature - another first for a sitting US president.

Toxic wildfire haze spreads across South East Asia as 'super' El Niño intensifies

MORE THAN 80 MIGRANTS FEARED DEAD AFTER BOAT RESCUED OFF CANARY ISLANDS

More than 80 people, including a baby, are feared to have died in a boat which was adrift in the Atlantic Ocean for 27 days. Spanish Maritime Rescue teams located the vessel some 65 nautical miles southwest of Gran Canaria's coastal town of Arguineguin on Wednesday and found 44 survivors, with five dead bodies also on board. The boat is believed to have departed The Gambia in West Africa in early August with 127 occupants on board. Human rights activist Helena Maleno Garzón, founder of Spanish charity Caminando Fronteras, said 83 people had lost their lives. Rescuers

were forced to leave the five bodies they found due to the rough sea conditions, Maritime Rescue said. The organisation was unable to verify how many people were originally on board. The 44 survivors are men from sub-Saharan Africa, Maritime Rescue said in a statement. "Once the rescue was complete, adverse weather conditions in the area - featuring 20-knot winds and 2.5m waves - made it impossible to recover the five bodies found on board the vessel," it added. Three of the survivors were airlifted to hospital in critical condition. The rest were transported by sea to Gran

Canaria, where they disembarked in the early hours of Thursday morning. Fernando Clavijo, head of the Canary Islands government, posted on X: "It is intolerable that lives continue to be lost. The Canaries cannot get used to or accept as normal the fact that the Atlantic continues to be a death trap." The Atlantic route from West Africa to the Canary Islands is one of the world's deadliest migration crossings. Thousands of migrants attempt the perilous journey each year seeking to reach Spanish territory despite the risks posed by rough seas, strong currents and long distances.



Palestinian teens killed during settler attack on West Bank village, officials say



Feminist activist and journalist Gloria Steinem dies, aged 92Funerals have taken place for two Palestinian teenagers who local officials say were killed by Israeli settlers and soldiers in an attack on their village in the occupied West Bank on Wednesday. The village council in al-Mughayyir told the BBC that Omar al-Nassan, 19, and Khalil Abu Alia, 16, were killed as they tried to stop Israeli settlers stealing sheep and that confrontations broke out. The Israeli military stated that its forces had entered the village to provide security for an Israeli civilian

and police trying to retrieve livestock. It said the forces fired on and struck what it called "key instigators" of a "violent disturbance", in which Palestinians threw stones at its troops. The deaths come amid a recent surge in settler violence in the West Bank, with more than three attacks per day on average recorded by the UN so far this year. Al-Mughayyir, near Ramallah, has seen repeated settler attacks. WhatsApp messages in groups used by settlers have indicated that they hope to force its population to move.

Channel smuggling gangs resort to 'mega-dinghies' as crackdown limits small boat supply

A drop in small boats illegally reaching the UK is forcing people smuggling gangs to adopt new tactics, a BBC investigation has found. And there are claims of more "mega-dinghies" being prepared, of the type seen arriving on UK shores in recent weeks. The image of a 15-metre long small boat carrying a record 230 migrants towards the UK drew condemnation from both newspapers and politicians. Ministers were accused of "losing control" of illegal Channel crossings, and the French police again found themselves criticised for not intervening. But evocative as the picture was, it also represented a new strategy by the increasingly frustrated people smugglers we encountered on France's northern shores - who attacked our crew with stones, and injured our cameraman. They are running low on small boats, we have found. And once rival criminal groups are now having to work together by loading more migrants on fewer, larger vessels - just like the "mega-dinghy". The UK and France



are announcing measures to increase the number of police officers on the French coast in order to try to stop the migrants. The latest initiative came as Andy Burnham prepared to host French President Emmanuel Macron at Downing Street for the first time since becoming prime minister. Gang members have told our sources that others are being prepared, to the concern of emergency teams on both sides of the Channel, because of the increased risk to more lives. On 4 August 170 people had to be rescued after theirs caught fire in the middle of the Channel. With French officers claiming they

are now intercepting two-thirds of small boats before they can reach the coast, that means fewer crossing opportunities. And for those hoping to make the journey, it means a higher price. Today, the gangs are quoting up to 2,000 (£1,700) per person. It used to be around 1,300 just a year ago. Their passengers also have to now pay in cash, to ensure commitment. During one early low tide on Gravelines beach, we saw the only small boat to launch that day, and it was not what we expected. At 09:30, a dozen or so migrants emerged from the sand dunes. Their distinctive orange life jackets, purchased

from a local sports shop, made them easy to identify. A need for speed at this point would be a fair assumption, but this was not to be the case. There was no running. It was almost orderly. A refined process where instructions were obeyed. As they waded into the calm shallows of the Channel, their "taxi boat" came into view. It is simply a small boat that has departed from further along the coastline to avoid detection. Only now, they are being forced to set off from even greater distances. This one had left from Belgium. The reason for the group not rushing was because the boat was already in the water. French police argue they are prevented from intervening at this point over fears of people drowning. It is to the long frustration of the British authorities, who would like their neighbours to at least adopt a more "case-by-case" approach. As they clutch their phones in plastic wrapping, the group patiently waits for what they hope will be a voyage to a better life in the UK. Some tell me they are from Afghanistan.

FEMINIST ACTIVIST AND JOURNALIST GLORIA STEINEM DIES, AGED 92

Gloria Steinem, who became a leader of the women's liberation movement in the US, has died aged 92. In a post on Instagram, her foundation said she "passed away peacefully" at her home in New York City on Wednesday, "surrounded by many who loved her". Steinem, who was a writer and magazine editor, co-founded the Women's Action Alliance - a group dedicated to fighting sexism - more than 50 years ago. She started her career as a journalist in New York and went on to co-found Ms. magazine, one of the first publications to focus on women's issues other than housekeeping and beauty. During the 1970s, Steinem was a vocal campaigner for women's reproductive rights, among other causes. She herself obtained an illegal abortion in London when she was 22 years old, and years later celebrated the US Supreme Court's 1973 ruling in the case of Roe v Wade, which granted women the constitutional right to abortion. Nearly half a century later she wit-



nessed the reversal of this decision. She also spoke out in favour of the legalisation of same-sex marriage, as well as equal rights and pay for women, and protested against the death penalty and female genital mutilation. Born on 25 March 1934 in Toledo, Ohio, she had a difficult childhood and did not go to school full-time until she was 12 years old. After university in the late 1950s, she went to India on a research scholarship and spent two years in a variety of roles, including helping village women organise non-violent protests against government policies, which sparked her interest in grassroots activism.

Kenyan president orders crackdown on foreigners operating small businesses

Kenya's President William Ruto has ordered a crackdown on foreigners operating small-scale businesses, saying local traders and hawkers need to be protected. His announcement comes amid growing debate about the increasing number of African migrants involved in Kenya's vast informal economy. "From next week, all [foreign] traders doing those small businesses should close them," he said, also promising to fast-track proposed legislation to preclude foreigners from certain areas of trade. Ruto said Kenya remained open to foreign investment, but argued that investors - including Chinese traders - should create jobs and expand production rather than compete with Kenyans in small businesses.



"It cannot be that a person comes from China or elsewhere to be a hawker or open a small shop," he said in an address to small-scale traders who had come to meet the president at State House in the capital, Nairobi, on Wednesday afternoon. "We have made efforts to improve the economy, we have not improved investor confidence for hawkers to come to Kenya," said Ruto, who plans

to seek a second term in election next year. It is unclear how many foreign nationals are involved in small-scale trading or how many would be affected by the new crackdown. Kenya hosts a large refugee population, some of whom live and work outside the country's refugee camps. Government figures show that Kenya had about 857,000 registered refugees and asylum seekers by the end of

June, with nearly 14% living in urban areas. Kenyan law recognises the right of refugees to work and operate businesses, although they are required to obtain the appropriate documentation. Refugees wishing to work or engage in a trade or business can apply for a special permit. In Nairobi and other major towns, migrants from the region can be found working in barber shops and salons, construction, operating motorbike taxis and street vending, as well as selling clothes, food and household goods. Some have fled conflicts or economic hardship at home, while others have moved to Kenya in search of better opportunities under the relatively free movement of people allowed within the East African Community.

In an interview shared exclusively with NDTV by JioStar, Karolina Muchova talked about her campaign this year. Question: Karolina, you arrive here, in terms of Grand Slams, having come off the back of a Wimbledon final. Obviously, not the result you wanted there, but what did you learn from that experience of going all the way through another Grand Slam to the latter stages, and what might you bring from that to this event? Karolina Muchova: Yeah, I think now it's been a while, so I was, in the first few days, obviously a little bit sad and trying to absorb it, I would say. But now, looking back, I take it really



positively. I think it was a great result. Pakistan Star Refuses To Meet King Charles, 'Royal' Controversy Follows: Report

A Pakistan cricket team player refused to attend the team's meeting with King Charles III at Clarence House despite being instructed to attend the event ahead of the third Test against England, according to a report by The Telegraph. The player was among seven cricketers dropped from the squad following Pakistan's loss in the second Test at Lord's. The report claimed that the entire Pakistan touring party, including the seven dropped players, had been asked to attend the meeting. Muhammad Awais Zafar, Aamir Jamal, Khurram Shahzad and Ali Usman were present at the event, while two other cricketers were reportedly reluctant to attend. One player decided to



stay away in protest, according to the report. The meeting was otherwise cordial, with King Charles III speaking to the Pakistan players and offering words of encouragement amid a disappointing Test series. Pakistan captain

Babar Azam presented the King with a signed bat, while Pakistan Cricket Board chairman Mohsin Naqvi also presented him with a gift. Pakistan made major changes to their Test set-up ahead of the third and final

Test against England, replacing almost half of their squad and releasing head coach Sarfaraz Ahmed and bowling coach Umar Gul following heavy defeats in the first two Tests against Three Lions.

The ICC Chairman Jay Shah said the inaugural ICC Women's Champions Trophy 2027 will mark "an exciting new chapter for women's cricket" as the tournament is set to be hosted in India across two venues, Vadodara and Mumbai in February. "As the inaugural edition of the tournament, it will bring together the best teams in the world in an intense, high-quality competition," Shah said, highlighting the tournament's role in providing greater incentive for teams to rise through the rankings and compete for a place on the global stage. "With a marquee ICC women's event now taking place every



year, we have a significant opportunity to build greater momentum, provide more consistency and create a stronger rhythm for the women's game, its players and its fans around the world," he added. The International Cricket Council on Wednesday

moved the inaugural Women's Champions Trophy to India from Sri Lanka and the six-team event will be played in Mumbai and Vadodara from February 14 to 28. Sri Lanka was dropped as the host as the sport is grappling with governance issues in the island nation. The ICC Board approved India as the new host on Wednesday. "The tournament was originally scheduled to be held in Sri Lanka but will now be staged in India as Sri Lanka Cricket continues to make the requisite reforms outlined at the ICC's Annual Conference in July. "The ICC assessed three candidates - Bangladesh, India and South Africa - against its established host evaluation criteria before recommending India as the replacement host, a decision ratified by the ICC Board on 2 September," said the ICC in a statement.
